DUNGARVAN RETAIN SENIOR FOOTBALL TITLE

MOUNT SION TOO GOOD FOR SRSFIELDS

Senior Football—Dungarvan 4-3 Fenor, 1-5
Minor Hurling—Na Risiq (Mt Sion) 2-8, Sarssealag (Dun garvan), 0-3

At the Sportsfield Waterford on Sunday last Dungarvan were lucky to retain their senior football title against a fit hard kicking Fenor side playing with a strong wind in their favour. They were held by Fenor to a lead of one goal and Fenor were shaping like winners. On the turn over however Fenor did not come up to the prospects held out for them in their mind. They were even though they did most of the pressing the experience of the Dungarvan backs which included Jackie Good, Frank Farrelly, Pad Neville and Tom Cahill proved too much for Fenor at the end of the game two lightning breaks through caught the Fenor backs out on each occasion and the result was a goal for Curran and a goal for Fenor to make the issue safe.

In the minor game the issue was never in doubt as Na Risiq captained by young Flannely of the All Ireland minor team were far and away too good for Na Sarssealag (Dungarvan). A few switches by the Dungarvan team might have brought added strength to some of the weak spots but Na Risiq were made and Mount Sion went on to retain their minor championship by 2-8 to 0-3.

The Senior Game

Three Months For Bicycle Larceny

Case Against Van Driver Dismissed

Case Against Van Driver Dismissed

Supt P O'Mahony summoned Joseph O'Donnell Strand Side South Abbeyside under Section 50 of the Road Traffic Act in respect of an accident which occurred on July 22nd last.
Mr T C Williams solr defended.
The Superintendent said that on the day in question the defendant who is 18 years of age was driving a bread van at Mitchell Street. He was sitting near the front of the van and was along he saw a child on or near the footpath on the right hand side. The defendant pulled the van to the left but as he was passing by the child rushed in behind the horse's hind legs and the wheels and was knocked down and the wheel went over the child's chest crushing it and the child died within a few minutes.

The Superintendent said that the only negligence he could allege against the defendant was that the seat he was sitting on was not for him to have a proper view.
In reply to the Justice the Superintendent said that there was nothing to conclude that the defendant was driving negligently beyond the accident.
The Justice said that unless there was evidence to put the matter beyond that he could not convict.

Mr Williams solr said that the facts were as stated by the Superintendent and that the unfortunate accident occurred the van driver pulled up at once.
John Wade in evidence said that he was standing at the corner of Mitchell Street when the horse van passed and he saw a child on the opposite side of the van. The horse was being driven about 4 or 5 feet out from the kerb on the corner side when the wheel passed over the child.

In reply to Mr Williams witness said that in his opinion the defendant was in no way to blame for the accident. He said that the horse was a bit high for the van so that the driver would not have a clear view.
Guard Giblin read a statement by the defendant after the accident.
The Justice said that having heard the evidence he had no hesitation in dismissing the case.

WATERFORD COUNTY COUNCIL

Water And Sewerage Schemes Estimated To Cost £261,200

Scholarship Awards

A special meeting of the Waterford Co Council to deal with water and sewerage schemes in the county was held at Dungarvan on Monday last. Senator Butler and later Mr D Heskin Chairman presided.
Messrs M O Ryan, T Power D Leahy M Hartly M F Walsh T Morrissey M McGrath T Kysus TD Roche W Dower J Mansfield and N Kelly were present.
Messrs S J Moyhinan County Manager, Dr M O Farrell Co Mgr D Sheehy County Surveyor and S G Dowling Co Secretary were in attendance.

At the outset of the meeting Mr Walsh extended a welcome to Mr D Leahy newly appointed member of the County Council. Senator Butler also welcomed Mr Leahy and the latter suitably replied.
At Ballyduff
A deputation from Ballyduff Lower of which Mr Hanly acted as spokesman came before the meeting and pointed out that the water supply there was inadequate. There are fifteen houses and a school involved in the shortage.
Dr O Farrell said that there was a well there which was a reasonable source of supply for the houses. The matter of the supply to the school was one for the Board of Education.

It was stated that a water diver was in the locality recently and water was found at a suitable place.
The Chairman (Senator Butler) said that the erection of a hand-pump in the village would not be expensive.
Finally it was decided to defer the matter.

Scholarships
The following scholarship awards were adopted—
Tenable at University College Cork—John Walsh, Cool Street, Cappoquin; James Hanly, Ballymacarby and Patrick Hallahan Square, Dungarvan.
Scholarship in Agriculture tenable at University College Cork—John Walsh, Cool Street, Cappoquin; Anthony's Nursing Home, Dungarvan.

Youghal Bridge
The revised application for a Bridge Order as recommended by the Youghal Bridge Committee was adopted.
Small Dwellings Acquisition Act
The amended regulations dealing with the above that the maximum market value of a house be £2,000 that the Act should apply to houses only and that the amount of the advance be 8/10ths of the value of the house were adopted.

Ardeken House
The Secretary read a report of a conference with the Local Government Department in Dublin on August 20th in which it was pointed out that it was proposed to develop Ardeken as a regional sanatorium to cater for 240 patients. The full cost of the building construction work would be met by 100 per cent grant from the Hospital Trust Funds.
The report stated that it was proposed to commence building work in the spring so that patients may be received by the end of 1949. The short term policy of providing 28 beds as a temporary measure has been abandoned.

The Secretary stated that a first grant of £11,000 had been made by Hospitals Trust towards the purchase cost of £11,300 of Ardeken.
The County Manager said that patients from Waterford City and County and from Kilkenny would get first preference and after that patients from Wexford and South Tipperary.
The members of the Council expressed themselves satisfied with the progress being made.

Water And Sewerage Schemes
The main item on the agenda was the consideration of water and sewerage schemes for the county. The priority list with the approximate cost—
1. Cappoquin and Lismore (£35,000) 2. Tallow (£20,000) 3. Tramore (£20,000) 4. Dunmore East (£18,000) 5. Passage East (£5,000) 6. Cheekpoint (£3,600) 7. Stradbally (£9,500) 8. Aglish (£3,000) 9. Ballyduff West (no figure) 10. Villiers-town (£2,800) 11. Glencairn and Lyon's Cross (£3,100) 12. Ballymacmague and Ballyduff (Dungarvan) (£2,900) 13. Faurimilewater and Castletiquart (£24,000) 14. Knocknecore and Ballyduff (£400) 15. Ballymore (£2,500) 16. Helwick (extension) (£2,200) 17. Bonmahon (no figure)

An item for the erection of pumps at various places in the county amounted to £5,000 bringing the total to £167,600.
The statement assumed that grants to the extent of 40 per cent would be made in respect of these schemes and taking this into consideration the annual loan charge (25 years at 3 1/2 per cent) would be £6,023.
Mr O Ryan said that the amount of grant was being assumed and before committing themselves the Council should know what they would get. He said that the question of the rates in the county was a very serious one.

The Secretary read a letter from the Local Government Department which stated that the schemes must be ready to be proceeded with and the contract works placed before the matter of grants would be dealt with.
The Chairman said that the grants would very likely be 40 per cent.
Mr Walsh said the Department should be pressed to grant 50 per cent.
