BALLYDUFF NEWS

Muintir Na Tíre—Reading the Annual Report of the Ballyduff Guild Muintir Na Tíre one is struck by the modest claims of achievement for the year under review

As a result of representations made by members of the Council Ballyduff district was chosen as one of six parishes to benefit from the Rural Improvements Scheme

This again entails a canvass of every farm and smallholder in the district with the result that a comprehensive return was submitted to Muintir Na Tíre Headquarters showing the value and tillage and of each holding and the amount of livestock held

As a result an agricultural expert from the Department will take up residence in the village next month and remain for at least five years

This expert advice and help will be available free and where supplies of manures seeds etc are concerned his recommendations will obtain priority

Another important activity of the Guild was the organising of a Horticultural and Home-Craft Show

This was run purely as an educational and cultural show and although very successful it resulted in a financial loss

This was outweighed however by the immense benefit obtained from the show and another one will be run next September

The building of the beautiful Parish Hall in such a small village was a big undertaking and was only rendered possible by the many local farmers and businessmen who acted as guarantors and the large amount of voluntary labour given

The hall is still in debt to the bank but every effort is being made to clear this debt as quickly as possible

This can only be done however with the co-operation of the people, particularly of the youth many of whom do not unfortunately realise that our hall is the social and cultural centre of the parish

For the past year the running of the hall has cost £237. This includes £88 10s for the installation of electric lighting and £12 for lighting and heating for three months

Despite the amount of work necessary to run the hall a perusal of the accounts shows that the only charge for labour is a small payment to a caretaker

All the work of organising etc is done freely by members of the Parish Council

Even the operation of the new projector at the weekly cinema shows is done voluntarily by a member of the Council

We were advised our readers to study the annual report published in this issue and to ask themselves what are they doing to assist in making our Parish Hall a success

Everyone in the district is considered a member of the Parish Guild and members of the Parish Council will point out how you can help
