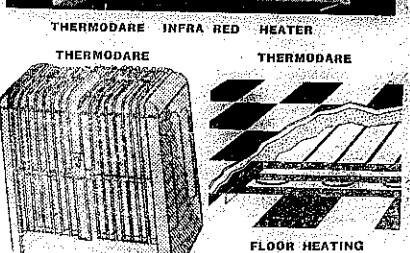
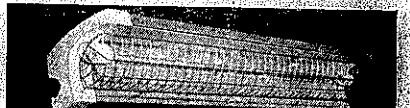

Mr. D. Gullinan, 5 Apr. Sec. Dungarvan, presiding at a public meeting attended by representatives from branches of the I.C.A., Dublin, Na Tire, Macra Na Feirme and N.F.A. from all over Waterford on last Thursday night at the Na Tire, Macra Na Feirme and N.F.A. hall in Dungarvan, said that a proper water supply was more important today than ever. The things which had contributed to the raising the standards of life in the country in recent years were commerce, motor, rural electricity and now piped water which would do much to remove the drudgery and semi-lazy conditions which existed.

The meeting sponsored by the Waterford Federation of the I.C.A. was called to discuss the problems of a piped water supply for rural areas and was addressed by speakers interested in various aspects of the matter. Members and officials of Waterford County Council were also present.

WOMEN'S VIEW

Miss G. Quinn, Ardmore, who presided at the meeting, said that in modern times when so much in the way of progress had been made, it was amazing to realise that only 12 per cent of the households in rural areas had piped water in their kitchens and that 88 per cent of the water which was needed for everything, in buckets from the wells.

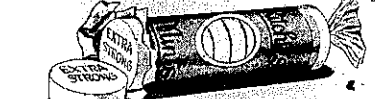

CLAIMS FOR WAGE INCREASES FOR DOCTORS, DENTISTS, OFFICIALS AGAIN ADJOURNED

Member Calls For Standing Orders

Stating that at present there were no standing orders in force which would hold a decision of the Authority as binding, Mr. T. Kinnon at last Monday's meeting of the Waterford Health Authority in Dungarvan, called for the adoption of a set of orders before the Authority dealt with applications on behalf of doctors, dentists and officials, for revised scales of salaries.

The claims were listed under two separate heads on the agenda and the County Manager, Mr. J. Hynes, Secretary, said that he had to attend the meeting, but left with the estimates meeting of Kilkenny Corporation.

When the increases for the doctors and dentists came up, Mr. Lannon recalled that when this matter had first come before them they had been unanimous in rejecting it, but then it had been placed before them again and now it was on the agenda for the third time.

"I" said Mr. Lannon, "asked that a set of standing orders be adopted here, and I was appointed as one of a small committee who were to draw them up, but I have heard nothing about it since. I want to have those orders adopted before dealing with this matter as we have nothing to hold a decision which we make at present. We can come to a decision that we reject this claim but it can be placed before us again if the medical people write another letter for the next meeting and I want to be fair to all, and I want to have this application adjourned until such time as we have adopted standing orders."

Mr. J. Hynes, T.D., Chairman, said that he would like to have a set of standing orders ready by the next meeting, but he would like to see them ready in about six months.

Mr. John Griffin expressed the view that it should be possible to have a set of straightforward orders such as they would require ready inside six days.

Mr. S. J. Hynes, County Manager, who was present at this stage, said that most other Councils, as far as he knew, had already passed these increases for the doctors. There were five vacant dispensaries in Waterford at present, and doctors would not apply for them at the old salary scales.

Mr. Lannon—That has nothing to do with it. The point is that if we reject this application today another letter can be written for the next meeting and we'll have to start all over again. I want to stop that.

ADJOURN

The Manager left at this stage when the Chairman ruled that the meeting would have to keep to the agenda and later when the matter arose Mr. C. Curran proposed that both applications be adjourned until the Manager was present.

There's a great deal of public money involved in these applications, said Mr. Curran, and the Manager should be here to answer the questions which will be asked.

When Mr. P. Browne said that they already know the Manager's views on the matter, Mr. Curran replied that while this was so, there were many points which he and other members would like to discuss before a decision was reached. As far as the number of awards points to raise, Mr. D. Madden seconded Mr. Curran's proposal.

Mr. J. Griffin said he would support the proposal to adjourn the claim from the doctors because on the last occasion when the Board discussed it the members had agreed for data concerning the staffing of hospitals and other matters. That request had been ignored and before reaching a decision he wanted to know what right the people had to specialist treatment and other health services. He knew nothing about this at present and his membership of the Health Authority had done little to enlighten him.

At the same time he thought that the claim from the officials should be treated as a separate matter and dealt with by itself.

Mr. Curran said that neither of the applications should be dealt with in the absence of the Manager and he again proposed that both applications be adjourned.

Mr. T. Gallagher proposed an amendment, seconded by Mr. Browne, that the adjournment be limited to the doctors' application.

By 10 votes to 7 the amendment was carried. The proposal of Mr. Curran to adjourn both claims was rejected.

The voting for the proposal was as follows: For—Messrs. W. Foran, J. Quicke, N. Walsh, M. Gagey, D. Madden, A. Hamilton, G. Collins. Against—Messrs. P. Roche, M. Morrissey, J. Power, W. Kennelly, T. Gallagher, P. Browne, J. Griffin.

CALL FOR REPORT ON PATIENT'S DEATH

At the conclusion of the Waterford Health Authority in Dungarvan last Monday evening, Councillor C. Curran referred to what he called a damming rumour which was circulating throughout West Waterford concerning the death of a patient at Ardara Hospital. The patient had been brought to the District Hospital in Dungarvan following an accident and had now been removed to Ardara. Mr. Curran said that he wanted to get particulars as to what form of treatment the patient had been given in Dungarvan Hospital.

Mr. James Delaney, Chairman, said that he would order a report to be prepared on the patient's case and that he would call for it at the next meeting.

Ald. W. Kennelly, T.D., Chairman, asked Mr. Curran to put his request in writing and the matter would then be investigated.

Mr. Curran—I will do that.

CUTS IN ASSISTANCE

Mr. Lannon then referred to a number of poor people in Dungarvan who had cuts made in their Home Assistance Allowances and their medical cards.

And, he said, "while that has been happening you have met increases for doctors and dentists, while poor people who will stand up here and suggest increases for doctors and dentists, while poor people are running out of the country they way they are."

Mr. Lannon then gave details of some of the cuts, and said the complaints applied to quite a number of cases, while there was also a lot of discontent about medical cards. He asked for information as to who held medical cards in the town.

The Chairman said that such a list could not be circulated, but Mr. Lannon might get the information in the office.

Mr. Lannon replied that this would satisfy him as he did not want to parade these names in public. "But he added, "I want the poor people to be looked after, and I want to know what's being done about it. Doctors don't want to come to these people as they're no good to them, but I'll see that they're treated fairly, and I'll raise the matter here and in Waterford and I'll go around the County until something is done."

Mr. Hynes, Secretary, said that Waterford had one of the highest percentages of medical cards in the country. He would have details of these for Mr. Lannon at next meeting.

THE GUINEAS

Newmarket, the home of the Guineas, first run in 1804, may truly be called the classic ground of racing. It is the professional man's course, and until comparatively recently, was devoid of the inevitable trimmings of other great race courses.

There was no grand stand, no crowd, no booth or side show and no fixed winning post, the distance to be run in any race being determined by the Judge's Chair being wheeled about from point to point on the course. Newmarket's celebrity was established by James I. Later, according to a persistent legend, horses which had been cast up on the coast of Galloway from the wreck of the Spanish Armada were brought to Newmarket where their swiftness was favourably noticed. After a decline in popularity Newmarket again blossomed in the time of Charles II since when it has never lost its place. In 1750 Newmarket was the birth place of the famous Jockey Club, which later was to infuse some law and order into the appealingly lax standards of that time. Many of its earlier innovations are still with us; parading in the paddock, the number board with the names and numbers of the jockeys, and the banning of the use of drugs.
