

## PENSMAN TAKES YOU behind the SPOTLIGHT

### AN ESTIMATES MILK RUN

Members and senior officials of Waterford County Council met in Committee last Monday for a milk run on the estimates for the coming year. I think the idea behind the closed doors was that the members would feel freer to express their ideas and to make suggestions about the many financial problems that exist in the absence of the press.

While a great deal of information about the matters discussed at the meeting was not immediately to hand, it appears that the situation, as to whether it will be worse rather than just bad, will depend on the allocations and grants or lack of them which will result from the Budgetary measures announced on Tuesday last.

The matter of service charges and as to whether there would be need to increase them in the event of a financial shortfall and the possibility of job losses resulting from cut-backs were matters that were, we understand, also mentioned.

Pending the outcome of the Budget and the financial allocations for roads, sanitary services, housing etc. to be made to the Council by the Department of the Environment for 1987, further discussion on the Estimates was deferred until Tuesday, April 21.

### DUNGARVAN MAN CHOSEN AS TAOISEACH'S AIDE

Lt-Commander Charles J. Lawn has been chosen by the Taoiseach, Mr. Charles J. Haughey, to be his Aide-de-Camp and so becomes the first Naval Officer to hold this important position.

Elder son of Mr. Tony and Mrs. Evelyn Lawn, Grattan Square, Dungarvan, Lt-Commander Lawn, following his first and second level education locally, joined the permanent Defence Forces as a cadet in 1973 and trained at the Military College, Curragh, the Naval School, Haulbowline and the Royal Naval College, Darnmouth.

In the course of his naval career up to this he has served as Executive Officer on LE Fola and as Executive and Operations Officer on LE Eithne. Since 1986 he has been Assistant Staff Officer of Operations at Naval Headquarters.

Aged 34, Lt-Commander Lawn now lives in Dublin with his wife (formerly Miss Ann Curran, Ballylangadon, Grange) and two children and on Sunday last he performed the first duties in his new position as ADC when he was officially received at the Taoiseach's residence at Kinsealy in Dublin.

It is a signal honour for Dungarvan's young Naval Officer to be appointed to such a post and especially so as it was the first occasion for a Navy man to be so chosen. We join with his many friends in Dungarvan and elsewhere in congratulating him and indeed his parents and the members of his family also on his appointment to such a very important and responsible position.

### DUNGARVAN A CENTURY AGO

A rather historic ledger bearing the title "Dungarvan Parochial Cash Book" covering a period from 1875 to 1912 has been loaned to me and as it reflects much about the life and times in Dungarvan in that period of a century ago we will reprint extracts from it in the

course of the next few weeks. The first section of the ledger was compiled by Very Rev. James V. Cleary, D.D., P.P. and consists of an "account of cash received and expended by me in the Parochial Church of Dungarvan since my appointment on 13th February 1876." In addition, the ledger contains comments made by the P.P. on the general economic conditions prevailing in the town and district in those years and from that point of view it is additionally interesting.

The first entries in the ledger indicate small church gate collections at Sunday Masses, averaging totals of £1-5-1d. "Pew rents" for reserved seats in the church were also paid but the return from these was also low, averaging £3-2-6 per quarter. Expenses incurred included organist's monthly wages, £3-6-8; organ blower's wages, 17/6 per quarter and many other recurring items such as bills for gas (which must have been the lighting system in the church) and the usual maintenance jobs.

As a result of the poor returns and large outlay, Very Rev. Fr. Cleary noted in an entry in the ledger for Sunday, July 9, 1876 that he preached that the church gate collections were insufficient "to supply the requisites of Divine Worship and keep the House of God in decent condition." He pointed out that pew rents were left unpaid by most of the families who appropriated the reserved seats and stated that "the rough stone floor of the church should be taken up and replaced by timber."

Following this sermon, the P.P. held a meeting with his parishioners at which it was agreed that they would undertake the collections at the church gates themselves (replacing the paid gate collectors), that they would pay a penny per head and 3d. per family for reserved seats on Sunday or 2/6d per quarter.

At this point the Sunday Masses collections were moved in from the church gates to the church doors and the amounts collected increased to £5 and £6 each Sunday while the quarterly pew rent payments went up to over £7.

An entry covering the Sunday Mass collections from January 13 to 28, 1877 stated that this was "a time of contested County election and great trouble and confusion."

We conclude for this week with the following extract dated February 18, 1877: "Sexagesima Sunday: A Mission was commenced in this parish by four Vincentian Fathers from Cork, viz. Fathers Dan O'Sullivan, McKenna, Genonvic and Cahill. It was arranged that the nave of the Church should be free of charge, that the poor may be encouraged to attend the exercises. The charge in the pews was so moderate that nothing more was expected than to cover the expenses of the Mission. It pleased God to strike poor Father Genonvic with apoplexy in the pulpit, and after a week's sickness to summons him to his reward. His sickness and funeral cost no less than £49-12-6. Hence the Church lost financially on the Mission."

## Civil Defence Regional Competition In Dungarvan

The Regional Civil Defence Welfare Competition for 1987 will be held in the Sports Complex, Dungarvan on Sunday next, April 5. Five teams from the No. 8 Region representing Kilkenny, Wexford, Tipperary (S.R.), Waterford County and Waterford City will compete in the competition to which the rules for last year's National Competition will apply.

Each team will be under the control of a Team Supervisor

who will accompany them at all times until they have completed their tests so as to avoid any security breach.

Three competition locations have been designated as follows: Dress Inspection — Courthouse; Oral Test — Courthouse; Practical Test — Sports Com-

plex. A meal will be provided for the members of the competing teams at the Sports Complex.

### TIMETABLE

All teams will report to Lawlor's Hotel for registration at

9.30 a.m. and the draw for competition places will follow at 10 a.m.

The practical tests will then commence at the Sports Complex at 10.30 a.m. with a break for a meal at 1.30 p.m. The competition will resume at 2.30 with Dress Inspection, followed by the Oral Tests at 2.40 p.m. until 5 p.m.

The proceedings will conclude with the Competition Dinner and presentation of prizes at Lawlor's Hotel commencing at 6 p.m.

Mr. Colm Bannon, Civil Defence Officer, Waterford County Council has requested that extreme care be exercised at the practical test site at the Sports Complex where a total of 15 high pressure gas rings will be operating but adds that all necessary precautions will be taken at the site.

A request has also been made that every effort should be made by teams and spectators to ensure that no damage is caused at any of the centres used for the competition.

## Deise Gun Club Releases Pheasants

The Deise Gun Club in Dungarvan has embarked on a programme of activity that will ensure that the pheasant does not become an extinct species of bird in Co. Waterford.

While the sixty-member club draws on the activities of many "gunmen" who re-use to take out membership of gun clubs in the county, the Deise Gun Club is determined that there will not be any shortage of pheasant in its shooting district in the years to come.

Recently the club expended in excess of £1,000 in replacing two year old pheasants and last week-end the first batch of them was released. In fact over the last half decade the Deise Gun Club has released more

than 2,000 pheasant and almost 2,500 quail.

"Only for the gun clubs there would not now be any pheasants in the country," said Deise Gun Club official Michael Moynihan. "The accusation often levelled at us that we are exterminating pheasants just doesn't stand up to scrutiny," he said.

The club is also going into a major breeding operation that will involve incubating 300 eggs, hatching and rearing them. That will embrace a time span of about twelve weeks and when the birds are then reared they will be released.

"Sadly," said Michael Moynihan, "there are far more guns in Dungarvan, and Co. Water-

ford as a whole, that are not contributing to the protection of pheasants than those which are."

## Waterford ICA Federation Announce Plans

The Spring Meeting of Waterford Federation was held recently in Carrickbeg, Mrs. Marie McDonald, President, chaired the meeting which was attended by 21 of the 24 guilds in the Federation.

After the formal business of the meeting the President welcomed new officers and specialists. These were as follows: Treasurer, Mrs. Arnette Phun-Kett; International Officer, Mrs. Nancy Morrissey; Production Officer, Mrs. Margaret Leahy; PRO, Mrs. Mary Shanahan; Waterford TA member, Miss Maureen Matthews was appointed to the Committee of An Taoise.

The wide range of interests for the countrywoman today was shown by the various specialist reports:

From the Chairman Officer, Mrs. Jenny Kiely, we heard that 56 members from Waterford Federation (a record number) will attend Waterford week at An Grianan, beginning 11th May. The Kellog Foundation, who originally donated the property to the ICA, are now giving a further \$85,000 to complete an extension.

Mrs. Margaret Leahy, Production Officer, reported that arrangements for Biannual Tests for Calf-rearing were well under way. The question of a short horticultural course based locally was under investigation.

Mrs. Maria Mullins, Competition Secretary, encouraged guilds to take part in both the Fetsy Lator Set-Dancing and the Hoecht "Amazing Grace" competitions. Tnamore were county winners in the set dancing and Ballinameela represented the Federation at the national final in the National Concert Hall, Dublin. Mrs. Nancy Morrissey, International Officer, has plans for involving guilds in the study of a particular country, its customs, dress, music, food and drinks and turn the results into an enjoyable social evening.

Mrs. Mary Fitzgerald, Officer for Irish, could offer another enjoyable experience when members attend one of her "Irish Evenings," time and venue to be announced. Mary is to be congratulated on obtaining an Arts award for Public Speaking in Irish.

Arts Award Officer, Mrs. Siobhan Lincoln urged members to

strive for awards in singing Sean-nos and Irish melodies in Irish and English.

Miss Lena O'Connor, Crafts Promoter, told the meeting of the forthcoming Federation Day in Dungarvan on 9th May. In addition to the usual crafts and flower arranging, there will be entries in cookery and painting. This event will be open to the public.

In the course of her address the President told us that Mrs. Maymo McDonald, former National President, was the ICA nomination for the Senate on the Cultural and Educational panel. She added that Waterford had been selected as the venue for the National Council meeting next spring. — P.R.O.

Messages of sympathy poured into Arus an Uachtarán last week-end following the death of President and Mrs. Hillery's only daughter after a long illness earlier in the week.





CATHERINES All-Ireland Finals — With the exception of Kilmaree, New York and Thurles in recent years, we always associate Joke Park with the above competitions, but in the early years of the Association, commencing with Brr. Clontarf, Moncorce, Terenure, Tipperary and Carrick-on-Suir all hosted finals. Dungarvan was a famous arena at that time and Dan Finlay's field was the mecca of all goals for these great clashes. Dunggourney (Cork) beat at Brian Boru's London in the 1902 All-Ireland in Cork, but the 1905 and 1907 finals were played in Dungarvan and then again in the 1911 All-Ireland when Limerick (Munster champions) refused to replay the final match interrupted at Cork, in 1912, Kilkenny beat the Dungarvan team 3-3 to 2-1 and were awarded the championship. These were all hurling games, needless to mention, and it was Dunggourney's peak period, winning the Cork senior championship in 1902, 1907, 1910. An old follower told us recently of a great game of hurling in the early 1900's between Dunggourney and Blackrock at Cobh. It was known as the Fr. Murphy tournament. Fr. Murphy was the then Parish Priest of Mogeely Parish and the object was to provide funds for Mogeely's new church which was under construction at the time. The "good old shoulder" was a distinguishing mark of the game at the time and this man was astonished to see some of the Blackrockmen "stretched" after some exciting tussles on the field. "Are they dead?" he enquired of his accompanying friend, "Yerra, no," was the reply, "they'll get up again." This man also related to us that two Dunggourney players missed the train in Killeagh on route for Dungarvan and sensing that it still had a long circuit to do via Cork, Mallow, Fermoy, etc. before reaching Talow Road Station where they would board it, they made a bee-line for the latter place, shaksmare along by the Half-way The Pike, finally reaching their destination and playing in the All-Ireland final against Kilkenny. Enthusiasm and determination was made of stern stuff in those days. Whatever was the reason for it, a year or two occasionally elapsed before those All-Ireland's were completed. Sentenced For Damaging Youghal Holiday Home

After forcing entry to a summer-house in Youghal to seek accommodation for the night two unemployed East Corkmen proceeded to cause malicious damage which included the smashing of the windows, District Justice W. F. O'Connell heard at Youghal Court last Thursday.

Richard O'Loughlin, Laurence Kelly Terrace, Killeagh, who pleaded guilty to entering the summer-house of Mrs. Mary O'Connell at 1 Summerfield Youghal, on the night of November 23/24 with intent to cause malicious damage in excess of £50.

Garda Inspector J. Hogan told the court that the defendants came by bus to Youghal that night intending to go to a disco in a local hotel. However there was no disco and when they failed to get a lift home they decided to break into the summer residence and stay there for the night.

Inspector Hogan said that when they forced their way in they proceeded to damage ware, curtains, and even smashed all the windows. The gardai were alerted and the defendants were apprehended.

The inspector said both defendants had a number of previous convictions.

NOT PREMEDITATED

Mr. John Brosnan, solicitor for Foley, said the malicious damage was not a premeditated act and if given time his client would pay compensation.

Mr. Patrick J. Lavan, solicitor for O'Loughlin, said his client had some drink taken. Though at present unemployed he has an offer of a £90 a week job starting next week.

District Justice O'Connell sentenced each defendant to six months imprisonment on each charge, the sentences to run concurrently. He suspended the signing of the warrants, however, to enable each defendant pay £105 compensation by May 1.

"If they fail to do so they will go to prison. It's as clear and as simple as that," the Justice added.

Fined For Assaulting Door Keeper

Con O'Connor (19), 64, Childers estate, Dungarvan, appeared at Dungarvan Court on a charge of assaulting Raymond Hanessy, climatologist at Ringnaslogue, Dungarvan on December 1 last.

Replying to questions by Supt. M. English who prosecuted, Raymond Hanessy stated that he was employed at the Dungarvan Sports Centre and on one night in question was supervising at the door of the complex. At about 9.15 p.m. he was letting out a group of people and the defendant was there and tried to get in. Witness said that he told the defendant that he had instructions to let no one in but Connors tried to push by him. He caught the defendant who then punched him in the face.

Cross-examined by Mr. E. P. King, Solic. (J. F. Williams & Co.), who appeared for the defendant, witness admitted that he told Connors on the occasion that he wouldn't be let in because he was under age. The age limit was 18 years.

Denis O'Donovan stated in evidence that he was in the Sports Centre that night and was standing near the door when the incident occurred. A group from Dungarvan had the centre booked from 9 p.m. to 10 p.m. He said that he saw a person trying to push his way in the door and being told that he could not be admitted. Witness said that he then saw him strike Hanessy.

Garda M. Murphy in evidence said that he had investigated the matter and had interviewed Con Connors. He said that Connors declined to make a statement and offered no explanation about what happened.

NOT UNDERAGE  
Con Connors giving evidence in his own defence said that he was 19 years old. He went to the Sports Centre often and was well-known there. He went

to the Centre on the night of December 1 and at the door he was told that a session was in progress. When he asked when this would be finished he was told he could not come in as he was under age and that he would have to be over 18.

Witness said he told the person (Hanessy) that he was not under age as he was 19 years. Some other people then came

along and were left in but as witness went to go in Hanessy caught him by the jacket and he then struck Hanessy with his fist.

Mr. King submitted that as the defendant was 19 years of age he was not under age and should have been allowed into the Centre on the occasion. When he was caught by the jacket he reacted by striking

the person who was attempting to put him out.

District Justice O'Connell said that Mr. Hanessy was in charge at the Sports Centre that night and told the defendant that he couldn't get in for whatever reason and when he attempted to restrain the defendant as he tried to push his way in he was struck.

Convicting the defendant, the Justice imposed a fine of £10.

# Change Expected In Starting Date For S.F. Championship

**NEXT SUNDAY**  
As a result of Waterford's win on Sunday, there will have to be a review of the published fixtures programme and it is now likely that April 19, which is the date of the semi-final against Galway, will not be the starting date for the football championships.

Because of the closeness of the under 21 hurling game against Limerick at Dungarvan on Friday of next week, it is also possible that a couple of the games which are fixed for next Sunday and which involve under 21 players, may be altered. However, the County Secretary told me on Monday that no overtures for postponements had been made and the programme of Phelan Cup quarter-final matches will likely go ahead as planned.

Presuming that it will, the list will be as follows:—  
**AT KILMACTHOMAS**  
A double-header here will have Ballinameela and Ferrybank in opposition in the opening game and Kilrossanty meeting Dungarvan in the second match at the same venue.

Ballinameela, who made heavy weather of beating off a stiff Brickey challenge in the first round, will need to be in their toes' all the way in this, if they are to beat Ferrybank, who surprised Clashmore at the same stage.  
Kilrossanty and Dungarvan both won their initial rounds at this venue and both played very well, for a first, outing. They met in the championship at Stradbally last year, and Kilrossanty won very decisively on the occasion. Not being under the same pressure in this one, Dungarvan might be able to lift their game and at least go closer.

The forecast here is Kilrossanty and Ferrybank.  
**AT LEAMYBRIEN**  
Close rivals, Stradbally and Kilmacthomas will be in action in the first game and this will be Kilmac's first outing since their forgettable county final appearance at Walsh Park last year. On their first round and semi-final form of last year, they could have the beating of Stradbally.

In the second game the re-fixed Tramore v. Nire tie should be quite a contest. The Nire are the reigning county under 21 football champions and will be a force in the senior championships this year (they say) and in this game we expect to be given a sample of what they will be like when the 'real thing' comes.

Earlier at the open Board meeting, a long discussion took place on the proposed grouping in the under 21 championships. The Chairman informed the meeting that the Eastern Board had rejected the recommendations and that now it would be a matter for the County Board to examine the situation. Some delegates thought that some of the proposed groupings were too strong and that these should be examined very closely by the Coisde Gnotha.

**REFEREES**  
The Chairman expressed disappointment at the very poor

response to his appeal for new referees. Only one or two names had been submitted, and one of these would not now be available. He said that the Eastern Board had ten new referees. He informed the meeting that Coisde Gnotha in accordance with Central Council instructions, were now, in common with all other counties, going to embark on a re-appointing drive. A Referee/Administrator had been appointed by the County Board and he would be responsible for the recruitment of prospective referees, arrange for their training as well as provision for assessment and grading of existing referees in the county. The new man will be named to the next County Board meeting and he will be expected to get to work immediately.

**GAELTACHT SCHOLARSHIPS**  
Nicolas Mac Craith told the meeting that twenty places had been reserved at Coliste na Rinne for the first three weeks of the summer courses and that the County Board intended having ten from each Division. The upper age limit is being changed and a decision about girls being allowed to apply, will be taken by the next meeting of the Board.

The Chairman stated that many would-be applicants didn't know about these scholarships every year, because some club secretaries failed to inform their members about the scheme. He said the chief qualification was membership of the Association. He appealed to clubs present to inform their members that application forms for the interviews will be available from the Board secretaries when the date of the interviews is decided on.

**REGISTRATION**  
In reply to a question, the Chairman was informed by the Divisional Registrar that only a small number of clubs had so far submitted their registers. The Chairman stated that the full list of those not registered will be read at the next meeting and defaulters will be dealt with in accordance with rule.

**UNDER-AGE HURLING SCHEME**  
Munster Council chairman, Michael O'Connor, has informed

Waterford County chairman, James Tobin, that this county (and Kerry) had been designated as areas requiring special attention for the development and promotion of hurling at minor and under-age level. He stated that priority would be given to these counties after schemes had been outlined in submissions to be made to the Council before April 27th. In order to devise a plan for submission to the Provincial Council, the Waterford Chairman appointed a special committee to deal with the matter. The members of the committee are: Rev. Bro. Tommie Rev. Bro. Griffey, Mouna Slon, C.B.S., Eugene McKenna, Waterford Regional College, Jim Greene, Rev. Fr. P. Fitzgerald, County Hurling Officer, John Klely, Chairman, Western Bord na nOg, John Moore, Chairman, Cotny Bord na nOg and John Jackson, Secretary, Bord na nOg, and these were addressed by the County Chairman at their first meeting on Monday night. They hope to complete their plans within three weeks at the latest.

**CONGRESS**  
Offaly's John Dowling was elected President, Elect, at Annual Congress last week-end at Wexford. The 55 year old Offaly county secretary and former All-Ireland referee, has been to Dungarvan on G.A.A. business on a few occasions and is pretty well-known here. He conducted the course for referees at St. Augustine's College earlier this year.

As a Congress it was rather dull and unproductive. Only ten of the 60 motions listed were actually approved. A few were referred to Central Council, 13 were withdrawn (but not before some discussion) and the record number of 21 were defeated.

The motion seeking to allow sponsorship and advertising to be accepted from alcoholic drink companies, etc., was passed by just one vote. It required a two-thirds majority (which was 159 votes) and it received exactly the number needed. Those successful included motions condemning the continued occupation of Crossma-

glen by the British Army; the continued imposition of V.A.T. on burleys, also D.I.R.T. tax on rates; that the G.A.A. should design a new emblem to be worn by its members; that the G.A.A. condemn the practice of strip searching, on humanitarian grounds; that the G.A.A. condemn the denial of basic human rights to Irishmen imprisoned in British jails, and the rights of those prisoners to speak their native language, wearing the Fainne and play Irish games.

The President in his splendid address spoke on the evils of drinking and was applauded at length, even though the Congress had previously passed the drink sponsorship motion.

He told delegates that the Association 40-day owned fields throughout the country with an estimated value of £100,000,000.

He said the total number of fields vested was approximately 1,500.

The New York President told Congress that a total of 64 teams were now affiliated in New York and many more would be accepted if field accommodation was available.

**WATERFORD SHOCK CORK**  
This is one game I will always regret having missed seeing. I had to be content to listen to the broadcast, and I did this sitting in a car outside the Congress Hall on the Quay in Wexford. Not twenty yards away a group of Cork delegates to the Congress sat and listened also. When the final whistle went, they got out of their car and returned to the hall in a stunned condition. It was without doubt, the biggest shock for a long time and for a second or two there was silence after the announcement was made to Congress and then a couple of hundred dele-

gates applauded, almost embarrassingly. Something wonderful had happened to poor Waterford and everyone was so pleased about it. They were very sincere and the feelings of satisfaction were genuine. I spoke with a few of Galway's delegation and they said they were delighted as it was time that Waterford got a break. They told me they were looking forward to meeting us on Easter Sunday in the semi-final. I suspected that their delight might be of the selfish kind as they would undoubtedly prefer a meeting with Waterford than a re-run of the All-Ireland. More about that later.

Last week I wrote that I would be satisfied if we stayed within seven or eight points of Cork and I would not be very surprised if their winning margin was more. Other commentators expressed similar opinions. No one gave Waterford a chance and anyone who saw them lose to Tipp, and play a very tame game against Meath, would have been absolutely reckless to have predicted that this team would beat the All-Ireland champions, Cork. But nevertheless it did amazingly happen and it was made happen by sheer guts and fierce determination by a Waterford side that really played their hearts out and just wouldn't give in. It was unquestionably their best display since coming together about six months ago. This was the game in which they really put their act together and proved what can be done. Thanks to team manager, Tony Mansfield, Ollie Wilkinson, Phil Fanning and John Galvin, the team have come on a 'ton' in a comparatively short time and it is hard to believe that only a few short months ago when Cork were winning the All-Ireland that we had only emerged as joint winners of Division 3 of the league, having shared the points with Mayo. It is amazing progress.

The response from the huge home crowd on Sunday gave testimony to the support for Waterford hurling and for everyone who had the privilege of seeing the game, it was a

day of glory to be remembered for a very long time to come. It was encouraging as well to find that the youth policy of the selectors is beginning to pay dividends already. If such progress is maintained for a few years more then hurling in Waterford will undoubtedly be back where it belongs.

Someone said to me in Wexford after the game that Cork must have believed what they read in the papers and as a result were overconfident and treated the Waterford team with a certain amount of contempt. Their favourite newspaper did blame overconfidence and on this occasion let the referee off without the slightest criticism — something that is rarely done when Cork lose. Their Cork city based staff reporter did comment on a couple of decisions about the umpire signals for a couple of Waterford points. The result, must have been a galling experience for Cork — we know the feeling only too well.

Now for Galway on Easter Sunday. The game will be fixed by the G.A.C. at a meeting in Dublin on Friday, but it is pretty certain that the venue will be Thurles and hopefully the two semi-finals will be played together.

Having disposed of the All-Ireland champions, Waterford are now up there to be knocked and we'll find that in the next couple of weeks, Waterford hurling will have taken on a new image. Again it is a time for us to keep our feet on the ground as we still have a long way to go Sunday's victory will have boosted our ego and our confidence, but it will be foolish to become too optimistic too soon.

# Fined for using Monofilament fishing net

Joseph D'Alton, Coligan, Dungarvan and Macnae, Roey, Mweelanorma, King, each pleaded guilty at Dungarvan Court to two charges of illegally using a monofilament net exceeding 30 meshes in depth off Ballycurreen South, Old Parish on July 25, 1986.

Mr. Pergus Power, Solr. represented the Southern Region Fisheries Board who prosecuted and Mr. J. P. Gordon, Solr., defended.

Mr. Power told the Court that on the date in question the defendants were seen by Fishery Officers hauling a salmon net of monofilament design and over 30 meshes deep in a boat off Ballycurreen South. He said that Joseph D'Alton had a number of previous convictions for similar offences.

Joseph D'Alton in evidence said that he operated a small 20 ft. boat with an outboard engine. He had been caught by Fishery Officers twice before and had been fined a total £1,600 in all. These fines were under petition to the Department of Justice for reduction at present. He said that last year the salmon season had been very bad and prices were down and on the date they were caught they had actually taken no fish. He added that the only type of salmon nets which could now be purchased were monofilament nets.

Mr. Gordon pointed out that this was the sole fishery prosecution in the Helvick area for 1986 and asked that it be treated leniently as the defendants

had co-operated fully with the Fishery Officers.

District Justice O'Connell said that as there were substantial fines outstanding in the case of Joseph D'Alton he would impose fines of £100 on each of the two charges against him on this occasion.

When Mr. Gordon pointed out that Poley was only a crewman

in D'Alton's boat, the District Justice fined him £25 on the first charge and marked the second charge proved and taken into account.

When Mr. Power sought £100 in costs and expenses from each defendant, Mr. Gordon submitted that this was excessive. The District Justice allowed £100 to cover both defendants.

3.—Dusting of pastures.  
4.—Magnesium licks and bullets.

**SHEEP**  
Dose lambs and hogget ewes at 3-week intervals on intensive farms. Levamisole drugs are quite adequate.

**CLOSING FOD SILAGE**  
Do not graze silage ground, if possible.  
Spread approx. 120 units of Nitrogen per acre now. Use Urea unless land has been recently limed.

**LEPTOSPIROSIS**  
Now is a good time for vaccination as animals go to grass. Bulling heifers should at least be vaccinated where leptospirosis is suspected.

**WINTER CEREALS**  
1.—Apply second Nitrogen dressing from now on.  
2.—Use MBC for eyespot control, or Sportak Alpha. If there is likelihood of MBC resistance e.g. after a crop of winter cereals being treated with MBC.  
3.—Growth stage 5-6 (just before 1st node), is the best time for spray for eyespot control. This is also the correct stage to apply Cycocel to winter wheat. Do not apply COC in very cold or frosty weather.  
4.—Sportak Alpha will control Rynchosporium as well as eyespot in winter barley.

**THE E.E.C. THIRTY YEARS ON**

## COLLISION AT DUNGARVAN ROUNDABOUT

A 2-car collision which took place at the roundabout at Springmount, Dungarvan, on last Christmas Eve, had a sequel at Dungarvan Court last week when the driver of one of the cars, Robert Davies, The Cottage, Ballinaha, Stradbally, pleaded to a charge of driving without due care on the occasion.

Supt. M. English who prosecuted stated that on December 24, a car driven by Frank Duffy, Aglish was in possession at the roundabout when the defendant came into it and an inevitable accident followed. It all appeared to be due to a misunderstanding on the defendant's part, he said.

The defendant told the Court that when he went to stop at the roundabout he accidentally put his foot on the accelerator instead of the brake and his car shot forward.

Asked whether he was claiming any expenses, the driver of the other car, Frank Duffy, stated that he was claiming £70 for coming to court. He also pointed out that before he had arrived he had been fined £100 in respect of an untaxed vehicle at the Court and asked that this might be reduced.

Supt. English pointed out that as Mr. Duffy had been summoned earlier at the Court as a defendant in another matter it could possibly affect his claim for expenses in the present case.

District Justice W. F. O'Connell said that he would allow only £25 expenses adding that Mr. Duffy had to balance his claim with the Supt. He imposed a fine of £5 on the defendant, Robert Davies and refused the application of Frank Duffy to reduce the £100 fine imposed earlier in respect of an untaxed vehicle.

# 96 complaints for Ombudsman from Co. Waterford

The Ombudsman, Mr. Michael Mills, last week presented his third Annual Report to the Oireachtas. The Report covers the year 1986.

The Report states that a total of 5,691 complaints was received during the year, a slight increase on 1985.

Of the complaints finalised during the year, 1,277 were solved in favour of the complainants. Assistance was provided in another 1,426 cases by guiding the complainants in a particular direction and by ensuring that they could have access to some other scheme or benefit.

A total of 1,993 complaints was not upheld and a further 716 cases were discontinued or withdrawn.

Dispute about telephone accounts represented the largest single area of complaint, followed by complaints against the Department of Social Welfare, the Local Authorities (as a group) and the Health Boards.

With regard to telephone accounts complaints were upheld in approximately one-in-three cases while assistance was provided in a further 20 per cent of the complaints.

### LEGAL BACKGROUND

In his Report Mr. Mills emphasises the statutory basis of his work and draws attention to the implications that this has for the day-to-day work of public servants. He praises the co-operation he has received from public servants but points out that public bodies subject to investigation are bound by law to facilitate his Office in investigating complaints.

The Ombudsman also refers to the value of having an Office like his which has the authority to carry out an independent assessment of decisions made by public servants. Mr. Mills said that the experience of the past 3 years had made him aware of the difficulties facing any public representative in seeking to change a decision taken by officials in the public service. The main reasons for this were that public representatives did not have access to the files, their representations did not result in an independent assessment of the original decision. The Ombudsman's Office, on the other hand, had access to all documentation, could interview officials and carried out an independent examination of the evidence.

Some cases investigated by his Office had involved representation from many politicians to the relevant public bodies over a number of years. The response from the public service each time had been that a re-examination of these cases had revealed no grounds for changing the original decision. He's Office subsequently examined the files in detail, interviewed witnesses and, in some instances, established very good reasons why the original decision should not have been made. Only an independent and detailed examination could have had this effect.

The Ombudsman said that he had identified a trend running through much of the correspondence he saw relating to Telecom which led him to believe that the Company needed to pay more attention to customer relations.

The Report comments on the high number of telephone complaints which the Ombudsman has received since Telecom was included in his remit in 1985. Mr. Mills highlights the great difficulty he and his staff have in examining telephone accounts complaints because, in

most cases, it is not possible for his Office to prove that a mistake had been made in the account. He could only make a judgment on the balance of probabilities from the evidence presented to him. Nothing he could do to resolve individual complaints would remove the public suspicion of overcharging until Telecom brought into operation a system which would enable all long distance, directly dialled calls to be registered. The Ombudsman felt that the level of telephone complaints to his Office should fall appreciably as a result. The Report notes that Telecom are planning such a system and that a pilot scheme has begun.

The Ombudsman also expressed concern that Telecom's procedures for detecting faults in its metering system should be sufficiently effective to detect such faults within reasonable periods. Towards the end of 1986, arising out of a specific complaint, the Ombudsman notified Telecom of his intention to begin a formal investigation into the procedures used by them in the detection and prevention of faults.

### SCHOOL TRANSPORT FOR HANDICAPPED CHILD

The following is one of the many cases investigated.

The mother of a physically handicapped boy wrote to the Ombudsman about a problem which was causing her some distress. She had been trying unsuccessfully since 1982 to obtain a grant from the Department of Education to assist with the cost of bringing her son to school each day.

The Ombudsman undertook an examination of the complaint in the course of which he studied the Department's files on the case. He established that there was no school bus service to the nearest school, even if there was, the boy was not

capable of using a school bus. Therefore, his mother had to take him to school every day. She obtained a part-time job in a town eleven miles away from her home and, since she was travelling there anyway, she took all her children, including her handicapped child, to a school which was nearer her place of work. Because she was not bringing her handicapped son to the school nearest her home, the Department refused to pay her any grant for transporting him to another school.

The Ombudsman was satisfied from his examination that the Department had not considered all the facts of the case and he asked them to review their decision.

The Department advised him shortly afterwards that they had reconsidered the matter and had decided to pay a grant from the year in which the woman first contacted them. She received £487.50.

### CO. WATERFORD COMPLAINTS

A total of 115 complaints from Co. Waterford were lodged during 1986 and of these 19 were adjudged to be outside the jurisdiction of the Ombudsman and 96 within his jurisdiction.

Of the latter 49 concerned the Civil Service with 24 against the Department of Social Welfare, 11 against the Revenue Commissioners, 4 against the Department of the Environment, 6 against the Dept. of Agriculture, 2 against the Dept. of Education and 1 each against the Land Registry Office and 1 other Civil Service Department.

11 of the complaints were against Local Authorities, 6 against the Health Board, 29 against Telecom Eireann and 1 against An Post.

Of the complaints lodged, 80 were finalised, the complaints in 10 cases were upheld, assistance was provided in 28 cases and 32 of the complaints were not upheld, the remainder were either withdrawn or discontinued.

## Waterford shock Cork to quality for league semi-final

WATERFORD 1-13; CORK 2-9

Waterford scaled new heights at Walsh Park on Sunday last as they made mock of the form book when beating All-Ireland champions Cork by a point in a hectic and fiercely contested National Hurling League quarter-final. The winning point came from team captain Anthony Cooney just seconds before the end to create what must surely be the shock of the season.

It was a victory which will do wonders for Waterford hurling. Following a dismal display against Tipperary at the same venue, it was felt that they could not hope to match the champions let alone beat them. Pre-match feeling was that Cork would win "pulling up" and following recent drubbings by Cork the only thing in doubt was their winning margin on the occasion.

Waterford, however, had other ideas. What they lacked in skill and experience they made up for in spirit and determination and it was these qualities which in the end fashioned their unexpected but highly deserved victory.

It was without doubt Waterford's finest hour in recent years and their display over the hour completely belied their role as rank outsiders.

Playing against the breeze they showed signs of nervousness in the early stages and were guilty of mistaking and poor control for a time. But once they settled down they dispelled all fears of easy capitulation and indeed showed that they were in no way overawed by the reputation of the champions.

Despite conceding a goal after fifteen minutes when Kevin Hennessy found the net, Waterford did not panic and were just four points adrift, 1-6 to 0-5 at the interval.

Teddy McCarthy stretched Cork's lead with a great point in the 37th minute but three points on the trot for Waterford

brought them to within two scores of the champions.

### MIGHTY EFFORT

Twelve minutes from the end it looked "curtains" for Waterford when Tomas Mulcahy was left unmarked to shoot home Cork's second goal. But it was then that Waterford, sensing that Cork were not invincible produced a mighty effort which sent Cork reeling. Shane Hennessy shot a brilliant point and Liam O'Connor added another. Cork's lead was restored to four points by Michael Mullins but the final five minutes belonged to the home side.

Shane Ahearn put Pat Bennett through for a goal and two minutes later Kieran Delahunty equalised with a point from a free. Excitement was at fever pitch as Waterford attacked and Walsh Park erupted when Cooney shot over the point which gave Waterford victory and sweet revenge against the all Ireland champions.

Waterford who now meet Galway in the semi-final on April 19, really surpassed themselves last Sunday and were given the inspiration for their sensational win by the brilliance of David Foran, Shane Ahearn, Anthony Cooney and Kieran Delahunty, whose accuracy from placed balls proved decisive.

## STOLE CHRISTMAS TREES FROM STATE FOREST

Con Connors (19), 64, Childers Estate, Dungarvan pleaded guilty at Dungarvan Court to two charges of stealing Christmas trees from a State forestry at Coolatool, Dungarvan. The first occasion was on December 5 last when 5 trees value £20 were stolen and the second was on December 12 when 15 trees value £60 were involved.

Supt. M. English who prosecuted said that on the first occasion the defendant cut 5 trees which he took into Dungarvan and sold for £11. On the second occasion he cut 20 trees but was caught on the way into town.

Mr. E. P. King, Solr. (J. F. Williams & Co.) for the defendant, said that the trees involved had been cut on the outskirts of the forestry and the defendant did not think they were part of the forestry.

Stating that he accepted that the defendant thought the trees were growing on a commonage, District Justice O'Connell applied the P.O.A. on both charges.

## INCOME TAX BOMBSHELL FOR FARMERS

A warning that many farmers face income tax bills of possibly tens of thousands of pounds unless a radical review of the income tax code as it relates to stock relief, has been made by former ICMSA Economist and current County Tipperary Chairman Mr. Pat Blake.

In a statement issued from Limerick, Mr. Blake identified three categories of farmers as being at risk.

1.—Farmers who attempt to solve their financial problems by disposal of stock.

2.—Farmers who transfer part but not all of their holdings to their son/daughter to qualify for the Young Farmer Installation Aid.

3.—Farmers who suffer a serious reduction in stock numbers through disease eradication but not compulsory disposal.

4.—Farmers who dispose of stock as a result of entering the Milk Cessation Scheme.

He explained stock relief is an allowance which farmers can avail of in order to reduce their tax liability when the stock numbers and values are increasing. This may be a considerable advantage in times of expansion but when there is a substantial drop in numbers at the end of an accounting year the income tax liability arising can be massive.

Mr. Blake stated that many farmers experiencing severe financial difficulty are in many instances being strongly advised by lending institutions to dispose of stock in order to meet part or all of their financial commitments. However once the stock are sold to meet bank demands the farmer can then be faced with an income tax liability of ten, fifteen or twenty thousand pounds in income tax, depending on the level of stock relief claimed over previous years.

This must surely be the last straw for those who are witnessing the whitening away of a lifetime's work and effort.


**MR. JAMES MONAHAN**


I slept in a barn one night in Currabawn, A shocking wet night it was but I slept until the dawn; There were holes in the roof and the raindrops coming through.

Community Information Services

LOCAL CENTRES BEAT THE RED TAPE

If you look up the Government Services part of the telephone directory, you will find over a thousand offices listed all over the country—and that is before you include the health centres, the local authorities and the schools. How, you might ask, can the ordinary citizen be expected to cope with this incredible complex of offices, services, regulations and civil servants which keeps expanding and growing more complicated as time goes on? Some would say that the citizen cannot cope, that there are people who, because they do not understand the system, are failing to get things to which they are entitled.

To overcome this problem, a group of voluntary workers set up in 1980 a Community Information Centre in the Court-house, Dungarvan, which is open at regular hours each week (see notes in local papers). Volunteers are trained by the National Social Services Board, and using a comprehensive set of information files, they can tell you about everything from driving licences to Pay-Related Benefit and from free health services to the address of the Society of One Armed Golems.

"We have files on taxation, consumer services, housing, social welfare, redundancy and family law as well as many other subjects," says Margaret McGrath, Organiser of the Community Information Centre. "We do not say that we can answer every question instantly but we can usually find out the answer for people."

What sort of questions do people ask at the Community Information Centre? Some people want to know if they are entitled to a pension, others want to know why they have been refused one. People ask about housing grants, free hospital services, income tax and so on. Sometimes the Community Information Centre can help if there is a long standing, complex dispute between an individual and an organisation, simply by clarifying matters for each of them.

And, of course, an individual like a widow can go to the Community Information Centre to find out what she may be entitled to. Volunteers can write letters on behalf of people, can refer them to experts on various subjects and can help them to fill in forms.

To highlight this service, a National Welfare Rights Week from 6th-12th April is being organised by the National Social Services Board. See advertisement in this week's issue for details of opening hours in Dungarvan and outlying areas. The service is free and confidential.

I.F.A. QUERY NON-PAYMENT OF HEADAGE

The failure of the Minister for Agriculture to pay headage payments in the reclassified Disadvantaged Areas will further depress farm incomes, according to IFA.

The Association has called on the Minister to utilise to the full the EEC scheme. The EEC pay half the cost of headage payments resulting in a major boost both to the rural population and the economy.

"The increased cost of reclassification of £15m. could be reduced significantly if the Minister succeeded in getting a 60% EEC refund," says the chairman of the IFA Rural Development Committee, Donal McDaid.

"Agriculture needs a boost at present and what better way to do so than through the payment of headage in 1987. The Minister's excuse that the money had not been provided in the estimates cannot be taken seriously." Mr. McDaid said that headage payments begin in November and continue through to the following March. The increased cost could easily be met either through a supplementary estimate or its inclusion in next year's estimates.

EEC BEEF PREMIUM SCHEME 1987

This Scheme will operate in Ireland from 6 April 1987. Applicants must be registered herdowners under the Bovine Tuberculosis Eradication Scheme.

From 6 April onward herdowners may apply for the EEC Beef Premium of about £14.70 (equivalent to 18 European Currency Units) on male cattle of at least 9 months of age which have been kept on their holdings for at least 3 months before date of application.

ARRANGEMENTS BETWEEN 6 APRIL 1987 and 13 JUNE 1987

During the period 6 April 1987 to 13 June 1987 herdowners may apply for Premium only on male cattle of at least 9 months of age sold at Licensed Meat Export Premises on a specified Mart Sales. Herdowners should not apply for Premium on cattle retained on the farm during this period as those cattle will be inspected later in accordance with the arrangements set out below for the period after 13 June 1987.

Special Application Forms to cover cattle sold up to 13 June will be available from this week at the local offices of the Department of Agriculture, ACOT Offices, Post Offices and Marts.

Herdowners selling male cattle at Marts or Meat Factories should complete and sign the applications BEFORE THE CATTLE LEAVE THEIR FARMS and must hand the forms to the Department of Agriculture's Inspecting Officer immediately they arrive at the intake point. The cattle will then be inspected and eligible animals will be ear-punched at the Marts. The applications will be retained and payment will be made from October 1987 onward on those animals found to be eligible for Premium.

Inspections will be carried out in Meat Factories whenever they are open to receive male cattle. Marts will be manned by Inspecting Officers during the normal entry times for sales of male cattle. The detailed arrangements for each Mart will be advertised in the local press and on posters in each Mart.

ARRANGEMENTS FROM 15 JUNE ONWARDS:

During the period 15 June 1987 to 10 July 1987 herdowners may apply for Premium on all male cattle of at least 9 months of age which have been kept on their holdings for at least 3 months before date of application.

An application form will be posted in late May to each herdowner. On receipt of these forms, herdowners should list all their eligible male cattle thereon—including those they intend to sell later—and should return the completed applications to the Headage Payments Section of their local office of the Department of Agriculture not later than 10 July 1987.

On-farm inspections on foot of these applications will commence in late June and continue until November 1987. The inspections at Marts and Licensed Meat Export Premises will also continue in order to facilitate herdowners who sell some of their male cattle before the on-farm inspections take place.

Herdowners will receive with the application forms, posted to them in late May a number of Inspection Certificates to allow male cattle sold at Marts or Meat Factories after they have submitted their June 1987 applications to be inspected.

These Certificates will be used as follows:

- (1) Herdowner lists male cattle being sold on Inspection Certificate and completes and signs the Certificate BEFORE THE CATTLE LEAVE THE FARM. Meat Factory the herdowner hands the completed Certificate to the Department's Inspecting Officer. (2) Inspecting Officer inspects the male cattle, punches those at the Marts and returns the Certificate, duly endorsed, to the herdowner after inspection. (3) Herdowner keeps Inspection Certificate(s) returned to him at Mart or Meat Factory until his on-farm inspection takes place. (4) The Inspecting Officer visiting the farm accepts for premium all eligible male cattle found on-farm and all those certified per Inspection Certificate(s) as being eligible for premium subject to a maximum of 50 per applicant for 1987. Payment of premium on these cattle will commence in October 1987 and will continue for some months. Applicants should note that only one payment will be made on foot of all applications lodged on or after 6 April 1987.
