DUNGARVAN PROGRESSIVE AND TOWN IMPROVEMENT ASSOCIATION.

A meeting of the above Association was held in the Courtroom on Tuesday evening. There was a good attendance, a large number of heavy raincoats attending. The proceedings were somewhat lively and at times a little heated was shown.

In the absence of the President, the chair was taken by the Vice-President, Mr. C. Silbery. He said he was sorry Mr. Thos. Power was not present, but he had been urgently called away to Dublin. He was glad to see so many attending the meeting, and he hoped they would do all they could to assist the objects of the Association.

Mr. Keohan, secretary, read the minutes of last meeting.

Before the Chairman signed, Mr. J. Daly called attention to the fact that the minutes did not state that their Association was non-political.

Mr. Keohan said no order was made to that effect.

Mr. Daly—But it was stated by the chairman.

Mr. Keohan said he would insert it, and the minutes were signed.

Mr. Keohan addressed the meeting and referred to the many things that could be done. They should try and get the subscription transferred to the County Council. The County Council demand this year was for £5,000, or a rate of 11s. in the £, which was a terrible imposition. He was glad that Mr. Brennan interposed in this matter at the County Council, but the Secretary referred him to his lodgers. They should look out for the £2,500 for the Cunningham Bridge and find out where that money was gone. It belonged to Dungarvan, and every effort should be made to have it secured for the town.

Mr. Brennan addressed the meeting, and said when base coin was sought to be passed in old times it used to be nailed on the counter, and he was prepared to give an account of his stewardship as Chairman of the Urban Council. He did not wish to enter into any disclosures as Mr. Thomas Power was not present, but he promised them he would give a full disclosure of his stewardship since he entered upon his duties up to the present moment. He objected to be made the target of poisoned gas before the elections in Dungarvan. He would say no more until the chairman of the Association was present.

Mr. Thos. Power, St. Mary street, said it seemed to him that this was not going to be a Protective Association with a rate of 11s. in the £. The roads cost £64 a mile to maintain, while in the county they were maintained for £23 a mile. The Dungarvan roads cost £290, but if they got a contractor they would have the roads done for less. He believed they should abolish the Urban Council altogether, and let the work be done by the County Council. Their local administration had become too costly. Mr. Brennan was referring to the chairman, but he was holding over his remarks.

Mr. Brennan—That is a pleasure in anticipation.

Mr. Power—Your present rate is 12/4, but it will be up to 4/1 this year.

Mr. J. Daly said they should come down to the brass tacks of the business. What was this Association formed for? It was on the eve of the elections, and it was clear it was an election move. He had been in Dungarvan for 25 years, and for that time there was a monument of inefficiency. They should take the reins in their hands. They could not have a sufficient water supply for domestic requirements. He sent on a sample of water for analysis and he got a report that it was not fit for human use. What was that due to? To the inefficiency of the people in the saddle. What about the quay? Could they blame the members of the Urban Council when an official of the council has to do a certain job? Was it not their duty to have it conveyed to the Minister for Local Government to send down an inspector to see that this extravagance should not be continued? Why not ask Mr. Burke, the Minister, to come down and ask him to go into this extravagance in connection with the quay? It was necessary to see that the proper money would be sent in at the coming election. Why did they not do it in last time?

SEQUEL TO HIDDEN GOLD. FIND IN DUNGARVAN.

DEFENDANT DISCHARGED.

At Dungarvan District Court on Wednesday, before Mr. Tray, D.J. Supr. Murray charged Thos. J. Sanford, Mitchell street, with stealing a box of gold containing £29 from the premises of Mr. Sexton on the quay. Mr. Williams defended.

Mr. P. Sexton said he had a quantity of gold in his house at the quay. It would be about £34 and was in a small cash box in a recess at the top of the house. He saw it on the 12th inst., but on the 19th it was missing and he found the little door inside which it was tightened up. He spent half an hour trying to open it and then reported the matter to the Guards. He had several men working at the house. Defendant was working there the previous week and gave him satisfaction. When he forced the door of the recess he found the money was gone.

By Mr. Williams—I purchased this house recently and it was unoccupied for a considerable time. When the money was taken I was not living there. The gold was in a purse in the cash box with brown paper around the box. The box was marked jewellery. The recess door was not locked and the door never fully closed, but two planks were against it and never entered his head that defendant took it. He was not informed that Sanford was looking for him on the 19th.

To Supr. Murray—I sent for Sanford and put it up to him and asked him if he took a small parcel out of the place, but he said he did not.

By Mr. Williams—Sanford asked what kind of a parcel was it, and witness said documents as he did not want to let him know what was in it. He did not think Sanford would take it if he knew it was his.

Supr. Murray stated on the 19th May he went to Mr. Sexton's house and examined the place and on the following day detained defendant. As a result of a statement defendant made, which was: "I want to tell you I took the money, but I thought it belonged to the people who were there years ago," he arrested him, and defendant said: "If you allow me up to the house I will bring down the money." As he did not want to be seen in custody he asked to go up, but being under arrest, witness could not allow it and went with him. They went into the garden at the rear of the house and to a place where a flower bed was against the wall. Defendant removed some flower pots and a bunch of primroses and then dug with a spade about 14 feet deep. He then said the money was gone, but as his mother knew where it was, they went into the house and the mother handed him the money (produced). The purse contained 6 sovereigns and 46 half-sovereigns. Defendant then made a statement, which stated he was working on the site on the 19th May. He noticed a recess which was partly opened with two planks against the door. He saw a paper inside the door and took it out and found the cash box inside. He shook the box and it opened, but he could not close it again. He did not look at the contents then, but brought it home and counted it with his mother and sister and found £29. He then brought the money down to Mr. Sexton's house and left the box with his mother. He searched for him and could not find him. He met his daughter and she said he was at the quay, but he was not there and he brought the money home again. On the 19th he brought the money to Mr. Sexton's house and hid it in the pantry.
