Before Mr. Troy, D.J.
Remanding Gravel.

Wm. Bensford, Abbeyside, charged P. Wright with removing sand and gravel from the fenshore outside his farm at Killgrovan.

Mr. Ryan, sol., for applicant, said Mr. Bensford was owner in fee for the past 60 years, and during that time by erosion, etc., he had lost about two acres of land. A certain number of men were making an onslaught on him by removing gravel and sand, etc. Defendant only gave check when captured and was afterwards found three again. He would ask for a substantial fine to put an end to the conduct.

Mr. Bensford contended Mr. Ryan's statement was untrue. He left the men at the gate and went over. The men got no drink.

The Justice—He did not go in the front door. He went in by the gate.

Mr. Skinner—He went in the back gate. The glasses the guard saw were whiskey glasses and two glasses were in the drainer since the night before.

To the Justice—He did not see the guard coming along the street. When he was challenging the men he saw him. To the Justice—He crossed over to the gate and then saw the guard.

To the Justice—He walked across the road and then saw the guard.

To the Justice—The guard never spoke to him. He only asked to see the glasses.

P. Whelan deposed he went to look at the timber. They were not in the bar when the guard brought them back.

To the Superintendent—He saw the guard and knew him. He never asked any question of witness. He did not know when he saw Kieley first. It would be about 10 or 11 o'clock. After that he saw him at the cross. He saw Kieley in his house when the guard brought him back.

To Mr. Skinner—Himself and the rest met Kieley outside the house and he brought them in to see the timber he had.

To the Justice—He did not notice if the guard was puffing after running. He got no drink. He was a particular friend of the other men. The guard did not ask for any explanation.

Margaret Riordan deposed she was the maid. There was no drink supplied and she did not see the men until brought in by the guard. Witness finish work at 6.30 and don't go in the bar until next morning. She opened the back door for Jas. Kieley and the guard.

To the Superintendent—The bar was closed. To go direct from the kitchen to the street you would have to pass the bar. She saw the guard bringing the men in. It would be about 12 when she went into the house that day.

Superintendent—Does anyone get a drink on Sunday?

Mr. Skinner—I will leave her answer to prove it is not a Sunday drinking house.

Witness—No. Continuing, witness said there were 4 or 5 men with the guard when he came in. Jas. Kieley was in the kitchen when he came in. She did not know how long he was in the kitchen. It might be 10 minutes.

To Mr. Skinner—What the most was Jas. Kieley was in the kitchen while the guard was in the bar until next morning. R. Mahony deposed he called Kieley over when he came out the gate and asked him for a fishing rod. He did not see the four men at all. When Kieley left him he went in by the back gate.

Mr. Skinner said he was placed in a very awkward position as Mrs. Kieley could not appear. It was only last evening he got instructions in the case. He would suggest the case be adjourned for the attendance of Mrs. Kieley.

Justice—I will adjourn the case until next court.

Larceny of Timber.
Supt. Murray charged Mr. Roche, aged 16, with the larceny of timber value about 2s. from the gas-house premises. Mr. Spears defended.

Sergt. Larkin deposed that acting on information received he proceeded to the gas-house accompanied by Mr. Lennon. He then proceeded to Davis street and made inquiries. He searched the house of defendant and found some timber freshly broken which was identified by Mr. Lennon as being from the gas-house.

By Mr. Spears—He had no search warrant for written authority to search the house. The timber in the house was not what is called "kippers." He did not know if the water in the field underneath the gas-house when in flood leave timber there.

George Lennon deposed he was lessor of the gas-house. On this evening he saw three boys going over the wall with a bag. He took note of where they went and then went to the barracks, and in company with Sergt. Larkin went to Davis street. Roche admitted being on the premises.

By Mr. Spears—the company was a Ltd. Liability Co. He saw one of the boys on the wall and the other two were in the field. He could not identify any of them at that time. The timber he saw was what was removed from the gas-house.

Mr. Spears held the boy was charged with stealing from the company. If it was a private company the names should have been on the summons. Defendant was 16 years.

STRIKING THE RATE.

INCREASE OF 1s. IN 2 OVER LAST YEAR.

Mr. John Kiersey, chairman, presided at the adjourned special meeting of the County Council on Tuesday. There were present—Messrs. D. Conway P. O'Gorman, D. Ward, Mrs. Walsh, T. Hart, John O'Donnell, J. McCalliffe, W. C. O'Connell, T. E. O'Shea, J. Goulding, M. Brennan, J. Kirwan and W. Slack.

Coming Year's Rate.
The principal business of the meeting was the striking of the coming year's rate. Secretary—I have reduced the figures as nearly as I could to meet with the recommendation of the council at its last meeting. The general rate as it now stands is 6/6 on land and 10/3 on buildings. In addition to that there are the usual separate charges, etc.

Mr. O'Donnell—What is the increase over last year?

Secretary—There is an increase in the general rate in Dungarvan of 1/1, Kilmacross 1/1, Lismore 1/1, Waterford 3/4, Youghal 1/7, and also increases in Clomel and Carrick districts. The rate for malicious injuries varies in the several districts.

Chairman—There were certain recommendations made last week and I would like to know if they have been taken into account?

Secretary—I did not take into account the proposed reduction of 5 per cent. in salaries and 30 per cent. in the rate collectors, as even if they are sanctioned the money will be required to meet the other deficiencies which have not been estimated. In the hurry preparing the estimate I overlooked the travelling expenses of members, as also the cases of Mr. Morrissey and Mr. Moloney.

Mr. O'Gorman asked how much would be the increase in the amount of general rates over last year?

Secretary—417.600. The last year the general rate was 4s. on land in Carrick and 7s. 6d. on buildings, etc.; while this year it is 6s. 6d. on land and 10s. 3d. for other hereditaments.

Mr. O'Gorman—We are not in a very bad position.

Secretary—You are going to pay nearly 500,000 as compensation for criminal injuries and you are only levying 450,000.

Mr. O'Gorman—We have no control over that. It is not our expenditure.

Secretary—You are only making provision for paying out of the rates 450,000 and you are borrowing the remainder. As to the separate charges, they vary in each district.

Mr. O'Gorman—In Tramore you have the separate charges doubled, as Mr. McCalliffe is carrying out salvage works and other things.

Mr. Conway—How do we stand as regards the agricultural grant? I understand that Mr. Blythe has hinted at giving a certain amount in relief in increasing the agricultural grant, and if that be so we could further reduce our estimate.

Secretary—I have heard nothing about it as yet. We expect to get the same little difference between your rates this year and last year.

Mr. Conway said if they passed the rate that day and the temporary clerks were brought in to work and later on if the Ministry of Finance gave them an increase in the agricultural grant they should do the work over again. Under the circumstances he thought they should await the introduction of the Budget before taking any steps to prepare the rate books.

Chairman—That would be a further postponement, and I think it would be better to strike the rate as they had it and if they got a special grant or increased agricultural grant it would go to the credit of reducing their liabilities in the Bank.

Mr. O'Gorman—Yes. You have other debts to be cleared off.

Secretary—I've got an increased agricultural grant which will assist on having it in the current year's rate.

Mr. Goulding said they should adopt the rate that day subject to that contingency.

Mr. Conway—I think the grant is increased the ratepayers must get credit for it in the estimate.

CO-OPERATIVE CREAMERY FOR CAPPOQUIN.

Following the successful meeting held in Cappoquin on Tuesday, 9th inst., for the purpose of establishing a Co-operative Creamery for the town and district, a further meeting of farmers and others interested in the project was held on the premises of the Backwater Valley Co-operative Society on St. Patrick's Day, when the movement was carried several stages further towards completion. Practically all the farmers who were present at the original meeting were again in attendance, while several additional farmers now put in an appearance to give the movement their whole-hearted support.

Mr. John Flynn, Carrigreen, presided, and amongst those present were—Messrs. W. Woods, Kilmalla; P. Morrissey, Affane; J. Cronin, Bawnfaun; Hugh Walsh, Kilmara; Hugh Walsh, Crinagh; Andrew McGrath, do; Thomas Walsh, Ballinac; Thos. Walsh, Tourin; Thos. Scanlan, Coolane; Thos. Ormond, Poultho; Pat. Prendergast, do.; M. O'Brien, Bewley; James Fives, Tourin; J. Kennedy, Woodstock; David Dunn, Bawnfaun; B. G. Usher, Cappagh; R. S. Walsh, Moneyroe; R. Bell, manager Cappoquin Estate; Michl. Cunningham, Dromore East; Jas. Hackett, Moonwee; Jas. Kett, Moneygurn, etc.

Mr. P. Courtenay, Organiser J.A.O.S., Dublin, attended, while Messrs. Thos. Flynn, Chairman Dungarvan Co-operative Society, and S. Fitzpatrick, manager Dungarvan Co-operative Creamery, were also present.

Messrs. Courtenay, Flynn, Fitzpatrick and others having given valuable technical details as regards the successful working of the co-operative system, the Chairman proposed and Mr. D. Dunn seconded, that a Co-operative Creamery be started in Cappoquin, and this was unanimously agreed to.

Nearly all present then signed the necessary guarantee forms, agreeing to become shareholders in the Society and to supply the necessary quantity of milk to the creamery, and it was decided to avail of the splendid site in the premises of the old foundry, kindly given by Sir John Keane, Bart., which is situated in a most central and convenient part of the town not far from the railway station, which will save the Society a considerable amount of expense in the transport of cream to the station en route to Dungarvan. It was explained that the work of installing the necessary plant and machinery for the new creamery had been already guaranteed and provided for, and arrangements were then made to have the work proceeded with at the earliest possible moment, so as to have the creamery in full working order, if possible, in the course of a couple of months.

Towards the close of the meeting, Mr. Courtenay said that in his long experience of organising work, he had seen a greater spirit of co-operation amongst the farmers of Cappoquin and district than in any other part of the country in which he had been engaged, and as they were all sound practical and intelligent men, this augured well for the success of the new creamery, and he appealed to those farmers who had not yet joined the movement to now come in and give their co-operation and support to the new concern, as they would never have any reason to regret it in the future (hear, hear).

A cordial vote of thanks to Mr. John Flynn for presiding concluded a most practical and highly successful meeting.



CONSPIRACY CHARGE.
DEATH SENTENCE COMMUTED FOR £500.

In the High Court, Dublin, during the past week, before Mr. Justice Hanna and a special jury, the action in which Mr. A. Carroll, solicitor, Parnoy, sued nine defendants for damages for conspiracy, false imprisonment, assault and for the trover of £550, was heard.

Mr. Wood, K.C., opening the case for the plaintiff, said that Mr. Anthony Carroll had been for thirty years one of the most successful solicitors in Ireland. In 1906 he was appointed to the Position of Court Solicitor for the East Riding of York, and had acted for the Board of Works, and the Irish Land Commission. He was a man prominent in his profession, a man whose sole view of life was to serve his clients faithfully, and to take no part in public affairs. Until April, 1922, he apparently had not an enemy in the world. The charges against the defendants were conspiracy, in which they kidnaped him, arrested him, and by threats and menaces robbed him of £550.

The jury might think that these acts had something to do with politics, but he would say that there was not the vestige of excuse, moral or political, for them. These men used the Free State position and exploited the Sinn Féin position for their own private greed and personal aggrandizement. They would find evidence that this diabolical outrage was conducted throughout under the citizenship of Mathias J. Donovan, a man now a P.C., and a former in Rathfriland, holding a substantial position, and for his ostensible position of respectability and reputation, he thought he could, and it is said he did, successfully ambush amongst others, Mr. Carroll for his own personal greed.

The leading defendant, counsel continued, who did not appear in court, Maurice O'Brien, the man who held the gun throughout, was another-in-law of Donovan, while Timothy Donovan, Thomas Donovan, and Patrick Donovan were cousins of Mathias J. Donovan. To make the family chain perfectly complete, Thomas Donovan was married to a sister of Maurice O'Brien, therefore, Mathias J. Donovan and Thomas Donovan were married to sisters. Maurice and John in addition were cousins of the three Donovans, and Nan Donovan, the wife of Thomas, was a sister of Maurice O'Brien, and a sister of the wife of Mathias J. Donovan, all living in and around Rathfriland. Plaintiff's case was that all these defendants were faithful adherents of Mathias J. Donovan, who he (counsel) might describe as the 'Poo Taw of Rathfriland.' Many of our good citizens, went on Mr. Wood, have left us apparently for less than this, but he is here confident in his citizenship and confident you will do justice to him. MR. CARROLL'S EVIDENCE.

The plaintiff, Mr. Anthony Carroll, was examined by Mr. Fitzgerald, and stated that he was appointed solicitor to the Land Commission in 1908, and was acting for that body in 1922. He explained in detail the various incidents relating to the civil bills which were then out against the defendants in the reach of arrears of annuities. It was stated by a member here on the last night that it was not the function of this body to regulate the morals of the people. That statement was correct."

ALL-IRELAND TOWN TENANTS' LEAGUE. DUNGARVAN BRANCH.

A general meeting was held in the Town Hall, Dungarvan, on Tuesday, 16th inst. Mr. Wm. Stack, Co.C., president, in the chair. Mr. T. J. Power, U.D.C., hon. secretary, was also in attendance. The meeting was large and representative.

The Chairman expressed pleasure at seeing some new members, and extended a hearty welcome to them into the branch. He hoped that other members would follow their example and bring the branch up to a standard worthy of the organisation. Since their last meeting some developments had taken place in reference to the Town Tenants' Bill.

The Government has given Capt. Redmond an assurance that they were preparing a Bill, and hope to have it introduced in time to replace the Rents Act, which expires in June next. It is very important that all branches should be most active at the moment to ensure that the Bill will be one that town tenants can look to for relief from their present position.

All the branches need a waking up, and your secretary here, who has done an amount of good in the movement and helped to a very great extent in placing the conditions and grievances of the tenants before the public, has been appealed to by several branches to take a hand in the work of organising. He believed the secretary would be happy in working in their behalf, but they should stand by him and give him some assistance by presenting him with a good typewriter to enable him to get through the huge amount of writing that he has to do in connection with the movement. He would suggest that a collection be made through the town, and he felt that for such an object one would grumble at giving a subscription.

The Secretary said he was very thankful for the Chairman's suggestion to give him a typewriter. It may be a surprise to most of them to know that often during the past four years he (the secretary) worked into the small hours of the morning to cope with the huge amount of work that the running of the branch entailed. He didn't grumble, because he looked upon it as the spare-work that would eventually bring about a big revolution in the conditions of the tenants in our cities and towns. The suggestion of the typewriter was a happy one, and he hoped they would carry it into effect. He was anxious to keep in touch with all the branches, and with the aid of a typewriter he would communicate with them monthly and do what he was capable of in establishing a connecting link between them all, and in that way get a great deal of co-operation into the work.

Mr. O'Gorman proposed, and Mr. John Quinn seconded, and it was unanimously decided, to appoint collectors to call on the tenants and their friends so that a good typewriter and a stock of suitable stationery could be procured at once.

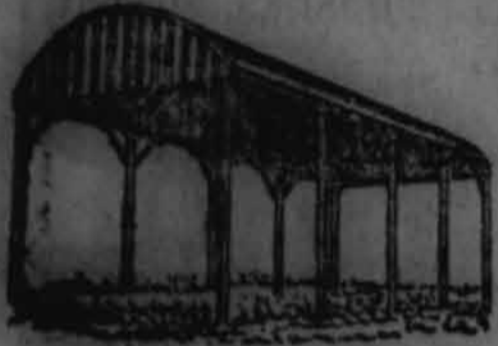

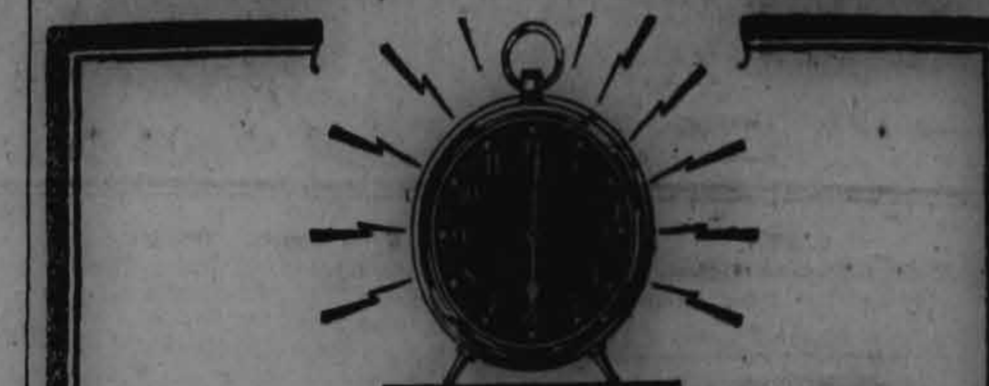
