Sheeping Breeding Scheme.—The Secretary explained that owing to the continued outbreaks of foot and mouth disease no rams could be imported into the county this year.
It was agreed to leave the scheme stand as at present.
Mr. Whelan said at the moment the only schemes they were putting into operation were the Live Stock and Poultry Schemes. They could regard the other allocations as provisional subject to reconsideration next March, and if then it is necessary to curtail the schemes more than they are at present.
The Secretary said he had the figures, and it is as well to let the figures stand. The schemes are not nearly as developed as they should be. There is no room to extend either the Agricultural, Horticultural or Poultry Schemes at all.
In reply to Mr. Flynn, Mr. Whelan said next year the unexpended balance of £441 would be gone.
As to the Horse-breeding, Mr. Hartley said there were a great many people in the country who gave their mares to registered sires, and they very often give them to unsuitable animals, for it does not suit at all to give small, light bred mares to thoroughbred sires.
Mr. Flynn.—The scheme is an inducement to them to do that.
Mr. Hartley.—If they were paying for the sires they would select a more suitable horse.
Mr. C. J. Curran explained how nominations were awarded in the early stages of the committee, and said finally they decided on £300 as the higher valuation and £75 as the lower, but last year the lower valuation was reduced to £50. For the success of the scheme the old regulations worked better, viz., the division of the nomination to farmers under £75 valuation and over £75.
In reply to the Chairman, Mr. Whelan said the Horsebreeding Scheme was dropped in some counties.
Mr. Curran said there was one thing in the Horsebreeding Scheme, viz., it was an inducement to a man to bring a good sire into the county.
Secretary.—I never had so many entries for mares under the Horsebreeding Scheme as last spring while I am in the county.
Chairman.—What would you think of knocking off the Horsebreeding Scheme altogether?
Mr. Delaney.—From what I see what the mares put forward produce is a waste of money. It would be better to turn it to something else. It would be much better to put it into pigs or fowl. It was only waste was produced.
Mr. Greene.—Horsebreeding should be left to individual effort.
Chairman.—I think the feeling of the majority is in favour of striking out the Horsebreeding Scheme this year.
Mr. Coughlan.—It is all a question of what we can cut out.
Chairman.—There is £140 for the Horsebreeding Scheme, and under the allocation made we are £137 down. It was agreed to drop the Horsebreeding Scheme.
Mr. Whelan.—If you mean to develop your schemes you must get more money. In some counties last year they increased their rates and got a small additional grant from the extra funds.
Chairman.—There is one thing certain that the rates are high enough.
Mr. Whelan.—A rate of 1d. is very small.
Mr. Curran.—Are we getting value for it?
Mr. Whelan said on the question of the increased poultry stations, he was looking for a high standard. He would rather see a dozen high-class stations in the county than three dozen mediocre ones. This is a section which is well worth developing. They found that some poultry station-holders are content when they just comply with the regulations. His idea was the station should be such that a person driving along the road would say: "There is a nice lot of poultry. How is it done?"
The Chairman said they should get turkey cocks from outside the county and present in-breeding. There was a great complaint that the birds were very delicate, and that was due to in-breeding.
Secretary.—I have got drastic instructions from the Department that in the case of any irregularity in future the station will be immediately cancelled.
Mr. Curran.—I don't know what the small poultry stations, where Plymouth Rocks have been kept since the start, and the farmers around the place have none of them though the Plymouth Rocks are there for 30 years.
Mr. Whelan.—£50 was set aside for the Potato Scheme this year, and if you wish you can exclude it for the coming year.
Chairman.—Potatoes were only 1d. per stone in Waterford last week.
Mr. Greene asked was there danger of in-breeding in the pig industry of the county?
Mr. Hartley.—That is a matter that should be kept within the county.
Mr. Greene.—A record should be kept of the boars. A certain number of men make a fashion of breeding boars and you have the same suppliers all the time.

CIVIL BILLS.

In a case in which Mr. John J. Walsh, Talbot, had a civil bill entered against Bridget Lynch, Camphire, for money due for shop goods, Mr. W. R. Hodnett, solicitor, Youghal, applied for an adjournment to the next court, which was granted, and a similar order was made in another case in which Mr. Hodnett should also have appeared for the plaintiff.

A KNOCKALARA CASE.

A case of abusive language in which two women from the Knockalara district were concerned, and which had been previously adjourned from the June Court to see how defendant behaved herself in the meantime, was further adjourned by the Justice for another month.

A ROAD TAX CASE.

Guard Connors, Cappoquin, summoned Mr. John Daly, Income Tax Collector, Lismore, for using a motor bicycle on which the road tax had expired.

Mr. J. W. O'Gorman, solicitor, Lismore, appeared for defendant.
The Guard's evidence was that on July 20th he found defendant riding a motor bicycle for which the road tax had expired a month previously. When he called defendant's attention to the fact, the latter said that he had quite overlooked the matter, but witness understood that he had taken out a licence immediately afterwards.

Mr. O'Gorman.—Did Mr. Daly seem surprised when you told him his license was out of date? Witness.—Yes.
Mr. O'Gorman said it was purely an act of forgetfulness on Mr. Daly's part in not renewing the license in time, as he was a very busy man and the matter escaped his attention. The defendant was collector of income tax in Lismore, and being employed by the Revenue Commissioners himself, he never was the class of man to attempt to defraud the Revenue by wilfully evading to pay his license, so he respectfully asked for a dismissal, as the license was taken out the moment Mr. Daly's attention had been called to the matter by the Guard, who was, of course, quite right in bringing on the case.
The case was dismissed.

CHARGE OF BEGGING.

Guard McGrath, Cappoquin, summoned an old woman named Mary Garg, residing in Barrack street, for begging on 31st August.

Complainant stated that on the date in question he saw a motor car arriving outside Walsh's Hotel and defendant immediately went out and spoke to the people in the car, who gave her some money. When defendant saw him approaching she moved away, but when he got up to her and spoke to her she denied having received any money. He then brought her back and the people in the car identified her as the person to whom they had just given 5d.

In reply to Mr. O'Gorman, solicitor, who defended, witness admitted that the defendant was not a habitual beggar, and there had never been any charge of begging brought against her previously in Cappoquin.

Mr. O'Gorman said his client had a son who was in good circumstances and well able to support her, so that she need not beg, and he would now resume on her behalf that she would not repeat the offence in future.
Defendant was fined 6d. and costs.

VILLIERS-TOWN BEGATTA.

Like the night of Duffy's Circus in Lismore, the night of the Villiers-Town Begatta also proved rather costly for some of the "boys" who were cycling home late to Cappoquin without lamps, as the following cases will show:—

Guard Fallon, Villiers-Town, summoned Patrick Curran, Cappoquin, for riding an unlighted bicycle on the night of August 28th, and he was fined 1s. and 2s. costs.

A file ruling was made in the case of James Byall, Cappoquin, charged by the same complainant with a similar offence on the same occasion.

Guard Fallon also summoned Daniel Frater, Cappoquin, for the same offence on the same date.

The Guard said when he asked defendant for his name he gave him a wrong name and address, saying he was "Daniel Cronin, Modigo," but witness got his correct name and address from John Kelly, who was with him, and who was also one of the defendants in connection with the same occasion.

Defendant—I am not summoned for giving a wrong name and address, as I am only summoned for having no light on my bicycle on that night.

Justice.—Does not matter, as it was a most important thing to give a wrong name and address to the Guard.

Defendant was fined 1s. and costs.

John Kelly, Cappoquin (referred to in the previous case) was next charged with having no light on his bicycle on the same night, and as he did not appear, a fine of 2s. was imposed.

Guard Duffy, Villiers-Town, summoned Mr. Lynch, Aglish, for allowing a motor car to remain stationary on the street with one lamp lit and the other without lighting-up time, and a fine of 4s. and costs was imposed.

Do. v. Patrick Bailey.

No light on bicycle. 2s. and costs.

Do. v. John Barry, Ballingnowa, for allowing a horse to wander on the public road. Fined 2s. and costs.

LICENSING PROSECUTION.

Supt. O'Riordan, Cappoquin, had a case entered against David O'Brien, publican, Farnane, Millstreet, for an alleged breach of the Licensing Act, but when it was called the Superintendent asked for leave to mark the case "withdrawn," as he intended to take out a fresh summons under Section 1, Sub-Section 2 of "The Intoxicating Liquor Act, 1924," for the next court-day, and the case was, therefore, marked "withdrawn."

RENEWAL OF LICENSE.

Mr. James Russell, Cappoquin, was granted a renewal of his wholesale spirit licence for his premises in Main street, there being no objection on the part of the Civic Guards.

ANNUAL CERTIFICATES.

The annual renewal of all the publicans' licences in the town and District Court area was then taken up, and Superintendent O'Riordan intimating that he had no objection to offer in either case, all the certificates were then signed by the Justice, while the usual Egginton Orders were also renewed for the next 12 months in all cases where such orders were already in existence.

LISMORE NOTES.

The 7th October.—Thursday next, the 7th October, is being anxiously looked forward to when at 7 p.m. in the Harrington Hall the Jubilee Sale in aid of the Lismore Hockey Club Funds will be held. There are special attractions apart from the sale such as the drawing of prizes for hams, chickens and assessments of various kinds. Last year the event was largely patronised, and we have every reason to believe that this year's event will also prove successful.

Gas.—The price of gas has been increased in Lismore to 13s. 6d. per 1,000 cubic feet except where quantities in excess of previous collecting periods from 1923 are used, and the charge will be 3s. 6d. per 1,000. The rate charged for meters will be increased by 50 per cent. also from 80/9/36, as engines will be 7/6 per 1,000 cubic feet.

Price.—The price of piglets in the price of fat pigs at the Lismore live weight market was 70s. per cwt.

The Late Rev. Mother Xavier.—One of the outstanding features at the funeral of the late Rev. Mother M. Xavier was the attendance of close on 50 members of the Children of Mary Sodality wearing cloaks and veils. They were nicely marshalled and bore evidences of sincere regret at their dear departed mistress. Due no doubt, to the unselfish and untiring efforts of the deceased, the Sodality is today in a flourishing condition, and is a monument to her memory. In 1884 this Sodality was formed at Lismore Presentation Convent, and the members had an affectionate regard for the religious, who guided their destinies since that time and took such a deep interest in their welfare.

Lismore Cinema.—Licenses for Month Granted.—Mr. Thos. Crotty, chairman, presided at a special meeting of the Lismore Town Commissioners held to consider the application received from the Lismore Cinema Company for a license. A discussion took place among the members as to their powers, etc., under the Act, and some members advocated their powers extended to the censoring of films and also the exclusion of pictures on Sunday nights, and a vote was taken which resulted in granting the license for one month on payment of 5s. at the end of which period the Commissioners considered they would be more conversant with the Cinematograph Act and the regulations, etc., relating thereto.

FARMING OFFENCES.

During last week 23 persons were prosecuted under the Dairy Produce Act for tendering to creameries or cream separating stations milk contained in dirty vessels. Two persons were prosecuted for tendering dirty milk. Two Creamery Companies were prosecuted for accepting milk contained in dirty vessels. Three persons were prosecuted under the Agricultural Produce (Eggs) Act, 1924, for offering for sale dirty eggs. One person was prosecuted for contravention of the Live Stock Breeding Act, 1925, and 10 persons for contravention of the Horse Breeding Act, 1918. Fines and costs were imposed in all cases.

In addition, seven persons were prosecuted for moving or causing to be moved, potatoes out of a prohibited area in compliance of the Black Spots in Potatoes Order. Fines were imposed on the owners of the potatoes and the cases against the other persons concerned were dismissed under the Probation of Offenders Act on payment of costs.

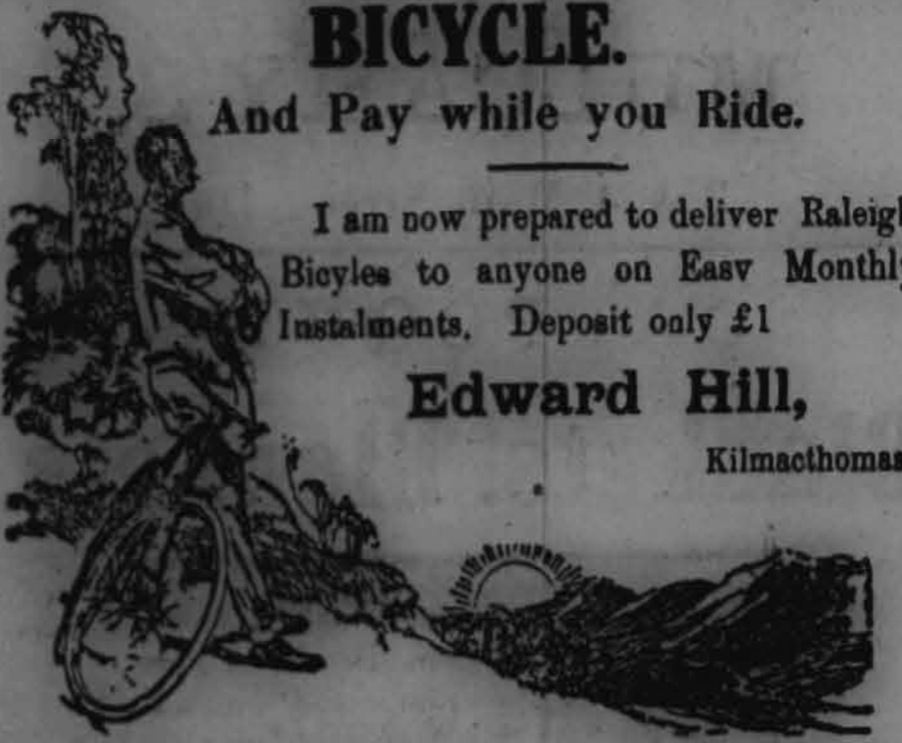

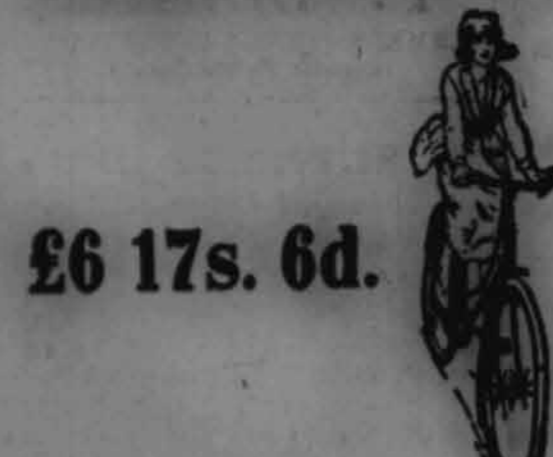

County Agricultural Schemes—The Co. Committee of Agriculture on Saturday last proceeded to allocate the funds at their disposal to the various schemes for the coming year, but following the national trend of events for some time past, money is getting very scarce, and neither the Government Department concerned nor the ratepayers can afford very much. The various County Schemes are now in operation for 25 years, and it is too bad that when highly developed they must be discontinued for want of funds. Those several schemes have done an enormous amount of good in all forms of agricultural activity, and our able County Instructors have laboured zealously and given of their best to the public to advance their interests on sound and progressive lines. For want of funds in recent years many really good schemes have to be dropped and this year the Horse Breeding Scheme has collapsed. In the past this scheme worked well and was much appreciated by the farming community, and even if needs in horseflesh were produced here and there, the same remarks would equally apply where breeding is concerned to other schemes. No matter what else we have failed to do, no one can deny that the best horses in the world—hunters, chasers and racers—are bred on Irish soil, and only last week the record price of £17,000 was paid for an Irish-bred yearling, while at the recent Dungarvan Sales dozens of yearlings made over £5 figures each. In place of having no money for horse breeding in the Co. Waterford, we think a paternal Government with an eye for business would present to this county for stud purposes a Solario, a Cornach, a Diomedes or some of our other Irish-bred crack horses, and we are sure the people would appreciate such a premium and would make his visit profitable. The Horse Breeding Scheme in the Co. Waterford was a complete success, and the Show Rings of Dungarvan, Lismore and Clomell, etc., have proved that. Never were there so many applications for nominations for mares as this year, and it is too bad that the scheme has been dropped. May we hope that the County Council will provide the extra funds necessary to continue this good work, and if they cannot, petition the Government to give us a grant for the purpose. It would be a far more profitable undertaking than purchasing aeroplanes.

Coal Strike—Though no official settlement has been arrived at in connection with the Coal Strike, which has lasted in England, Scotland and Wales since 1st May last, and no attempt was made to arrive at anything definite at the sitting of the House of Commons this week, yet what is known to the miners as an "organized retreat" has begun, and during the week big numbers of miners have returned to work in the several areas. The scarcity of coal is being much felt in all parts of the Free State, for despite all the coal that has been imported from Germany, Belgium, Poland and America, it does not appear to be inclined to saturate in our grates with any degree of satisfaction. Fortunately the fine weather has done much to ease the situation for our people.

Readmaking De Luxe—The making of the trunk road from Dulligan Bridge to Kilmacshannon is proceeding at high pressure, so also that of the trunk road from Fray towards Tallow. These new roads are being done on the latest style and the tar is rolled in with the stone at first, while subsequently the newly-rolled road is tarred and chipped. It is a beautiful job and is done regardless of expense under the National Rural Road Grant. Whether the new roads thus made will last longer or shorter than under the old style of making remains to be seen, for hitherto no means of road construction has been found able to withstand the wear and tear of heavily-loaded, fast-driven lorries. Should the roads now being made fail to stand the test of speed and weight, then we must fall back on a concrete-curved road. In carrying out the work on hands, Mr. Bowen, county surveyor, has the services of a large and skilled staff, well equipped with modern machinery, and if the very best results are not obtained, the fault will not be his.

And Bill They Go—The principal industry in the several counties of the Free State for the past few years is road-making, and the question of the amount of unemployment prevailing is governed by the grants received for public works and the numbers engaged in doing the necessary reconstruction. Now though absolutely necessary, the making of roads is no indication of material prosperity. It is only a makeshift in the matter of providing work, as the moment the particular grant is expended the status quo is again reached. What we want in this country is the expenditure of money on some industry which will be self-supporting, and where to get that is what is puzzling most people. In view of the wholesale closing down of factories in various parts of the country, it is evident that industries with us are declining, and the only real prosperous trade at the moment is done at the Atlantic Shipping Agencies, where our young people are leaving the land as fast as ever they can. Last Sunday morning another record was broken when 1,000 sailed away from Cobh to cross the ocean and seek in the towns and cities of the States that prosperity and peace and happiness they sought at home in vain. It is a sad state of affairs, but it is true, and how to end it is a difficult matter. To us the millennium has not come, and a parcel of Stubb's Gazette affords ample food for thought for all who care to understand.
