INTERESTING CASES HEARD.

The Circuit Court was opened at Dungarva on Wednesday, before Mr. Justice Sealy, K.C. A number of civil hills, which were undefen ded, were first dealt with and decrees given.

KILLING A COW.

Margaret Allen, Moonamean, sought £20 compensation from Patk. Foley, Moonamean, for the killing of an in-calf cow and trespass on her

Mr. McFniry, B.L. (instructed by Mr. Spears, solr.) for applicant. Mr. Ryan, solr., defended. Margaret Allen deposed she lived at Moonamean where she had about 20 acres of land for which she paid £3 5s, rent. She was a widow, She had two cows and a jennet on the land on February 27th last. She went to a neighbouring shop for messages on the evening of the 27th, and when she came back her cow was killed. In consequence of what her son Declan told her she sent her son Patrick to Foley on the morning of the 28th February. Foley only told him to

Cross-examined by Mr. Ryan-The cow was 9 year-old. Witness had her since 1921. Foley had three dows going around the road. Witness didn't see Foley's cows on the road or she didn't see the cow being killed only what she heard. She didn't send up to Foley's that night as she was too upset. The bog was not a commonage. Witness was paying rent and rates for it. She never saw her son chasing the cows out of her garden with a dog.

To Mr. McEniry-It was after 7 o clock when the cow was killed, so she sent up to him at 8 next morning.

Mr. Byrne, V.S., Dungarvan, said on Febmary 28th he went to Moonamean at the request of Mrs. Allen, and held a post mortem on the cows. She was bearing twin calves. He found an area of congestion on the right flank with congest on on the wall of the womb. The congestion would be caused by contact with some hard substance. The animal was in a healthy condition otherwise. In his opinion death was due to shock caused by violent contact with something hard. There were very few hoof marks

By Mr. Ryan-He found no external marks.

To his Lordship-If cattle got in and butted the cow with their heads it would cause the con-

Declan Allen said he came home from school on the 27th about 4 o'clock. He fed the cows with turnip. At 6 clock he went to put them in. He saw the cows on the ground and three of Foley's cows with her. He was sure they were Foley's cows. He turned Foley's cows away and went for John Mahony to lift the cow. but she was dead.

By Mr. Ryan-It was not pitch dark when he saw the cow. It was fairly dark.

To his Lordship-He knew Foley's cows. They were three ted ones. He turned them into his own field while he was going for Mahony. To Mr. McEniry, B.L.-Witness did not know

the cow was dead when he went for Mahony. John Mahony deposed he was a farmer's boy and lived about a quarter of a mile from Mrs. Allen. On February 27th Mrs. Allen's son came for me to lift the cow. When he went to the cow she was dead. Witness saw Foley's cows in Allen's field and he drove them out in the road. One of Foley's cows had turned-in horns. It was juicy kind of weather at the time.

By Mr. Ryan-When he came Foley's cows were in the pext field. It was fairly dark at the time. He did not drive the cows to Folev's as it was not his business. Witness was friendly with Foley. He baled in the other cow for Mrs.

miles away from Mrs. Allen. On February 28th witness was sent for by Mrs. Allen to bury the cow. Witness found the cow lying on the left side. There were horn marks on the right side. By Mr. Ryan-Witness was a brother of Mrs. Allen. He did not point out the marks to Mr. Byrne, V.S., as he should see them himself.

Young Allen came to witness next day and after dinner. Witness saw Michael Allen chase the cow out of . den with a dog across two fields. Witness's

cattle were in the house at the time and could not possibly get out. Witness milked the cows By Mr. McEniry-Witness had 20 acres of

land. He had 51 acres tilled. He had three cows, four weanlings, six sheep and one horse. They never strayed.

Mr. McEniry-Have you a cow with horns growing into her head? Witness-No, I have a cow with horns growing out of her head (laughter). He could not exactly say how many cattle he had on February 27th.

To his Lordship-He was dealing in cattle for 20 years and could not remember how many he had on February 28th without thicking, as he would have them to-day and have them sold to-

Mrs. Foley said on February 27th there were three cows and four calves on the land. They

were in fields near the house. Her husband left the house at 12.30 and returned at 6.15. Witness put the cows in the yard to feed the calves about 4.30 p.m. She then put the cows in to malk them and fed them. It would be impossible for their cattle to be down at Mrs. Allen's.

Guard Cuffe said on February 28th he went to see the cow. He saw no marks of horns on the skin. There was not any sign of a struggle. By Mr. McEniry-He remarked to Mr. Byrne that it was very strange the cow was not marked. John Mahony, re-called by his Lordship, said young Allen came to him about 6 o'clock. The three animals he found were three red cows. Witness and young Allen didn't talk about Foley's cattle being the cause of it. They all started talking about it at 7.30.

His Lordship-Whose was the brilliant brain that thought of it first? Witness-Anyone with brains at all would know it (laughter).

His Lordship-What is the period of incubation? Is it an hour and a half? (Laughter.) Why didn't you talk about it until about 7.30? His Lordship said his view of the case was that plaintiff had a strong case except for the evidence of Thos. O'Donnell. He gave positive evidence that the hide was torn. In their evidence the Veterinary Inspector and the Guard say they saw no external wounds. He believed these men. Thos, O'Donnell came up here and perjured himself to get something for his sister. He was not at all satisfied with the evidence of Foley with regard to the number of cattle he had on this particular date. In view of the perjured evidence he would dismiss the action.

SALE OF A COW. This was an action to recover £15 in the sale of a cow. The action was brought, by Mr.

David Connors, Kilrossanty, against Mrs. Mary Mr. Spears, solr., for plaintiff, and Mr. E. A. Rvan, solr., defended.

David Connors, in answer to Mr. Spears, de defendant for £28. Defendant's brother bought the cow and took her away and defendant had er until March, 1922. Witness then took back the cow and allowed Mrs. Dee £13 for her, and Mrs. Dee was to pay the balance. Witness went. several times to Mrs. Dee for payment, but she always asked for time. When witness got the cow back he blistered her throat twice and then fattened her and sold her for £20.

By Mr. Ryan-The transaction took place between himself and John Clancy. The cow had defendant sustained no loss, as witness when taking he cow back allowed her a good average Witness made several demands for payprice. ment, but she always wanted time. To Mr. Spears-It was quite clear that the cow

CLAIM FOR WAGES This was a civil bill for £10 brought by Patk, Valley Co-operative Society for wages due for

work done Mr. Williams, solr., for plaintiff, and Mr. Ryan, solr., defended.

Plaintiff deposed, in answer to Mr. Williams that he was a miner with forty, years' experience, which he learned in Bute City, Montana About three years ago he was hired by Nicholas Connors to sink a pump for the Society. The agreement was £1 per foot for the first 20 feet and £2 per foot afterwards. Witness sank the pump to a depth of 32 feet and got heaps of water for them. Then he was asked to make a tunnel. There was no agreement for that. but witness thought he would be paid at the usual rate. He did not finish the tunnel as they could not keep the water pumped out. Witness was never paid any money as he took credit for it in the store to the amount of £45. Witness then got a bill for £6, and the Society got a decree for that amount. Witness never agreed to take £40 in full settlement, as he understood he would be paid for the work done in the tunnel afterwards. Witness had shares for £10 in the

Society, and he might as well have it in the sea. By Mr. Ryan-He wanted £50 and he agreed as they had it in credit on him. Witness got two bills from the Society, but went to Mr. Lucy and told him that he was expecting they

THRILLING FEAT OF AIRMEN.

THROUGH SNOW, FOG AND ICE. The North Atlantic Ocean, which meant disaster to all who previously attempted to fly it, has been conquered by a German-Irish crew-Baron Von Huenefield, Herman Koehl (pilot) and Commandant Fitzmaurice, Chief of the Irish Free State Air Force. Leaving Baldonnell Aerodrome, Dublin, last Thursday morning at 5.30

p.m. in the "Bremen," a German Junker monoplane owned by Baron Von Huenefield, the daring aviators landed on Friday evening at 5 o'clock on Greely Island—a desert island off the coast of Labrador and north-west of Newfound were, we learn, effected by Messr- Maurice Fitz. cess of the aviators has won the admiration of the world.

HOW THE BREMEN WON THROUGH. It is still uncertain whether the German mono-


