SAND FOR MANURE. PERMISSION GRANTED. NEW CLERK TO BE APPOINTED.

RATE ESTIMATE 1930.

A quarterly meeting of the County Council was held on Tuesday. Mr. P. O'Gorman, V.C., presided. There were also present-Messrs. M. O'Ryan, L. Hallinan, John Butler, W. O'Don. nell P. Fitzgerald, C. J. Curran, D. Coughlan, D. Heskin, T. Harty, M. Curran, M. F. Dalsh P. Cunningham, W. Stack and P. J.

SAND FROM THE FORESHORE.

Mr Fitzgerald moved a resolution that the resolution approving of the Prohibitory Order in respect of the seashore from Tallacoole to Barnawee bridge re removal of sand be rescinded. In connection with the question, Mr. O'Gor. man, solr., said he appeared there on behalf of 60 or 70 farmers in the district, who saked that their means of living be not taken away from them as would be the case if they were not allowed to take sand for manure and seaweed. All these men pay rates, and as the majority of this council are farmers he was sure they would do nothing to injure the industry of their brother-farmers. He thought they should not prevent the removal of sand from a place where there was no coast erosion going on. There was a Prohibitory Order in existence from Clones to Ballyvoile. There was a very suitable place between Mr. Dunne's and Mr. Heafy's where there was a rocky surface, and he would ask the council to open a place at that point as his clients say if they went in at the other end they might be caught by the tide. The 60 or 70 farmers concerned with making a living in this area should not be mulcted for any vested interests. They would not remove gravel or sand for any purpose other

Mr. C. J. Curran-Is there any prohibition as regards seaweed? Mr. Bowen-No

sand, and there is nothing in the Order to in-Chairman-There would be no difficulty in

removing sand or gravel 50 yards out. When it is away from the coast there is no harm. Mr. M. Curran said two or three farmers came from the same area before the Finance Committee, and said if the sand were taken opposite their places they would be in a bad way The council should be very careful about what they did in the matter; also people were drawing sand and selling it.

Mr. Harty-Is there any objection to tak ing the sand from the bank outside? Mr. Heskin-It should not be taken to b

Mr. Harty-Anything from low-water mark down is good.

Mr. C. J. Curran-It is good manure when brought into the yard and let the sewage get

into it. Can you, Mr. Bowen, give us any idea of the volume of sand taken from this place for manues 9 Mr. Bowen-It is very small.

Mr. C. J. Curran-The principal manure is scaweed, and no one prevents them from tak-

The Chairman said he saw lighters of sand brought from Youghal to Lismore for manure. Mr. C. J. Curran-Coast erosion is having its effect all over the country, and every Co. Council is taking action protecting their property. Has the County Surveyor made any survey to find out how much land is lost in this county by coast erosion in a given period? Mr. Bowen-Whiting Bay is disappearing

The Secretary read the letter from the Depart ment of Industry stating it was not within their power to sanction the removal of sand for agricultural purposes from a place in respect of which a Prohibitory Order is in force.

Mr. W. J. O'Gorman-The Prohibitory Order is not made vet.

Mr. O'Ryan-We have asked the Department to make the Order

Chairman-You gave your sanction to the Order and now you have a resolution to rescind it. We don't want to create a hardship for the farmers. Let the Government do it, but we

Mr. Bowen-You are asked to rescind Order which you did not make and which has not been made.

Mr. Butler said a considerable portion of the coast to which the proposed Order would apply was rockbound and there was no danger coast erosion.

The Secretary then read the original letter from the Department of Industry suggesting that a Prohibitory Order be made as regards removal of sand and gravel between Tallacoole and Barnawee bridge, and the County Council approved of that suggestion at its last meet-

Mr. O'Ryan-Have you received notice that the Order is made? Secretary-No.

Mr. O'Ryan, in seconding the resolution rescind, said the men who came before the council had a grievance. They were using the sand for manure and for improving their land. They had no right to prevent them doing that. In his district when people were refused the right to cut turf they rose against it. When the people of Ballinacourty area had their rents fixed the question of sand for manure extered into the agreement. They were new only claiming their rights and they should give them what they required. He would not be in favour of giving permission to take gravel or do anything to bring about coast gracion. In

Mr. M. Curran-I have no objection to local people taking it, but I object to a wholesale trade being done in it by people who don't pay a farthing to the rates.

Mr. C. J. Curran said in the Order they need not include the coast between Ballinacourty and Barnawee as coast erosion would not affect it.
Where the sea was encroaching on the land
they should not allow the removal of any sand
or gravel. An Order existed from Clones, to Ballyvoile.

Mr. Fox said in Tramore a few years ag sand was being removed wholesale from the foreshore to Kilkenny in lorries and they had

Mr. O'Gorman said his clients only wanted sand and seaweed for agricultural purposes.

Mr. Bowen said he knew every bush in the place, and he saw it seven times a week. Mr. O'Gorman had given his clients very good value for their money. There was no question whatever of preventing the removal of sea weed. It was not in any Order and the Order had nothing to do with it. Seaweed was 95 per cent, of the whole outfit for farming, and sand for agricultural purposes was a mere bagatelle, and would get no one into trouble in a thousand years. As to sand being considered in fixing the rents of the adjoining land, he would like to know what value the farmers put on it. There was coast erosion going on in a portion of this place and the council should help to make the Prohibition Order. That Order was not applied for by the council or by him, but he approved of a certainpart of it. As to the

signatures to the petition in regard to this matfound though an exhaustive canvass was made only one-third eigned in favour of it and two thirds did nothing or are definitely opposed to it. The council have a definite duty to perform to the ratepayers to conserve their property and keep the cost of works, etc., as low as possible For the protection of their works the council are bound to approve of the Order so far as it is necessary to protect their property. Were it not for the Probibitory order in existence they would be faced with a serious expenditure be fore this in the neighbourhood. They knew what was happening at Ardmore, Whiting Bay and Tramore, and they wanted to prevent any-

thing like that happening at this place. He regarded the Order in question as necessary. Mr. C. J. Curran-It is only a question of He referred to the breaches in the wall between Barnawee and Ballinacourty which should be of the Order so far as gravel and sand were concerned, but he had no objection to the removal of a small quantity of sand for manure. He thought the council was bound to support the Order except so far as agricultural sand for the people in the district was concerned.

Mr. Fox-How will you regulate it? Mr. Bowen-They will not take much. Mr. O'Rvan-As it is the County Council will have to enforce the Order, the people in the area can be allowed take sand for agricultural

Mr. Bowen said so far as the foreshore was concerned, it was the property of the State, and they could make an Order without consulting the County Council.

Mr. Butler disagreed with Mr. Bowen as to taking the valuations of the signatories to the petition. He thought he should go by population and not by valuation. They were men of small valuations, and if the population were taken the percentage for the petition would be 100 to 1.

Answering Mr. O'Ryan, Mr. McCoy, solr. said they could shut their eyes to people taking agricultural sand.

Mr. O'Ryan-That settles it then. Mr. Bowen-The Ministry will not take any action without consulting me, and I have given you my advice.

Mr. O'Gorman, solr., said he would agree to have the resolution withdrawn if the County Council made an Order that they would not prosecute those people for taking sand for agricultural purposes.

Mr. Bowen-The County Council are an honourable body and most of their officials are honourable men, and you can trust them to do the decent thing.

CLERK TO BE APPOINTED.

THE MISSING POSTMAN.

ACCUSED AGAIN IN COURT. FURTHER REMAND GRANTED.

On Friday last the ten persons in custody in connection with the disappearance of Laurence Griffin, postman, Stradbally, on Xmas Day were again brought up on remand before Mr. McCabe, D.J., at Waterford.

Mr. Finlay, B.L., again represented the State and Mr. Connolly, B.L., defended 7 of the prisoners. Mr. Redmond B.L., the two Guards, and Mr. H. D. Reane, solr., appeared for Mor.

The court was crowded during the hearing. Evidence of having made mans of severa places in Stradbally, Kilmacthomas and Bonnahon districts in connection with the case was given by Sergt, Elwin.

Bridget Frawley, wife of Guard Frawley stationed at Stradbally, stated on last Christmas Day her husband came to his tea about 6 o'clock, and Guard Dulea came with him. Guard Dules was in civilian clothes and a trench coat Some little time after Laurence Griffin came

into the room, and she would say that he was in a drunken condition.

She gave him a soprollately. She asked Dules and Griffin to have some tes, but both declined. Dules took some port wine, and was then perfectly sober. Dules and Griffin remained about 15 minutes.

Griffin, when in Stradbally used keep hi bicycle in a store on the ground floor of wit. ness's house, and did so on this day. Both men left together, and her husband

went with them, and her husband, returning took a lighted cendle, and was away about 15 Witness, sister, and husband had some ter

o'clock, and returned about 8 o'clock, left again and returned finally at 10.30. Sergt, Cullinary was with him then, and remained till about 11, and when the sergeant left her husband went out again, and did not return for about 20

Early in January she remembered that Dulea called to the house to see her husband, who was ill. When she was letting him out of the house Dulea said to her that she was not to say to anyone that she had seen Larry on Christmas

She asked why, and he said that it was noth-

Cant Redmond-Is your husband still in the Civic Guards? Yes. Where is he stationed? In the Depot in

Sergt. Murphy stated that on January 24th he accompanied Supt. Mechan to the house of the defendant, Thomas Cashin, at an early hour in the morning. The defendant himself came down dressed in his trousers and shirt and opened the door. The Superintendent told him to dress and come to the barracks. Cashin asked to go upstairs and witness was sent up with him by the Superintendent.

Cashin entered his wife's bedroom, and wit ness stood at the door. Mrs. Cashin said: 'What's up now?" and Cashin said: "I am wanted at the barracks." Mrs. Cashin asked: What for ?" and Cashin said: "I don't know. Mrs. Cashin then said in Irish: "An feat mor marbh" adding in English: "What time

Witness had a fair knowledge of Irish and would translate the phrase: "The big dead man, or the big man dead."

Witness was not cross-examined. James Carroll, Stradbally, said that he was in the Club in the village on Christmas night last. About 10 o'clock Pat Cunningham, the defendant, and some other men came into the Club together. Later Guard Frawley visited the place for a few minutes. Witness left Cun. ningham and his friends behind him in the

Club when he left at 11.15.

Witness was in the village at 8.30 a.m. on St. Stephen's Day and saw the door of Whelan's Hotel open. The defendant, Morrissey, was standing at the doorway.

About 6 o'clock he saw the defendant, Murphy, and Nora Whelan talking in the lane at he back of the Civic Guard barracks. Murphy was in uniform (and Nora Whelan was in her indoor clothes. She had no hat or coat.

To Mr. O'Connor-John Cunningham came into the Club about 8 o'clock on Christmas night. Patrick Couningham came in over half an hour afterwards.

To Mr. Keane-There was nothing unusual about Morrissey standing at Whelan's early in the morning. Patrick Power, Carrigahilla, said he was

standing at Whelan's corner in the evening about 6.30 p.m. He saw Larry Griffin Dulea and Guard Frawley standing outside Frawley's residence. Witness next saw Guard Fralwey come up and go into Whelan's by the back. Sergt. Cullinan, who was standing at the back way at Byrne's corner, followed him. After a few minutes Guard Frawley came out and rejoined Dulea and Latry Griffin, Sergt. Cullinan followed him out and went to Byrne's corner again. Larry Griffin and Dulea then bassed around one corner. They were close to

Dules was rolling a bicycle. Griffin had his arm around Dules. They went up the Chapel road. Witness could not say where they went later, because he did not look around the cor-

ess spent about half an hour at the corne after that. He did not see any of the Whelan family. Griffin was sick and vomiting when he

asked her if there was an iron bar in the bouse Whelan said: "There are no bloodstain Prior to her saying that he had not suggested

anything in the conversation to her.

Sergt. T. Mulcahy, Tramore, stated that on
January 25th he saw the defendant, Patrick
Whelan in the Civic Guard Station at Strad. ally. He cautioned him that he was going to question him about the disappearance of Griffin. Whelan said "All right," and, in reply to var-

ious questions, made the following statement:-I got up about 8.30 or 8.45 a.m. on Christmas Day. I was collecting money at 11 a.m. Mass at Stradbally. When I came home from Mass I was knocking around the house. Jim Skehan was with me coming from Mass, and I invited him into the house. We had about three bottles of stout in the sitting room. Skehan had dinner with me and he left about 3 or 4 p.m. Charlie Moere and Frank Campbell came about 2.30 p.m. We had a few drinks. I stood the drinks. They left before

"I heard that Larry Griffin called with

letters, but I did not see him. 'The sergeant came into the premises the back door at about 6.30, p.m. I said: 'Good night, sergeant,' but he never spoke. He went up the back stairs, but he was back again in a few minutes. I don't know whether he went into the bar or not. He went out the back door, and returned in about half an hour. He did not say anything, but went up the back stairs. He came back after a few minutes. He went out by the back kitchen. "I think I might have had a few drinks through the evening after Moore and Camp. bell going away. At about 8 p.m. Jack Galvin and Ned Dunphy called at my house. I don't know who let them in but it might be myself. They came into the kitchen. The three of us sat down and had a chat some bottles of stout. I might have had a 'half one.' Neither of them paid for any

"I don't think my son took out any drink to George Cummins. I only saw Jimmy about 5.30 p.m. that evening. I had about a dozen bottles of stout and a few balf ones before Galvin and Dunphy came in on Christmas night. While I was in the kitchen my two daughters were in the sitting-room, and in and around the house, and they may have played a few tunes on the piano.

On Christmas Day or Christmas night I never laid eyes on Larry Griffin, either in my house or outside it. I heard he called with the letters. I don't know who took them from him, but I believe it was one of my daughters. Galvin and Dumphy left about 10.30 or 11 p.m. They left by the glass door leading into the yard.

"Neither of my daughters sung at the piano that night-I am sure of that. Before Galvin and Dunphy came in Denis Hannigan came in and I forced him to have a drop of wine. Hannigan and I sat on the sofa in the sitting. room while he was drinking." Witness was not cross-examined.

Mr. Finlay asked for a further remand of all the prisoners for another week. He added that he made the request in view of the Justice's own observations on last court day about remands. He (Mr. Finlay) thought it proper to intimate to the court that that was the last occasion on which he would ask for a remand in custody, and he would deal with the case finally on next court day.

The accused were remanded to March 1st.

DEATH OF MR. GEOFFREY CUMMINS. FAHA. KILMACTMOMAS.

The death of Mr. Geoffrey Cummins, of Faha, Kilmacthomas, which sad event occurred last week, occasioned very sincere regret. De ceased, who had reached in advanced age, had been in failing health for some time prior to the end. He belonged to an old and respected family in the district. His demise removes a popular figure, and one whose many generous acts will cause his memory to be long cherished by those who benefited by his generosity, and they were legion. The interment took place in Stradbally Cemetery amid many manifestations of sorrow. R.I.P.

PREE LIBRARY FOR CO. WATERFORD.

GRANT FROM CARNEGIE TRUST.

At Tuesday's meeting of the County Council,

Mr. O'Gorman, V.C., presiding, Mr. O'Rvan moved his motion that a rate of 1d. in the & be levied on the county for the purpose of establishing a Library Scheme under the Carnegie Trust and so avail of the Carnegie grant. He said this was the last year that the free grant would be available, and as 20 counties in the Free State had already

availed of it, they should consider the matter and see if they could promote it. Mr. Walsh seconded.

Mr. Wilson, Sligo, who represented the Carnegie Trust at the meeting said 20 counties had adopted the scheme and the libraries were proving an unqualified success. Cork Tipperary. Kerry, Wexford, Kilkenny, had availed of the grant. This was the last year the grant would be provided. If the County Waterford availed of it this year they would get a free grant of £950, while they would also get a supplemental grant in the future. This is a capital grant, and the maintenance and upkeep of the library would afterwards come from the rates. Lismore had already four Carnegie Library buildings for which they struck 1d. rate each year. In any scheme started he would recommend that these libraries come in under the County Scheme, as it would be to their advantage as they would get the benefit of the larger stock of books from the Central Library. If 1d. in the & rate were struck and Lismore area came in and co-operated it would be possible to appoint a Librarian and build up in Dungarvan a large library of books which could be sent to every part of the county in a special van. Dangar. van urban area should merge with the County Council and strike a similar rate and so share

the stock of books of the county. Mr. Heskin-Do you suggest 1d. in the £ for the whole county apart from Lismore?

Mr. Wilson-No. The 1d. is for the whole

Chairman-If we merge Lismore Library in the County Scheme we will have only to pay the 1d. ? Mr. Wilson-Yes. The County Coun. cil can appoint a Library Committee to deal with the scheme and a County Librarian would be appointed at a salary of £250, and he would

Mr. Heskin-In appointing a County Librarian will it create any hardship on the existing Librarians in Lismore and elsewhere?

Mr. Wilson said he did not think so. Mr. O'Rvan said if he thought the scheme would be the means of bringing good reading matter to the public he would be prepared to ask the ratepayers to make a sacrifice in that respect. In some districts only thrashy matters were read, and he wanted to create an appetite for good books. He was in favour of giving good sound literature to the people.

SUCCESSFUL YEAR.

Mr. James G. Duke presided at the annual meeting of the above Association, which was held in the Devonshire tion, which was held in the Devonshire Arms Hotel, Lismore, on Feb. 14th. The members present included Messrs. R. Bell, J. V. Brien, Thos. Coghlan, Ml. O'Connell, Geo. Bell, — Cremin (representing the Agricultural College, Mt. Melleray), Ml. McGrath, T. Flynn, R. Bell (jun.), Jas. Fives. P. Walshe, W. McGrath, J. T. Barry and Miss K. D. Barry (Secretary and Supervisor). Mr. D. O'Donovan, County Technical Instructor, also attended.

The following report was read by the Supervisor:—

the Supervisor:-Gentlemen—I beg to submit to you for your consideration the annual report on the working of -our Associa-

tion during the year 1929.

The Association, which comprises 28 members owning 348 cows, had a successful year's work and I am pleased to state that, notwithstanding a few exceptions the development of the cow-testing scheme in the district is a marked success.

For 315 cows that completed a full lactation period the average yield was 6,092 lbs. of milk with 216.15 lbs. of butter-fat, and an average test of 3.54. This shows an increase of 21 gallons of milk over the averge for 1928. If the price of butter-fat be taken is. per lb. and separated milk at id. per gal., the average cow in the Association in 1929 would earn £12 16s. 6d.

Of the 315 cows which wave complete recards, 10 yielded over 10,000 lbs of milk, 8 over 9,000 lbs., 22 over 8,000 lbs., 49 over 7,000 lbs., 79 over 6,000

The average yield for the ten best cows was 11,967 lbs. of milk with 453.18 lbs. of butter-fat and an average test of 3.76. Valued on the foregoing basis, each earned £26 11s. 6d.

The ten worst cows gave an average yield of 2,710 lbs. of milk, 93.99 lbs. of butter-fat, and average test 3.50; and only earned £5 11s. 6d., or a difference of £21 under the ten best.

The highest yielding cow in the Association was the registered dairy

Shorthorn cow, Beauty (R.8492), the property of the Agricultural College, Mount Melleray. She gave a yield of 15,179 lbs. of milk in 43 weeks, 622.33 lbs. of butter-fat, and an average test of 4.10 per cent.

The best heifer (recognised progeny), Silver Princess, gave a yield of 7,955 lbs. of milk and an average test of 3.74, and is the property of Mr. John Flynn. (instructed by Mr. W. R. Hodnett) for plaintiff herd yields by upwards of 215 gallons since the formation of the Association





At that time I had only a very vague conception of the nature and ex. tent of the clerical and other duties involved, but now after two years' practical experience I am in a position to state candidly that my pre-sent salary of £20 per annum represents only in this important branch of local administration the primary object of which is the protection of the flocks and herds of the county from contagious or infectious disease. I conscientiously consider that I am giving you service worth many times my present salary and, in positive proof of this assertion, I propose to submit for your information and guidance a brief summary of the main duties and responsbilities appertain-

ADMINISTRATION. The office is one quiring professional or technical qualifications, as is evidenced by the fact that the provisions of the Local Authorities (Officers and Employees) Act, 1926, apply to the filling of a vacancy. The Clerk is the Executive Officer of the Local Authority, and, as such, is solely responsible for ensuring that all the directions of the Department of Agriculture and of this Committee in connection with the administration of the Diseases of Animals Acts in the county are carried out. He is the medium for the conveyance of your instructions to the Depart. ment and to the several Local Veterinary Inspectors and vice versa and, accordingly, occupies a pivotal position in the mechanism of your organisation. In order that the objects of the Committee may be successfully realised it is essential that the Executive Officer should be thoroughly conversant with the provisions of the numerous Orders and Regulations made by the Department since the passing of the Diseases of

ing to the position, viz :-

Animals Act of 1894. CLERICAL DUTIES.-To furnish the Department and their Inspectors with required returns, statistics, etc., and to attend to sun. dry correspondence. To receive reports of animal diseases from the Veterinary Inspectors, the Civic Guard and the general public, and to take necessary action thereon. To prepare and circulate every month an agenda to each of the 45 members of this Committee. To attend meetdirections and orders arising out of the minutes. In this connection I might mention that during the two years ended 31st December, 1929, the number of necessary business letters issued by me, excluisve of agendas and communications to the Department, totalled 408. On taking over the position my first work was to instal a modern system for the proper filing of the Committee's

SHEEP DIPPING. The duties under this heading involve a considerable amount of work from April until November of each year, e.g. perfection of arrangements for summer and autumn dippings; reception of tenders for sheep dipping work and supply of dip; the keeping in constant contact with your Veteriary Inspectors who supervise this work. It is necessary for me to obtain from the Inpectors the dipping fees received by them; to hand over same for lodg, ment to the credit of the County Council; to check tre counterfoils of all certificates issued to sheep owners availing of the public centres; to collect any deficit revealed as a result of this checking; to keep an inventory of the equipment utilised at the public dippings; and to see that all utensils entruted to the contractors are returned and safely stored.

BOVINE TUBERCULOSIS .- The duties :n cidental to this section are such as to take up a good deal of my time all the year round. In proof of this if should be of information to you to be informed that during the past two years I have had to deal with the papers of 246 cases of bovine tuberculosis submitted by your Inspectors and the Portal Authorities at Water ford. The papers of each case have to be carefully scrutinised, checked, completed, one set transmitted to the Department, and a sunmary of each case entered in a Special Register which is kept open for inspection by the Department officials. LATE MR. T. Y. FAREELL, YOUGHAL.

A prominent Youghal citizen Mr. Thomas V Farrell, The Red House, died on Sunday, aged 78 years. A thoroughly capable and energetic business man and an able public administrator, he took an active part up to quite recently in every movement initiated for the improvement of his native town. As member of the Town Commissioners and their successors, the Urban District Council and as member and subsequently Chairman of the Youghal Board of Guardians for many years, his keen intelligence and sage counsel were always looked up to and availed of by his colleagues. He took a deep and practical interest in the development of the local tourist traffic, being a Director of the now defunct Youghal Motor Tourist Co., Ltd. When that Company went into liquidation be pu-chased their boat "The Victory," and ran her himself for several seasons on the Blackwater between Youghal and Cappoquin. On the death of his father Richard Farrell, he was senior mem ber of that well-known firm or shi milling merchants, and became Director when it was converted into a Limited Company. Mr. Kavanagh-We had considerable corres pondence with defendant's superior officers locally and in Dublin and there has also been correspondence between the local T.D.'s.

His Lordship-That has nothing to do with it. I am administering the law, and I don't give a button about anything outside, Mr. Kavanagh-It is not incumbent on to prosecute.
