DOCTOR'S FEES. DECREE FOR £75.

On Wednesday His Lordship Mr. Justice Sealy, K.C., opened the Dungarvan Circuit Court.

A number of undefended Civil Bills were ruled and decrees given.

Doctor's Fees.

Almost once a month for 5 years. That would be about 60 visits? Yes. How did this old man get on under your treatment? He got on very well, and he told me I was making a new man of him. He got a stroke of paralysis in 1926 and was paralysed on one side. At the time he was staying with his son John. His son knew witness was visiting him and never told him not to do so. Witness treated him for paralysis and as a result he was able to go out with the aid of a stick. In 1928, he got bronchitis, but recovered and was able to go about. For another period he was living with his step-daughter Mrs. Colbert. White-church, and it was there he died on Jan 1930. Some days before his death he was unconscious, witness treated him for days until a nurse was got, witness gave him drinks and injections. During the time witness was attending him he supplied such medicines as were required by him. During the first two years he gave him about 12 bottles a year at 2s. each. For the last 4 years he gave him 12 to 15 bottles of medicine a year at a cost of about

2s. per bottle. During all the time he attended him he got no money from the deceased except that once he gave him 2 sovs. and on another occasion he gave him £1, as he was leaving on a holiday.. Witness discussed payment with deceased and he told him he would pay him at the end as if he paid him then he might leave him there. Deceased also said he wanted to make a will and witness told him to see 3 Solicitor. He was a farmer and shopkeeper and made money, and was well able to pay. Witness could not have given him free treatment as a red ticket patient. The ordinary charge would be 10s. a visit. Deceased was very anxious that he should visit him regularly. There was never a suggestion about his visits to Aherne, but the last week of his life the Colberts said to him one day,—Who sent for you?

Cross-examined by Mr. McEnery—A lot of people in the country get

ROBBERIES AT DUNGARVAN.

SWIFT ARRESTS.

An unusually large crop of serious robberies took place in Dungarvan, recently, the premises broken into being the Railway Stores; The Shandon Dairy Co. and the Co-Op Stores. From the Railway Company Stores on the night of April 4th and 5th, a quantity of Clothing, trousers, flannels etc., consigned to local firms as also Basic Slag the property of Mr. J. J. Crotty, were taken. The value being about £8. From the Dungarvan Co-Op Stores 4! was taken from a drawer and from the Shandon Dairy Company though a determined effort was made nothing was got.

The matter was reported to the Guards on Sunday morning at 10 o'clock and Officers went to work directly and by 6.30 that evening not only was all the stolen property received, but three arrests had also been made. During the day Guard Wren discovered the stolen goods hidden in a cave near Mr. D. Dempsey's Shandon. The cave was blocked up with stones. Guards went into hiding to watch and at 6.30 p.m. when the parties came for the stuff they were captured. Those arrested were Peter Delaney, Davis Street, Dungaryan, and James and Ml. Cleary, Ballinamuck. All the accused wer brought before Mr. Sexton, P.C., and remanded in custody. Ml. and Peter Delaney were charged with breaking into the Railway Stores and Co-Op stores and Peter Delaney and James Cleary, with breaking into the Offices or the Shandon Dairy Company, on the 21 and 22 Mar. On Wednesday the three men were brought before Mr. Troy, D.J., at Dun-garvan, Supt. O'Shea, prosecuted





HAVOC OF THE FLOODS.

HOW TIPPERARY MAN LOST HIS

A very welcome change in the weather conditions occurred on Wednesday. On Wednesday night the outlook was anything but promising, as leaden skies gave every indication of a continuation of the rain which delayed the state of the same state. a continuation of the rain which deluged the entire South of Ireland for
nearly a week. A sudden change in
the wind, however, was followed by
a clearance, and to everybody's great
relief the day broke fine and bright.
The drying properties of a northwesterly wind were quickly in evidence and there was speedy subsiquence of the floods, which threatened
ruin to the farming community in the
country, and which had caused grave
inconvenience to pedestrians and venicular traffic. Though the wind was
rather cold, there were periods of
bright sunshine, and, generally, there
was evidence of a return to more
seasonable conditions.

Last evening the cold north-westerly

Last evening the cold north-westerly wind died down and the remainder of the night was dry and rather mild, with expectations of continued fine

The damage done by the flooding of Tuesday and Wednesday to the railway lines in the south was repaired the following day and the normal traffic is now running between Dungarvan and Cappagh, which is still

being worked on.

Due to the severe flooding of the river near Ballinrea portion of the main Cork and Crosshaven road was undermined between Carr's Hill and Shannon Park Cross. In consequence of this the traffic has been diverted on o a by-road. Up to a late hour last

night this position was unchanged.

Due to the heavy ram of the last three days the stream which runs to the woollen mills at Blarney became greatly swollen, and the rush of water swept away the dam near the vicinity of Waterloo, about a quarter of a mile from Blarney. It is not believed that there will be any stoppage caused at the mill by the bursting, but consider-

able flooding was caused in the area in close proximity to the little river.

At ten o'closk lase night the mill stream at Midleton overflowed its banks, and in a short time several por-tions of the town, including the Main Street, were under water. This morn-ing, though the rain had ceased, the

In Midleton the most extensive floods ever experienced here have completely inundated one-half of the Main Street, including Charles street Main Street, including Charles street and the adjoining areas, and at the moment the inhabitants of the locality are marooned. The great inundation of water began about 8 o'clock last night and is only slightly falling at the time of wiring. Thousands of poundsworth of damage has been caused to local merchants, who are helpless to stem the raging torrent, which burst through their premises with lightning?like rapidity. As yet there are no means of getting from the there are no means of getting from the flooded area to dry land. except by horse-drawn vehicles. The water is two feet deep in many places, and a number of bridges in the northern side of the town have been swept away. The Midleton District Court, which was to be held to-day, was adjourned, as the District Justice (Mr. Farrell) was un-able to reach Midleton owing to the

last night.

In the Glen of Aherlow further areas of tillage lands are being inundated, and trees uprooted by roaring torrents from the Galtee Mountains.



The dairying industry occupies a key position in the agricultural economy of the Irish Free State. Its importance is only fully realised when we examine the exports of the produce and manufactures of the country. In 1929, our exports of live cattle and pigs were valued at approximately £15,500,000, bacon and pork at £4,000,000 and dairy products at £5,000,000. Our exports under these

Now the exports under all these heads are directly linked up with the dairying industry of which the dairy cow is the basis. Fortunately, we have in this country a type of animal which, with proper selection and care is capable of fulfilling the dual purpose of producing milk economically pose of producing milk economically and, at the same time, producing store stock suitable for conversion into meat. We have at our doors an apparently insatiable market, which is sought after by every country in the world which has a surplus of agriworld which has a surplus of agricultural produce to export. If we consider the total butter imports to Great Britain we find that these have increased from approximately 3 1-3 million cwt. at the beginning of the century to almost 61 million cwt. in 1929—an increase of practically 100 per cent. in twenty-nine years.

There is always good demand for an

There is always good demand for an article of good quality, and it invariably pays better to produce a good quality article than a mediocre one. Owing to the clean bill of health which our animals possess, we have almost a monopoly of Great Britain's livestock import trade. In the products of livestock, however, and particularly in dairy products, of which butter is practically the only one we export, we have to meet very keen competition.

In 1929, we supplied only 8.8 per cent. of Great Britain's demand for butter, while Denmark and New Zealand, with cow populations not greatly in excess of ours, supplied 33 per cent. and 20 per cent. of Great Britain's butter requirements respectively. In the same year, it must be remembered that only 68 per cent, was sent to the British market, while New Zealand's butter export represents the product of only two-thirds of the surplus milk of that country, the remaining third being converted into cheese, which was also exported to Great cent. of the cheese imported into land. Great Britain in 1929. It might be mentioned here that the cow population of the Irish Free State is about demand. except for earlies, there is 1 million, Denmark 1 million, New really little importation from abroad.

Zealand 1 1-3 million. Of course there are several factors to be taken into account when com-paring the export of dairy products of various countries. Denmark and New Zealand specialise in dairy cows which are bred for milk production only, as these countries have no considerable cattle export trade. The situation in the Irish Free State is different. Our cattle export trade is about two and a half times as valuable as our total export of dairy products. It is therefore of great importance that our dairy cows should be capable of producing young store stock which can be converted into meat at an early age in accordance with present-day market demands. Another factor which must be taken into account when comparing the export of human foodstuffs is the relative populations of the countries and the proportion of the total production which is consumed at home. The milk equivalent of the butter and milk consumed in the Irish Free State is estimated at 129 gallons per head of the population per annum-a figure which is considerably in excess of that consumed in any country for which data under this head are available. The total quantity of butter con-sumed by our three million inhabitants is 64.6 per cent of our total production, leaving only 35.4 per 'cent.

The rate of consumption in New Zealand is somewhat less than in this country, but since the population is only about half of ours, the total consumption is about one half that of the Irish Free State, leaving a greater amount available for export. How to overcome this drawback is one of the most serious problems with which Irish Agricul-ture is confronted at the moment. Attempts to convince farmers that winter dairying is a profitable proposition have failed hopelessly up to the pre-sent. It is well known that winter calvers produce larger yields than spring calvers but. except in the case of high yielding cows, the extra milk obtained from winter calvers will not pay for the extra cost of production. Before at Mr. J. J. 

RELIEF GRANT WITHDRAWN.

The withdrawl of the £1,000 relief grant for the repair of footpaths has been the reply of the L.G. D. to a demand on behalf of Ballinasloe workers for what they claim is the standard wage payable in the town. The rate of wages has been fixed five times, the Galway Co. Council Finance Committee at length deciding the rate at 35s. a week for labourers and 75s. for tradesmen, following a protest by the workers against a reduction. The committee have now re-fixed the wages at 30s. and 63s., respecticely, and asked the Department to re-allocate the grant.

BELFAST PORT FIGURES.

At Belfast Harbour Board an increase of 45,800 tons was reported in the total tonnage of vessels arriving from January 1 to April 4, as compared with the corresponding period last year. The auditor's report showed an increase of £15,000 in receipts during 1930. The total receipts were £318,500.






