BRITISH ELECTION.

ANOTHER CRISIS.

It is almost universally agreed in British political circles that the expec ted dissolution of Parliament will take place at he end of next week. Various events and official statements indicate this eventuality and the election date is suggested as October 28th or 29th. Difficulty still exists in the Cabinet

in regard to the programme on which the National Government will appeal to the country, the question of tariffs being the main obstacle to agreement. It is thought that the adoption of a tariff policy will definitely compel the Liberals to withdraw support from the Coalition.

To a number of searching questions in the House of Commons, the Prime Minister gave guarded replies, though he refused to state when the House was expected to resume after next week.

FARMER'S SAD DEATH.

BROTHER REMANDED.

The tragic death of Mr. Wm. Lannon, at the residence of his brother, Mr. Richard Lannon, Rathguage, Bonmahon, on Sunday night, and the arrest of his brother on the capital charge on Monday and his remand to the next District Court at Kilmacthomas, on bail, created a sensation in profit. That is an example to be foi-

It would appear that Mr. Wm. Lannon, who is aged 54 years, returned home from America about a year ago, and sometimes afterwards went to live on a farm near Tramore. On Sunday last he came on a visit to his brother Mr. Richard Lannon at Rathguage, Bonmahon, and when proceeding from the kitchen to his bedroom to retire for the night and while crossing the threshold of the room he collapsed, his head coming in violent contact with the floor. Rev. M. Dowley, C.C., Kill, and Dr. Walsh, Bonmahon, were quickly on the scene, but he never rallied.

When the inquest was resumed at 8 p.m on Monday, Dr Walsh, Bonmahon deposed:--I made a post-mortem examination of the body of William Lannon, with Dr. Coffey. There was a wound three-quarters of an inch long on the scalp. There was evidence of an old-standing advanced disease of the Mahon Bridge since the writer first the heart, which was of sufficiently grave nature to cause sudden death.

> In reply to Supt. Kelly, Dr. Walsh said that the mark on the scalp could he caused either by a fall or by a blow. Dr. Coffey, Waterford, correborated. the previous witness.

Supt. Kelly, asked for a further adjournment of the inquest, pending the result of legal proceedings. The De puty Coroner acceded to the request. Shortly after this second adjournment of the inquest, Mr. Frank Drohan, P.C., Newtown, Kilmacthomas, at Rathguage, and Richard Lannon, (owner of the place) was brought before him on the charge that he did on the previous night willfully and with malice aforethought slay and kill his brother, William.

Supt. Kelly, deposed that he had arrested the accused on that day, and having given him the usual caution, charged him with the crime. Accused said:—"I have nothing to say, I didn't kill him." Witness asked that accused be remanded to the next District Court

Accused was remanded, bail being allowed himself in £100, and two sureties of £50 each

At 3 p.m., on Tuesday, the remains of the late Mr. William Lannon, were removed for interment to the family plot in Kill cemetery. The funeral was one of the largest seen in the locality for years—a worthy tribute to the memory of one who was a general favourite with all. The deepest sympathy is felt with his wife, brothers and sister in the heavy blow that has befallen them.—R.I.P.

MUIRCHU'S GUN.

Within a few days things are to be made more lively for trawlers found poaching in Saorstat waters. The Muirchu, the fisheries patrol boat, is now in the Dublin Dockyard Co.'s premises, where the annual overhaul is being completed. When she puts to sea again, she will be armed with a modern 3-inch quick-firing gun, described to be as amongst the most useful weapons in the small armaments class. It is capable of firing several rounds per minute, and could be most destructive if necessary, at comparalively long range. A team of expert gunners will be in charge of the gun.

Since the Muirchu was taken over by the Department of Fisheries, it has not been armed, her armaments having been removed by unauthorised persons in Dun Laoghaire harbour in 1922. They were never restored, and now and then poaching trawlers have escaped because of this drawback. When she next appears a surprise will be in store for the trawler which attempts to ignore her authority. Whilst the Government recognises that the present patrol system is not adequate, it is hoped that the arming of the Muirchu will render her much more

valuable for her duties. Designed to define more specifically the law in regard to territorial waters and the procedure to be followed in respect of the enforcement of the law, a Bill is nearing completion which will strengthen the fishery authorities in dealing with the poacher. Machinery to deal with the present difficulty in collecting fines will also be provided by a Bill. Outstanding fines at pre-

sent amount to about £500 Meantime, the new Sea Fisheries Association is making good progress.





LISMORE WEIR.

Blackwater Fisheries.

Mr. J. Kennedy, Chairman,, presided at the monthly meeting of the Lismore or No. 4 Blackwater Fishery Conservators, and the others present were Major Lingfield, Capt. P. Dunne, Messrs. E. A. Rice, solr., Vice Chairman, J. Power, W. O'Brien, W. Baldwin, F. C. Poprese. win, E. C. Penrose.

Messrs. T. Drohan, Secretary and Inspector and W. Buckley, Assistant Inspector, were also in attendance.

Lismore Weir.

Major Lingfield, said, arising out of the minutes of the last meeting, which included Mr. Holt's report on the Lismore Weir, he was fully acquainted with all the facts and had dealt with them in detail at a meeting of the Owners' and Lessees Association at Fermoy last April. Mr. Holt's contention that the re-opening of the No. had arrived at a conclusion without sufficient investigation. Having taken soundings at the place last July he (Major Lingfield) had already pointed out to the Board that they were not able to get within 70 feet of the gap because of the tremendous flow of the water there. The soundings were taken by him at dead low water. What it would be at the top of a spring tide they could imagine. They wanted the flow through the gap reduced to a considerable extent. With regard to the argument that the proposed alteration would lead salmon into a blind alley, he suggested that it would be a very costly matter to put a wire grating barrier between Poul Pollen and the South Bank. That would provide an effective means of preventing the fish going up into that bay. He believed that both Mr. Drohan and Mr. Buckley would bear him out in the statement that very little river-borne refuse would come down that way at all, but would come through the end of the Weir. And he didn't think that any objection that such a grating would be blocked by flood-borne refuse would be justified if raised. That was the suggestion he had made. With re-regard to the contention that the result of salmon going in numbers into that blind alley was that they would be liable to be poached, he didn't see anything in it. After all, when they considered that 100 yards below netting was going on day and night throughout the whole season, they might ignore that argument. He re-gretted he hadn't been able to be present at the last Board meeting or there wouldn't have been any need for all the discussion giving the idea that they were not agreed on the matter. They had been all of one mind about the great advantage to be derived from the opening of the hatches referred to. Mr Carroll, solr., had stated that the hatches had been closed at the instance of that Board. He (Major Lingfield) had been speaking to the oldest living member of the Board who was convinced that Mr. Carroll had been wrongly informed. His recollection as far as he could go back was that they were always having for the day when far as he could go back was that they were always hoping for the day when they would be able to have those hatches open. Now that that was accomplished they should bear in mind the fact that in 1867, after the gap was legalised the statement was that the fish ran freely. At any rate fish hadn't run freely within living memory up through the gap with the hatches closed, but on the contrary, the only fish going up were peal and he didn't think anybody could give an instance of a single salmon having jumped through the gap. Peal being faster than salmon would go where salmon would not. He didn't believe that a spring salmon had gone up since the gap was closed. Now that the hatches were re-opened he had great hopes that they would find fish pass up.

The Chairman—Have they re-opened them,

Mr. Rice—They have.
Replying to Major Lingfield, the Secretary said he had had minutes of the Boards meeting going back 30 or 40 years, but they were so decayed it was almost impossible to decipher them.

The soldiers named on the en-closed list served in the Graet War, and are buried in this cemetery. We propose, after obtaining all necessary consent of the next-of-kin, to erect over each of the graves, if not already marked by a private memorial a headstone conforming with the standard designs adopted by the Imperial War Graves Commission, bearing the regimental badge, and particulars together with a religious emblem in each case, if desired.

We shall be obliged if you will grant formal permission to erect head-stones over these graves. We suggest that, as is usual with the case of these War Graves, permission to erect the headstones be granted gratis.





Agricultural Conditions

ist SEPTEMBER, 1931.

Weather and Farm Work.—The weather over the greater part of Saor-stat Eireann was very fine for the first week in August. During the second week in August. During the second and third week showery conditions were general and about the middle of the third week heavy rain and flooding was experienced in several districts. The last eight or ten days were particularly fine. Generally the weather during August was favourable for farm work and afforded farmers a much needed opportunity for cutting and saving old meadows, carting in of the earlier saved hay, and drying and carting home of turf. The aftercultivation of root crops received attention during the month, but the pressure of work in connection with the sure of work in connection with the saving of hay and the harvesting of corn crops towards the end of the month, coupled with the sodden state of the soil on tillage land, limited the amount of after-cultivation which could be successfully undertaken.

Pasture and Live Stock.—Pastures

generally were well covered, and in many districts could have maintained a heavier stock of cattle. The prolonged periods or rainfall during the summer kept the ground in cold condition and, though the supply of grass was plentiful, stock generally did not thrive as well as might be expected. Sheep and lambs, more so than other stock, have shown the effects of the soft condition of the pastures. In wet cold land there was marked improvement in pastures resulting from the welcome periods of warm sunshine enjoyed in the opening and closing stages of August. Reports of Hoose in calves were received from many councillations. Trade in wool remained depressed and values at sales in Dublin during August showed no improvement. ties, but apart from this the health of stock was good.
