URBAN RATES 1932-33. INCREASED DEMAND FROM COUNTY COUNCIL.

TOWN RATE REDUCED BY 1/6. POOR RATE INCREASED BY 1/9.

Mr. J. Butler, Chairman, presided at a special meeting of the above held on Wednesday. The other members present were Messrs. T. McCarthy, Ml. Clancy, Jas. Hackett, Wm. O'Donnell, T. Power, Mce. Griffin, M. J. Keane, and J. F. Moloney.

The meeting was called to consider the estimate of expenditure for the year March 1932 to March 1933, pre-

pared by the Clerk.

The Chairman explained the object of the meeting, and said that before proceeding he would give them the figures of the financial position at the close of the last financial year on March 31st. On that date their liabilities were-£1,512 10s. 6d. and their assets-£1,503 14s. 11d., so that at the close of the last financial year the Council did not owe a £10 note. I doubt very much (continued the Chair-

man) if there is any other Council in the Free State that can say they are less than £10 on the wrong side after the year. That was our position at the 31st March.
