the work are not in a position to purchase material and the Society would feel grateful if the Council could arrange to give the work by the day to two of its members. Mr. McCarthy-Since last Friday the Carpenters Union had a meeting

and decided to send this letter. What they want is that if the Council have say two weeks work, that it be divided between two carpenters, and not given to one.

Mr. McEvoy-If they are paid daily wages, will the work be done inside the Engineer's estimate? Mr. McCarthy-I propose if we have

over two or three days work in future that it be divided between the carpenters. Mr. Griffin-That should apply all

round, you have plumbers, masons, etc., anyone should not have a monopoly of the Council's work. Mr. McCarthy-I agree with you.

ASSISTANCE MOUNTS UP.

Ald. T. D. Connolly, presided at the meeting of the above held in Dungarvan, on Wednesday. The other present were—Messrs. J. Butler, Wm. Stack, Jas. O'Donovan, T. Tracey, D. Coghlan, J. O'Regan, D. Heskin, P. Caulfield, M. F. Walsh, T. Dunne, T. Synott, J. Cosgraye, Michl. Curran.

Home Assistance. Mr. Phelan, Superintendent Assistance Officer, submitted a report on the expenditure under Home Assistance for the half-year ended Sept., 30th, 1932, which showed the amount expended as £14,876 14s. 2d. That showed an increase over the corresponding period last year of £2,531.

Secretary in reply to a member said he anticipated that for the year, the estimate for Home Assistance will be exceeded by £5,000.

Mr. O'Donovan-I know of necessitious persons who are drawing Home Assistance due to the fact that the Government would not grant them Old Age Pensions. There were more pensions passed at the last meeting of the Pensions Board than were passed during the life of the late Government. Chairman-The new cases were not

so numerous. The majority were ap-

plications to increase the amounts from 8/- to 10/-, etc.

Mr. Butler—As the question of pensions was raised, I presided at a meeting recently, at which farmers who had given over their farms to their sons or daughters were granted pensions. There were pensions also granted to people with deposit receipts in the National Bank and in one case a woman over 70 years applied for a

claim as her husband was earning too much money Mr. Walsh-I know of a case in Lis more where a person with £300 is get-

ing a pension. Lismore Hospital.
Nurse O'Keeffe, Lismore, reported the number admitted to the District Hospital during the month as 12; discharged 5; remaining 9; in the Fever Hospital the number admitted was 70: discharged 25; remaining 57.

Safe For Assistance Monies. Jas. McGrath, Assistance Officer, Waterford, applied for a safe to be installed in the Dispensary, Waterford, for holding the above monies. Mr. Phelan was directed to procure a safe to be embedded in the wall, cost not to exceed £10.

Increase Of Salary. Arising out of the application for an increase of salary (adjourned from the previous meeting), from Miss Walsh, Nurse Instructress at the Co. Hospital, Waterford.

Mrs. Hicks, an official of the Irish Nurses' Union, appeared in support of the application and informed the Board that Nurse Walsh's salary was the same now as when she was appointed 25 years ago, namely £75. The application was for a salary of £150 a year. She had turned out probationers who were second to none, and some of whom were now receiving bigger salaries than Nurse Walsh. The Secertary in reply to Mr. Coghlan, said Nurse Walsh, was in receipt of 14/- a week in lieu of rations.

Mr. Dunne-To some of us an application for an increase of 100 per cent. looks big, but when you consider the matter it is not. In my opinion she should have got this increase 10 years ago, so I have great pleasure in proposing that it be granted.

The Secretary explained that the increase would not mean 100 per cent. as Nurse Walsh was in receipt of a bonus of £31 17s. 6d., so that the increase will be £41 instead of £75 and the Board will be recouped by the De-

partment for one half of her salary. The prosposition was passed unanimously, subject to sanction.

PROPOSED MARCH ON DUNGARVAN.

HOME ASSISTANCE SCALE INCREASED.

At Wednesday's meeting of the Board of Assistance, Ald. T. D. Connolly, presided.

A deputation from the Waterford Branch of the able-bodied unemployed Association appeared before the meeting in support of an application made by the Branch, demanding an increased scale of Home Assistance; the abolition of the present system of private inquiries by officials into the circumstances of recipients of Home Assistance; the abolition of the voucher system and the substitution of cash payments instead.

The deputation consisted of 3 men from Waterford and 2 from Rathgor-mack, representing the unemployed of Carrick No. 2 area.

Mr. McGrath, speaking for the deputation said that the unemployed of Waterford City demanded that the scale of Home Assistance should be revised and that vouchers be substituted by cash and that the Board should adopt the scale included in the letter before the meeting. Their members also demanded that vouchers be substituted by cash. Vouchers are humiliating and on his opinion are a brand of pauperism. They were too long held in subjection by a miserable pitance—a pittance that was not enough to keep body and soul together He hoped that the members would unite their voices with theirs and help to end this mockery, this slur, for it it a slur on a Christian country.

Mr. Dunne—I am a member of this Board since 1925, and during that time I always held that the scale of relief was inadequate; 8/- for a man and his wife was ridiculous. What they had heard from the deputation were facts. often wondered how the men in Waterford were so patient. He was sure the Board would be reasonable in their attitude and do their best to meet the demand of the deputation. I have a scale in mind, but will not put it forward until I hear what other members have to say.

Mr. O'Donovan-I agree with what Mr. Dunne has said. I suggest that the recipients of relief be classified and that men who did not want to work will not be put on the same foot-

ing as decent workmen. Mr. Caulfield-I am in sympathy with what has been said, but where is the money to come from? HOUSING SCHEME ADOPTED. 400 COTTAGES TO BE BUILT. . APPLICANTS GALORE.

For Flynn-M. Curran. Cullinane was declared tenant.

New Housing Scheme.

The Board next took up consideration of the question of adopting a Housing Scheme for the county; a large number of applicants for houses under the scheme being present.

The eScretary said that in reply to the advertisements issued, they had received 644 applications from the seven rural areas as follows-Carrickon-Suir-55; Clonmel-17; Dungarvan -140; Kilmacthomas-140; Lismore-

70; Youghal—25; Waterford—197. November on the Farm.

November is a transition month in the farmers's year; in this period the end of the grazing season arrives, and the beginning of winter rationing occurs. It marks the end of the busy bustling season, and the commencement of dead winter, when, as regards field work, it is neither possible nor generally necessary to make haste. There is often a gloomy silence in the clear November day, although, generally speaking, the month gives an amount of rain and windiness. It is often characterised by evening fogs and rimes, and frequently hard frosts over take the last of the mangold and other root crops still in the fields.

While the weather o fthe past month continued fair, live stock required nothing out of the ordinary in the matter of protection, but now that conditions have changed, and will most probably be cold, damp, and generally wintry for many months to come, preparations must be made for the com-fortable, yet healthy, housing of the farm's stock of cattle and horses. Dairy stock and strong stores will not be suffering just yet in sheltered areas, but calves of this year's rearing must and piercing winds. Ill-treatment in this manner at the present time causes loss of valuable flesh in the case of tender young stock, and frequently leads to coughs, chills, and other ma-

Housing should, therefore, be the first object. A suitable building should have good lighting and ventilation, without draughts. Coddling in ruinous, but young stock do not suffer and disinfecting, and possess other desirable properties. Even with good flooring, some clean, dry bedding material is advantageous, as it adds to the comfort of the animals, and absorbs liquids, etc.

Before calves are finally housed the buildings should be cleaned out down. Whitewashing the interiors makes them fresh and more lightsome, and destroys disease germs. A gallons of water, in addition to a small quantity of one of the common sanitary compounds, makes a cheap and effeltive anti-disease mixture, and all farm buildings should be liberally

It is generally better to allow lea to lie for a month or more after ploughing, the reason being to permit the soil to mellow cay a trifle. If sown on a freshlyploughed pasture field, wheat-or, in fact, any crop-is apt to be stunted; the fresh fibrous turf also keeps the soil too loose for the best resistance of winter weather conditions.

When it is desired in any event to drill wheat in November on lea, and where the ploughing has been unavoidably delayed, it is advisable, first to harrow and tear out the turf, and then plough it underneath with deep, broad furrows. Since the sod will not under these conditions have decayed, and there has not been sufficient time: for the liberation of an adequate supply of plant food from the soil reserves it is desirable to apply manures to refined and exemplary character, who assist the little wheat plants in getting established in the seed-bed. On most types of land the following will be found to give good results:- 1 cwt. sulphate of ammonia, 4 cwt. of superphosphate 35 per cent., or "Semsol," with 2 cwt. of kainit per statute acre.

Annually on the approach of the

winter feeding season an estimate should be made of the supplies of home-grown crops available for use on the farm, in order that one may gauge roughly, whether it is necessary to spare fodder in the event of supplies being scarce. Such an autumnal stock-taking was never more necessary than it is in the present season, when, owing to the very low prices prevailing, farmers have not been disposed to sell their summer stocks of cattle, and it looks as if they must arrange to over-winter them. When it is found that fodder supplies are not equal to requirements, steps must be taken to prevent waste, and at the same time to supplement those foods that it is feared will be shori in the most suitable and economical manner. For one thing, hay must be spared.

It simply MUST, if cattle are to have anything by spring-time. For dairy cows from 16 to 20 lbs. of hay per day in two feeds is quite adequate for maintenance, provided it is good. dried pulp, bran, or crushed oats. may be used to supplement the smaller supply of hay. value 1 lb. of dried beet pulp or bran equals about 11 lb. hay; while 1 lb. of equal parts of crushed oats and pollard may be used instead of 2 lbs.

Straw, though bulky, may be used to a certain extent to economise hay. It must not be fed to high yielding cows, as an immediate decrease follows. It can be given to store stock or dry cows, with which immediate production is not a matter of such importance. If straw must be given to milking cows in times of scarcity, the amount must not, with the addition of hay, exceed a total of 14 lbs. alto-"MAC."— in "Farmers" Gazette."







Weather and Work.—The weather during the month of October was vari-able in character; the early part of able in character; the early part of the month was fine, dry, hard and rather cold frosts at night, but the second half was unsettled, with occasional very heavy showers and cold winds. On the whole, however, very fair progress was made with seasonal farm operations, and at the close of the month all normal farm work was well advanced. During the month farmers were engaged in threshing the cereal crops, lifting and sorting the potato crops, pulling and storing mangels, lifting and delivering the sugar beet crop, and in cleaning and ploughing stubble land. During the month land was also prepared for the sowing of winter wheat and in some cases the crop was sown. In other cases the crop was sown. In other cases the farmers are waiting for more suitable weather before sowing. Reports generally indicated that a consider-ably increased area of land will be put under wheat this season.

Potatoes.—The great bulk of the potato crop was lifted during the month under generally satisfactory conditions. The crop on the whole was good, although the effects of blight on the tubers were observable in many places. The yield generall was well above the average, especially in the case of the Arran Banner variety, which proved exceptionally high all round, and the tubers almost everywhere were of good quality so that even in the most unpromising areas ample supplies of potatoes are available this year. Shipping demand was active during the month, but prices, which opened around £2 per ton, were not high enough to induce farmers to market heavily; consequently sales were mainly for local consumption. Demand for seed was good during the month, especially for that of the "Up-to-Date" variety for the foreign export trade, the price re-turned to the growers being £3 per

Mangels, Turnips and Sugar Beet. The greater part of the mangel crop was pulled and stored during the month. Contrary to anticipations earlier in the year, the crop did well on the whole, and the yield generally was well up to average and the roots remarkably free from disease. Turnips made steady progress during the month, and although it was reported from some districts that there appeared to be excessive development of leaf, the crop promised to be up to average. Sugar Beet was being delivered to the Sugar Factory during the month.
