One attribute of a first-class ration which is usually stressed in writings on animal feeding is that it contains a large variety of feeding stuffs, derived from a number of different plants. It is worth while to consider ertain aspects of this question. We ealise at the outset that compara-ively few foods are balanced, as re-ards the amount of protein they ingards the amount of protein they include, for any class of stock, and the same holds good in respect of minerals. It follows that two or three foods, at least, will be necessary to make up a ration conforming at all closely to the scientific requirements. The usual advice, proffered, however, is that the number of different foods used particularly with cows, should be seven or eight, in fact the more the better. With high producing animals the greatest difficulty often is by get them to eat enough nutrients to mals the greatest difficulty often is get them to eat enough nutrients to support the highest performances of which they are genetically capable, and in such cases the most reasonable way of tempting their appetites is to offer them a good variety of foods.

Effect On Digestibility.

We do not really know what effect palatability has on digestibility, but, from our knowledge of the physiology of digestion, it may have an appreci-

of digestion, it may have an appreciable influence. Scientific Reasons.

process.

The main scientific reason advanced in favour of variety in the ration is that it improves the biological value of the proteins. Proteins are made up of amino-acids, which occur in very different proportions in the different proteins. The argument is that if you include in the ration products from several different plants, the probability is that you will get a better mixture of amino-acids in the whole, and that the risk of having the productivity of the animal held up for lack of some particular amino-acid is reduced to a minimum. But the whole thing is a step in the dark, and no one could call it scientific. What is wanted is a complete analysis of all proteins, both those in the com-mon foods and those built up by animals, and then it would be possible to decide what particular proteins lack in the way of amino-acids, according to the purpose for which they are being fed, and what others are most suitable for making good their deficiencies.

The reader will probably be rather glad that at the moment we have no basis on which to build up a ration whose proteins will be so mixed as to attain their highest biological value, and that the only course open to us is that the only course open to us is that of feeding a variety of feeding stuffs, on the rather "hit-ormiss" principle that that will improve our chances of getting somewhere near the optimum. Professor Mollgaard, the distinguished Danish Mollgaard, the distinguished Danish authority on nutrition, has, indeed, concluded that in general there is little improvement in the biological value of the proteins by using a wide mixture of foods, and that variety is only important if the total protein fed is low and just about the minimum requirement—that is, when the wast age of amino-acids must be kept very low or some will be deficient, and limit production.—S, in "Farmers' Gazette."

"A sum of 201.304 has been saved to the rates by reason of the progressive decrease of the estimates submitted for the past twelve years. This is an extract from the report on the annual estimate and demand for the financial year, 1934-35, submitted to the annual meeting of the Waterford Mental Hospital Committee by Mr. T. F. Casey, Clerk. The nett amount demanded from the contributing bodies, he stated, was £24, 275, a decrease on the previous demand of £100, despite an increase in the number of patients in the institution. Having given the daily average of patients for the past three years, the report went on to point out that the patients from the Co. Waterford in this period had increased by seventeen, while those from the city had been reduced by four. As the expenditure of the hospital was apportioned on the basis of the daily average number resident, the County Council would receive no benefit from the decrease of £100 in this year's estimate. This was the twelfth year in which the estimates presented had been reduced.

In an appended tabulated statement it was shown that starting with a reduction of £3,500 in 1023-24 there was an uninterrupted series of decreases in the subsequent years as follows:—1924-25, £346; '25-20, £437; '20-27, £433, £1,502; '28-29, £1,200; '29-30, £175; '30-31, £100; '31-32, £1,000; '32-33, £1,502; '33-34, £300. Mr. Casey added that he had not provided in his estimate for the maintenance of some seventy patients proposed to be taken over from the County Home; as he did not think the necessary additions and alterations would be carried out within the financial year covered. It would be well to bear in mind that the maintenance of these patients alone would put up the next estimate by some £2,500, whilst renavment of loans might ac-

of these patients alone would put up the next estimate by some £2,500, whilst repayment of loans might account for a further increase of £2,500, making a total of £5,000 unless a very substantial contribution was received from the Hospital Sweepstakes Fund. The estimate was unanimously adopted, the Rev. Chairman (Very Rev. Canon Walsh, P.P., Tramore)

and several members paying glowing tribute to the efficient and economical management of the institution.



Thomas McGwire Gyles and Charlotte Stuart, the trustees of the will, were the plaintiffs, and Sir Joseph Glynn, President of the Council of Ireland of the St. Vincent de Paul Society, and J. E. McGwire, claiming to be heir-at-law, and the Attorney-General are the defendants.

Mr. C. Lavery, K.C., with whom was Mr. F. Sweeney (instructed by Messrs. Wm. Mooney and Sons), applied that the property should vest in Sir J. Glynn, Rt. Rev. Mgr. Dunne, P.P., V.G.; Rt. Hon. James Mc-Mahon, and T. A. Murphy, on behalf of the Society.

THE BEQUESTS.

He explained that the testator left his personal estate in trust, the income to be paid to his two executors for their lives, and after their deaths his personal estate was bequeathed to the St. Vincent de Paul Society, with the request that Clonea House be used as a sanatorium for the poor and infirm, with gifts over to a society of nuns in Berne, Switzerland, and ultimately a gift over to the Federal Government of Switzerland.

The Court had held that that was an invalid gift. Accordingly the income of the real estate having been the property of the executors, and they having died it now reverted to the Society of St. Vincent de Paul. and the Council after consultation with the Bishop, was now prepared to accept the gift of the real estate upon the trusts of the will.

PERSONAL ESTATE.

The personal estate consisted of Clonea House and farms. The farms had been sold to the Land Commission, and they were represented by Land Bonds for £6,952 held by the Land Commission. Clonea House and the lands immediately adjoining were not sold, and the application was that all this property, with the money in court to three separate credits of the suits, be vested in the Society. Clonea House, with offices and gardens and farm of 180 acres, with the test tor's interests in the farms of Dunsillagh and Tullacoolmore, were bequeathed to the Irish Branch of the Society of St. Vincent de Paul as a sanatorium for persons exclusively of Irish birth, but wholly irrespective of

The testator added: "For, whether Catholics, Protestants, or Israelites, I desire them to be there equally well treated and made at home, the only proviso being that with poverty they shall combine respectability, and I make this proviso for two reasons: one, that I don't wish to think that the old home of my childhood should ever degenerate into anything like a beggars' hotel or a rabbit warren in habited by rogues and vagabonds; the other reason, because I do not wish to think that the tender charity shown by said Society, in worthy imitation of its illustrious founder, should incur, not the chance, but the certainty, of being repaid by lies and abuse . . .

Those who, according to my wishes, are entitled to the first place of all are those members of the said Society who have sacrificed their own health in the tedious, unwholesome, and often thankless task of seeking to restore that of others.'

"And I trust that my present action as a citizen of the world have eschewed such considerations, for I was baptised and brought up a Church of Ireland Protestant, and although from that standpoint have long been extremely unorthodox in much of my In the High Court, Dublin, on Monday, Mr. Justice Johnston, in the matter of the will, dated Oct. 10, 1905. of Mr. Wm. W. McGwire, late of Clonea House, Dungarvan, made an order referring the funds in Court to the Examiner for allocation, and directed that the Land Bonds in posparticular form of Christian faith in which I was educated, chiefly because it is so conveniently elastic, as the fact that so unorthodox a man as Dr. Farrar was allowed to die Dean of Canterbury sufficiently proves.

Mr. Justice Johnston asked if the Society of St. Vincent de Paul had considered the advisability of publishing the will in book form, because it really was a literary curiosity.

Mr. Lavery said he did not think the Society would publish the will.
