Chairman-Some members of the Council made a tour of the Loughmore schemes yesterday for the purpose of hearing any complaints or grievances. Taking it all round there were very few complaints. There are f course, a few cases mostly of windows and doors not fitting properly. The inside of the houses look very good, and are very neatly kept. The contractor also attended and promised when the list of repairs needed is given to him he will put everything right. Personally, I thought there would he far more serious complaints.





SALMON FISHING.

The salmon season which officially opened at midnight on Thursday, promises to be one of the best seasons experienced for the past five years. A well-known Blackrock fisherman said that Friday and Monday, the first two official fishing days of the season, were by far the best that have been experienced in Cork for a long number of years past, and he had great "There are matters of outstanding hopes that the present season would be one of the most successful that he eyer had during his twenty years of net fishing. The best catch so far was thirteen salmon, one of which weighed 26 lbs. and the remainder averaged between ten to twelve pounds Good catches are also reported from Passage and Cove.

The wholesale price of salmon on Friday was 2s. 1d per lb., but there was a considerable fall in the price yesterday when fishermen only received is. 7d. per lb. 

DOG SHOWS PROSPERING. CONTRASTS WITH THE PAST By "PHILOKUON."

DOG showing being an amusement and not an industry, is influenced to a considerable extent by the state of trade and the amount of money that people can afford to spend in the way of pleasure. As a matter of fact, showing within reason, and keeping a few dogs is no particular extravagance and is not comparable in cost with the money frequently spent on other forms of recreation. It is by no means a prerogative of the rich : one has only to attend any ordinary dog show to see the numbers of the working classes who are interested. They may not breed more than a litter or two in the course of the year, and in most cases the expense is recovered by the sale of puppies or from stud fees. They have their fun at the minimum

The general experience, however, is that when times are bad dog shows suffer. When there is more money about they prosper. We have had a striking illustration in recent times. 


