WHAT WE SHOULD OR SHOULD NOT PUBLISH—

We desire to draw the attention of the public, or such of them as it may concern, to the fact that we are obliged to put a stop to what is becoming an intolerable nuisance.

For quite a long period we have been pestered with requests not to report certain cases heard before District and Circuit Courts. There requests come generally from people who are defendants, in some cases both the complainants and defendant in the same case make requests not to publish their cases...

We are obliged to state that no attention will be paid in future, to such requests, and in particular we must refuse all efforts at personal interviews. We are not responsible if people are cited as defendants, or in any way connected with legal cases.

At a recent District Court, there were 15 cases (all trivial), out of these 11 defendants called to the office requesting not to publish their cases, while letters were received from two defendants.

Compliance with these requests would simply mean that we would be obliged to discontinue the reporting of Court cases altogether. We desire now definitely to state that cases which in the opinion of the Management are of sufficient interest to justify publication will be published and we request all persons concerned to cease the annoying practice of pestering us by letter or personal call.

Dr. T. J. O'Connell, General Secretary of the teachers who are affiliated to the Trade Union Congress, re-stated today that he had received a "virtual ultimatum" from the recently formed joint council of the T.U.C. and the Irish Labour Party.

Labour's decision to boycott the election followed the Government's recognition of the Ballynary Cottage Tenants and Rural Workers' Association as a body entitled to nominate representatives to the new Chamber.

The Labour leaders announced they would not nominate candidates for the election.

Already, however, the teachers had nominated their general secretary and their next President, Mr. T. J. Nunan, to the Cultural and Educational Panel for the election, and since then their nomination have been accepted.

The joint council of the T.U.C. and Labour Party express "profound regret" at the teachers' nominations and call on the executive "to correct this breach of discipline" by immediately withdrawing their nominees.

The teachers' executive it is understood, will defy this order, and the organisation may be expelled from official Labour.

HANDLING FARMYARD MANURE.

SOME DEVICES TO FACILITATE THE JOB.

Discussing agricultural machinery topics in the current issue of the Journal of the English Ministry of Agriculture, Mr. S. J. Wright, M. A., Director, Institute for Research in Agricultural Engineering, Oxford, says that there has been so much discussion in recent years about the uses and abuses of farmyard manure that it is surprising that so little progress has been made towards improved methods of handling the material...

A GERMAN LOADER.

The more elaborate of these devices can be left out of account here, because most of them could not be installed in connection with existing buildings without practically reconstructing them from the start. In any event, these permanent systems do not take the dung right to the field, but only to a dump from which it must be re-transported later.

MECHANICAL SPREADERS.

Incidentally, a British loader that made its appearance in 1937 also included a device for breaking up long or matted dung, but the writer has heard nothing of the machine since it appeared, and so can give no particulars about its performance. The German report, already referred to, also claimed for mechanical loaders, and handling devices that greatly increased the efficiency of manuring by making it easier to apply the dung at the right time and without wastage.
