An Esteemed Kilrossanty Lady's Demise

The Late Mrs. Mary Riordan

A melancholy surprise was occasioned in Kilrossanty and the surrounding districts on Sunday night when the news circulated of the death of Mrs. Mary Riordan, wife of Mr. Thomas Riordan, farmer, Carrabeen, and sister of Mrs. James Coffey, farmer, of the same townland. The deceased had been in failing health for some time prior to the end, which came calmly and peacefully after her reception of the last Sacraments of the Holy Catholic Church of which she was a truly pious and zealous member. It is but recording a truism to chronicle that she enjoyed the good-will and respect of all in her neighbourhood. In fact it is no exaggeration to say that the late Mrs. Riordan was persona grata with all sections of the community. Of a cheery and bright disposition, she made lasting friendships with those with whom she came in contact, and the news of her passing (at a comparatively early age) will be keenly felt by the extremely large friendship circle which it was her privilege to enjoy. Her demise will be almost a personal loss to those of our less fortunate brethren to whom, from time to time, she extended a helping hand in unostentatious charity. We join with the neighbours in general in expressing heartfelt sympathy to the husband, sons and daughters, brother and other relatives in their bereavement.

By the way, her sorrowing spouse, and her brother were prominent players on the famous Kilrossanty Football Team captained by Mr. Patrick Wall, senior, Ballinavouga) of their hey-day, which was then second to none in the country.

A cortege of extremely large and representative dimensions accompanied the removal of the remains on Monday evening to St. Brigid's Parish Church, where they were received by the reverend Pastor, Fr. Crotty, who recited the prayers for the dead. Solemn Requiem Office and High Mass were offered up next morning in the presence of a crowded congregation.

Rev. W. Meahan, C.C. Kilrossanty, was celebrant of the Mass, and the priests assisting in the choir were—Very Rev. J. Crotty, P.P. do; Rev. P. F. Walsh, C.C. Ballinacorney; Rev. J. Lavin, C.C. Stradbally; Rev. J. Power, C.C. Kilgobinet; Rev. P. Shine, C.C. Rathgorman; and Rev. M. O'Connor, O.F.M. Carrickbeg.

The burial took place afterwards in the Churchyard.

SEWERAGE AND WATER SCHEMES COMPENSATION CLAIMS

Mr. Mr. Morrissey, T.D. Chairman, presided at the weekly meeting of the above on Friday last, also present—Messrs. T. McCarthy, J. McCarthy, J. Doherty, P. Quinn and J. Byrne.

Mr. McCarthy referred to the state of the bathing boxes at the men's bathing place, said they were in a filthy condition, due to being taken down and burned.

Chairman—You cannot burn them as they are of concrete.

Mr. McCarthy—I mean to burn any timber parts. You cannot get people to go into these boxes to undress in the summer time.

S.S.O.—I agree with Mr. McCarthy they were in a bad condition two weeks ago, but they have been washed out since and nailed up.

Mr. Doherty—I was down there and saw them nailed up.

Mr. McCarthy—It is only a question of time until they are broken open again. There would be no complaints if my suggestion to provide portable boxes was taken up some years ago.

Chairman—It would be only proper to take them away if they were not kept closed, and were not given proper supervision.

Mr. McCarthy—14 days ago they were in a scandalous condition.

S.S.O.—That is so.

Mr. Quinn—They are locked presently.

S.S.O.—Yes, nailed up locks would be broken.

Chairman—They are nailed up at present, and the responsible officer should inspect them a couple of times a week.

Mr. McCarthy—The people of Dungarvan know how large boxes are used in the winter, and they will not go into them in the summer.

NUISANCE AT WILLIAMS' MARSH. Mr. Byrne said there was a greater nuisance existing at Williams' Marsh which he said was caused by indiscriminate dumping. It is really a scandal and something should be done to check it.

Mr. McCarthy—It is really very bad.

Mr. Byrne—I saw carcasses of animals there. I am very much surprised that the people up there don't make a strong protest.

Chairman—Have we power to act there? S.S.O.—It is private property. I will give you a report up on this night week. The matter was adjourned.

HOUSING SCHEME. The report of the clerk of works stated that 95 men were employed on the housing scheme.

REPAIRS TO HOUSES. Applications for repairs to their houses were read from Fr. Templeton and N. Shanahan, St. Patrick's Terrace, Abbey-side.

Mr. McCarthy said his attention was drawn to both these houses, and they are very bad.

Similar applications were read from Patrick O'Connor, St. Monica's Terrace, Abbey-side, and Mrs. K. Kelly, St. Thomas's Terrace.

The matter was referred to the B.S. POUND FEES. The Council decided to pay 5/- and 4/6 pound fees to the pound-keeper. The account arose, due to the impounding of a dog and goat.

DUNGARVAN DISTRICT COURT

Hold on Wednesday before Mr. S. J. Troy, D.J.

Civil Bills. A large number of Civil Bills, in which decrees were granted in some and adjustments in others were first disposed of.

No Court on February 23. The Justice announced that there would be no Court held in Dungarvan on Feb. 23 as he will be doing duty in another district that day.

The next Court therefore will be on February 22nd.

Lights. Grand Juror prosecuted John Drohan, Knockeylan, Kilrossanty, under the Lights on Vehicles Act. A fine of 3/6 was imposed.

Wandering Animals. Grand Juror charged Denis Wall, Lower Strand St., with allowing an animal wander on the Public Road.

The Justice imposing a fine of 5/- said he would make a gentle start by that, by degrees it will get more and more expensive until finally the owners of wandering animals will get a shock.

A similar fine was imposed on Patrick Wright for a like offence.

Weights and Measures Act Offences. Sgt. Kelleher prosecuted James O'Connell, prosing, for selling by weight, and deducting weight from Alice Wall, Bonacourt.

Mr. Farrell, Solr., for defendant said he pleaded guilty to a technical offence. The Sgt. will tell the Court that Mr. Deo was paying a higher price than that paid in the market that day.

Sgt. Kelleher agreed that 9d. was the market price that day and Mr. Deo was paying 10d.

The Justice held there was a technical breach of the Act but dealt with the case under the P.O. Act.

Licensing Cases. Superintendent Walsh charged Mrs. J. Butler, Main St., with a breach of the Licensing Act on Sunday night 1st January.

Mr. Farrell, Solr., appeared for the defendant. Grand Juror gave evidence of entering the premises and finding a marked tin, the counter, the licensee and the man said he came in for cigarettes. There was no sign of drink.

The Justice said a very technical offence was committed. He imposed a fine of 2/6 on the licensee and 2/6 on the man found on the premises, not to be recorded.

In a similar case against Mrs. E. O'Neill, on the same date the Justice said that a technical offence was committed and imposed a fine of 5/-. The men found on the premises were fined 2/6.

The Justice remarked that he thought the publicans of Dungarvan gave very little trouble.

Superintendent Walsh—Very little. Larceny of 11/-. Superintendent Walsh charged Mr. Roche, Glenahoula, Kilmacshamus with the larceny of 11/- from Jas. Norris, Garrynagarra.

Norris in evidence said he worked at the mill. He stated that Mr. Hayes, arbitrator, considered 470 ample compensation for Mr. P. I. Power, but suggested it might be less expensive to the Council in the long run to pay more, in order to avoid the costs of arbitration proceedings.

He stated that it might be wiser for the Council to pay even as much as 2100. Miss Bridget Dev. Mary St. who originally claimed 215, is agreeable to accept 47, which is a reasonable sum for loss of yard for several weeks.

J. J. Quailly, O'Connell St. has agreed, after considerable correspondence, to accept the sum of 114 2s. to include both his engineer's fee and solicitor's costs. I suggest that this be sanctioned.

John Foley, Shandon, through his solicitors, has agreed to accept the sum of 27. This figure is reasonable.

John Bluet, Loughmore, is agreeable to take whatever the Council think is reasonable. Alexander Ballott—It was reported by Mr. Hayes that Mr. Ballott suffered no damage, and that no compensation should be paid to him.

The Council recommended payment of the above amounts, subject to sanction.

DEATH OF WELL-KNOWN CAPPOQUIN CITIZEN

The Late Mr. Jeremiah Dempsey.

The death of Mr. Jeremiah Dempsey, which took place at his residence, Church Street, on Saturday last, has evoked feelings of deepest regret, not only in Cappoquin, where he was held in the highest esteem, but throughout the County, and also in his native County of Cork.

The deceased gentleman, who had reached a ripe age, enjoyed good health up to a few months ago, when he fell ill. From this illness, borne with patience and fortitude he never recovered, and passed peacefully away at mid-day on Saturday. During his illness, he constantly received the ministrations of both Very Rev. Father T. Fitzgerald, P.P. and Fr. T. Dunphy, C.C. and he died fortified by the rites of the Holy Church.

The late Mr. Dempsey was a native of Glabbevin and first came to County Waterford when he was appointed Clerk of Works and Overseer at the building of the Bridge at Ballyduff. When this work was completed he came to live in Cappoquin, where he purchased a business house, and where he established himself as a Building Contractor. His engineering skill, and the high standard of his work soon won him numerous patrons, and he was entrusted with many important contracts all over the County. He built several Cottages and many National Schools. He was also responsible for the erection in later years of a number of Civic Guard Stations and other public buildings. The beautiful Parochial House at Cappoquin was his work, and he designed and built the fine Club House for the Cappoquin Bowling Club.

From the time he settled in Cappoquin Mr. Dempsey interested himself in, and gave generous assistance to every movement for the improvement of the town of his adoption. He was a strong member of the Bowling Club, of which he was Vice-President up to the time of his death. Cycling and athletics of every form also benefited by his help and he was for many years President of the Committee which ran annually most successful Sports Meetings in Cappoquin.

From his earliest years the late Mr. Dempsey interested himself in the Irish National movement. He was a staunch supporter of the old Irish Party and was a most familiar figure at their Conventions for many years. In later times, he was prominently associated with the Fine Gael Party, and presided at many public meetings in Cappoquin and elsewhere.

Funeral. On Sunday evening, in the presence of a large concourse, the remains were removed to St. Mary's Catholic Church and were received by the Very Rev. T. Fitzgerald, P.P. and Fr. Dunphy, C.C. on Monday morning Requiem Masses were offered.

The funeral which took place at Affane on Monday, was extremely large and representative and furnished an impressive and sorrowing tribute to the esteem and popularity in which the deceased gentleman was held. The cortege was headed by Fathers Fitzgerald and Dunphy.

Daly, Mrs. Treacy, Mrs. Dalton, Con and Nell Dempsey, Kitty McGrath, (nieces and nephews); James and Peggy Norris, Mrs. Barry Murphy, Cork, J. J. Treacy, Bandon, Cuaird M. Daly (Cousins etc.).

The funeral arrangements were carried out by Mr. E. Fraher, Cappoquin.

Special Meeting

At a special meeting of the above at the Courthouse, Dungarvan, on Tuesday, January 24th Mr. S. J. Moylan, Commissioner, Mr. J. Bowen, Co. Surveyor, Mr. J. H. O'Sullivan, Secretary Waterford Co. Council attended.

The minutes of the previous meeting having been read, the County Surveyor's report was read.

In this connection, referring to the death of John Moore, under sad and tragic circumstances at Ballymartin, while driving a tractor the property of Waterford County Council, the Commissioner said that he wished to tender his deepest sympathy to the parents and relatives of the deceased man. Mr. Bowen and Mr. O'Sullivan said they wished to associate themselves with the Commissioner in tendering their sympathy to the parents and relatives of the deceased man, and a vote of sympathy was passed, all present standing.

County Surveyor's Report.

Sir,
I have pleasure in submitting the Provisional Road Works Scheme for the year 1938-40, together with estimate of costs of work proposed to be done in that year.

The scheme includes a sum of £32,270 for the maintenance of main roads. There is no provision made for any improvement works on main roads. A sum of £1,000 is also included for contingencies on main roads. Of the above mentioned sum it is estimated that £13,308 will be received as a maintenance grant. Last year's total provision for main roads was £28,182, being made up of a grant of £11,162 and £17,000 from local funds.

For County roads I have estimated a sum of £32,035 for maintenance work only. For steam rolling of important County Roads I have added £23,500, and for contingencies I have added £1,000, making a total of £56,535. To this must be added a sum of £3,200 for repayment of loans for works done on county roads in previous years. The maintenance figure of £32,035 is for some 1,172 miles of roads, some of which are of first importance.

For Urban Roads in Dungarvan, I have estimated a sum of £900, together with £220 for repayment of loans. Previous allowances in respect of these streets have been much too low, and it is not possible to maintain them in proper condition.

The total of the estimate under all heads is £94,945. This includes a maintenance grant of £13,308, and £18,637 from Council's funds.

Last year the gross total was £54,552 including maintenance grant £11,162, and from Council's funds £43,390.

For six years the roads have been hopelessly starved. The reason given at the commencement of that period, by the Co. Council of the time, for the sweeping reduction of work on roads, and held out ever since, viz.—the taxation of agricultural produce going into England, no longer holds and it is, therefore, anticipated that the full amount of my present estimate will be passed.

There are two other small sources of revenue for road work, "Improvement Grants," and "Relief Grants." The Improvement Grant is from the Road Fund, and amounts to £8,500 for current year. This has been the only source for improvement of main roads for many years past, but its amount is so small that the effect is quite unappreciable. For some very obscure reason, and against the unanimous advice of all the County Surveyors, this grant is deferred to the Winter months each year, even though all the work must be done in the open, and the use of tar involved in nearly all the work. I would estimate that the value of this grant is reduced by 30 per cent, as against having it in the proper season of the year. No contribution in aid is given local sources.

Relief grants are aided from local funds but are hampered in by regulations and conditions that render working difficult and efficiency impossible. They also are winter grants. A further disadvantage is that the work cannot be done where it is most desirable and necessary but is governed by the number of unemployed available, with no guarantee that a job partly done in one year will be continued next year. The amounts provided are too small to have any serious effect on the general road position in the County.

The cost of road works, like all other works, have been steadily rising for a number of years. This is due to various well known causes. For six years we have been doing only a fraction of the works

necessary on our roads, and the value of the annual provision has been seriously reduced by increased costs. In addition it is necessary now to do a better class of work for the more severe requirements of traffic.

Main roads have been reasonably maintained, with a few exceptions. However, deterioration is going on, and increased work is necessary. No improvement work has been done. Efforts are being made to render these roads safer for the travelling public by various means such as reduced camber, stronger sides, super-elevation signs, and removal of corners. Much still remains to be done.

County roads have been very seriously deteriorated in recent years. The money allowed is quite useless for the accumulated arrears of work to be done. For several years, on hundreds of miles of roads the surfaces, once 14 to 16 feet wide are now down to 8 feet or 9 feet, leaving only a strip of deeply rutted surface. For several years practically no stone for repairs has been applied on county roads. The result is that these roads have gradually become worse and worse with the continued neglect, so that to-day we have a large mileage of important roads all over the county in a state bordering on the impassable. It is surely time to change this, and make a serious start at bringing our roads back to a reasonable condition.

Wet weather in recent times has also had its effect, especially where no provision was made for it. Since early in May last, the weather has been almost continuously wet with numerous floods. This has a dangerous effect. The contingency fund proved hopelessly inadequate, and has been over-expended.

Traffic has been increasing steadily, and its weight and speed have been increased also. With the anticipation closing down of some or all of the Railways, heavy lorry traffic on roads may be expected to increase a little. I would again suggest that lorries be taxed on their maximum gross travelling weight, and not on the weight of the empty vehicle, and to enforce the maximum by positive means.

The incidence of road costs does not yet appear to be generally understood. The motorists are paying in special taxation annually a sum greater than the total cost of all the roads in the State.

Yet we hear people say that the farmers and rate-payers are providing "roads for the motor." They do nothing of the kind, but on the contrary the motorist is providing indirectly free roads for all other users, and a good sum to spend each year. Only a fraction of the motorist's taxation, however, goes into the Road Fund, more of it helps to provide the increased Agricultural Grant, and there is also a big help to the Exchequer. In fact the roads are unique in that they are a public service producing a substantial profit each year, as they enable the Government to levy special taxes for their use in excess of the total cost. Even though rate-payers have to contribute directly to road upkeep, they are relieved in rates and taxation by a sum more than equivalent to what they pay, by a special taxation of motorists.

It is to be regretted that a larger proportion of motorist taxation is not put directly through the road fund into work on the roads, and this is a matter to which public attention might profitably be directed. While the motoring public pay, and are willing to continue to pay, in special taxation each year the total cost of the roads, why not give them roads? There is no greater asset in the public services than good roads, and if the rate and tax payers of the county have not roads there is little else of tangible benefit available to the majority from other public services. Road-making is a ready means of solving unemployment on a productive basis.

A suggestion is at present current in the Press of the County that a monopoly should be regulated and a monopoly given to some particular body. The County Councils should be very wary of this, and should see that their rights are not interfering with Councils should be allowed to use their own plant for haulage of their own materials anywhere without let or hindrance from anybody, and, furthermore they might bear in mind that the great bulk of the Rate-payers are not protected by a monopoly and have to face unlimited competition from all parts of the world, in the world's markets, and cannot afford to pay fancy rates to provide comfortable conditions for any monopoly.

A special effort should be made to provide access to some of the unutilised scenery of this county by the provision of good roads, signs, etc. Much of this scenery is at present difficult owing to bad roads. In addition to improving existing roads several lengths of entirely new road are most desirable, to open up country now hidden from public view. This is a development of which a broad view should be taken, as it would undoubtedly prove to be a source of national revenue in the future.

The Jews and their Woes

It has become customary, in these days of Jew-baiting and the outlawing of Jews, to commiserate with the unhappy Jewish race and wail indignantly over their woes. Yet this Jewish question, which seems to be a problem of modern times, is as old as Western civilization itself, and full of difficulties as it is to-day, it is no more so at present than it ever has been, before the birth of Christ. Jewish colonies in Egypt were already the source of much disturbance in the cities of Egypt, and in one case were slaughtered indiscriminately for persistent resistance to the authority of Rome. But the real wanderings and persecutions of the Jews did not commence until the destruction of Jerusalem by the Roman army, when the whole Jewish race homeless and unwanted spread over the whole known world, and down-trodden, mocked, and persecuted, began the age-long struggle for existence which has made their race a by-word for fragility, ambition, and love of gain.

The Jewish race has no country. Jews are at best, tolerated in most countries, and therefore they have no protection against the hostility of the world except money and unity amongst themselves. The money, for which they plan and scheme night and day, they have saved out of petty enterprises; enterprises which are in the main, unproductive as far as the welfare of the countries to which they belong are concerned. For instance, Jews in Europe and North America do not work on the land. They do not, as a whole, join their countries' armies, navies or air forces, nor do they work in factories, mines or shops. They generally thrive on what we should call unproductive enterprises such as pawnshops, usury, second-hand dealing, cinema and theatre proprietorship, and later, when they have become richer, on stock-broking and what we should call "big business." None of the above-mentioned enterprises can be called necessary or necessarily conducive to the welfare of any country, but the Jew, who is not welcome, in many cases, on the land, or in the factory, has perforce to live by such means, and astonishingly, has been very successful. Unfortunately for himself he has in the meantime gained for himself a reputation for shabby business methods and guile which makes him distasteful even to those who would defend him against his persecutors.

The unity of the Jewish race is astonishing when we remember that they are scattered over the earth in small colonies here and there, with no incentive to national and religious feeling. Some are rich and influential in the Jewish faith, such as those of the United States, where they have thrived and fattened and lost the stigma of their race, some are poor and down-trodden as in the ghettos of Germany, Poland and Roumania, but all are in outlook and at heart Jews, who see to it that their kindred Jews get every chance, and who help financially and otherwise to place each other in positions of influence and power.

Jews have always been at the back of Socialism and attacks on the Christian convictions of those amongst whom they are grudgingly allowed to live. In Socialism, in particular, they see a means of enslaving their hated Christian neighbours, and in Russia seventy-five per cent. of the Soviet High Command were at first Jews. Trotsky, the erstwhile god of Russian Socialists, is a Jew. Karl Marx, the head and fount of revolutionary Communism was a Jew and Bela Kun the Communist leader, who in 1919, immersed Hungary in a blood-bath is a Jew. Leon Blum, the popular front leader in France is a Jew, and prior to the Nazi regime in Germany, Socialism and revolutionary Communism was sponsored by Jews, one Jew in particular, being very prominent in advanced, "Red" movements. These examples are sufficient to show that the link between Jewry and Socialism is no accidental one, but a very enlightening one. The aspect of Socialism which appeals to the Jew is the destruction of national and religious feelings, which would break the barriers which prevent him from controlling, with his great financial power, the masses who at the moment hate him for his race and religion.

There is no doubt about the power and influence of the Jew in countries where he is free to develop to his fullest, in the industrial and commercial spheres. The outstanding example of such countries is the United States Republic. Before the shooting of the German diplomat in Paris by a Jewish youth, and consequent increased persecution of Jews in Germany, Americans were not over-eager to join battle with the German people. But since that regrettable period, Americans can attack on Germany.

A letter was read from the Department of Local Government and Public Health. The letter stated that the amount which it proposed to provide in the year commencing 1st April 1939, for the relief of rates on agricultural land will be the same as in the current year £1,870,000. The only changes in the claim forms will be to bring forward by one year all references to the financial year and the calendar year. The letter was marked noted.

Maintenance of Libraries
In a letter regarding the maintenance of Libraries, from their Solicitor to Mr. J. H. O'Sullivan, Secretary, Waterford County Council, it was stated that in his view, the maintenance of Library buildings come within the purpose of the Acts. The Principal Act fixed the rate for libraries at a penny in the pound, but by the 1920 Acts this was increased to 3d. Therefore, the maintenance of libraries expenditure must be defrayed out of the rates struck for the purpose, and by virtue of the Acts themselves. It was decided that the Libraries' Committee be informed accordingly.

Deputation
The meeting was attended by a deputation of rate-payers from the Moonruid district, who complained that the Moonruid road leading through the mountain was in a very bad state of repair.

Mr. Bowen said that the County Council had no jurisdiction over this road, and had never undertaken its repair. In his time, Members of the Council, it was stated, had been repaired in former years. Continuing, he said that at present, some of them had to drive through their neighbour's fields, as the road was impassable, and that children were in many cases enduring great hardship in attending school. The majority from other public services, the County Council could not undertake the repair of this road, as it had no authority to do so, but the County Council would make a representation that it be placed on the list of minor Relief Works of the Board of Works.

When the same deputation referred to the dangerous conditions which were obtaining at Moonruid Cross, it was stated that the matter would meet with the Council's attention.

Agricultural Grant
The County Surveyor asked if there was any information concerning the £90,000 arrears of the agricultural grant. Commissioner—If the money was there, it could without doubt be spent usefully and would relieve the county.

Co. Surveyor—We are entitled to have a statement about the £90,000, the public would like to know what is going on. Commissioner—They got a substantial refund in Kilkenny during the past two years. They must be paying their annuities better than they do here.

The Secretary was instructed to write to the Department concerning the matter.

Relief Grant for Dungarvan
A letter from the Department intimated that a grant of £910 subject to local contribution of £170 would be allocated for relief in Dungarvan, the work to be done being footpaths and roads. The money would have to be spent before March 31st. Secretary—Is the £170 included in the road works scheme.

County Surveyor—The Urban is separate from the County. The works proposed to be done will include Gahery's Lane, Carbery's Lane, Fair Lane and the Esplanade.

The County Surveyor said he selected these works as they would be useful and appreciated by the Council.

Appointment
Mr. M. O'Hara, B.A. D. Ph. was appointed to fill the vacancy on the Vocational Education Committee.

Resignation
Mr. Robert Murphy wrote tendering his resignation from membership of the Diseases of Animals Committee.

The Border

According to legends, St. Patrick banished the serpent from Ireland. Whether this is fact or fiction, the serpent ever crawled its lethargic way across our plains or valleys until twenty years ago, when a deadly creature, bred in England, and fed and nurtured in the incubators of the Orange Lodges of Belfast, first bared its wicked head, carefully groomed by its mother and father, David Lloyd George, and wound itself around our country. It cut off the head of Ireland from its body and feet, and while it injected its poison into the head of the nation, it paralysed its trunk and extremities and choked the flow of the blood of a nation. This serpent, Irishmen, according to their various natures, call by various names, but for general purposes it is called the Border.

This Border is the last flash of brilliance which has come from the British lamp of diplomacy. It was designed for the protection of Britain by the division of Ireland, and its evil effects need not be dwelt upon here, for they are too numerous to mention. It has struck most of all those who were led to believe that it was created for their sole benefit and exploitation, but it has served its purpose: for it has been the bane of our industry, commerce, and national life for the past twenty years, and it has made Ireland safe for England.

It is the sheer injustice of the Border which is most galling to all Irishmen, who see a hypocritical Britain making laws for and contending with minorities all over the world, while in Ireland she subsidises a paid gang to outrage the sentiments and national and religious convictions of a number of people who are a minority in a small section of their own country, but who belong to the majority of the whole population in religion, and who are big. They see a Britain which makes concessions to Hungarians, Poles and Sudeten Germans, veers over Chinamen and Abyssinians, and dots on "martyred" Spain, subsidising a regime of religious persecution, civil outrages and bigoted bigotry in Ireland, and their minds grow bitter at the sight. They see refugees being harboured in Ireland, while Irish refugees leave Belfast slums for the slums of Glasgow, they hear of President Roosevelt denouncing German terrorism, and they wonder why our own divided brethren in America do not come forward to denounce British and Orange terrorism at home.

But apart from all these aspects of the question let us view it in this light. If a number of Englishmen subsidised by Ireland, set up a state of their own in Lancashire, and in defiance of the convictions of the vast majority of its inhabitants of England, gave their allegiance to Ireland, what would happen? In addition if they broke every law of taxation and freedom of speech, what would happen? If they strove to drive out any loyal Englishmen who protested against the division of his country, what would happen? We in Ireland who have good memories, know. But evidently Britain does not think that what is good enough for us is good enough for herself, or for Sudeten Germany, whose might she greatly degrades. But of course, the Sudeten Germans had no behind them. We have nothing or nobody behind us. Therefore "Down with the rats," say the British, and wipe away a score or 300.

A great amount of foolish talk is heard about the right of the non-Catholic population of Ulster to claim a separate state in this small island for themselves. They have a right to local autonomy certainly, such as is allowed to the French Canadian inhabitants of Quebec in Canada, but there is no justice in their claim to set up a separate state, which is ruled from abroad by an Empire and a class distasteful to the majority of their people. And since these Orange-subsidised lobbies of minority status are so loud in their untruthful cry of "Not an inch of our people's Tyrone, Fermanagh, Down, Co. Sligo, Down and South Antrim, who are Nationalist, from their yoke? But they ignore the protestations of these Nationalists, and cry in a loud "Not an inch" of the land that by executing this slogan they can keep us at a distance—Time will tell.

There would be no Border if England did not say for us, indeed. The average unemployment figures for Northern Ireland are equivalent to one in every twelve of the whole population. The Border towns, Derry, Enniskillen and Newry are made from loss of the flow of free trade and their populations are being on a diet provided by British taxpayers. If

After all defeat was a small thing, compared with the spirit in which that defeat was taken. The most sorrowful day in his life was the day their hurlers were defeated, but they were one happy body with a splendid spirit of co-operation, and boasting no ill-will to anybody, and with such a first string team as they had, he was sure that the Waterford hurlers would not figure once more at Croke Park in 1939.

They had rules which had been drafted by their Central Council, and sanctioned by Congress, and until Congress decided to abate these rules, they would abide by them. He questioned the fact of the enforcement of some of these rules was practical, but until Congress decided otherwise, they would live up to them.

During the coming year there was no reason why with a good spirit, they should not be a credit to their County and to the G.A.A. If they had good clean games they would get patronage and support. People do not wish to witness ugly incidents where they had expected good clean sport, and for that reason they had good games this year. The Convention of the Gaels of County Waterford will be held in the Court-house, Dungarvan, on Sunday next, beginning at 2 p.m.

The following is the Secretary's Report for the year 1938:-

I submit herewith, for adoption, by County Convention, my report for the year 1938, with Statement of Accounts and Balance Sheet.

The year 1938 can be considered the greatest year, that the Gaels of the Decies have ever known, and for the first time in history a Waterford senior hurling team appeared in an All-Ireland Final at Croke Park.

I wish to congratulate Mount Sion in winning the Senior Hurling Championships, they are worthy Champions, and I can certainly raise my hat to the gallant losers, Erin's Own, who nearly regained the Championship when they last held it in 1933.

The minor hurling competition was well up to the standard of past years, Tallow defeated P. H. Pearce in the final; P. H. Pearce has appealed this decision to the Board, on the grounds that the match was not properly laid out.

In inter-county matches, all honour must go to our Senior Hurlers, who won their first Senior Munster Championship; we were defeated by a small margin in the All-Ireland, but to-day the Decies hurlers are the foremost combination in the country.

In Junior Hurling and Football we were defeated by Limerick. In minor football we defeated a good Tipperary team, but were outplayed by Kerry in the Munster Semi-Final.

The greatest set back in recent years, was our minor hurlers defeat at the hands of Kerry in the first round of the Championships. Kerry is not a hurling County, whereas we always figured in the Senior or in the Junior Hurling League.

In Senior Football we were defeated by Tipperary who contested the Munster final against Kerry. In the National Hurling League we have defeated Limerick and Kilkenny, and are four points up for two games, our remaining matches in the competition will be played in the next few months.

Waterford may be hailed as League Champions. Our Senior Footballers, have fared badly in the League, and are at the end of the table for two matches. Even though we lost financially in this respect, we are proud of our remaining matches.

As already stated, the year 1938 was the greatest in the history of the Decies G.A.A. apart from clearing off about two hundred pounds of debts, we have presently £150 cash at bank; the outlook for the year is bright.

In conclusion, I would like to thank all the Clubs who gave me their earnest co-operation during the year, the Eastern and Western Secretaries, who helped me in every way, I wish to thank the Gaels of the Decies, who have given me such a wonderful reception on our return from Croke Park.

We were beaten, but the Gaels of the County appreciated the men who fought for the honour of the Decies, and this year, with a bit of help, we can expect the words of our Chairman, (to last year's Convention) that the colours of Gaelic Waterford will grace the Blue Riband of the Gaelic world, the All-Ireland Cup.

Kellerher made a plunge at him, and he defended himself, backing across the road, and falling against a shop front. Mr. Power pushed Kellerher back, and then proceeded up town, with Mr. Daly. When they reached Mr. Power's place, Kellerher came along, and made a kick at him. They went into Mr. Power's yard and closed the door. He then charged at the gate and used bad language.

Cross-examined by Mr. McNamara, witness said he did not know the defendant purchased stones from Mr. Goggin, Friar Street. There was also a tender from Goggin, who purchased premises from which witness had been ejected. He proposed that Kellerher's tender be not accepted, because he thought it was wrong. He did not use the word "Grabber." He had not spoken to Kellerher for some time. He had spoken to him after the old I.R.A. conference at which Goggin's attitude was considered. He didn't "cut" the man over the stones because he wouldn't support him against Goggin. At the Council meeting he said they both tendered for the same stones. He didn't use the word "grabber" on the night Kellerher threatened and struck him, and he defended himself. They were both bleeding. It was all Kellerher's fault.

The Justice—If you had your way Kellerher's stones would not be accepted? If they were his own I would not object. Did Goggin also tender? Yes. Mr. McNamara—The whole thing is a sequel to a vendetta between parties. The Justice—Where did it light take place?

Outside Cole's Chemist shop. The Justice—A very suitable vicinity (laughter). You gave as good as you got? If I got one other kick I would not be in Court to-day. Didn't Kellerher get the worst of the fight?—He was working next day. Mr. McNamara—There's not much to be got out of this man. Mr. Hodnett—Not very much that you would like.

Mr. R. Power, U.D.C. gave corroborative evidence. Kellerher first attacked Lynch absolutely, and Lynch defended himself. Cross-examined by Mr. McNamara, witness said he was friendly with both parties. He concluded from what Lynch told him that the stones tendered for by Kellerher were Goggin's. He knew that Lynch had a grievance against Goggin. Witness seconded Lynch's resolution. Kellerher was in a very bad temper, and he struck the first blow.

The Justice—Did Kellerher get the worst of the row?—I couldn't say, if he did, he deserved it. John Kellerher stated that he bought the stones from Goggin, and his tender was perfectly bona fide. His tender was rejected at the first meeting on Mr. Lynch's proposal, and he felt he was badly treated. Witness was speaking to Mr. Daly, when Messrs. Power and Lynch came along. He approached them to ask for an explanation of their action. He put his finger on Lynch but didn't strike him then. Lynch attacked him, blackened his eye and scratched his face. After this he was very vexed, and he followed them up the street to Mr. Power's to get an explanation. He called Lynch a "sucker"—that was all (laughter). He had no trouble with Lynch since.

Cross-examined by Mr. Hodnett—His tender was accepted at a special meeting before he had the row with Lynch. The Justice—Don't say anything more about the finger (laughter). Wm. Glavin, who was in the car, teaching Miss Gillespie to drive, corroborated her evidence. The Justice—Did you say you would take the responsibility?—I had to say something. Mr. MacNamara—I don't think my client should have been prosecuted at all.

The Justice—There is not a tittle of evidence against him. Glavin, not the lady should be in charge. The Supt. said that if his Worship read the papers in the case, it would be seen that he had no option.

The case against Fitzgerald was dismissed and Miss Gillespie was let out under the First Offenders Act, and ordered to pay 30/- costs.
