Dungarvan Circuit Court.

Before Mr. Justice Sealy, K.C. Money Out of Court.

Mr. Ryan, Solr. made application for the payment out of Court of £50 on behalf of Margaret Keane, O'Connell Street.

Mr. Ryan then explained that there was a sum of over £700 in Court. The applicant who is now about twenty years of age is living with her mother and sister. She is apprenticed to a hairdresser in Dublin at a fee of £50 which includes Board and residence.

His Lordship said he thought the hair-dressing business a very good occupation for a young girl and made an order empowering the Registrar to sell sufficient stock to realise £50. He allowed £2-2-0 costs.

Re-issuance of License. Mr. Molloy, B.L. instructed by Mr. Henry D. Keane, Solr. Waterford, made application for an order for the renewal of the license to the Carriglea Convent, Dungarvan.

His Lordship made the order sought. Claim for £300 Fails. Miss Ellen O'Leary whose present address is Patrick Street, Cork sued Mr. Richard Murray, Clara, Modeligo, for £300.

The amount was sought as reasonable recompense for work done for the defendant. The defence was a denial that the work was rendered or done at the request of the defendant or if it was, that it was not done in return for the upbringing of the applicant.

Mr. McDonald, B.L. instructed by Mr. E. A. Ryan, Solr. for applicant. Mr. McGuire, Solr. instructed by Mr. T. C. Williams, Solr. defended.

Miss E. O'Leary applicant, in reply to Mr. McDonald, B.L. said she resided with the defendant since she was three years old, up to about a year ago. The defendant is a first cousin of her father's. She went to school from the defendant's place until she was twelve years old.

She then went to school from the defendant's place until she was twelve years old. She was then taken away from school and did all the work a girl would do on a farm. When the defendant was 17 years of age, defendant got laid up with pairs and witness had to work outside on the farm. Since she left school she had to go to the creamery every day. She helped in the sowing of crops, the feeding of the cows, etc.

Defendant kept a farm labourer except in the winter when things were slack. She was about ten years doing this heavy farm work. She got clothes, board and lodgings and was treated very well. Defendant was kind to her. He always told her that he would give her the place. He wanted her to marry subject to his approval. He wanted a man to come in there with £500 or £600. He told her she could tell a certain man about that, but witness said that man would not come there. He then said he would sell the place and do the best he could for her. Defendant's wife told him on one occasion to give her £100. Witness had to do the work on the farm and was told to do it by Mr. Murray. Witness is now earning £30 a year as a domestic. She left without any particular reason.

To His Lordship—She left in September. To Mr. McDonald—At times Mrs. Murray made things very unpleasant, and she often had rows. Mrs. Murray was not keen on having witness there. Witness went for a week's holidays and when she came back Mr. Murray made some suggestions and witness left.

To Mr. McGuire, B.L.—Mr. Murray treated her as her own father would. He treated me as a daughter, but witness would prefer her own home.

To Mr. McDonald—Her mother died when witness was three years old, and her father married again and sold the farm.

After much legal argument, His Lordship, summing up, said his girl is the nearest approach to a daughter. At the age of three years she is taken into the defendant's house and brought up as a daughter. She went to school, and all this time the relationship of the adopted daughter went on. There was no suggestion of a contract or wages paid. This poor girl, would have been well advised before she left to have put Mr. Murray about getting recompense, but she left.

Messrs. M. McEnery, B.L. and Michael Binchy, K.C. (instructed by Mr. Farrell), appeared for the applicant, and Mr. Budd (instructed by Mr. E. A. Ryan) appeared for the defendant.

Mr. McEnery stated that the applicant owns a farm on the mountain, of 111 acres. Only 30 acres of this was arable land, which had been reclaimed by him. William Downey, defendant, said he knew Declan McGrath, who had lived about five miles from him, and he had done handymen labour for him. His sister died, and left a pair of little-worn shoes which he kept as mementos. They were kept in the parlour in a corner cupboard. The parlour was of the kitchen. Prior to the disappearance of the shoes, McGrath asked him for the shoes for his wife. He replied that any shoes would not buy them. McGrath came on the day mentioned on her own accord for milk. She volunteered to scrub the house, and do some cooking, and in the meantime he was turning in the cows to get milk for her. When she was gone he missed the shoes. On the following day he met McGrath, told him that the shoes were missing and told him to ask his wife. McGrath told him that if his wife took the shoes and if they were over ground he'd get them. McGrath went back with him and stayed with him until after 3 next morning, and they were on the best possible terms. The next time McGrath came over to his house there was no one in the kitchen. Witness afterwards found the shoes.

Justice—Mr. Downey's evidence seems very strong to me. I give a decree of £1 to plaintiff, with no costs to either party.

Witness—How long are you in Killongford?

Witness—Five years.

Mr. Ryan—Didn't you do work at defendant's house?

Witness—Yes.

Mr. Ryan—Didn't you know that there was a room of the kitchen in which was a pair of shoes, which were of sentimental importance to defendant as they belonged to his dead sister?

Witness—Yes.

Continuing, plaintiff stated that on the evening when defendant made the charge about the shoes, the butter-cloth and the flour-bag, she was at the time across the border waiting for Curran's milk car, from which she often got milk. She often previously got some milk from Downey, but on the last occasion she got new milk. There was nobody at Downey's on that day.

Mr. Ryan—Isn't Mr. Downey so poor that he has no servant about the place?

Witness—He doesn't need them.

Mr. Ryan—Are you aware that later your husband visited Downey's house and that when he left the missing shoes were under the table?

Witness—They weren't in my house anyway.

Mr. Ryan—Are you aware that after Downey made the charge, your husband spent almost seven hours in his house, and stayed almost until morning, on the most friendly terms?

Witness—He never spent a night away from me.

Mr. Molloy—You instructed your Solicitor to write asking for a written apology?

Witness—Yes.

Declan McGrath, husband of plaintiff, said he worked last September for Downey. He had been at home on the day when it was alleged that the shoes were stolen, and saw his wife come in with a bottle of milk wrapped in a newspaper. She had nothing else. On the day Downey charged his wife, he was talking to him. Defendant came down the road on horseback, and used the words given by his wife, and said that if she didn't hand over articles he would arrest her. The cause of all this was that his wife had called a cousin of defendant's a robber, some time before, and defendant brought this charge against his wife as a result.

He saw none of the articles referred to in his cottage, and they had been there he would have seen them. He had gone down to Downey's a few days later for tools, and asked Downey if he had got the

LISMORE CIRCUIT COURT.

(Before Judge Sealy.) Mr. E. A. Ryan, Solicitor, Dungarvan, on behalf of Mr. Hally, solicitor, for Commissioner Moylan, applied for a renewal of the licence of a Forestry Court-house, which is also a Town Hall.

There was no objection, and the application was granted.

Grazing Rights. Michael O'Brien, Injor, applied for an interlocutory injunction to restrain the Minister for Lands from erecting fences and in other ways encroaching on what he claimed as grazing rights and right of way at Lacknagreena.

Messrs. M. McEnery, B.L. and Michael Binchy, K.C. (instructed by Mr. Farrell), appeared for the applicant, and Mr. Budd (instructed by Mr. E. A. Ryan) appeared for the defendant.

SAD DEATH OF YOUNG TOURANEENA MAN.

The Inquest. Dr. D. T. McCarthy, Coroner, held an inquest at the District Hospital, Dungarvan on Monday last on the body of a young man, Michael Tobin, aged 23 years, an employee of the Knockmeal Coon, Society, and son of Richard and Mrs. Tobin, Touraneena, Ballinacraigh.

The following jury were sworn—Messrs. P. Quann (foreman), Pierce Casey, M. Cummins, D. Cooney, Jas. Barron and J. Patterson.

Mr. A. R. Farrell, Solr., represented the next of kin of the deceased.

Messrs. E. A. Ryan and Co., Solrs. represented the Knockmeal Co-Op. Society. Sergts. O'Neill and Russell, Dungarvan and Scott, Touraneena, represented the State.

The first witness called was Richard Tobin, father of the deceased, who said his son was employed as a lorry driver at the Knockmeal Co-Op. Creamery. He was aged 23 years and unmarried. The deceased had breakfast with witness on the morning of January 13th. He last saw him alive on Sunday last 29th January, he was then unconscious.

To Mr. Farrell, Solr.—Prior to the accident he was in the best of health.

To Sergt. Scott—Deceased had a good breakfast on the morning of the 13th, that was the date of the accident.

Mr. T. Callaghan, Manager, Co-Operative Creamery, residing to Mr. Farrell, said the deceased was in the employment of the Co-Operative Creamery approximately 2 1/2 years. His main duties were looking after and driving lorries. It would be part of his duty to see after and mend punctures. At the time of the accident, the car was a sort of turban race, the containing walls of which are about nine feet high and twelve inches wide, the level of the water comes to from six to nine inches from the top of the containing walls. It is not an easy matter to get across this turban race except by a ladder, which is used by the staff for the purpose of cleaning the water strainer. There is an old wall 7 to 8 feet high and 17 inches wide against which the containing wall of the turban is built. Witness did not see the accident and as far as he knew there was not any other eyewitness.

As a result of inquiries from the deceased and other employees, witness ascertained that the deceased was testing a motor-tube when he was standing on the wall testing a motor tube when he fell and fell off the wall, on to a shrub, he said no more. Witness saw the shrub, it was an alder shrub. Deceased was an exceptionally good workman, and witness personally feels his loss.

To Sergt. Scott—From inquiries made by him since the accident he found that a few employees went to this turban, deceased was not acting under direct orders as to where he should test his tubes.

To Mr. Farrell—Witness did not know before the accident that the men tested tubes at the scene of the accident. When talking to the deceased, for the accident, during deceased's 2 1/2 years at the Creamery witness only remembered him being absent one day. At the time the accident occurred it was during a spell of hard frosty weather. Apart from the wall which he would have a lean over to test the tube, there is no rail to catch. The old wall on which he was standing is 22 inches lower than the containing wall, over which he was presumed to be leaning at the time of the accident.

To Mr. Ryan—As far as Witness can conceive there is no practical use for a rail at that particular place.

Dr. Mullaney, M.O.H., Seokanane said he examined the deceased on January 13th. He was suffering from a penetrating wound through the tissues and muscles of the left buttock. Witness treated the wound and had deceased removed to Hospital. He saw him in Hospital on Saturday last, 28th January. He was then suffering from pelvic peritonitis with general toxæmia. Witness believed this condition resulted from the wound, probably due to the penetration of the rectum at the time of the accident. His injuries were consistent with a fall as described by himself.

To Mr. Farrell—Such a fall would give a terrible shock. His internal injuries were very considerable. In general language deceased died from blood poisoning. Dr. Casey corroborated the evidence of Dr. Mullaney.

Mr. Farrell, Solr., addressing the jury said this unfortunate occurrence was very hard on deceased's family, and he has no doubt but that in future the Manager will see that this place is not made accessible.

EAST CORK JOTTINGS

Annual General Meeting of Inch Hurling Club.

A Good year's Work—The Rev. P. Mortell, C.C. (President), presided at the Annual General meeting of the Inch Hurling Club on January 25th and there was a good attendance.

The Secretary's report of the year's work of the club was as follows—We began the year with our 1937 tournament unfinished. Castlemartyr and Kilkronat had already met four times in the final without a decision being reached.

A fifth meeting was arranged but Castlemartyr failed to field a team and the match was awarded to Kilkronat. Against this decision Castlemartyr successfully appealed and a replay was eventually agreed to. It was not, however, able to get a date for the match, which was eventually won by Castlemartyr.

Thus ended a tournament which did more to popularise hurling in the district than anything of the kind had ever done before. The rest, however that we were not able to get an earlier date was a considerable handicap to us, as we were not able to get any important matches going until this was finished.

In the meantime we had entered for the Divisional Championship in "B" grade hurling. In the opening round we were drawn against Killeagh, the match being played on our grounds on April 3rd, and resulting in a win for Inch by 4-4 to 1-3.

We next met and defeated Castlemartyr by 2-5 to 0-3. Thus for the second year in succession we qualified for the Divisional Semi-final. Our opponents this time being Youghal. The match took place in Killeagh on September 28th, and was easily the best match in the Championship. After a gruelling hour's play the match was declared "a drawn game."

We certainly were not in luck this day, for our boys gave a wonderful display, especially in the concluding stages. The replay—three weeks later—was decisively won by Youghal. At that time the influenza epidemic was raging in the district, and as a result, we could only field a depleted team, some of those who did play left a sick bed to do so.

Two weeks later Youghal won the Championship. A decision on which we congratulate them. This it happens that for the past two years the teams that beat us in the east won the Championship. We took part with an experimental team in the Castlemartyr tournament, and were pleased with the display given by our boys. We played practice matches against such teams as Killeagh, Youghal and Kilkronat, all of which our team did well.

This briefly is the record of our players on the field, and it is one of which we are proud. They played the game as we would wish them to play it, and accepted defeat when it came, as well as victory, which came to us often, in the same admirable spirit—the spirit of the genial Gael. I have no hesitation in saying that either on the field or off a better conducted, better disciplined, or more respectable body of young men are not to be found within the ranks of the Association than this young team of ours. If they practice during the coming months as they did in the past, I believe that when we meet in five months hence we shall have the pride and pleasure of halting them Divisional Champions.

It was a source of deep regret to us to lose the services of Fr. Brev who was transferred during the year to North Cork. The backing up of the club was a labour of love to him, and he worked unsparingly for its welfare.

Fr. Mortell, who did us the honour to accept the presidency has placed us under many obligations to him for his kindness and his example. To him is due the fact that our delegates have been able to attend every meeting of the governing body for months past, and we were proud to have him as our representative at the recent East Cork Convention.

All our officers have worked splendidly during the year. The Captain and Vice-Captain were rarely absent from the play, and were always prompt in the hatches. Our Vice-President Mr. John Treacy gave as such attention to the affairs of the club as to his own private business, and was always brimful of enthusiasm and optimism even when clouds were lowering.

To Mr. Seftins, our Chairman, the club owes more than to any other man. He made sacrifices for his welfare, but few others would have made, and were it not for his capable and faithful help we could not have survived the opening matches of our first year.

Of the work of our respected Treasurer, Mr. Martin Collins, I can only speak too highly. To him is due the fact that we are able to present a balanced sheet to-night which shows our Bank Account to be on the right side. Another who deserves special mention is Mr. Alick Fitzgerald who looked after the "gate" at all our matches and never let a penny go wrong. Indeed all the members did well and gave us an abundance of any kind had no place in our Councils. The Valuation Bill

Visitors to this country have always told us that they considered that the cost of living here must be very high, and, in support of their convictions, they point out that food, clothes and especially what are called luxuries are dearer here than they are in any other country in the world. It would be interesting to hear their replies, if we were to inform them that the country is taxed to the limit of its endurance, and that rates are soaring year by year. They would doubtless reply that living in the Island of Saints and Scholars has its own drawbacks after all.

As if things were not bad enough, a Bill will soon come before the Dail to authorise the revaluation of property, with the exception of agricultural land. The obvious purpose of this, it is evident is to facilitate the collecting of millions of extra money without taking the precarious step of increasing the scale of taxation. As the country is taxed to the utmost, it would obviously be unwise to attempt further dragging of rate-payers, therefore a new weapon had to be found.

It is hard to discover the benefits, which it is alleged, will arise from this new measure. The money which it will supply the Government with, will be balanced on the other side by unemployment, soaring prices, and a reduced spending power amongst all ratepayers. Schoolkeepers and householders will employ a smaller number of employees to meet the new demands upon their budgets, for they cannot make an all-round reduction in their scales of remuneration. Prices will soar because firms will need an increased income to meet increased demands, and less money will be put into circulation by rate-payers who will, perforce, have to become more thrifty. It may be argued that all this will be counteracted by increased activity in Government schemes but it is far better that people spend their money themselves and thus give employment than that it be spent for them by their Government. The ordinary taxation which is levied upon them is surely high enough for the running of any country's affairs.

Agricultural land will not be taxed, and this is the one bright feature in the proposed measure. It would obviously be unfair to tax the land of people, who for almost six years bore the brunt of the Economic War, and saw their savings, where there were any, dwindling away, and their children denied any comforts so any of the innocent workmen which would help to relieve the weakness of their non-stomachy lives. But farmers will not altogether escape the effects of the new measure. Buildings on their holdings will be revalued and thus farmers who had the energy and enterprise to erect hay barns, barns or sheds, will be taxed for their efforts, while those who stored away their money in banks will escape an increase in the valuation of their holdings. Thus, those who deserve a reward for their industry will get exactly the opposite, and will doubtless be chary of undertaking any such enterprise in future.

There are those who suggest that the result of the new Bill when it becomes an Act, will not be the increase of housing valuation, as much as the desirable standardization of valuation which has been a long time pending. Doubtless it is desirable that the valuation of the country be brought to-date, but it is not desirable that it should be increased. Besides the annual revision scheme which functioned up to the present time saw to it that nobody's valuation was undervalued. Since this method has been abandoned, it is obvious that the rate payers of Ireland may look forward to an increase, for our valuers would never have gone to the trouble of revising this new expensive scheme, had they not had this end in view.

At a meeting of the above there were present: Messrs. M. D. Broderick, Chairman; M. Ahern, R. Power, E. P. Lynch, J. R. Smyth, P.C., R. Savage, P.C., J. Whelan, E. D. Condon, J. Dwyer, B.E.

Considerable discussion took place on several applications from persons living in houses "unfit for habitation, but capable of repair at reasonable cost."

The Chairman said in one of the cases, owing to the condition of the roof, the husband and wife and four children had to sleep in one bed in the kitchen.

Mr. Power—Is not that man entitled to a house? The Clerk—No, in the circumstances.

Mr. Power—Some of the laws were made to be broken, and they should be. The Council agreed to give the applicants a house as soon as the circumstances justified.

ANONYMOUS LETTER The Clerk said he had received an interesting anonymous letter. Chairman—Don't read it. Put it in the fire.

ACKNOWLEDGEMENT Mrs. M. Lafford, Raheen Road, thanked the Council for their vote of sympathy on the death of her mother.

GRAVEL ON PROMENADE The Clerk said that there was a large quantity of gravel thrown upon the Promenade during the recent gales. The Co. Surveyor had ordered it to be put back on the beach.

Mr. Lynch—What's the good—it will be thrown up again in the next storm. REPORT ON MILK The Chief Superintendent, Garda Station Cork wrote to state that some of the samples of milk taken had been found defective.

The Chairman—That is very satisfactory. MAJORITY INQUIRY Mrs. O'Sullivan, Gibraltar Cottage, wrote to state that a large pane of glass had been broken, and other damage had been maliciously done to her house. Trespass cost £32-2-6.

The Council decided that they could not accept any liability in the matter. LETTER FROM UNEMPLOYED A letter was read from the Hon. Secretary of the Unemployed Men's Association, complaining that a number of men whose names were on the pre-Christmas panel had not been employed at all.

The Chairman said they got panels from the Labour Exchange and they were bound by them. Mr. Whelan—We have nothing to do with the grants, but to contribute our own proportion.

Mr. Savage said the Surveyor was made responsible for the work under the grants. After a long discussion, it was decided to hold a special meeting of the Council with the Town Surveyor to deal with the whole question, the meeting being unanimous in its desire to give employment to men who had been excluded.

RURAL ROADS Mr. Lynch said he had again to complain of the condition of the outside roads around the town. The interests of the ratepayers concerned were neglected.

Mr. Power—Good ratepayers. The Clerk—And they are ratepayers. It was decided to consider the matter in connection with the responsible official.

Mr. Smyth said the back roads which had been steam rolled a short time ago were in a bad way. Mr. Lynch said there must be something wrong.

Mr. Condon—The material was bad. Mr. Doherty—The heavy traffic of the lorries would erode any surface.

Mr. Power—The main streets are in good condition after 12 years. Mr. Doherty said that was explained by the fact that there was 8 or 9 inches of a top put on.

The Chairman said they would discuss the matter with the Engineer. Mr. Smyth—It is disgraceful.

ALLOTMENT SCHEME A letter was read from the L. G. D. approving of the Allotment Scheme submitted by the Council. In certain cases the charge would be 18/- as compared with 14/- last year.

Mr. Power said it appeared that the Country was getting more prosperous. The Chairman—Yes, with some people. The Clerk said there was a large number of allotments not yet applied for.

Mr. Smyth—Nobody will take them. Mr. Power—The plots is so far out they don't want to exert themselves. The Chairman—It is too far to walk!

TOWN SURVEYOR Some discussion took place on the necessity of collaboration between the Town Surveyor and the Council, and it was decided to ask that official to attend every alternate meeting for a short time, and also to visit the Board Room during the day, for consultation with the other officials.

LAST RELIEF GRANT Replying to a query, the Clerk said there was a balance of £950 to be spent of the last grant, but it should be all used up by the end of March.

Mr. Lynch said there were many men unemployed, and they should get work. It was decided to ask the Engineer to put on as many men as possible.

PIG FAIR Mr. Lynch called attention to the Pig Fair which the Council had started for the benefit of all concerned but which had received very poor support from the farmers of the vicinity whose interest it was to develop it. They had a large number of most important buyers from the city present, but the supply of pigs was utterly inadequate.

If the fair fell there, the farmers would have reason to regret it. Some of them said this was the first they had heard of it. The Clerk said the fair had been advertised in the Press, and posters had been put up all round.

The Chairmen said on consultation with the Clerk they had 500 handbills distributed in addition. Mr. Power said he expected to see the Chairman, and other members present on the opening day. He endorsed Mr. Lynch's remarks very strongly.

If the farmers didn't avail of the competition offered for the fair they would have reason to regret it. The Town Clerk said he had visited the fair.

The Chairman said he was unfortunately unable to attend on the opening day, but he would do all in his power to make it a success. Mr. Power said they would have to bestir themselves by canvassing and otherwise to get the farmers to support it. They seemed to favour the opposition shop.

Some discussion took place on the question of erecting a public weighing scales, and the Clerk was asked to make enquiries. The Chairman said at the present rate of going, the farmers would soon be at the complete mercy of the co-operative. It was up to them to look after their own interests.

On the proposal of Mr. Power, seconded by Mr. Whelan, a hearty vote of thanks was unanimously passed to the Cork Buyers' Association for their attendance and support.

Mr. Lynch proposed a sincere vote of sympathy with Mrs. Byde, Clonard, on the death in Dublin, of her son Martin. This was seconded by Mr. Ahern and joined in by Messrs. Condon, Power the Clerk and others.

The Chairman said they all associated themselves with the proposal. His death was a tragedy and to a promising career. The proposal was adopted in silence.

THE GAS WORKS The Committee who visited the Gas works reported that it was necessary to carry out certain improvements with a view to keeping the works going satisfactorily.

The Clerk was directed to make enquiries regarding the raising of a long term loan for the proposal. ADJOURNMENT OF MEETING It was decided to adjourn over next week to give the Clerk an opportunity of clearing off some arrears of office work.

Waterford Co. Committee of Agriculture

At a meeting of the above held in the Courthouse, Dungarvan on Saturday, January, 28th.

The Minister for Agriculture wrote stating that he had under consideration the results obtained from the Lime Subsidy Scheme which has been in operation under the Committee of Agriculture during the past few years.

This scheme is serving a useful purpose and with a view of extending its scope the Minister has secured sanction for the expenditure in 1939-40 of an increased State Grant to augment the funds which the Committee will devote towards the scheme.

It will also be possible to arrange in each County for the early adoption of the scheme so as to provide that the period for delivery of the lime will be longer than has been possible hitherto.

Accordingly, the Minister will be prepared to reconvene your Committee, within the financial year 1939-40, their actual expenditure (exclusive of administrative expenses) in excess of a sum of £150 (which will require to be defrayed from the Committee's ordinary funds) on a scheme for subsidizing, as in 1938-39 and previous years, the purchase of lime for agricultural purposes during a delivery season which will extend from February, 1939, to the 31st January, 1940, the maximum amount which may be so recouped being £1,350. Payment of this Grant will commence not earlier than 1st April next and will be conditional on the Committee's ensuring that the conditions of the scheme are fully complied with.

The procedure to be followed in the administration of the Scheme, and the general conditions to be incorporated in the County Scheme adopted by each participating Committee will, subject to the modifications and extensions mentioned in the 24th, 25th, 26th, and 27th paragraphs of this letter be on the same lines as were laid down in connection with the 1938-39 scheme (see the Department's circular letter E. 3322/34 of the 20th July, 1934).

Particulars of the scheme as finally adopted should be forwarded to the Office of the Minister for Agriculture, Dublin, for their approval as the form for that purpose set forth.

It is suggested that with a view to minimizing delay in putting the Scheme into operation, your Committee should immediately invite kiln-owners to submit quotations for the supply of their own freshly burnt lime or freshly burnt ground lime. Such quotations should include the price of the lime exkiln and on rail, and specify the capacity of the barrill.

Having regard to the increased output of lime consequent on the operation of this Scheme the Committee are requested to make a special effort to induce the kiln-owners to quote lower prices than those for 1938-39 season. Particulars of the quotations proposed to be accepted by the Department should be furnished to the Department as soon as possible, together with a statement showing how these quotations compare with those for the 1938-39 season. The Minister reserves the right to decline to approve of the acceptance by the Committee of the tender of any kiln-owner whose quoted price for lime exkiln is in excess of that for 1938-39.

In the selection of applicants special consideration should be given to districts in which there is particular need for lime and the Committee should, in due course, inform this Department of the arrangements they propose to make in this connection.

It should be noted that lime-kiln owners selected for the purpose of the Scheme must be required to furnish to the Committee at the end of each week during the distributing season a return of the quantities of lime delivered during that week to approved applicants under the Scheme. In the course of their ordinary duties the County Agricultural Instructors should endeavour to verify whether the supplies of lime indicated in the returns have been actually delivered, and whether the lime has been applied to the land as required under the scheme.

Verification need not be made in every case, but it should cover a sufficient percentage of cases to give reasonable assurance that the conditions of the scheme are being generally fulfilled.

It will be essential for the Committee, as a condition of obtaining payment of the Minister's contribution towards the cost of this scheme, to take effective steps to secure that the above mentioned verification has been duly carried out and a certificate to that effect from the Instructor must be obtained before payment of subsidy is made to kiln owners. In the event of an Instructor finding evidence of irregularities in connection with any of the weekly returns in question he should at once furnish a full report to the Secretary for Agriculture, Dublin, to enable the Department to exercise its general supervision over the operation of the Scheme. The Department will make special investigations in any cases of irregularities reported and the staff of the Committee should co-operate in this connection with the Department's Officers.

Moreover, each kiln-owner should be notified that it is a condition of this scheme that, in the event of any fraud or serious irregularity being detected in connection with it, the kiln-owner concerned will not be paid subsidy nor allowed to participate any further in the Scheme and that criminal proceedings may be instituted against him.

The latest date for deliveries of lime under the Scheme will be the 31st January 1940, and such participating Committee should bring that fact to the notice of the selected applicants and of the kiln-owners.

As it is advisable that the Scheme should be in operation as soon as possible, I have to request that, unless a meeting of the Committee is issued to be held at an early date, the Secretary should consult the Chairman as to the summoning of a special meeting for the purpose of dealing with this matter.

Full instructions as to the method of claiming payment of the grant provisionally offered under this Scheme will be sent to the Secretary at a later date.

The Committee approved of the scheme.
