INFECTIOUS DISEASES.
The following Infectious Diseases were notified to this Office during the Month—
Typhoid—1, Erysipelas—3, Tuberculosis—1,
Scarlet Fever—1,
Diphtheria—1,
Whooping Cough—1,
Measles—1,
Rubella—1,
Scarlet Fever notations were received from the Tralee Dispensary District, two (2) from Cappoquin Dispensary District and one (1) from Bandon No. 2 Dispensary District.

FEVER HOSPITALS.
All there were twelve (12) admissions during the Month. During the Month, twenty (20) patients were admitted during the Month, seventeen (17) discharged there and one (1) death leaving fifteen (15) undergoing treatment at the end of Month.

NOTIFICATION OF BIRTHS.
Births notified during the Month numbered sixty-nine (69). Four (4) Records pending for Medical Assistance were issued.

TUBERCULOSIS.
During the Month there were 68 attendances of all patients at T.B. Clinics which were made up of 66 patients, 1 insured and 2 uninsured. Four (4) Insured cases, 3 uninsured and one insured, were attended by the T.B. Officer. 10 insured attended at other Doctors. (3) patients, 2 uninsured and one insured, are under treatment in Sanatoria, patients, 10 uninsured and 2 insured in day Institutions and 7 non-Pulmonary, insured and 4 insured in other Hospitals. Four (4) Contracts were examined, 2 were notified for disinfection, 2 Spots or other specimens were examined.

The Tuberculosis Officer made the following recommendations during the Month:—
1. Examination in one case. Extension of Domiciliary treatment in 7 cases. 2. Disinfection in one case. 3. District Nurses paid 177 visits to 59 patients and in addition made the following report—
Number of Dressings—14. Number of cases requiring disinfection notified—1.

MATERNITY AND CHILD WELFARE.
District Nurses in their Districts throughout the County attended 11 Clinics. The attendances were as follows—
Mothers—45, Infants—20, Children—37.

GENERAL SANITATION.
During the Month Sanitary Sub-Officers throughout the County carried out 552 inspections of dwelling-houses.

MILK AND DAIRIES ACT, 1935.
Reports of 126 premises of 64 registered dairies were received during the Month also the results of 23 Milk Driest Tests. (2) Milk Driest Tests were reported satisfactory and also fourteen (14) samples and I recommend that the usual fee be sent in each case.

The Dairies and Cattle Inspectors tried out 22 inspections of premises in County. Their reports are satisfactory.

SCHOOL MEDICAL INSPECTION.
The following Schools were inspected during the Month—Ballinacorney, Kilmacross, Tallow Bays, Tallow Girls, Sheen Millard S.O.J., Glencairn, Glendine, Angarra, Knockmore, St. Catherine's, Kilmacross, Kilmacross, Tinnock, and Pillmore.

The total number of children inspected was 403. The following principal defects were found—
Dental—116, Tonsils, and Adenoids—7, Skin—17, Malnutrition—23.

All required cleaning up and attention at all cost.

An order was made for the Engineer to do the work done.

WELL AT STRAIGBRAOD.
The Engineer reported that having inspected the well at Straigbraod he found conditions as stated by Dr. White. The well is situated in the middle of a field, and is entirely unenclosed. There is considerable evidence of pollution by cattle, and the well is surrounded by concrete walls and a good well about 2 ft.

The report was approved, at a cost not exceeding £2, provided the owner of the well is agreeable.

KILMACROSSHOMAS REQUEST.
The M.C.O. Kilmacrosshomas, on behalf of the residents of Kilmacrosshomas wrote requesting that the street lighting of the village be extended during the month of April, and if possible during September.

On the Engineer recommending the extension, it was decided to ascertain the cost.

TENDERS.
Tenders for stinking pumps at Dunasilly, Newtown Lower and Ballymacrae, were considered, that of Daniel Ryan, being accepted, subject to Engineer's satisfaction as to his capacity to carry out work, this being lowest.

WATER SUPPLY AT MAHONBRIDGE.
The Engineer regarding the above, reported having inspected the water supply at Mahonbridge, and that water was taken from three sources at present—
(a)—A well on roadside near the village which goes dry in summer and is liable to contamination.
(b)—Well on Thomas Flynn's land at Mahon, liable to pollution by cattle, appears to be a good spring.
(c)—Well beside river on George Harris land, liable to flooding from the river.

It is recommended that the second be protected from cattle. If the board desired to install the residents still further, the water from this well could be piped to a tap on the roadside.
The report was approved.

MONSTER MEETING OF FARMERS IN DUNGARVAN. FAIR DAY CROWDS HEAR FEDERATION SPEAKERS WATERFORD FARMERS ASKED TO JOIN.

A monster meeting of farmers was held in the Square, Dungarvan on Wednesday last, May 17th, fair day. The meeting which was under the auspices of the Irish Farmers' Federation was addressed by Waterford, Dublin, Wicklow and Kildare speakers.
Mr. O'Kennedy, Provincial Chairman of the Irish Farmers' Federation said he had come to ask the n if they had any grievances, and if they had, were they prepared to come together to remedy those grievances from which he knew they suffered. Perhaps some of them had heard speakers asking them to join various organisations and having seen what became of these, might say that they would not do any good now, but if they were definitely determined to remedy their grievances they could have the position altered.

He himself had the honour of being a member of the Limerick Milk-Producers Association. He mentioned milk because milk appeared to be the most predominant factor in the agriculture of Co. Waterford. The farmers around Dublin had sold milk at a loss, until when the situation became impossible they came together, and remedied that. They had been getting 3d. per gallon for milk in summer, and 7d. per gallon in winter. Through the collective action of all the milk producers the prices were raised to 8d. per gallon in summer, and 13d. in winter. He mentioned this in order to point out what collective organisation could do.

They had set out to stage a demonstration which was most successful. Those who were present and would think of the difficulty of stopping a fair in Dungarvan, could think of the difficulties in doing so in Dublin, but it had been done.

Farmers' grievance were being heard everywhere and there were different policies in different countries. They should think of what they would do if they were in the Minister for Agriculture's position, when the farmers were not organised.
The Minister for Agriculture had to keep his end up against the other Ministers, and the Minister for Industry and Commerce had been successful because of the organised industrial union behind him. The point he wished to stress was that their representative was powerless without their opinion to back him up.

How the majority of the farmers had survived during late years was a mystery to him. His problem and their problem was that it took too much of his agriculture produce to discharge his obligations, and that he had not enough produce to do so.

Compared with 1914, it was accepted that every individual should have a remuneration greater by 64 per cent, but what was their position? Their obligation were about four times greater. How many gallons more of milk had they with which to pay now than in 1914? Could it be said that their cows were four times more prolific now?

They were told that they should change their methods of farming for more modern ones and make two blades of grass grow in place of one. Anybody could see that those who took up new branches of farming in the last 10 years were back again to the old position. They were back again to the cow, the sheep and the pig.

A voice—And the plough.
Mr. O'Kennedy—Yes and the plough to feed the cow and the pig. Continuing the speaker said that certain experiments had been tried during the past years to take the place of things established for a century. Were these experiments successful? He feared that they were not. After leaving an agriculture college, where he knew everything, and knew how to make bad land good, and good land better, he had 20 years experience during which he was not able to put his knowledge into practice. The best knowledge he had gained in that agricultural College was that the methods which were followed in his locality were best, as they had a foundation of centuries behind them.

They had been through a war and people who fought in all wars were compensated for their losses. Were they being compensated. They had to carry on their farm work, pay reasonable wages and try to maintain their position. Their obligations were too high and they couldn't meet them. He couldn't do it and he felt that he was no bigger fool than the rest of them.

He as a business man must ask himself can he reduce expenditure in order to make ends meet. When speaking of reductions in rents, annuities and labour charges, and saying that labour charges were too high, he did not want to be understood. The present wage for their farm workers was not high enough, for the worker, but was not within the farmer's means, and they couldn't increase their output. Was it unreasonable to demand for farmers 6d. a gallon for milk? As far as he could remember milk was 4d. a gallon in 1914. In asking for 6d. a gallon now they were asking for an increase of roughly 50 per cent, while everybody else wanted

Mr. McLoughlin, Hon. Sec. of the I.F.F., and a member of the Executive of the Dublin Farmers' Union said that for the demonstration it was part of his job to prepare slogans and he had conceived the idea of a "pageant of State" in the form of tableaux.

In the first lorry there was a man who recited a rallying call, a call which asked them to stand together and fight together against those who were imposing on them.

He wished to tell them these particulars as the Press did not report them as fully as they would have wished.
For years past there had been put in that position. He didn't believe much in talking, as doing something was more important.

The land was capable of supporting at least twice as many people, but a third of it was going derelict because it was farmed by politicians, not farmers.
They didn't want charity, but they were paying subsidies to everybody, and they were at least entitled to a subsidy for their workers.

They would be told by the politicians that this was a political meeting. They should be in their guard against that. They would hold a County Convention in Waterford or Dungarvan, but unless they joined the organisation they would get nothing.

Mr. Hally, East Waterford said that they should be there to celebrate the great day on which Michael Davitt struck the first blow for Ireland in Mayo. That was here to resurrect, under a native government the rights which had been won for them. The farmers who were down and out-to-day were the men who fought for Ireland's independence and kicked out the Black and Tans and an alien government. They were hearing a lot about industry, but if they didn't build up the agricultural industry, it would be like helping their fingers and cutting off their arms. They were bickering and fighting in the Dail and weeping crocodile tears over the state of industry. The only relief the farmers got was that every boy they had was relieved out of their pockets.

The political parties would make a tug of war out of their demands.
Votes of thanks were passed to the speakers and the listeners.

SUCCESSFUL CONCERT AT THE PIKE.

On last Sunday evening, a most successful concert was held at the Pike Amusement Hall, visitors from all parts combining to make the attendance the largest ever seen at a function of this kind. The entertainment was of a quality hardly ever found at concerts such as this, all the artists, young and old, contributing applause of the large audience was certainly richly deserved, and again and again artists had to return to the calls of "Encore." The programme was varied, every interest being catered for, so that the entertainment never flagged from beginning to end, a tribute to the merits of the artist, and the painstaking thoroughness and direction of the organisers of the concert. They are to be commended for their enterprise in initiating this project, and congratulated on its grand success.

A hornpipe dance by Mr. Gusto Burke, which was greatly enjoyed, came next, followed by violin selections by Mr. Tom Norris, a local artist who was loudly applauded.

The next item, one of the high-lights of the evening was a song from Miss Biddy Hanrahan, Ballinacorney. This young lady has a very pure and sweet voice, and she sang most charmingly and sincerely. A novel feature was the melodeon-playing of a local contributor, Mr. Mick Norris, who was heard with great enjoyment by the audience and loudly applauded. The Misses Kitty Murphy and Mary Kiely, members of the local dancing class, danced a hornpipe gracefully and were a source of great interest to the audience who were greatly impressed by the high standard which these young artists have attained.

Mr. Joe Connerly, N.T. Villierstown, who next contributed with a song which was loudly encored, deserves a special word of praise. His contributions all through the evening called forth gushes of laughter, for Mr. Connerly is a master of the comic art.

The Misses Biddy and Caitlin Whelan, Ballinacorney, were a revelation to their audience. Having played a beautiful selection of Irish airs on the violin, they then proceeded to dance and play a hornpipe at the same time, all in perfect time and both in perfect harmony with each other. The number of people in this country who can accomplish this feat does not exceed a dozen, and these are we are certain, very few of these who are so young and yet so accomplished as the Misses Whelan.

Mr. James Keohan, Dungarvan, who next appeared, and whose song was, at the request of the audience followed by an encore, needs no word of praise, for his glorious voice is already widely praised. He was at the top of his form on Sunday evening to the great delight of the audience.

Brennan as Commandant Carton, all being remarkably good, while Mr. Joe Connerly surpassed himself as "Biddy," a role in which his talent found a ready and fruitful outlet. DUNGARVAN URBAN COUNCIL

At the weekly meeting of the Dungarvan Urban Council on Friday evening, Mr. Mansfield was acting Chairman, and also present were Messrs. Quinn, Byrne and Connors, Dr. Casey, M.O.H., and Mr. Williams, solr.

HOUSING PROBLEM

When the pay-sheet had been signed, and the question of the housing scheme, and demolition had been mentioned, Mr. Quinn said the meeting was too small to deal with important business.

Mr. Connors said the Council should be abolished altogether. The members were shirking.

Mr. Williams, solr., said the new houses would be finished in another month, and it would take nine months to get the affairs straightened out.

Mr. Byrne suggested adjourning the important business until Tuesday evening, as the Chairman and Vice-Chairman were away.

Mr. Williams said that first the Council would have to decide which houses were to be demolished. Then maps would be prepared and particulars sent to the department. Then there would be an enquiry which would take some time.

Mr. Quinn asked if it were not necessary to have 120 houses condemned.

Mr. Williams said that where two families were living in one house, that would count as two houses.

Mr. Quinn—The Council should be clear on that.

Mr. Williams—There is no doubt about that point.

The Clerk then read a communication from the Department, which stated that the fixing of the rent was a matter for the Council, and suggesting that a list be prepared of the people to be moved, with their weekly incomes.

On the Chairman suggesting that the meeting be adjourned, it was decided to adjourn until Monday night.

SPECIAL MEETING.

At a special meeting of the Dungarvan Urban Council on Monday night, May 22nd, there were present Mr. M. Morrissey, T.D., Chairman, T. McCarthy, Vice-Chairman, Messrs. Dahill, Byrne, Connors and Mansfield, Dr. Casey, M.O.H. and Mr. Williams, solr.

DEMOLITION ORDERS.

The Chairman said they should decide finally about the demolition of houses and the areas which they would decide to clear. Senator Butler and he had had a long interview with Mr. Moylan, of the Department, who told them that the enquiry would take a long time, and asked them to convey to the Council the desirability of having all enquiries carried out as quickly as possible.

In the case of Quay Street, it was stated that there were four families living in two houses which would be suitable for one family each.

Mr. Williams said that the Council should be satisfied that every house was unfit for habitation, as overcrowding did not mean that a house should be demolished.

The Chairman suggested that they leave this street over until afterwards.

Mr. Byrne asked would the houses be fit for habitation if all the necessary improvements were made.

Dr. Casey said there were no backyards there.

Mr. Byrne said that in his opinion it was an unhealthy area.

Dr. Casey asked would the Council consider it advisable to convert the four houses into two.

It was decided to defer this matter until later.

Regarding New Chapel Street, Dr. Casey said that if the landlord said he was prepared to put the houses into a sanitary condition, he did not know what their position would be. If each two houses were made into one, they would have nine good houses.

In Cross Strand Street, the M.O.H. said that there were, according to the census six families living in four houses but two families had since left.

In reply to Mr. Dahill, the Chairman said that they could not compel landlords to develop areas.

Mr. Williams said that if the owner of a site did not develop it, the Council could compulsory acquire it.

Mr. Dahill—it would be a very desirable area for building.

Mr. McCarthy—Where will the tenants come from.

Dungarvan Visitation on Sunday.

Most Rev. Dr. Kinane, Bishop of Waterford and Lismore, administered the Sacrament of Confirmation to a large number of children at Dungarvan Parish Church on last Sunday. The Dungarvan troop of Boy Scouts formed a guard of honour as His Lordship entered the Church.

Before administering the sacrament, His Lordship, speaking to the large congregation present, said that at stated times was required to come to each parish to find what was its state from the spiritual and religious stand-point, and to correct and advise if necessary. In fulfilment of this he had come to the parish, but as well as being a visitation it had also been a pleasant visit, and he had experienced great kindness from the people and their priests, having been the guest of their Parish Priest during his stay.

He was most pleased with his visit, and congratulated the people and the priests, especially the Parish Priest on the state of the parish, and that God might give them even greater benefits by his ardent wish and prayer.

The children he examined were well instructed, and large numbers of them could really do better. It was a pleasure rather than a labour to examine them. He usually did not try to puzzle children, but on this occasion, so good were the children that he did try to puzzle them, but could not do so. He wished to thank all who took part in the preparation of the children, the priests, parents and teachers, especially the teachers.

He wished to urge on parents, the necessity of co-operating with their teachers and priests in the spiritual and moral training of their children. Natural ties made parents the first educators.

The first way by which they could train their children was by good example, and if parents were virtuous and faithful to their religious duties, they would go a long way in doing so.

Secondly, by exercising a gentle and firm control over their children, they would guard them from childhood, through adolescence, until the dangerous years when they became men and women. This was a most important and fundamental matter. What greater happiness for parents could there be than to see their children growing up good and virtuous in every way?

In a touching sermon on the Blessed Eucharist, His Lordship said that this Sacrament surpassed all the other Sacraments in excellence and dignity. A worthy reception of it produced many great effects in the souls of the recipients, and it increases Sanctifying Grace more than any other Sacrament. As material food is the nutriment of our bodies, so is the Blessed Eucharist the food of our souls. As material food merges into one with our bodies, so does the Blessed Sacrament become united with our souls, and this union is closer than any in nature.

Our Holy Father had appealed for their help to secure peace, and frequent and fervent reception of the Blessed Eucharist would do this. He hoped that they would fall in with these wishes. It would be the greatest folly to refuse to take part in this every way?

Having administered the Sacrament to the children of the various schools His Lordship addressed them briefly.



LISMORE DISTRICT COURT

(Before Mr. Troy, D.J.)

A number of Civil Bills were first dealt with, most of which were adjourned.

FISHERY CONSERVATORS.

The Lismore Board of Fishery Conservators were plaintiffs in a case in which they sought for payment of three moieties in respect of fishing rights by Thomas Joyce.

For the plaintiffs it was stated that the former occupiers, James F. Carey and Katherine Carey had transferred their rights to Thomas Joyce and the Clerk was satisfied that Thomas Joyce was the occupier. Through an error the names of James F. and Katherine Carey had remained on the collector's books as occupiers, but subsequently the name was changed.

Joseph Power, Clerk to the Lismore Board of Fishery Conservators said that he fixed liability from 1st March, 1937, on Thomas Joyce, for £17 16s. 3d. or three moieties of £5 18s. 9d. each. The former occupiers were the Careys. He wrote in the name of Thomas Joyce that morning. He was absolutely satisfied that Thomas Joyce was the occupier.

To Mr. Carroll solr. (for defendant). The date of his appointment as collector was April 14, 1938. The rate for the year ending September 30, 1937, was struck on October 28, 1936. Katherine and James F. Carey appeared as occupiers for the year. That morning he had changed the name of Thomas Joyce on the advice of his solicitor.

For the year ending September 30, 1938, the rate was struck on October 27, 1937. The name of Thomas Joyce was put in ink on last Monday. It was put in pencil in August 1938. For the Fishery Conservators it was stated that a fishery collector's book was different from another collector's book and was for the collector's guidance. The rated occupier was the person who appeared in the books as occupier when these books were produced in Court. The Clerk had always been allowed to enter into a rate-book such persons as appeared to him to be the occupiers.

The Justice questioned this, stating that he must see something to show that the Clerk had authority to change the names. Mr. Carroll, for the defendant, said that it was a fundamental law that these names could not be changed in the manner suggested.

NON-PAYMENT OF RATES

The Cork County Council were plaintiffs, represented by Mr. O'Gorman, solr., in an action for non-payment of rates against Margaret Lynch, Ballinogue, represented by Mr. Carroll.

Defendant stated that she was a married woman, wife of an R.I.C. pensioner in receipt of £11 1s. 6d. per month. Her son, John Lynch, did not work constantly. She had 3½ acres of land and premises which she let at 5/- a week. She had a public house but did little business, and had only one cow and a donkey. She would try to pay at a rate of 15/- a month. An order to this effect was made, the first payment to be made on June 1st.

ALLEGED BREACH OF WARRANTY.

Declan Conway, Ardmore, sought for £25 for breach of warranty by Bartholmew O'Leary, Tour, in connection with the sale of a horse.

Mr. A. R. Farrell, solr., appeared for the claimant, and Mr. Carroll, solr., appeared for the defendant.

Mr. Farrell stated that before the sale of the animal, Declan Conway was looking for a horse, and Bartholmew O'Leary sent a man named Foley to tell him that he had a horse which would suit plaintiff. The bargain was made, defendant giving a warranty that the animal was quiet and kind. After the horse had been working for a short time, she kicked so badly that she broke the tackle, and nearly injured the boy in charge. Plaintiff and a man named Supple who was experienced in dealing with horses tried to coax the animal out of this mood, but it was no use. The animal had been well treated by plaintiff, a large farmer who was experienced in these matters. Plaintiff had to keep the animal since and feed her.

Plaintiff said he was all his life in charge of horses. He got a message by a man named Foley that defendant had a horse which was quiet and kind and fit to do anything. He went to defendant's house where defendant told him the animal was quiet and kind. He paid £18 for the horse with 10/- huck, and that day the horse worked well. Following some wet weather, the horse worked for two days, but on the third day behaved in a most vicious manner, kicking and attacking the other horse and smashing the tackle. The boy in charge refused to work the animal again. Michael Supple, who was experienced with horses tried the horse out with plaintiff. The horse behaved very badly and in a very dangerous manner on this occasion also. The horse was seven years old and was supposed to be settled down at that age.

Defendant had told him to "be careful, she's hot." He didn't mind that until afterwards. He had to keep this horse and had at the same time to get another. To Mr. Carroll—He did say that he liked the way the animal worked, and having been told what the mare could do and could not do, he took her on trial. He relied on his own skill and judgement to find out whether the horse suited him or not. He

had paid for her and was told "be careful, she's hot."

After further examination plaintiff asked "Do you insinuate that I came here to perjure myself? That is the suggestion. Mr. Carroll—No, I suggest that you or the boy in charge were so incompetent that the animal was soured.

Plaintiff—Thank you. Continuing, plaintiff said that he did not abuse the animal. Patrick Salmon, ex-employee of the last witness, stated that he worked the mare for part of two days. He was following horses for 7 or 8 years. The mare behaved badly, and he believed would have no more to do with her. The mare got "frothy mangolds and hay," and was fairly well treated.

Michael Supple said he made a trial of the animal with a double harrow. For two journeys she proved alright, but on the third she kicked the tackling off her.

In his opinion a seven-year-old horse could turn out a kicker. He agreed that a double harrow had a big pull, but he put no unbearable strain on the horse. He agreed that if the tackling was wrong, it would sour the horse.

To the Justice—If he received a warranty for a horse he would ask for a trial as well. Mr. Farrell said it was obvious that the plaintiff got something other than what he wanted. They would say that they had relied on the warranty, but were grateful for the trial.

Mr. Carroll said that the trial negated the warranty.

WATERFORD MAN TO PAY £1850—

Before Mr. Justice O'Byrne and a jury in the High Court, Dublin, on Tuesday, Mrs. Angela Lyons, Kilmallock, County Limerick, claimed damages against Mrs. Bridget Mangon, Kilmallock, Co. Clare, widow, carrier, and John English, Knockhouse, Waterford, Court Official, for personal injuries suffered by her on July 27th, 1938, when the motor car of Mr. English, the plaintiff's brother-in-law, in which she was travelling and a motor lorry owned by Mrs. Mangon came into collision, at Ballinoris, Cratloe, Co. Clare. Patrick Lyons, husband of Mrs. Lyons and a hotel proprietor and retail merchant in Kilmallock, claimed damages against the defendants for consequential loss sustained by him arising out of the accident to his wife. Both defendants denied negligence.

The jury found for the plaintiffs against Mr. English and assessed damages at £1,850 and judgment was given accordingly. They found that the driver of Mrs. Mangon's motor lorry was not negligent and judgment was given for the dismissing the plaintiff's action against her with costs, the plaintiffs to be paid the amount of those costs by Mr. English.

WATERFORD CO. COUNCIL

At a meeting of the above on Tuesday, May 16, there were present Mr. S. J. Moylman, Commissioner, Chairman; Mr. J. H. O'Sullivan, Secretary, Mr. J. Bowen, Co. Surveyor and Mr. Jephson, Assistant Co. Surveyor.

CO. SURVEYOR'S REPORT Sir.—In the last quarter work on the roads was very limited, owing to the fact that the year's work was nearly completed previously. Weather was most unfavourable.

MAINTENANCE. Generally main roads are in a good condition. The work and material provided are able to keep pace with the wear and tear of traffic. It is not possible to carry out substantial improvements. There are still a few lengths of main road long over due for re-surfacing. It would be very desirable to have these lengths done, as well as the improvement of a number of bad corners, at the earliest possible time. The current year's Improvement Grant should help in this.

COUNTY ROADS. County Roads still leave very much to be desired in their condition, which is generally poor and worn down. Many of these roads carry important traffic, and should have been classed as main roads. Substantially increased funds are essential to secure a reasonable standard of repair on county roads, and this is due as much to increased costs as to increased traffic.

ROAD WORKS SCHEME. The Road Works Scheme for current year provides for increased expenditure, and should secure a reasonable volume of work for County Roads. It is hoped to effect some improvement in their condition.

SPECIAL GRANTS. A grant of half the cost of re-surfacing part of the County Road from Tramore to Dunmore East, between Ballynattin Cross and Kilmacomb Cross, has been secured. This is a most necessary work. The cost is estimated at £8,000. Work is now in progress. A grant has also been indicated for part of the roads from Cappoquin and Lismore to Youghal. A scheme has been submitted, but so far instructions to proceed with the work have not been received. The grant expected is two-thirds of the estimated cost, £22,500, spread over a period of three years.

RELIEF GRANTS. A relief grant of £9,350, to which a local contribution of £2,250 is to be added, has been allocated for County Roads, for the current year. Of this a sum of £2,600 is to be expended during the Summer. For the Urban District of Dungarvan, a Relief Grant of £2,660 with local contribution of £340, making a total of £3,000, has been allocated for current year. Of this a sum of £900 is to be spent during the summer.

LOCAL CONTRIBUTION. Local contribution for relief grants have been provided by the Road Works Scheme. For special grants the local contribution may be financed by a loan, or alternatively by drawing on accumulated balances to credit in the general roads account.

YOUGHAL BRIDGE. Restrictions of traffic over Youghal Bridge continue in force, but are not being properly enforced. Speeds are very much too high, and there is no check on weights of vehicles. Unless this state of affairs can be changed, there is no option but to close the bridge to all traffic, except while Civic Guards are available to deal with the traffic. The Department have been asked to give us the outline of the procedure to be adopted by the Joint Bridge Committee. As soon as this is available the Committee should meet forthwith and get on with the arrangements for a new bridge.

PLANT. Machinery and plant is generally in good working order and repair. Should the amount of work to be done on the roads increase, it would be necessary to consider some additions and renewals. It is essential to have sufficient plant available to deal with the work in the proper season.

The following resolution was proposed: "That the local contribution this year towards the reconstruction of the road from Cappoquin and Lismore to Youghal be financed out of the credit balance in favour of the Road Account."

Mr. Bowen regarding Youghal Bridge said they had found difficulty in getting Guards there all the time. Every day was regulated. The weight of vehicles was the most important point, and it would take time to erect a weighbridge so that there should be proper supervision at the bridge.

The had not made any substantial progress with the erection of a new bridge owing to difficulties of procedure. He felt that there was considerable risk in keeping the present bridge going. Even since November he had noticed considerable deterioration. They should get in touch with the Cork side and arrange what was to be done.

FIDDOWN BRIDGE. In a report on Fiddown Bridge, the Co. Surveyor reported that this bridge was part of the Railway Company's undertaking. Since its erection it has been maintained by the Railway Company who collect tolls from users in accordance with a prescribed scale.

The Council was asked by the Railway Company to take this bridge and maintain it as a liability of the Co. Councils of Waterford and Kilkenny. There was no statutory authority to compel Councils to take over the bridge.

It would unquestionably be a serious loss and inconvenience to the public if the bridge were closed down. The Railway Company would appear to be bound by law to maintain the bridge. He could not see any reason or inducement to take over the bridge, and he recommended that the offer be declined for the present. The Chairman said that the Council could not take over the bridge, which was the liability of the Railway Company.

ASSISTANT CO. SURVEYOR'S SALARY. Regarding the application of Mr. L. O'Gorman, Assistant County Surveyor, for an increase of his salary, the Department wrote, approving of Mr. O'Gorman being allowed one extra increment when his next increment was due.

It was decided that the Minister be asked to reconsider his decision and to grant Mr. O'Gorman two increments, viz. £30 as from January 1st 1939, and that it be pointed out that Mr. O'Gorman has had 10 years service as an assistant, and has now to perform Board of Health work in his area.

ROAD GRANT. A notification of a grant for the reconstruction of the road from Cappoquin to Youghal and a branch road to Lismore was received, stating that sanction had been obtained for making a grant of two-thirds of the costs during the first year subject to a maximum grant of £5,000, of which one moiety will be borne by the Road Fund, and the other by the Employment Scheme Vote. 

LAST MINUTE BEFORE THE SECOND NEWS BY THE SENIOR ANNOUNCER.

TWENTY-NINE minutes past ten. I am in a large room, alone, sitting on a high chair before a small desk. Above my head a brilliant light is burning. On the floor, within easy reach of my long arm, lies a large volume—a dictionary—and on the desk rests a sheet of typescript.

In exactly one minute the red light over the clock will flash on, the microphone will be "alive," and to an unseen audience of perhaps one, perhaps thousands, I will commence reading the Second News. It all seemed so easy to me before I was initiated into the secrets of broadcasting. Before I felt the terrors of "mike fright," or knew the extent of the caustic criticism that can result an announcer's desk by the morning post.

Often, long ago, I "tuned-in" the day's news, and pontificated. I must confess, upon the announcer's English: his stress was wrongly placed on that word, his pronunciation of this one was nothing short of atrocious.

Never would I deign to consult a dictionary. It was not necessary. The announcer was wrong and that was all there was to it.

And I make further confession: I wrote to that announcer in no uncertain terms. I told him that he was not fit for his job; that anyone that would pronounce "astute" as he pronounced it—"stay-tus"—should have his head examined; and, finally, that the world at large would celebrate his resignation.

"Well, brother announcer, you could not hit back. You just had to take all my abuse, even though I now admit that the dictionary has since proved how correct you were. I recall that incident now as I wait for the red light. And I think that someone where to-night someone as righteous and as charitable as I was will bear from a loud speaker the words I will address to the round piece of metalwork before me. Yes, he will for them down one by one—my "errors." Of course, all announcers make mistakes, and I make more than most.

But my prototype will add to his list words and phrases that I have found to be correct on the large book on the floor. He will consult no dictionary, no grammar, but he will write to me, or more likely, to my employer, pointing out my shortcomings and demanding my instant dismissal. "Pant," grips me. Perhaps he was in China, and knows how to pronounce the long conglomeration of consonants and vowels that is the baptismal name of the mandarin who found a living dinosaur grazing on sagebrush in the heart of the Gobi Desert. How I wish that the News Editor had omitted the item! Perhaps he had swapped a yarn or two with a traveller for razor blades who called regularly on customers in that unpronounceable village near Bokhara, and made to-night's news via the earthquake route. The clock ticks over. Half a minute to go. Suddenly I remember a word appearing somewhere in that script I am about to read. When used in the sense indicated, where does the accent fall? Is it on the first, the second, the third or the last syllable? I cannot recall. So I grab the dictionary, open it, hastily thumb through it pages until at last, after what seems an age, my eye rests upon the word. I never heard anyone pronounce it in the manner given. But I will now. My protection and my authority is that black-covered, much-thumbed dictionary of the English language. For a few remaining seconds I try to relax. But not I will think of that walf-crown I placed on Howling Tiger in the £45. If he came in I would have won £15. I could take a few days holidays on that £15. I could go down to the country and fish, or play golf, or just laze around under the trees. But Howling Tiger developed "lack of interest" after the first lap, and from what I hear may still be trying to complete the course. Why did I ever become a radio announcer? I don't know. I now try to solve this problem; get quite added; hear the time signal go out. The clock ticks over again. It is 10.30. The red light over the clock flashes on. "Here is the weather forecast for to-night and to-morrow..." The second news is in the air.

WATERFORD HOSPITAL SCHEME

McDonald and Dixon, Architects wrote regarding the Waterford General Hospital project, stating it was agreed, in order to effect economy, to consider the modification of the accommodation, and with this object in view the commissioners will prepare a means of reduction in certain departments for transmission to us. In the meantime it was agreed to consider the saving which would be effected by replanning without making provision for the possibility of extension in the future, and to adopt a form of concrete construction in lieu of brickwork originally specified. It was agreed to hold a further consultation with the Department when the amended proposals are ready.

An order was made that the Commissioners report to the Architects as early as possible.

DUNGARVAN HOSPITAL.

It was pointed out by Commissioner Moynihan that the erection of the Hospital would free the building at present occupied as such, adjoining the Co. Home, for the use of patients transmitted from the existing General Hospital, Waterford.

LISMORE HOSPITAL.

The documents are prepared in draft working drawing stage for these buildings, and when the principal of the omission of the laundry from the Fever Hospital is agreed, the plans may be revised, and transmitted to the Quantity Surveyor.

FEES.

Messrs. McDonald and Dixon, Architects, wrote asking for £1,150 10s. balance a/c due in connection with the balance by them in respect of the County Hospitalisation Scheme.

NURSES HOME AT FEVER HOSPITAL.

The Board sanctioned payment of £45 (on the recommendation of Mr. Jephson, Engineer) to Mr. P. Nolan for work done to the Nurses' Home at the Fever Hospital, Waterford.

FEVER HOSPITAL, LISMORE.

Mr. Ormonde, Engineer, reported that the walls, hall, etc., badly needed distempering. He estimated the cost at £27.

WATERFORD FEVER HOSPITAL.

Mr. Jephson, Engineer, reported the roof of the scarlatina wards of the above are beyond repair and recommending that they be re-laid in asbestos slate on existing timber, at an estimated cost of £1100. It can be done in sections by contract or by the men ordinarily employed. It was decided to advertise for contractors.

KILMEADEN DISPENSARY.

A letter from the Ministry of Local Government and Public Health inquired if the Commissioners prepare taking any steps with regard to the floor of the waiting room.

MIDWIVES' SALARIES.

A letter from the Department with reference to the minutes of the previous meeting of the Board, stated the Minister has sanctioned a scale salary of £60, rising by annual increments of £2 10s. to £80 a year for dispensary midwives in the employment of the Board. The letter stated the scale did not apply to Mrs. Shanahan, Rathgormack, Mrs. Maher, Kilsheelan, and Mrs. Meagher, St. Mary's Dispensary, who hold positions under the Temporary Board of Assistance. The scale to come into operation on the 1st ultimo. The Minister is not prepared to approve of the proposal that the part services of the Midwives should be taken into account for the proposal of adjusting their salaries under the new scale.

Dr. O'Mahony wrote stating there is no other building available for a dispensary in the town of Tallow, and recommended that a site be procured for the building of


