The Late Mr. T. O'Donnell.

The death of Mr. Thomas O'Donnell,
which took place at his residence on last
Tuesday evening, 20th ult., at an advanced
age, and after a protracted illness, has re-
moved a much-respected resident of
Cappoquin.

The late Mr. O'Donnell was a member
of one of the oldest families in West Water-
ford, being a native of Mellery district,
where he resided up to a few years ago, but
on account of failing health he came to re-
side with his brother Mr. William
O'Donnell, Main Street, Cappoquin, where
he died.

He was a fluent Irish native speaker, and
was a veritable "mine" of Gaelic culture
and folklore. A staunch supporter of the
Fianna Fall Government since its inception,
he also took a keen interest in the Sinn
Fein and Volun-er movements, and his
home was always a haven of rest for
wanted men during the troubled times.

About twelve years ago he met with a
rather unerving experience, which after-
wards had a most detrimental effect on his
health. He was returning from a visit to
some relatives in County Tipperary in the
month of November and was trudging his
way across the Knocknashdown moun-
tains, when he was caught in a terrible
snowstorm and lost his way. He had to
remain during the night on the cold
mountainside, as he dared not venture
further, on account of precipitating into
the mountain cliffs, which lurked on either
side of him. How he survived such a
terrible ordeal, only himself could have
narrated, but on the following day he was
found suffering from terrible exposure
which he had endured. However, with
good treatment and care, he made a great
recovery. He was a great bowler and
football enthusiast and was the life and
soul of any company on every occasion.

His passing, though in the fullness of
years has occasioned deep sorrow in the
hearts of all who were intimate with him.

On Wednesday evening, the removal of
the remains took place to St. Mary's
Catholic Church, where on the following
morning, Masses for the repose of his soul
were offered up, and the funeral took place
later that day to the family burial ground
in St. Declan's Cemetery, Dromore, Cappel-
quin. The attendance at the funeral was
as on the previous evening, very large and
representative, which testified to the
popularity and esteem in which the de-
ceased was held.

grave-side.

TO-MORROW—

Sunday, July 2nd, will be a truly great
day at Youghal, D.V. The new Church (of
Our Lady of Lourdes) just completed on
the Upper Strand will be solemnly blessed
and dedicated by his Lordship, the Most
Rev. Dr. J. J. Roche following the first
Mass and a sermon. The project of the
Church for the Strand, with its rapidly
growing population and the increasing
number of summer visitors has been
talked about for a long time past. Some
few years ago an energetic local Comm-tee
took the matter in hand, and with the ap-
proval and very practical assistance of His
Lordship the Bishop, and the Very Rev. D.
Canon Dinneen, D.D., P.P., the contract for
erection was placed with the well-known
contractors, Messrs. J. Murray and Son,
with the extremely satisfactory result that
Mass will be celebrated on Sunday, begin-
ning to-morrow for the present season, and
it is hoped that in the near future arrange-
ments will be made for daily Mass.
Hitherto to relieve the great congestion
on the Sabbath during the summer season,
an extra Mass was celebrated in the Parish
Church, and the Convent Chapel was also
available to meet the requirements of both
visitors and residents. For the future the
new Church of Our Lady of Lourdes will
help to supply a long felt want.

At Fermoy, on Sunday, a crowd estimated at 22,000 witnessed the defeat of Waterford Senior and Minor hurlers at the hands of Cork's Senior and Minor selections in the Munster Championships.

The defeat of Waterford, last year's Munster Champions in the senior match was rather unexpected, especially by Deise supporters, as much confidence was placed in the strengthened team which did duty on Sunday. Indeed, at the commencement of the game it seemed as if the hopes of the Waterford men were justified, for the Deise players rammed in a goal and a point in the first few minutes, but Cork stemmed the attack and turned the tables by taking the lead after fifteen minutes play which Waterford never recovered.

In the second half the Corkmen continued to attack, and ran out winners with a winning margin of three goals and a point.

In the minor match Waterford also began by setting the pace in the first half, having a ten point lead after twenty minutes, and a five point lead at the interval, but a reshuffle in the Cork team worked wonders and Cork scoring seven goals and three points in the second half, ran out easy winners by a margin of 16 points.

The interest, hopes and fears of all Munster were centred on last Sunday on the meeting of Waterford and Cork in the Munster Hurling Championship matches at Fermoy. Of the huge crowd which was present a large percentage was composed of Waterford supporters who had come from every town, village and parish to witness the encounter. In their opinion the team which did duty on Sunday was much stronger one than that which won last year's Munster championship, and gave Dublin a hard road to victory in both Final, and naturally their hopes were high at the opening whistle of this encounter.

Cork on the other hand, despite the defeat of the seniors by Waterford last year, felt that their team was 100 per cent fit, and well up to the best senior standard, and man for man at least as good as the Waterford fifteen. Given conditions such as these when neither side is over confident or unduly pessimistic, a match has an added attraction. Hope rather than confidence was the keynote to the feelings of the 22,000 spectators of Sunday's Senior match, and beautiful weather gave both teams every chance of showing their paces.

Both teams were very much in earnest, for both counties were staging a come-back to Senior hurling, and felt that the outcome of the game would be a guide to their future in the Gaelic arena.

The programme was opened with the Minor Championship match at 2.30, refereed by Mr. M. Hennessy. Clare, following which the senior teams lined out. In the absence of Mr. W. O'Donnell (Tipperary), owing to the recent death of his father, Mr. J. Roche (Limerick) refereed.

The pitch was well prepared, but the prolonged drought of recent weeks left the ground not exceptionally hard, a factor which told against Waterford, for the ball was inclined to hop somewhat higher than the Deise men expected, and several of the Waterford stars were seen to miss ground balls, certainly not a fault of theirs in previous games.

The following changes were made from the team which defeated Cork at Dungarvan, on July 10th last year by 5-2 to 1-3. A. Fleming, had come out to right full-back, and M. Hickey had moved out to right half-back in place of W. Walsh who was off. J. Mountain moved from left half back to fill the vacancy caused by the absence of J. Fanning at left full-back. Mick Regan, of Portlaoise, who last year helped London to win the All-Ireland Junior title, came on at left half back. E. Moylan, who last year participated with Waterford at centre-field, J. Butler replaced P. Sheehan, and L. Byrne moved to right corner forward in room of

THE GAME.

Remarkable enthusiasm marked the lineup of the senior teams, who were played around the grounds by the Thomas Kent Pipers' Band. Following the playing of the National Anthem the game was started. Waterford played with the aid of a very slight breeze and had the sun on their backs. The ball had scarcely gone between the opposing sides when Barron was off on a solo run through the Cork defence and parting to Goode who put L. Byrne in possession in the square, the latter player had but little trouble in beating the Cork goalkeeper. This was the fastest score ever known in a Munster Championship, the ball travelling from the centre-field line to the Cork net without touching an opponent's hurley and before three-fourths of the spectators had realised that the game had begun. The Cork centre-field sent well out. Keane returned a stinging shot from Lynch and Butler snapping the ball drove well into the Cork lines but Quirk recovered in the nick of time. Regan beat Barrett and Lynch for the next exchange but the ball was returned and Curley saved in his usual brilliant fashion from Sullivan. Greaney doubling on the puck out crossed to Barron; and a free to Christy Moylan landed the ball in the Cork square twice in quick succession. The Cork full-back lashed over the side line and the cut-in by Barron was saved, but Andy Fleming racing up the field snapped the ball and secured Waterford's first point. With only five minutes play the Deise lads now had a four-point lead and their supporters had high hopes of an easy victory.

A minute later Cork were going all out for a score. Regan repulsed but from a cut-in by Brennan from the corner O'Sullivan forced the Waterford net. Fleming beat Buckley in the next exchange and a free to Waterford was cleared by Lynch, and Barrett sent Cork attacking. A free by Moylan on the half-way line was cleared. Campbell who was outstanding in the Cork back line beat out the next Waterford raid. In the next duel Hickey and Young fell in over three rows of spectators. Waterford were getting no chances now and the Cork half-back line were letting nothing pass them. Another free by Moylan went all the way to the Cork goal-line and Goode laid in a desperate last into the net. It was now noticed in the Waterford team that Hickey and Fleming had changed places. Barrett and Buckley were foremost in the next raid, when Waterford were penalised 50 yards out. Lynch sent the ball in, securing the equalising point off the free. Quirk cleared from Moylan and Barrett was inches wide with a free from centre-field. Christy Moylan led another Waterford challenge which was repulsed and a great struggle commenced. Murphy and Quirk started for Cork and Curley brought off another brilliant save. "The Dungarvan Observer" SATURDAY, JULY 1, 1939. Irish Speakers Increase. The population of the Twenty-Six Counties in 1936 was 2,806,935, and of these 661,601, or 23.7 per cent, were returned as Irish speakers. The corresponding percentage for 1926 was 19.3. This information has been issued by the Department of Industry and Commerce during the week, and has been headlined in the daily press. At first sight it would appear that the language has made great progress since 1926, but further examination of the statement gives pause to the reader. It goes on to say that personal judgment enters so largely into the information furnished in regard to knowledge of the language that the number of Irish speakers would appear to be far less susceptible of exact measurement than any of the other matters into which it is the purpose of the Census to inquire. In other words, it would seem that so many people consider themselves fluent speakers of the language that they have described themselves as Irish speakers, when the probability is that many of them are just students or school-children who do not ordinarily use the language in their homes or at their work, and perhaps never will. All these have been put in the same category as the inhabitants of intensely Irish-speaking districts, so that the returns are not in reality a true guide to the growth and spread of the language as an everyday one. The number of Irish speakers in the Gaeltacht has fallen by 6,566 or 2.7 per cent, a loss which cannot be made good by the increase in other parts of the country of 132,365 or 44.7 per cent. The Gaeltacht is the cradle of the language and should be the first to show an improvement in this respect as a result of
