

WATERFORD COUNTY BOARD OF HEALTH

At a meeting of the Waterford County Board of Health on Thursday, July 12th, Mr. S. J. Moylan presided.

DEPUTATION'S REQUEST.
A deputation of the Ballyduff Water Supply Consumers waited on the meeting with a request that Patrick Fitzgerald, waterworks engineer, be reinstated. The Commissioner heard the deputation, and promised to keep their representations in mind when considering the matter.

LETTING OF COTTAGES.
The following cottages were let—Knockboy (Dungarvan District) to Patrick Ahearn, c/o Mrs. E. Dea, The Burgery. Kilrossanty (Kilmacthomas District) to Michael Cheasty, Gortnalacht, Kilrossanty. Stradhally (Kilmacthomas District) to William Kett, Stradhally. 306 Comeragh (Kilmacthomas District) to Ellen Navan, Williamstown, Stradhally.

ERROR IN VALUATION.
Jas. F. Keogh, Tramore, reported that since he took up the collection of Water Rent, September 1928, the amount of the same has been charged on £11 valuation. It had since been ascertained that the valuation should be only £8 15s.

Mr. John Morgan now claims a refund of the overpayments he has made, viz. £2 per year.

The matter was adjourned pending decision as regards rates.

TRAMORE GOLF CLUB.
Jas. F. Keogh reported that the Tramore Golf Club have now connected their new premises at Newtown with the Water Main. He asked that a fixed charge be specified for the Club as water rent.

The Secretary was asked to ascertain the P.L.V. of the place and the Engineer to report the use being made of the water.

RUSSELLTOWN PUMP.
No action was considered necessary in view of the Engineer's report of which complaints of the water being red had been received.

The Engineer reported that this condition occurs occasionally with water pumped from the strata into which pumps like this one are sunk. It disappears after a short time and may not recur for a long time afterwards.

LISMORE WATER SUPPLY.
Mr. O'Gorman, solicitor, wrote stating that the Lismore Town Commissioners may terminate their agreement with the Lismore Estate Company by giving notice, and the Lismore Estate Company could then enter into a new lease with the Board of Health as well as agreed on, but the Town Commissioners themselves could not by any legal process hand over their lease to the Board.

WELL AT BUSHLE GRANGE.
The Engineer reported that the above is a public well on the side of a boreen. It serves four or five families. It is partially protected at present, but not sufficiently well to prevent cattle drinking from it, or dust being blown into it. The supply in his opinion, is quite adequate.

Proper protection would cost £7.

An order was made that the work be done.

CLASHMORE CARETAKER.
An order was made that the wages of William Murphy, caretaker of Clashmore Waterworks be increased to £4 per annum.

BALLINAGOL WATER SUPPLY.
The Engineer submitted, (1) plans of the Ballinagol Water Supply, and (2) suggested to be advised as to whether this scheme should include connections to the Board of Health Cottages in the village.

(1)—The plans were approved and will be sent to the Department for Sanction, and (2) the Scheme does not include for connections to the cottages mentioned.

FERRY AT AFFANE.
The Engineer reported that, in the case of the pump at Affane, the rising main consists of old fly flush jointed pipes and in most cases the threads are very badly worn. In his opinion it would only be waste of time and money to attempt any sort of repair.

The rising main with fittings must be renewed.

The Engineer was asked to get the work done.

AERIDHEACHT AT RING

Successful Revival of Popular Gaelic Fixture

There was a very fine gathering of Gaels in Ring on Sunday last to witness the first Aeridheacht held there for over ten years and judging by the success which attended the efforts of the organizing committee it can be safely said that this annual fixture has come to stay. Large contingents came from all parts of Munster and amongst the 150 competitors, representatives were notified from Waterford City, Forthaw, Dungarvan, Kilkenny, Clonmel, Ardmore, Limerick, etc., etc. The Waterford Gaelic enthusiasts travelled by bus and a fleet of cars and included members of the Waterford Gaelic League, Clann na h-Eireann, Gasra an Phainne and Waterford Dancing Schools. The spacious College grounds provided an animated appearance as car after car and bus after bus unloaded their full quotas of passengers. The opening ceremony of the Aeridheacht was performed by Rev. Father O'Farrell, S.T.L., St. Kieran's College, Kilkenny (who is a well-known figure at Waterford Feiscanta). Associated with Rev. Father O'Farrell on the platform were "An Fear Mor," who presided, Rev. Father Baldwin, C.C., Ring, Rev. Father Flynn, Curry, C.C. (a former vice-president of the Waterford Gaelic League), the professional staff of Ring and Ardmore Colleges, etc., etc. Also included in the large gathering were many members of the Holy Ghost Fathers and Christian Brothers, who are at present holidaying in Ring.

Speaking at the opening of the Aeridheacht, Rev. Father O'Farrell expressed his delight at seeing such a representative gathering which showed the growing spirit of the Gael in winning back for Eire the culture which was once her pride and the envy of other people. He exhorted those present to redouble their efforts in every respect to achieve the object which they had set before them and bring back Irish as the language of the school and the street, the price and the people. The language was the hall mark of our Nation, and if we wished to earn the respect of other nations we must show that we have a distinct nationality and individuality of which we are justly proud and which can compare with the best of any other nation. He condemned the growing practice of aping the foreign and pagan life and customs of other countries and thus making our own country a second-hand nation and one which would command not the respect but the derision of visitors and tourists to our shores.

"An Fear Mor" also spoke and welcomed the visitors to Ring, especially those who came from afar to support the Aeridheacht and the sheet ice which it was held viz. to further the cause of the language and Gaelic culture.

mountains by a pass since called Dog's Gap. Dozens of anecdotes, of a similar nature, are to this day recounted concerning Declan's life.

There are several ruins, monuments and relics at Ardmore associated with Declan's name. These include Cathedral ruins, a holy well, Ogham stones, the Round Tower and the Ogham or "Beannachan" where St. Declan was buried. Other relics are a bell, a cross, a stone called the Dublin Deuglain and baptismal font.

The Pattern of Ardmore is probably the oldest and strangest celebration of its kind in Ireland. It consists of the performance of certain religious exercises in honour of St. Declan at the Cathedral ruins and Holy Well adjacent. The "Rounds" or stations begin with seven Paters and Aves which the pilgrim recites kneeling before the well. Then he walks three times around the ruin proceeding "doiseal" (sunward) towards the Rosary. On the third circuit he kneels inside the ruin where he finishes the Rosary. A second series of Paters and Aves is then added, following which the client bathes his limbs and senses in the shallow pool of water adjoining. Finally, as a rite of devotion, the pilgrim scratches the sign of the cross on a large stone at the east end of the ruin.

The Pattern commences on the 24th of July each year and continues for eight days. During the Pattern special devotions in honour of the Saint and his wonderful works are recounted on many a hearth.

A biographer says that three separate springs of pure water immediately gushed from where the drops of blood fell. These springs are still issuing from the strand and are supposed to have curative properties.

Another story says that Declan raised to life seven hostages of the king of Munster who had died of plague. It would have been injurious to the king's honour had they been found dead in his custody. Tradition also recounts that Declan was once being entertained by a pagan host in South Tipperary, who instead of the usual dish, placed before him roast dog. The Saint is said to have prophetically detected the trick and thereby converted his host to Christianity.

This incident is embellished by adding that the dog returned to life and leaping off the table ran over the Comeragh

AD INTERIM TRANSFER.

Formal evidence having been given, and Supt. Kieley stating that there was no objection, the application was granted.

INSURANCE CASES.
Mr. F. St. J. O'Neill, solr. (for Mr. D. Casey, State Solicitor), prosecuted in a number of cases for unstamped insurance cards.

In one adjourned case against Bridget Nason, Mr. Hodnett said the defendant was unable to meet the claim, and a fine of 1/- and 4/- costs was imposed.

In another case against Julia Aherne for failure to stamp the cards of two employees, Mr. O'Neill said the amount due with him for a conversation.

Defendant was fined 5/- in each case, with 4/- costs.

RECKLESS DRIVING.
Supt. Kelly charged John Boyle, V.S., Midleton, with reckless driving.

Mr. W. St. Clair Rice, solr., Midleton, defended.

David O'Shea, attendant, Mental Hospital, Youghal, stated that about 3.30 p.m. on 28th June he was cycling home from Killeagh when he met a friend, Peter Egan, Youghal, motoring against him.

Egan was close on his own side of the road. He stopped, and witness closed up with him for a conversation. While so engaged a motor cyclist came along from the Killeagh direction, on his own side, but as he approached them he came to the handlebar of his cycle, cutting his hand badly.

The cycle was doing about 35 miles per hour.

Mr. Rice said that Dr. Boyle had no recollection of hitting anyone. He admitted being on the road that evening.

Witness further stated that it was Dr. Boyle, whom he knew and once worked for. The doctor did not stop. He had 18 feet to pass.

Cross-examined by Mr. Rice, the witness said he knew Dr. Boyle well. He got such a shock at seeing the blood on his hand he didn't stop him. Egan's car was on the grass margin. There was little traffic at the time.

Guard O'Connor said he interviewed Dr. Boyle that evening. He said he had been at Killeagh fair that day, and also at Youghal. He could not possibly have hit anybody.

Cross-examined by Mr. Rice—Dr. Boyle was not the type of man that would not stop if he had done any damage.

Hit and run?—The Justice—Tip and run. (Laughter.) There were no marks of impact on the cycle. It must have been a glancing blow.

Defendant said the first he heard of the matter was when Guard O'Connor called on him at Midleton. He cycled along the road that evening. He saw the motorist and cyclist talking. He wasn't aware of hitting anyone.

Mr. Rice said there was no question of speed or reckless driving.

Defendant was fined 1/-, with 10/- expenses, for "careless driving."

Mr. T. K. Keane for plaintiff, and Mr. J. N. R. McNamara for defendant.

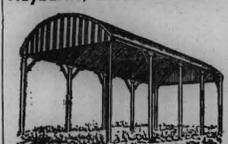
Plaintiff's case was that he did the work on the understanding that defendant would help him with his beet crop, but he failed to do so.

REFRIGERATION.

Now that the hot weather is here a refrigerator is a necessity in every home of ten families in this country food is kept in such a way as to be a menace to health. Food often becomes unwholesome and sometimes even poisonous because of inadequate refrigeration.

Cheap, badly made ice boxes have little or no practical value as refrigerators. They are not efficient enough to check the growth of microbes in food. A person can buy for one pound a sort of box that looks well and in which one can, with ice, keep milk from souring for twenty-four hours. It may look and taste all right, but it is not all right. For when such food is not properly chilled the bacteria in it multiply constantly, and also much of the bacterial growth takes place before it can be detected by ordinary taste or smell.

ICE-BOX PERILS.
Cheap, badly made ice boxes have little or no practical value as refrigerators. They are not efficient enough to check the growth of microbes in food. A person can buy for one pound a sort of box that looks well and in which one can, with ice, keep milk from souring for twenty-four hours. It may look and taste all right, but it is not all right. For when such food is not properly chilled the bacteria in it multiply constantly, and also much of the bacterial growth takes place before it can be detected by ordinary taste or smell.

SIMPLE TESTS.
The simplest way to test the efficiency of a refrigerator is to place a thermometer in the food chamber and keep it there for half an hour. The temperature should be about 45 degrees and certainly not more than 50 degrees on the Fahrenheit scale. Such a test should be made in a room where the temperature is from 70 to 80 degrees. At 45 degrees bacterial growth is markedly hindered, although it does not entirely cease. Germs multiply with great rapidity at above 50 degrees. Engineering tests of household refrigerators show that temperatures are often ten degrees or more higher. Such temperatures make it possible for billions of germs to grow in food, making it unfit for human consumption.

BACTERIA MULTIPLY FAST.
Experiments show that bacteria multiply with terrible rapidity. In a test fifteen drops of milk contained 3,000 germs. Kept twenty-four hours in the 50 degree temperature the bacteria count became 11,500, and when raised to 55 degrees, 18,000; to 60 degrees, 180,000; to 65 degrees, 450,000; and to 85 degrees, 1,400,000. Many kinds of bacteria are quite harmless. But, if the germ present in food in a poor ice-box chance to be typhoid bacilli or the microbes of common meat poisoning, serious and immediate illness—perhaps death may result.

Comparatively slight decomposition of food also may cause persons to complain of feeling rather poorly or kind of run down, because of insufficient nourishment or because their strength is exhausted in combating the actions of the germs.

All this proves what an asset to health a proper refrigerator is, and, should serve as an incentive to those who have started the pure milk campaign. Also it should encourage everybody to support them in every way possible, in their good work.

COUNTY COUNCIL OF WATERFORD

Sheep Dipping Order, 1937

County Waterford Sheep Dipping Regulations, 1933.

WE, the Executive Committee of the Waterford County Council acting as the local authority under the Diseases of Animals Act, 1931, The Diseases of Animals Act, 1934, and of every other power enabling us in this behalf, hereby order as follows:—

1. All sheep in the Administrative Area of County Waterford required to be dipped under the Sheep Dipping Order, 1937, shall be caused to be dipped by the owner or person in charge thereof at such times and at such dipping stations as may be specified in a Notice signed by an Inspector of the Local Authority, and served by post or otherwise on the owner or person in charge of the sheep referred to in the Notice. It shall not be a compliance with these Regulations to dip sheep at any other place or places save those as prescribed in the Notice above referred to.

2. All sheep in the Administrative Area of County Waterford shall be dipped under the supervision of a Dipping Inspector appointed by us under the Sheep Dipping Order, 1937 twice yearly (with an interval of not less than seven or more than fourteen days) in the period between the 1st day of August and the 31st day of October, provided that in any case in which inclement weather renders dipping impossible on the date appointed, the dipping shall be carried out on the next day that the weather is suitable therefor without any further Notice being given by the Inspector.

3. A fee of one penny per sheep in respect of sheep dipped in the Comeragh and Knockmeadown Mountain Areas, and a fee of two pence per sheep in respect of sheep dipped in the Lowland Areas—the expression sheep includes lambs—shall be paid to the Inspector of the Local Authority, in all cases by the owner or person in charge at the time of dipping of the sheep, save as provided in Article 4 (d).

4. (a) Where the Local Authority or their Veterinary Inspector concerned is satisfied that an owner or person in charge of sheep in the Area to which these Regulations apply has in his possession or under his charge a proper swim tank, the Local Authority or their Veterinary Inspector for the District may, subject to such conditions as may be deemed fit, allow the sheep of such owner to be dipped in such swim tank on such dates within the prescribed dipping period as may be appointed for the purpose by an Inspector of the Local Authority, and such dipping shall be deemed to satisfy the requirements of these Regulations, provided (1) the dip used is a dip approved by the Minister for Agriculture, and (2) the dipping has been supervised by and carried out to the satisfaction of the aforesaid Inspector.

(b) Any exemption given under this Article may at any time be withdrawn by the Local Authority or their Veterinary Inspector concerned.

(c) Applications for such exemption should be addressed to the Local Authority's Veterinary Inspector for the District and must be made on or before the 31st day of August.

(d) Where, with the permission of the Local Authority or their Veterinary Inspector concerned, an owner uses his own tank and an approved dip, no fee shall be payable for the supervision of the dipping by an Inspector of the local Authority.

5. Dip approved by the Minister for Agriculture shall be used in all cases and except where exempted thereunder under Article 4 (a), shall be supplied by the Local Authority.

6. Whenever required by an Inspector of the Local Authority, the owner or person in charge of sheep in the area to which these Regulations apply shall accompany the Inspector to the mountain or place where such sheep graze, at such time as required by the Inspector, and shall collect all the sheep off such mountain or place.

7. An owner or person in charge of sheep in the Area to which these Regulations apply shall comply with all reasonable requirements of an Inspector of the Local Authority as to the collection and dipping and dipping of all sheep in his possession or under his charge, on lands in his occupation, and shall afford all reasonable assistance and facilities that may be required for the dipping of all such sheep.

8. No sheep in the Area to which these Regulations apply shall be moved into or disposed for sale in any fair, market or saleyard in the Area between the 1st day of September and the 31st day of October unless they have been twice dipped in accordance with these regulations after the 1st July previous, and are accompanied by a Certificate of Dipping signed by an Inspector acting for the Local Authority, which Certificate shall be produced by the person in charge of the sheep on demand by any member of the Garda Síochána or Inspector of the Minister for Agriculture or of the Local Authority, who may require on such Certificate of Dipping particulars of the sale of any such sheep at such fair or market or saleyard.

9. Any owner or person in charge of sheep in the Administrative Area of County Waterford who fails to comply with any of these Regulations shall be deemed guilty of an offence against the Diseases of Animals Act, 1934.

These Regulations shall apply to the entire area of the County of Waterford and

KILMATHOMAS NOTES

WELL-KNOWN CITIZEN'S DEMISE

The death of Mr. Patrick Kirwan, Hill Cottage, Kilmathomas, which occurred on the 13th inst., at the County Hospital, Waterford, after a comparatively short illness, in his 45th year, has occasioned widespread public sympathy. DUNGARVAN URBAN COUNCIL

At the weekly meeting of Dungarvan Urban District Council on Friday, July 14th, the following members were present: Messrs. M. Morrissey, T.D., Chairman, T. McCarthy, Vice-Chairman, P. Byrne, J. Mansfield, and J. Dahill.

After the minutes had been read, a pay-sheet for £14 lbs. 8d. was passed.

A number of tenants wrote asking for repairs to be done at their houses, and Mr. Hackett applied for grants for painting the ladies' bathing boxes.

Mr. Byrne—This lady deserves payment, as she had made a good job of the place. Mr. Dahill—Was there an order made for the work?

Chairman—No, the matter was referred to the S.S.O. In the case of one tenant asking for repairs to her house Mr. McCarthy said that she had been applying for six months, and nothing had been done.

ACKNOWLEDGMENTS. A number of acknowledgments of votes of sympathy passed by the Council were received, including letters from Mrs. O'Connell, St. and Mr. Money, Bridge St.

TENDERS FOR RANGE. The tender of Michael Moloney for a range for the house of a tenant at £6 4s. 6d. being the lowest, was accepted.

Mr. Byrne—I never heard that a security was necessary for procuring a range. The Clerk said this order was made because some people who had got ranges did not pay.

Mr. Byrne said these people should be made pay. He knew people who were able to pay and did not, and then poor people had to pay up.

Mr. Dahill—The poor suffer. BOROUGH SURVEYOR'S REPORTS. The B.S. reported on four houses, as requested by the Council.

Mr. Dahill asked that an order be made that repairs be carried out. Mr. Byrne mentioned a house in Mitchell St. in which repairs to the sanitation were needed. He had brought it to the Council's notice but nothing had been done.

It was referred back to the B.S. The B.S. also reported that he had interviewed the representatives of the Dublin Leather Co. The Council's authorities were of the opinion that the situation would be remedied if the sewer was carried out to the water.

Mr. McCarthy—In my opinion the stuff should be let out when the tide is going out. It is no good piping it out at any other time.

Mr. Byrne—I don't think it can be remedied. I wouldn't interfere with the factory. Although they don't employ 100 per cent. local labour yet, they have done a good thing.

After further discussion Mr. Byrne asked if all the people had been notified of the new sewerage scheme. Mr. Mansfield said that he had been approached by 3 or 4 Youghal Road residents on the matter.

Mr. Dahill said he had been approached that evening by residents of Youghal Road to have their notices served.

Mr. Byrne—Are we definite that the houses at the Convent are to be condemned?

Chairman—Yes. Regarding this matter, the Chairman continued, the procedure was that the houses must be inspected by the S.S.O. to find out the reasons for having it condemned, and then by the B.S. to find out what repairs are needed to make it fit for human habitation.

REQUEST OF GOLF CLUB. The Secretary of the Golf Club wrote regarding the Council's charge for the Club's Annual Dinner in the Town Hall, and stating that although the Club was being charged as if for an all-night dance to which admission would be six or seven shillings, the admission to the Club was not charged to this amount.

Mr. Dahill—There's an order made. Chairman—We discussed it the last time. It was decided that the order should stand.

Mr. Byrne—We should make an order that the porter get something at every dance. The Chairman said that in his opinion the charges could be revised. This could be done if some members held a motion to that effect. The motion could also include provision for the porter.

MUNICIPAL AUTHORITIES ASSOCIATION. Correspondence was received from the above body asking that delegates should attend the next meeting and that the Council should be notified.

Mr. McCarthy—We were members at one time. Mr. Byrne—Last year's members were very sorry we weren't affiliated.

It was asked that the cost of affiliation would be £3. Mr. Dahill—What benefit will we derive from membership?

Chairman—Any legislative regarding urban affairs would be trashed out. Mr. Mansfield—The money is needed more for other things.

It was decided not to affiliate. WASTE AND LEAKAGE. A letter from the Department was read, asking for the results of the Council's investigations for the elimination of waste and leakage of water.

The Chairman said that Mr. Conkey had been in town during the week, and made a survey, and he felt that there was a lot still to be done regarding leakage. He had suggested ways and means for this, and indicated plans which should be met. It would be well if these instructions were carried out, and until this was done they wouldn't be in a position to do anything.

Mr. Mansfield said that Mr. Conkey had suggested a lot of things for the elimination of waste which their officers couldn't do. They should ask Messrs. Bell and Waller to send down engineers.

Mr. McCarthy—I think you're right. Chairman—Mr. Conkey told me that some of his suggestions were not carried out. Some of them were but there has been no determined effort to carry out his suggestions. He gave instructions, and it's for our officials to carry them out and co-operate with the engineers.

A poor attempt has been made to check upon the leakage. Mr. Dahill—Our water inspector has made an inspection of my house. I saw him do so.

Mr. McCarthy—He has done that all right. Mr. Dahill—We have it from the E.S. that there's no leak in the main.

Chairman—Was it tested? The Engineer told me it wasn't.

Mr. Byrne—No doubt we can't dispute the qualifications of the engineers, but we are sometimes in their failures and the mistakes they have made. I have some knowledge of the new system, and when the water is let in again it will be a failure. We have 130 new houses now and water can't be supplied to them.

Mr. Mansfield—The whole scheme was a bunch of "ifs" from start to finish. A letter, signed by a number of Buttery St. residents, was read stating that they would not be able to pay the rents of the

WARBLE FLY. It was stated that Detention Notices had been served under Article 4 of the Warble Fly (Treatment of Cattle) Order on three owners for non-compliance with the Order. All had since complied.

CARRICK-ON-SUIR DISTRICT COURT.

(Held on Monday, before Mr. F. J. McCabe, D.J.).

MOTORING OFFENCES.

Guard Geesley, Glenbowe, v. Patrick Nolan. Defendant was summoned for having driven a car that was licensed and insured in his brother's name and was registered "owner driven."

It was stated that Guard Geesley was on sick leave and could not attend court.

Mr. Quirk said as his client was admitting the charge, the absence of the guard would make no difference. Confined, Mr. Quirk said defendant works with his father and his brother as builders. When he drove the lorry on the occasion he did not admit to the fact that it was registered owner driven and was insured in his brother's name.

Patrick Nolan the defendant bore out Mr. Quirk's statement. At the time he drove the lorry arrangements were being made to have the license and insurance adjusted. Witness did not think he was committing an offence.

Justice—Did you know you were not covered by insurance?

Defendant—I did not think it was an offence to drive in the circumstances. I thought as it was insured in my brother's name it would make no difference.

Justice—You had committed one of the most serious motor offences you could have committed. If you had had an accident, some poor widow and children would have had nothing to get from the insurance company.

Defendant—I did not intend to drive again until everything was put right about the insurance. We were engaged adjusting it.

Justice—But you should not have driven on that occasion. I have sent people to jail for having driven uninsured cars. I regard it as a very serious offence.

In reply to the Justice, witness said his wages were £4 a week.

Mr. Quirk said the father and two sons carry on business as builders.

Justice to defendant—Are you married?

Defendant—I am, sir.

Mr. Quirk—He has a large family.

Justice—Have you a driver's license?

Witness handed in his driver's license.

Justice—I take a serious view of your having driven this car uncovered by insurance in your name. I fine you £3 and I shall endorse your driver's license.

DANGER OF COMING FIRM

BYE-ROAD.

Patrick J. McGrath, Carrickbeg, was summoned by Supt. Donnelly, Farrmore, for dangerous driving of a motor car at Ballygarra, Portlaoise.

Mr. Binchy appeared for defendant.

Mr. A. R. Farrell, solicitor, said he had a watching brief on behalf of Mr. Moloney, a motorist who had been mentioned in the case.

Mr. Binchy said his client admitted that he did not slow down as much as he might have done when coming from the bye-road to the main road. He blew his horn as a precaution.

Supt. Donnelly said defendant drove straight across the main road and closed the road completely. Mr. Moloney, who was coming along on the main road, had to run into the fence to avoid striking Mr. McGrath's car. There was no other alternative.

Mr. Binchy said that owing to the narrowness of the road at the place in question Mr. McGrath could not have seen Mr. Moloney's car, nor could not have a view of the main road.

Justice—The other car was entitled to the road. The man did a very dangerous thing to come on as he came from a bye-road. When a motorist is coming from a bye-road to the main road he should act as if he knew there were twenty motor cars on the main road where the bye-road forms at. It is by carelessness in coming from a bye-road that many lives are lost in motor accidents.

In reply to the Justice, defendant said he makes his living by driving his car for hire.

Justice—I am all the worse off because you are a professional driver.

In reply to the Justice, defendant said he has not been doing much driving for hire recently, as the weather is hot for Tramore and such places. He has been driving 13 years and has never had an accident.

Justice—I am surprised at that. Men who see when driving, as the Supt. has described, are a public danger. He asked defendant how many times he was asked to slow down to drive a car.

Defendant—Once or twice.

Justice—Are you married?

Defendant—Yes. I have four children.

Justice—I fine you £2 and endorse the conviction on your driving licence. You are getting off very lightly.

TRILBY'S CAR.

John Holden, Carrickbeg, was summoned for driving an unlicensed motor car. The case was adjourned at last court.

Mr. Binchy, for defendant, said his client sold the car to Mr. Holloway, of Carrick. The car had no license and no insurance. He was driven to Carrickbeg by a friend of defendant's. It was sold in Carrick to Mr. Holloway for £25.

Defendant, at Holloway's request, drove the car a short distance when he was stopped by a Guard. The car had not been insured by the defendant. It was Mr. Holloway's intention to insure the car and pay the road tax.

Justice—The car has not been insured or licensed?

In reply to the Justice, Mr. Binchy said defendant (Holden) is a builder in Carrickbeg. He received from Carrickbeg that day.

In reply to the Justice, defendant asked the court to fine the defendant three times the tax, mitigated to 2/6, for not having the car taxed; 2/6 for not having a driver's license; and £2 for not having the car insured. He gave him six months to pay the fine.

EIGHTH ANNUAL REPORT.

The following report was submitted by the County Librarian at the last meeting of the Libraries Committee.

I have the honour of submitting to you hereunder the Eighth Annual Report on the progress and working of the County Waterford Libraries.

GENERAL REPORT.

There was an increase of 10.11% in the total number of books read this year as compared with last year. When we take into consideration the fact that the book stock actually decreased during the year under review, we are justified in claiming that the County Waterford public have definitely acquired the reading habit, and that despite the inadequate supplies and facilities, especially in our larger centres, the Library Service is catering for an ever widening circle of readers.

While progress has been made within the limited scope of our present organisation and resources, it is well to bear in mind that to be in consonance with the latest demand, our Library Service must be developed on a broader basis than is possible with the meagre funds at our disposal.

Generally speaking, the smaller country centres have fared better than the larger urban ones, and thus a real equilibrium in development has not been maintained. Practically 25 per cent. of the population concentrated in urban areas. Dungearvan and Tramore have had differential treatment in the pejorative sense of the word, due to the fact that development altogether outstripped financial provision.

Thus we are led to the very incongruous position which pertains in Dungearvan, which town has no less than five separate centres. While the policy of numerous small centres so situated as to cater for the largest possible number of borrowers, is inherent in the very nature of a county library scheme, the multiplication of centres in thickly populated areas is both wasteful and technically unsound. The creation of one large juvenile centre well stocked, would be of infinitely more advantage to children. In such a centre copies of children's classics could be made available in sufficient number to insure that every child would become acquainted with the best juvenile literature in a reasonably short space of time.

Of course no policy of centralization can be put into operation for Dungearvan until a special library building has been erected.

In order to meet with the exigencies of the present situation, a plan, and graduated financial scheme to bring a specified period of years must be accepted by the County Council, and put into operation as soon as possible. Otherwise our Library Service will continue to be ill-adjusted and all our major problems remain unsolved.

CENTRES.

In Dungearvan there was an appreciable increase in the number of books read during the year. Great credit is due to Miss Chase and her helpers for the smooth-running and general order maintained in all the largest centres.

Tramore Centre still maintains its previous record, under the able guidance of Mrs. B. Browne, who, without any hiccup whatsoever, takes for 800 borrowers. Despite unstarable premises and pressure of work, Mrs. Browne's records are always strictly accurate, and she administers the affairs of the Tramore Branch in a most conscientious manner. I cannot speak too highly of her work and zeal, sometimes under very adverse and trying circumstances. It is one of the model county libraries in the County.

Since its re-organization under the efficient administration of Miss Molly Cunningham, Stradbally Centre has made very considerable progress.

Kilmacshingaun Centre presents a particular problem. Since the resignation of Mrs. Callahan, who formerly acted as Honorary Librarian, the centre has been moved to the National School, and is now in the capable charge of Mr. J. O'Connell, N.T. As the school is most inconveniently situated for town borrowers, there has been a very considerable falling off in the reading of books by adults. We have been unable, so far, to make any other suitable arrangements at Dungearvan and Cappoquin have made steady progress during the year.

NEW CENTRES.

The following four new centres were opened during the year:—Dungearvan Boyes outs; Crelmua; St. Augustin's, Dungearvan; and Glongarra. The total number of centres in the County is 69.

JUVENILE READING.

The considerable increase in juvenile reading leads us to reflect on the particular problems which the supply of suitable children's books creates for Irish Libraries, and which formed the subject of Fr. Stephen Brown's paper at this year's Library Conference, at Castlebar. We continue our remarks to books written in English.

The supply of children's books by Irish authors, having a definitely Irish character, is infinitesimal compared to the demand. Therefore Irish Libraries are obliged to draw upon other sources of supply. This results in the circulation of a large number of books whose background, atmosphere and whole scale of values is very distant from our national, cultural and religious aspirations, having no relation to our life in Ireland, and making no roots in the national soil.

As the publishing of Irish books is necessarily a commercial undertaking, it would seem as if Irish Libraries were dealing with an insoluble problem in this question of children's reading. A small population produces a correspondingly small number of authors, and if these are purely regional it is difficult for publishers to dispose of a sufficient number of volumes to occupy their initial expenditure. The only hope seems to be in the increase of the number of Irish authors writing children's books and a determined and organized effort on the part of Irish publishers to push their goods on every English-speaking market.

REQUEST CARDS.

Our system of specially printed Request Cards, first introduced this year, has proved very successful. However, we would like to see a more widespread use of these cards so that informal lists would be also more widely used. This would greatly facilitate filling work at Request Cards, and save a many expensive handling of special requests. In this connection we wish to point out that requests for general works are always given priority over requests for fiction.

LOAN OF BOOKS.

Recent heavy withdrawals of fiction from stock are to a considerable extent due to the negligence of certain borrowers in their treatment of library books. Popular works of fiction, some of which are at the end of their useful life, have been so badly misused that they are practically unrecognizable. This is a very serious matter, and it is imperative that all borrowers should be made aware of the damage they are doing to the library stock. It is in the interest of every borrower to take special care of library books, which are the common property of all the categories. Those who are indifferent as to whether the books are clean or dirty, worn or well preserved, should remember that a very large proportion of the borrowers do appreciate clean and well-kept books, and furthermore that they have a moral obligation to take all due and reasonable care of common property.

CATALOGUES.

Last year three catalogues were issued, one covering a large number of Irish books, one covering a large number of books in the Irish language section, and a select list of Catholic works in the library.

READING.

In the general section books of travel, biography and history, accounts of living men, and other works of a very high standard, are very recent European history is very considerable. Apparently no borrowers have yet despaired of the value of the books, and we are glad to find that the staff are themselves well-versed in the history of the County Library.

The lighter type of fiction is still the choice of the majority of readers, though there is a tendency to choose more serious works. In order to encourage this tendency we have adopted the policy of applying the more important novels, as much as possible, and of dealing with replacements of fiction stock, to reject the purely ephemeral and restrict only those of some literary value. All novels leading with Irish life are stocked, as of course the supply of such books is very scanty, and the poorest of them have at least the value of being in the library atmosphere. If however poorer they may be they are scarcely worth the level of some of the cross-channel publications.

Our collection of books in Irish is still in a very poor state, and it is greatly in demand and teachers have found our section of children's books particularly useful. The number of children's books in simple

WATERFORD CITY MANAGEMENT

In the Seanad on Wednesday, Mr. O'Kelly, Minister for Local Government, moved the Second Stage of the Waterford Management Bill, 1939, which, he said, was to extend to the City of Waterford the system of city management already in operation in Dublin, Finswick, Cork, and Dun Laoghaire.

Mr. G. Douglas said he thought it was a matter for satisfaction that a Bill of that kind would receive the support of all sections. He took it that there was no local objection to the measure.

Mr. S. Goulding said that so far as he was aware there was no opposition in Waterford City. Although he could see in that type of measure the danger of the introduction of the thin end of bureaucracy, he admitted that for the purpose of efficient administration such a measure was essential.

Mr. Butler welcomed the measure and said he believed the citizens of Waterford were satisfied with it.

The Minister, replying, said that the principle of management in boroughs had been generally accepted as a good principle and had been widely extended in the past few years. On the whole, the system had worked satisfactorily.

The Second Stage was agreed to, and the report stage was fixed for Thursday.

Mr. P. F. Baxter said that the County Council had rates higher by £252,000 than in 1937, and there was no additional help being coming from the Government, although much of this increase was due to Government policy.

In addition the capacity of the taxpayer to carry the burden was not nearly what it was in 1937. The representatives of the Minister had given a larger grant than at present, and the Minister had changed the basis of administration so that the grant was forthcoming of the amount of employment given. The fact was, however, that the number of males employed on the land was 43,000 fewer than when the scheme was brought in. Yet the Minister proposed to make permanent a scheme that had his result.

What the Minister should try to do was to get the number of males employed on the land up to its present level, and not to do that.

THE RATES RELIEF BILL

WATERFORD T.D. REFERENCED.

In the Seanad on Wednesday, Mr. O'Kelly moved the Second Stage of the Rates in Agricultural Land (Relief) Bill, which, he said, was a permanent measure on the lines of temporary measures at present in operation.

Mr. J. Butler (Waterford) drew attention to the position of farmers with agriculture and with the rates in the urban areas. They got no relief, and sometimes had to pay the rates the rates their neighbours in the rural area might have to pay.

Mr. Goulding (Waterford) said the fact that certain people could "get away" with not paying their rates was a very serious matter to others to pay their rates.

SOUTH TIPPERARY GAELTEAGHT.

A praiseworthy enterprise commenced this year was the founding of an Irish language movement at Newcastle, County Tipperary. This pretty village, which is situated close to the Ballymacoby district in Co. Waterford, is the centre of a Gaelic Gaeltacht area, and many of its older inhabitants speak their native language with a dialect which is very different from the English spoken in the area.

It is here, and only here, that the Gaelic language is spoken, and it is a very beautiful language. Wonderful enthusiasts from all parts of South Tipperary are on holiday in Newcastle at the moment, and certainly the air of the locality seems to have been re-created there once more.

STOCK.

There was a decrease in stock of 56% values this year. The number of books read in 1939 was 2,576, as compared with 2,006 in 1938. The total stock is now 20,504 as compared with 21,089 at the end of last year.

CARRICK-ON-SUIR DISTRICT COURT.

(Held on Monday, before Mr. F. J. McCabe, D.J.)

MOTORING OFFENCES.

Guard Geasley, Glenbowser, v. Patrick Nolan. Defendant was summoned for having driven a car that was licensed and insured in his brother's name and was registered "owner driven."

It was stated that Guard Geasley was on sick leave and could not attend court.

Mr. Quirke said as his client was admitting the charge, the absence of the Guard would make no difference. Continuing, Mr. Quirke said defendant works with his father and his brother as builders. When he drove the lorry on the occasion he did not admit to the fact that it was registered "owner driven" and was insured in his brother's name.

Patrick Nolan, the defendant, bore out Mr. Quirke's statement. At the time he drove the lorry arrangements were being made to have the licence and insurance adjusted. Witness did not think he was committing an offence.

Justice—Did you know you were not covered by insurance?

Defendant—I did not think it was an offence to drive in the circumstances. I thought as it was insured in my brother's name it would make no difference.

Justice—You had committed one of the most serious motor offences you could have committed. If you had had an accident, some poor widow and children would have had nothing to get from the insurance company.

Defendant—I did not intend to drive again until everything was put right about the insurance. We were engaged adjusting it.

Justice—But you should not have driven on that occasion. I have sent people to jail for having driven uninsured cars. I regard it as a very serious offence.

In reply to the Justice, witness said his wages were £4 a week.

Mr. Quirke said the father and two sons carry on business as builders.

Justice (to defendant)—Are you married?

Defendant—I am, sir.

Mr. Quirke—He has a large family.

Justice—Have you a driver's licence?

Witness handed in his driver's licence.

Justice—I take a serious view of your having driven this car uncovered by insurance in your name. I fine you £3, and I shall endorse your driver's licence.

DANGER OF COMING FROM BYE-ROAD.

Patrick J. McGrath, Carrickbeg, was summoned by Supt. Donnelly, Tramore, for dangerous driving of a motor car at Ballygarret, Portlaur.

Mr. Binchy appeared for defendant.

Mr. A. R. Farrell, solr., said he had a watching brief on behalf of Mr. Moloney, a motorist who had been mentioned in the case.

Mr. Binchy said his client admitted that he did not slow down as much as he might have done when coming from the bye-road to the main road. He blew his horn as a precaution.

Supt. Donnelly said defendant drove straight across the main road and closed the road completely. Mr. Moloney, who was coming along on the main road, had to run into the fence to avoid striking Mr. McGrath's car. There was no other alternative.

Mr. Binchy said that owing to the conformation of the road at the place in question Mr. McGrath could not have seen Mr. Moloney's car, nor could not have a view of the main road.

Justice—The other car was entitled to the road. The man did a very dangerous thing to come on as he came from a bye-road. When a motorist is coming from a bye-road to the main road he should act as if he knew there were twenty motor cars on the main road where the bye-road farms at. It is by carelessness in coming from bye-roads that many lives are lost in motor accidents.

In reply to the Justice, defendant said he makes his living by driving his car for hire.

Justice—It is all the worse offence because you are a professional driver.

In reply to the Justice, defendant said he has not been doing much driving for hire recently, as the weather is bad for Tramore and such places. He has been driving 13 years and has never had an accident.

Justice—I am surprised at that. Men who act when driving as the Supt. has described, are a public danger. He asked defendant how many times a week he would be hired to drive a car.

Defendant—Once or twice.

Justice—Are you married?

Defendant—Yes, I have four children.

Justice—I fine you £2 and endorse the conviction on your driving licence. You are getting off very lightly.

UNLICENSED CAR.

John Holden, Graignamanagh, was summoned for having driven an unlicensed motor car. The case was adjourned at last court.

Mr. Binchy, for defendant, said his client sold the car to Mr. Holloway, of Carrick. The car had not been in use for some time. The car was driven to Carrickbeg by a friend of defendant's. It was sold in Carrick to Mr. Holloway for £15.

Defendant, at Holloway's request, drove the car a short distance when he was stopped by a Guard. The car had not been insured by the defendant. It was Mr. Holloway's intention to insure the car and pay the road tax.

Justice—The car has not been insured or licensed?

In reply to the Justice, Mr. Binchy said defendant (Holden) is a dealer in a small way. He cycled from Graignamanagh that day.

In reply to the Justice, defendant stated the annual tax on the car is £16.

The Justice fined the defendant three times the tax, mitigated to 2/6, for not having the car taxed; 2/6 for not having a driver's licence, and £2 for not having the car insured. He gave him two months to pay the fine.

The following four new centres were opened during the year:—Dungarvan Boy Scouts; Crehana; St. Augustine's, Dungarvan; and Glangarra. The total number of centres in operation to date is 69.

JUVENILE READING.

The considerable increase in juvenile reading leads us to reflect on the particular problems which the supply of suitable children's books creates for Irish Libraries, and which formed the subject of Fr. Stephen Brown's paper at this year's Library Conference, at Castlebar. We confine our remarks to books written in English.

The supply of children's books by Irish authors, having a definitely Irish atmosphere, is infinitesimal compared to the demand. Therefore Irish Libraries are obliged to draw upon other sources of supply. This results in the circulation of a large number of books whose background, atmosphere and whole scale of values is very distant from our national, cultural and religious aspirations, having no relation to everyday life in Ireland, sinking no roots in the national soil.

As the publishing of books is necessarily a commercial undertaking, it would seem as if Irish Libraries, with an insoluble problem in this question of children's reading. A small population produces a correspondingly small number of authors, and if sales are purely regional it is difficult for publishers to dispose of a sufficient number of volumes to recoup their initial expenditure. The only hope seems to be in the increase of the number of Irish authors writing children's books and a determined and organised effort on the part of Irish publishers to push their goods on every English-speaking market.

REQUEST CARDS.

Our system of specially printed Request Cards, first introduced this year, has proved very successful. However, we would like to see a more widespread use of these cards so that informal lists would be altogether replaced. This would greatly facilitate filing work at Headquarters, and ensure a more expeditious handling of special requests. In this connection we wish to point out that requests for general works are always given priority over requests for fiction.

CARE OF BOOKS.

Recent heavy withdrawals of fiction from stock are to a considerable extent due to the negligence of certain borrowers in their treatment of library books. Popular works of fiction, sometimes at the end of three or four months have been so badly mishandled that they would be altogether replaceable. This is a very serious matter, as it is impossible to retain them for circulation. This throws an undue heavy strain on our already overburdened resources and reduces the supply of books available. It is in the interest of every borrower to take special care of Library books, which are the common property of all the ratepayers. Those who are indifferent as to whether the books are clean, free from filth, worn or well preserved, should remember that a very large proportion of the borrowers do appreciate clean and well-cared-for books, and furthermore that they have a moral obligation to take all due and reasonable care of common property.

CATALOGUES.

Last year three Catalogues were issued, one complete catalogue of Irish books in stock, a complete catalogue of books in the Useful Arts section, and a select list of Catholic works on Sociology.

We hope next year to issue an up-to-date catalogue of the Biography, History and Travel section of our stock of General Works. The catalogue is at present in course of preparation, but owing to pressure of routine work its completion is retarded. This is mainly caused by the fact that long journeys have to be made by the Library Van, as Headquarters is not centrally situated. This results in a considerable loss of time and an unnecessary deterioration in the Library Van.

READING.

In the general section books of travel, biography and history, accounts of flying aces, personal accounts of adventures in the Great War, continue to head the list of favourites. The demand for books on very recent European history is very considerable. Apparently borrowers have not yet despaired of piercing the veils of propaganda which shroud the truth, and have to content themselves with imaginative expositions of biased history.

The lighter type of fiction is still the choice of the majority of readers, though there is a tendency amongst many to escape from the rut and adventure into the field of the more literary novel. In order to encourage this tendency we have adopted the policy of duplicating the more important novels, as much as possible, and also when dealing with replacements of worn stock, to reject the purely ephemeral and restock only those of some literary value. All novels dealing with Irish life are restocked as of course the supply of such books is very scarce, and the pocketed of them have at least the value of being local in atmosphere. However poor they may be they can scarcely fall below the level of some of the cross-Channel pot-boilers.

Our collection of books in Irish, which constant additions are made, are greatly in demand, and teachers have found our section of children's books particularly useful. The number of children's books in simple

WATERFORD CITY MANAGEMENT

In the Seanad on Wednesday, Mr. O'Kelly, Minister for Local Government, moved the Second Stage of the Waterford Management Bill, 1939, which, he said, was to extend to the City of Waterford the system of city management already in operation in Dublin, Limerick, Cork, and Dun Laoghaire.

Mr. J. G. Douglas said he thought it was a matter for satisfaction that a Bill of that kind could receive the support of all sections. He took it that there was no local objection to the measure.

Mr. S. Goulding said that so far as he was aware there was no opposition in Waterford City. Although he could see in that type of measure the danger of the introduction of the thin end of bureaucracy, he admitted that for the purpose of efficient administration such a measure was essential.

Mr. Butler welcomed the measure and said he believed the citizens of Waterford were satisfied with it.

The Minister, replying, said that the principle of management in boroughs had been generally accepted as a good principle and had been pretty widely extended in the past few years. On the whole, the system had worked satisfactorily.

The Second Stage was agreed to, and the report stage was fixed for Thursday.

Mr. P. F. Baxter said that the country districts had rates higher by £322,000 than in 1932, and there was no additional relief rates coming from the Government although much of this increase was due to Government policy.

In addition the capacity of the taxpayer to carry the burden was not nearly what it was in 1932-33. The predecessors of the Minister had given a larger grant than at present, and the Minister had changed the basis of administration so that the grant was forthcoming on the amount of employment given. The fact was, however, that the number of males employed on the land was 43,000 fewer than when the scheme was brought in. Yet the Minister proposed to make permanent a scheme that had this result.

What the Minister should try to encourage was greater and more efficient production and his present scheme did not do that.

This scheme gave relief to a type of farming that should not be encouraged.

THE RATES RELIEF BILL

WATERFORD T.D.'S REFERENCES.

In the Seanad on Wednesday, Mr. O'Kelly moved the Second Stage of the Rates on Agricultural Land (Relief) Bill, which, he said, was a permanent measure on the lines of temporary measures at present in operation.

Mr. J. Butler (Waterford) drew attention to the position of farmers with agricultural land within the urban areas. They got no relief, and sometimes had to pay three times the rates their neighbours in the rural area might have to pay.

Mr. Goulding (Waterford) said the fact that certain people could "get away" with not paying their annuities was not an incentive to others to pay their rates.

SOUTH TIPPERARY GAELTEACHT.

A praiseworthy enterprise commenced this year was the founding of an Irish language movement at Newcastle, County Tipperary. This pretty village, which is situated close to the Ballymacarbery district in Co. Waterford, is the centre of a Breac-Gaelteacht area, and many of its older inhabitants speak their native tongue with a bias which might be envied in Ring or the Dingle Peninsula. The Gaelic spirit is there, and only needs attention and a little assistance to blossom in a practical fashion. Youthful enthusiasts from all parts of South Tipperary are on holidays in Newcastle at the moment, and ceiliidhe are in full swing, so that the old atmosphere of the locality seems to have been recaptured there once more.

Irish published each year is very small, and it is consequently impossible to build up a really varied selection. This defect is somewhat counterbalanced by constant change in the school population, but still leaves a very restricted field of choice.

STOCK.

There was a decrease in stock of 583 volumes this year. The number of worn books withdrawn was 2,136, and 1,553 new books were purchased. The total stock is now 20,506 as compared with 21,089 at the end of last year.

BORROWERS.

There was an increase of 218 borrowers during the year:—Adult Borrowers, 6,516; Juvenile Borrowers, 2,562; Total, 9,078.

BOOK ISSUES.

The total number of issues for the year, according to available returns, is 124,083. 1937-1938, 123,070; 1938-1939, 134,083.

DR. HYDE PAYS SURPRISE VISIT TO RING COLLEGE.

He also addressed the assembled nuns and complimented them on their meritorious work.

As he bade "slán libh go leir" those assembled sang the National Anthem and amid further enthusiastic applause the party sped on their way with the cheers of the students ringing in their ears.
