KILLEAGH PAST AND PRESENT

Samuel Lewis in the Topographical Dictionary of Ireland, described Killeagh as "A post town and parish in the barony of Imokilly, County of Cork and province of Munster. Ten miles west from Youghal and 114 (S.W. by S) miles from Dublin on the nearest road from Cork to Youghal, containing 17,785 inhabitants, of which number 698 are in the town."

A current is said to have been founded here in the seventh century by St. Abban, near the spot now occupied by the parish Church. The town consists of one regular street containing 112 houses, and is neatly built. It is a consistorial Police Station, and has a sub office to Cork, Youghal and Castlemartyr. Fairs are held on June 1st and Nov. 1st, at which a great quantity of livestock is sold.

A court is held for the manor of Inchiquin, the jurisdiction of which extends over the parishes of Killeagh, Ardagh, Danganovon and Clonripnet. The water of the river Dissour which passes by the town, is high repute for its bleaching properties. The parish comprises 5,800 statute acres, as rated by the county assessment and valued at £4,495 3s. 4d. per annum, of which a small quantity is bog. About 400 acres are woodland and the remainder is arable land, of good quality and well drained. Sea sand and seaweed are used as manure and there is an abundance of peat for the poorer classes. The principal seat is Ahadoe House, the residence of Sir Arthur de Capell Brooke-Barr. Not more remarkable for its natural beauties than for its having remained in the same family for more than 600 years. While nearly all the other estates in the South of Ireland have been confiscated, it was granted in 1172 to Philip de Capell, and is called "The Maiden Estate" to distinguish it from the numerous forfeited properties in the vicinity. From its elevated situation it commands beautiful views of the distant ocean, while the deep wood of Glenbowee, which is one of the few remnants of the ancient forests, lies stretched below. This romantic glen, which is thought to be equal in beauty to the elaborate Wicklow Dargle, commences above the town of Killeagh, and winds upward for some miles until it is lost in the mountains. Its precipitous sides are thickly wooded and winter dashes along with all the fury of a mountain torrent, fully justifying the name of "Glenbowee" or the deafening valley.

The present house is about 3½ miles from the sea and is situated on a site has been selected with great care, and a fine view of the sea, and the mountains, has been opened by the present baronet. This road which passes over a deep ravine by means of a neat iron bridge—commands some delightful views among which are the magnificent prospect from the Warren Hill. The Baining House Glen, the Fox's Bog, and the Upper Cascades. In the grounds is a luxuriant vicararia or bladder nut tree. Also an ancient Sycamore of great size. From the seat of Roger Green Davis Esq. (Now owned by Mr. Patrick O'Mahony, late of Berrine, Co. Cork) it consists of a centre and two wings, ornamented with Doric columns, and with a portico at the eastern end.

This handsome mansion, which was completed in 1839, is near the summit of an eminence from which a splendid prospect is obtained of the county extending to Youghal, with its fine bay and to Capell Ireland. There is also Mount Uniake, the seat of the Norman Dunlake. It is an ancient family mansion, situated near the mountains which have been brought into cultivation, and is surrounded by a grove of fine trees, and some- times extensive views of the sea and the vale of Imokilly (This mansion was destroyed by fire during the Civil War period in Ireland).

In the Roman Catholic divisions this parish is the head of a union or district comprising also the parishes of Danganovon, Ardagh and part Clonripnet, and contains two churches, one at Killeagh and the other at Inch in Ardagh.

A castle—said to have been built by the Carews, formerly existed here, which was charged in 1844 with an annuity to William Skiddy, Mayor of Cork.

There is a rock of red clay formation rising like a pyramid and nearby covered with moss and plants, and there are also some extraordinary subterranean caverns in the district.

KILLEAGH 1939. The little town of Killeagh, so picturesquely situated at the gateway of lovely Glenbowee is one of the truest, prettiest and most progressive towns of its size in the province of Munster, it not in all Ireland. Everybody has heard of the beauties of Glenbowee Wood and hundreds of young people from the counties of Cork and Waterford go there year after year on the first Sunday in May to take part in the merry-making that is always carried on practically from dawn till dark. Just across the street—right opposite the wood gate important hurling matches are usually in progress on May Sunday, and these add considerably to the day's enjoyment.

The Catholic Church, which stands at the northern end of the town is one of the most beautiful in the Diocese of Cloyne both externally and internally, and is a fine specimen of the Gothic style as the way to Youghal or to Cork seldom fail to spend some moments in silent prayer in the sacred edifice. Right beside the church is the residence of the Parish Priest, Very Rev. P. O.C. Sheehan, P.P., who has just celebrated the Golden Jubilee of his ordination, and who was the recipient on the occasion of congratulatory messages from all over Munster, as well as from "lands beyond the sea."

In striking contrast to the beauties and grandeur of the church are the schools which stand in the foreground and are low-roofed and small-windowed. Steps are at present being taken to have new and commodious schools built, not alone in the town but in the country districts also. There are many important business establishments in the town and these include the well-known grinding mills of Messrs. Ronsayne. The Saw Mills and Hurley making factory of Mr. P. O'Mahony, where hurleys for many of the Munster teams are manufactured. The well-known bakery, provision and general warehouse of Messrs. Lynch. This enterprising firm had the distinction of winning first prize and numerous other prizes for the quality and all round excellence

WHY SOWS FAIL TO MILK WELL. One of the commonest enquiries I receive in connection with the failure of a sow or gilt to milk adequately after she has farrowed. Usually the query reaches me when the litter is one to two weeks old, and it is then, in fact, generally too late to be of much assistance.

It is a common belief that milk supply depends directly on the food consumed while suckling, and while to a certain limited extent this is true the real position is more complicated. If a sow has a really poor milk supply a week after she has farrowed it is going to be difficult to improve the situation sufficiently to ensure weaning a satisfactory litter merely by putting her then on to an improved ration.

Another opinion is that milking capacity is all a question of breeding, and that when a sow does not milk well she is merely showing up her hereditary capacity as it should be culled at once. The capacity to milk is certainly inherited, and some breeds and strains do milk better than others, while a few individuals milk well however they are fed, within certain limits. In the majority of cases what is inherited is the capacity to produce a good milk supply provided the feeding is adequate.

Others know of cases where sows will never milk well, however well they are rationed. The experience of most observers is that during the earlier part of the in-pig period there was little demand made on the dam for feeding the young, growing foetuses. Then, later on in pregnancy, the increase in size of the litter did make a considerable demand on food supplies. Finally, after birth, the supply of milk required for the provision of a heavy and constant food supply.

In one respect this construction is proved correct from observation, because gilts which are reasonably well fed do not stop growing while in-pig, but no amount of special feeding is sufficient to make up for the deficiency. It is not so long ago that we became accustomed to the expression "cleaning up." This, of course, simply meant that a cow was being fed at a rate greater than the actual need for the growth of the foetus so as to lay up a reserve which would provide for a successful lactation later on.

In much the same way, there is reason to believe that it is sound practice to feed a sow or gilt well from the time of service, because although the early period may not make heavy direct demand, the laying up of a reserve is a natural and necessary method, and prevents a drain on tissues, which ought not to be called in for this purpose. The feeding has been well looked after in this way it is unusual to have trouble with the milk supply.

The principle of reserves, however, is not so simple as it seems. The most information is collected the more the effect of previous attention becomes apparent. It is even coming to be realized now that the feeding of a parent or possibly a grandparent can have an effect on the reproductive capacity of a pig.

I can remember much being made of the statement that acquired characters cannot be inherited, but the never knowledge about feeding is showing that serious deficiencies in one generation may result in the next. It is not surprising that some interesting experiments carried out on successive generations of pigs have shown a marked deficiency of either protein (fresh-forming food) or lime had a cumulative effect, and that after two or three generations serious consequences would result.

When the rations were short of protein the pigs were stunted and grew slowly, the females took a long time to come on heat, but once they had been served they farrowed fairly normal litters and their milk supply was fairly regular.

On the other hand, when the rations were short of lime the pigs continued to grow more or less normally, and there was no interference with breeding. Nevertheless, in addition to many accidents due to weak bones, the milk supply of the lime-deficient gilts and sows became progressively worse and the number of pigs born dead increased. Over four generations of pigs born dead in each successive generation was 4.8, 8.8, 28.3 and 50 per cent.

The important point to note here is that this rapid rise in mortality was clearly associated with a number of other symptoms which were observed, including a continuous decrease in the size of the litters both before and after farrowing. In the last generation there were practically no live piglets and the piglets that were born were very small.

The fact that all litters are fed under similar conditions after 10 weeks old can not eliminate the effect of nutrition during pregnancy, or the effect on the milking of the sow of her family nutritional history.

The best way to cure a poor milk supply is not to let it occur. The first thing to do is to get the sow out to a nice laxative diet with plenty of bran in it. If at all possible, she should be turned out on to the best available piece of grass, even if it is in winter. Her ration should contain at least 10 per cent, and for a time preferably 15 per cent, good protein and mineral concentrate. It is absolutely essential that this should contain plenty of lime.

Other reasons for sows not milking well are chills on the udder, though this usually follows a too-heavy stocked udder rather than an underdeveloped one, and injury to the teats, though I consider that this is usually over-emphasised. Excess of sugar-beet pulp seems to be associated with poor milk supply, while excessive feeding of mangolds will produce so much milk as to be unwise and invite chills and inflammation.

On Friday, a mistake there cost his country the Aga Khan Trophy, and on Saturday he had another interview with the most formidable obstacle on the course when his mount, Schneeman, did a somersault at the bank and left Rittmeister stretched on the turf.

HOME-GROWN FOODS SPECIAL VALUES OF WHEAT BYE-PRODUCTS. Among home-grown foods, wheatfeeds, such as bran, weatings and superfine weatings, are referred to by Dr. H. E. Woodman in the third revised edition of the Bulletin on "Home-Grown Feeding Stuffs."

A large proportion of the ash, fibre, oil, protein, and vitamin (B and E) originally present where wheat kernel found its way into the wheatflour. This was all to the good from the standpoint of the nutrition of farm animals receiving three by-products in their ration.

Apart from its palatability as a constituent in rations for bullocks, dairy cattle, horses and sows, "the well-known dietetic qualities of bran lead to a high demand from feeders for this wheat by-product. It possesses special properties that make it valuable for maintaining the health of cattle and horses," says Dr. Woodman.

It was rich in vitamin B. and E. and when fed in the dry state tended to prevent scouring, and when mashed in warm water was a mild laxative. Weatings was one of the most popular of all foods for inclusion in the rations of porkers and baconers. It had a higher feeding value and was less fibrous than bran. Superfine weatings had the highest feeding value and contained the least fibre.

Wheat germ meal was a protein-rich food containing about 32 per cent. protein, and about 9 per cent. oil. It should prove, Dr. Woodman concludes, a valuable food for inclusion in moderate amount in

NEW EGGS ACT.

The Minister for Agriculture has made an order under section 1 of the Agricultural Produce (Eggs) Act, 1939, appointing the 1st September, 1939, as the day on which the Act will come into operation. On the same day, the regulations made under the Act (entitled the Agricultural Produce (Eggs) Regulations, 1939) will come into force and the Agricultural Produce (Eggs) Acts, 1924 and 1939, together with the regulations made thereunder, will be repealed.

As from the 1st September next all persons engaged in the acquisition of eggs for sale by wholesale, that is, to another person for resale, must be registered in the register of wholesalers. If their business consists of the acquisition of eggs for sale to registered wholesalers they must be registered in the register of dealers.

On and from the 1st September, 1939, wholesalers and registered dealers must pack all eggs acquired from producers in approved packages supplied by approved manufacturers, a list of whom may be obtained from the Department of Agriculture. All eggs so acquired must be packed in the manner and with the packing materials prescribed by the regulations, and a ticket containing the prescribed particulars must be associated with each producer's lot of eggs when packed in the manner prescribed.

All persons who immediately before the 1st September, 1939, are registered in the register of exporters kept under the Acts of 1924 and 1939 will be deemed without prior application or payment or registration fee to be registered provisionally in the register of wholesalers, but such provisional registration may be either confirmed or cancelled according as the premises are found on inspection to comply or not to comply with the statutory requirements. Persons engaged or proposing to engage in the business of acquiring eggs for export or sale to retailers in Eire, and who are not immediately before the 1st September, 1939, registered in the aforesaid register of exporters, should write to the Department of Agriculture for the prescribed form of application for registration in the register of whole.

A separate application must be made in respect of each premises which is proposed to register. A memorandum explaining the provisions of the Act as they affect registered wholesalers may be obtained on application from the Department of Agriculture.

Persons engaged in the business of acquiring eggs for sale by retail are directly affected in several important respects by the Act and regulations made thereunder. They are required to examine whether 48 hours after they have been acquired. They are required to mark eggs which are second quality as defined in the regulations with the words "Second Quality" in the manner prescribed. It will be an offence for any retailer to sell or to expose for sale or to consign any second quality eggs unless they are marked in accordance with the regulations, and it will also be unlawful for him to have any second quality eggs in his possession after the lapse of 48 hours from the time of their acquisition. The regulations further provide that (save as hereinafter mentioned) all eggs acquired from a producer and retained must within 48 hours after acquisition be marked in the prescribed manner with a code-mark to indicate the period during which the eggs were acquired on his premises. This requirement does not apply to eggs which have been clearly and legibly marked in durable ink by the producer on whose premises they were produced with the name of those premises and the date on which they were dispatched.

A memorandum explaining the obligations of retailers, under the regulations, may be obtained on application to the Department of Agriculture. Copies of the Act and regulations may be obtained from the Government Publications (Sale) Offices, 34 College Street, Dublin, or through any bookseller. Price 1/2 net and 8d. net respectively, postage extra.

Co. Cork Girl Deported.

A pretty Irish girl, Miss Catherine Roche who has been working in London for some twelve years as a waitress, and more recently as a cafe cashier, has been deported under an expulsion order signed by Sir Samuel Hoare, the Home Secretary.

Miss Roche, who came from Co. Cork, was a prominent member of the Irish Club at Blackfriars Road. Three months ago she was interviewed by the manager of a branch cafe at Holborn where Miss Roche was employed as cashier. The cafe is one of a chain owned by a famous firm. A few hours afterwards the girl was dismissed without notice. No reference was given to her, and her efforts to get similar employment with other firms was unsuccessful.

It is understood that Miss Roche was prominent in collecting funds for the support of the wives and dependents of the thirty-three Republican prisoners who are held without trial in Belfast Jail, and also on behalf of the dependents of the Republican prisoners in the British jails.

DUNGARVAN 200 YEARS AGO.

(Continued from last week).

There are 16 Town Commissioners, elected by the rate-payers, for the purpose of business on the cleaning and lighting of the town. They are also roads and harbour commissioners under the "Dungarvan Harbour, Markets and Improvement Act," passed in 1863, to improve the port and harbour thereof; to vest the markets of the town in the town commissioners, and to enable them to extend and regulate the same; to transfer from the Grand Jury of the county to the said commissioners, the management of the roads and bridges in the said town, and to carry out other improvements. The commissioners meet for the transaction of business on the first Monday of each month. Any male person of full age—being the occupier of premises within the township, of the yearly net annual value of twelve pounds sterling—is qualified to become a commissioner. The present Chairman of the town commissioners is Mr. Michael Arthur Anthony, of Ringville, and the present Borough Justice is Mr. George Fitzmaurice of Tournure-House. The exports are chiefly grain, butter, pigs, cow-hides and pitwood. The value of the business on the first Monday of each month in 1869 was 311. The rateable valuation of the Parliamentary Borough is £13,770. The property and Income Tax, for the year ended 5th April, 1863, amounted to £664. The Poor-rate, on the electoral divisions of Dungarvan, in 1869, was six shillings in the pound, being the highest of that of any other Union in Ireland. Dungarvan formerly had the name of being the cheapest town to live in throughout Ireland, and as an instance of this we give the prices of some articles—beef, 9d. per lb.; mutton, 10d. per lb.; bacon, 11d. per lb.; hams, 1s. 1d. per lb.; eggs, 1s. per dozen; potatoes, 8d. per stone of 14 lbs.

The castle of Dungarvan was built by King John and probably it was the same prime fortified town, enclosing it with a wall, having towers and bastions. The castle and fortifications having gone to decay, they were repaired in 1463 by Thomas, Earl of Desmond, to whom, as we have before stated, the customs of the town were delivered, to be appropriated to that purpose. The walls and towers are long since removed, but the ruins of the castle and its fortifications are still to be seen, forming a part of the military barracks. This place of defence was placed on the interior of an oblong fort, which was regularly fortified and mounted with cannon—some of which are there to the present time, and it was also protected by circular towers at the angles. The external defence was approached by a narrow passage between two battlemented towers, at the extremity of which was the entrance or keep, a narrow towerlike building, flanked on each side by circular castles. The gateway, which is very narrow, opens into a small quadrangle, and there are recesses, space from the gateway, and there are the masonry walls—probably intended to project those who were there to annoy the assailants. The interior building, or castle, was elevated some few feet above the external fortification, and was in itself capable of resisting an attack, even after the loss of the outer works.

There was formerly a well within the enclosure, but it is now filled up, the water being brackish.

The site of the castle was until lately the property of the Duke of Devonshire. It is now belonging to the Government, who have a fine military barracks for the garrison of the town. It is a modern building, and planted as it is in the centre of an ancient and venerable fortification, looks singularly mean and inappropriate; the soldiers too, with their modern dress and breech-loading rifles, do not harmonize with the appearance around them, and give the idea of being intruders on the property of the heroes of distant times.

None of the town wall now remains, except a small portion to the rear of the house now occupied by Mr. Richard Byrne, at the upper part of Church-street. The circuit of the town wall was as follows—It ran from the sea, near the Church, along the north side of "the dead walk," to Friary Lane or Augustine's Street (formerly called Clubber-lane), down to the house now occupied by Mr. Carbery, in the main street, where was standing until a few years ago; the wall continued down Carbery's lane, in a circuitous route to the military barracks. Where Mrs. Olden's stores are situated was formerly the Passmore House. It gave particulars of the poisoning of Colonel Jones. Near this place was St. Mary's abbey, an auxiliary to St. Augustine's abbey at Abbeyside, from which it is said, there was a subterranean passage, from one to the other, under the river. A portion of the ground, now safe for the erection of the bridge, was an ancient grave-yard, and there are persons living who remember to have seen a few old tomb-stones there. When the workers were excavating for the foundation of the new school house, they turned up several human bones. Previous to the erection of the bridge the town was confined to the portion as stated within the circumference of the town wall, the street now called William-street was then known as Quarry-lane, in consequence to its leading to some large stone quarries in that locality, and it was from this place the stones were taken, used for building the causeway; previous to the year 1800 this street was called Mill-lane, as it leads to a wind mill that was at work in the field now the chapel-yard. The old chapel was then situated where the monastery is now, and among the other improvements effected.

It is not too much to say that Dungarvan is now, with its fine open square and handsome shops, an improving little town.

WORLD GIRLDE OF TALLOW NOTES

Lancashire Could Make 80 Rings Round the Equator. Lancashire's production of cotton cloth is now so extensive that it would stretch eight times the distance between the earth and the moon, according to the latest figures which have just been published. The total output of piece-goods made for sale during 1937 was 3,376,175,000 linear yards, the equivalent of slightly over 3,000,000,000 metres.

The figures are only now available because there is necessarily a time lag before the total production from all sources can be worked out. They are difficult to appreciate, but it may be stated that the yardage of the products of Lancashire looms for the year was sufficient to provide a belt of cloth approximately 80 times round the world.

These figures refer to goods made by cloth manufacturers and do not include there is the yardage of cloth made on commission which would provide another circle the earth once again.

The clearest idea of all, however, can be gained from the fact that the cotton cloth production of this country is sufficient to provide every living soul on earth (according to 1933 estimates) with two yards each if the goods were confined to the British Empire the provision would be eight yards each.

In 1937 Lancashire cotton weavers paid £50,037,000 for their raw materials (prior to the gross value of £84,500,000. The average net output of the 173,595 persons employed was £142 and this last year with £123 in 1938. This last point may be said successfully to refute any claims of Lancashire's loss of efficiency.

FRUIT CROP. The fruit crops in the town and surrounding districts also benefited from the July rainfall, as the orchards now clearly in leaf, apples and pears being in profusion, their glorious colourings and formation being clearly outlined by their green leafy background. New groves in the district has already marketed a goodly portion of his crop in the Dublin market at very remunerative prices, receiving an average approximately 21/9 per barrel, for a 25 barrel lot.

BOARD OF ASSISTANCE

TENDERS TO BE INVITED FOR CO. HOME REPAIRS.

The Engineer reported that after a further inspection of the County Home premises he finds that some of the walls of St. Anne's ward, attendant's dining-room, sisters' kitchen and pantry, the refectory and surgery are very damp, due to very defective external plaster. He recommends that the external plaster on these walls should be renewed. Internal plaster and a new floor are required in the Sisters' kitchen.

The estimated cost of the above work would be £90. Two new windows and new skirting are also required in St. Elizabeth's ward at a probable cost of about £12.

SITE FOR PORTLAW DISPENSARY.

The County Surveyor wrote enclosing Mr. Doyle's report on the above, pointing out that he concurred in the recommendation, and stating that possibly the best site is that placed second on the list—that at the Square or Main Street.

In selecting a site for a public service such as a dispensary, the chief consideration should be the maximum suitability and benefit for the public, and the accessibility and facility for public use.

The engineers' report stated that the most suitable site is that between the Boys' School and Haughton's Cross. There is over an acre in the field, and sewer, water and electric wires are in the road alongside.

The Curragmore Estate is the owner. The next most suitable site is the yard in Main Street. If not of sufficient size, more space could be got by adding some of the field at the back.

The Irish Tanners' Co. Ltd., are the owners. The next most suitable site is that offered by Miss Malcolmson. She offers about an acre of Clodiagh grounds inside the Brown Street-Queen Street corner.

Another possible site would be in the field owned by Mr. White, Knockaun at Flahavan's Lane Cross.

It was stated that in the case of the latter three also, sewerage, water, and electric wires are convenient.

Mr. McCarthy—Isn't the Council available? There's nothing about depriving a man and his milk.

The Chairman said that Mr. Roche was not in order.

After further discussion, Mr. Roche was giving the use of free for the Free Milk scheme, Mr. McCarthy—Can't you get working on August 2nd?
