THE BROOD MARE IN WARTIME

Many of the hunters produced in this country are bred and reared by farmers who keep one or two three-quarter or thorough-bred mares for the purpose. In most cases they are now in foal to Hunter or Thoroughbred sires, and will soon be foaling. The pressing question will then

arise—is one to breed again or not? The modern tendency has been to breed our hunters nearer and nearer to the thoroughbred; pace has become more and more popular in the hunting field generally, and in consequence the type of youngster coming on to the market to-day is proving too light and highly strung for

Since petrol was rationed many second class hunters have been broken in to harness. They now pull their weight in tradesmen's vans, and their market value has, if anything, tended to improve.

It is, of course, impossible to foresee how long present conditions will last, but many breeders are inclined towards leaving mares empty for the duration of the wan and towards risking the fact that they may eventually prove doubly difficult to get in foal again. Regular breeding is a habit; encourage when possible. They also have to reckon on the fact that the mares will be eating good hay and good pasture and giving no return.

There is, however, every reason for believing that horses of all types will be wanted in this country for many years yet. It would be a pity to stop breeding at this time, and to find—as I feel sure we should—that in four or five years' time we have to start once more importing



The examination will comprise questions in Arithmetic, (involving a knowledge of fractions, decimals, percentages and mensuration), English (including Essay and Dictation) and Irish. There will also be an oral examination for the purpose of testing candidates' general knowledge of rural conditions. The standard required generally will not demand higher educational attainments than are usually achieved by pupils who passed the sixth standard in a primary school.

Individual candidates may, if they express their desire to do so beforehand, take the Arithmetic test and the oral examination through the medium of Irish.

WHEAT HAS STILL A GOOD CHANCE.

Many farmers who have not sown the winter wheat they planned propose doing and it must be admitted that it has met with reasonable success due to the favourable seasons. It must be remembered, nevertheless, that it is not a policy which can be recommended, for the success of spring sowing of winter wheat varieties is so dependent upon the character of the seasons as to make it largely in the nature of a gamble.

For later sowing a true spring wheat should be chosen, such as Red Marvel or A1.

Red Marvel produces a large, starchy grain of poor bread-making properties. The straw is medium in length and strength. There is, however, probably no spring wheat that will yield better than Red Marvel.

A1 takes slightly longer to ripen than Red Marvel, but when the land is in good heart it may stand better. The grain is white and, like Red Marvel, of poor breadmaking qualities. Both Al and Red Marvel may be safely sown as late as the middle of March. WHERE THE SEASONS IMPEDE.

April Bearded, as its name implies, should be selected for late sowings, and may be drilled up to mid-April. It does, not, however, crop as well as the varieties previously mentioned, and should, therefore, be considered only where seasonal difficulties have prevented an earlier sow-

It is important in the case of spring-sown wheats to have a good, firm tilth, A greater quantity of seed, too, is required than would be the case for winter-sown wheats because of the poorer tillering powers. Not less than three bushels (that is 13½ stone) per acre should be sown, and many farmers favour a still heavier seeding than that suggested. Having regard to the fact that the grow-

ECONOMISE IN CALF REARING.

Heifer calves for the maintenance of the dairy herd must still be reared, in spite of a diminution of the acreage under grass, higher prices for whole milk and an increase in the price, and a shortage of supplies of good concentrates. The calves must, too, still be given a good start.

Suckling always has been and still is the ideal way to rear a good calf. Even in the rearing of heifer calves in dairy herds suckling can be practised to a limited extent by using as foster mothers any heifers or cows which are fractious, poor yielders or unsuitable for hand or machine milking. Where older cows are used as fostermothers, however, only those with sound udders should suckle heifer calves reared for herd maintenance.

As a rule two calves can be suckled for eight or ten weeks, then a succession of pairs as long as the cow is giving sufficient milk, and thereafter one calf at a time. To make the best use of a nurse cow the calves should be taught to eat a suitable dry food mixture from the fourth or fifth week so that they will suffer the least possible check in growth when weaned.

On milk-selling farms, however, the great majority of the calves reared must be brought up on the pail, and the question often asked is: How little whole milk is needed to rear a dairy calf? Opinions expressed to the writer many years ago were GENERAL MEETING OF more or less agreed that anything from 50 to 100 gallons would be consumed per calf reared.

It is no doubt true that where the milk produced formerly was utilised for the MOST SUCCESSFUL YEAR manufacture of cheese or butter, many had become accustomed to the liberal use of milk in calf-rearing, and they turned to the production of milk for sale.

Some years ago numerous experiments were carried out on the rearing of heifer calves for the dairy herd on the minimum quantity of whole milk.

CLONMEL EX-SOLDIER'S DEATH.

About an hour after having conversed with a resident of the locality on the road at Creggane. Four-Mile-Water, Co. Waterford, on Sunday evening, John Lambe. Glenconnor Cottages, Clonmel, was found D. Shortly after being found he died, and the circumstances surrounding his death were investigated by Dr. McCarthy. Government Department intimating that Coroner, Dungarvan, at an inquest at Creggane on Monday.

Mrs. Mary Lambe, widow of the deceaed. who identified the remains, said her husband was aged 53. He was an ex-soldier, and was a tailor by trade, but did not do any work since he left the army. He was in receipt of a disability pension in respect of pulmonary tuberculosis and neurasthenia, caused by war service. She last saw him alive on Saturday last, when he was in bed all day with a pain at the left of his chest. He had been in poor health. particularly recently. He also suffered from severe headache. Witness was in bed when he was leaving on Sunday morning. and he called goodbye to her. He also

bade goodbye to his daughter. Mr. Thomas Condon, O'Connell St., Clonmel, said on Sunday evening he was returning to Clonmel about 8.50 (S.T.) through Creggane, by motor car, accompanied by his son-in-law, who drove the car. A little beyond Four-Mile-Water Bridge he saw an object on the road. The car was stopped, and witness got out and approached the object, which he found to be deceased lying on top of a bicycle on the road. He was lying full length diagonally across the centre of the road on his left side, and his arms were under him. He was breathing very heavily, and died while witness was present. It was about 20 minutes from the time witness came on the scene until deceased stopped breathing. He remained with the body until the priest and the Guards came.

Richard O'Loughnan, Clashavaugha. Newcastle said he was standing outside (S.T.). He saw the deceased on the road and spoke to him. After a while deceased wheeled his bicycle away in the direction of Clonmel. He walked with the bicycle as far as witness could see. He did not notice anything unusual about the deceased, who was found about 50 yards from where he parted with witness. Witness did not hear any crash, and no car passed until Mr. Condon came along. Earlier in the day deceased complained of a headache and had a bandage round his
