## YEARS AGO

Roger Boyle, Earl of Orrery, fifth son of Richard Boyle, first Earl of Cork, was born at Lismore in the county of Waterford, on the 25th April, 1621. To give a resume of the life of this celebrated character, would. of itself take up a large volume, and as some particulars of his life have already been given in the pages relating to Lismore, suffice it to say that he was the greatest statesman and soldier of the age he lived

Robert Boyle, the seventh, and youngest son of Richard, Earl of Cork, was also born at Lismore in the County of Waterford, on the 25th day of January 1626. He received his academical education at Leyden, and after having travelled through France, Italy, and other countries, learned several languages, and made a great number of curious observations, he settled in England, and spent the the last forty years of his life at the house of his sister, Lady Ranelagh. A catalogue of his works was published in London in 1690. To attempt the character of this illustrious person would be vain and needless.—We shall merely subjoin the following lines from an ancient author, in which mention is made of this great man: Lismore, long since, the muses ancient seat Of piety and learning the retreat.

Her Alma-mater shone as bright as noon As Oxford, Cambridge, or the great Sour-

Who made all arts and sciences his own. Ignatius Brown was born in this county, in the year 1630, but educated in Spain, where in the twenty-first year of his age, he was admitted into the society of Jesuits; Poictiers in 1676. He diedat Valledolid in pointed Chaplain to the Queen of Spain. Valentine Greatrakes, an estated gentleman of this county, was born at Affane in

1628, and was remarkable for the wonderful gift of healing the king's evil, and various other diseases by striking the parts affected, whereby he is said to have performed many cures. He spent all his income on charity, and had hundreds of poor people about his house, waiting for the application of his touch. He himself stated in a letter at the time to the hon. Mr. Boyle, that an inward inspiration informed him of his gifts; that he touched several persons and fully cured them of pains in the head, convulsions, dropsies, and several other distempers. His reputation increased to such a degree, that he was sent for from England to cure a lady of quality, in Warvickshire. As he advanced thither, he was nvited by several magistrates of many towns to pass through the same and cure their sick; and King Charles II being informed of the wonderful gift he had, commanded the earl of Arlington to order him to repair to White-hall Palace, whence he withdrew to Lincoln, whither large numbers, of all ranks and sexes, came expecting the restoration of their health. He did all without payment, or receiving any present or reward. In Lord Orrery's memoirs, in MS., it is mentioned that a Mrs. Lowe was a witness to his curing the falling-sickness and gout, by stroking the

parts affected with his hands. Mr. Greatrakes was in Dublin about the year 1681, but how long he lived after is uncertain. Robert Cooke, an eccentric gentleman who lived in Cappoquin in this county; for many years before he died, neither ate fish, flesh, butter, milk, etc., nor drank any kind of farmented liquor. He died about the year 1726. It is remarkable of this man that he lived to a good old age. He farmed a large tract of country near Cappoquin,

and had several other pecularities besides those mentioned, such as keeping none but white cows, and had his coach drawn by William Congrave, a poet of considerable ability, was born in the county Waterford, where his father was agent over the Earl of Burlington's estates. His majesty King

William ordered him a donation of one hundred guineas for a poem written on the death of Queen Mary. He died at the early age of fifty-six years.

Mr. Charles Keane, the Tragedian, was

born on the 18th January 1811, in the city of Waterford. As an actor, a scholar and a gentleman in the truest sense of the word, the city has produced one of its greatest ornaments in him. He died in 1868.

The Right Hon, James Anthony Lawson, LL.D., Justice of the Court of Common Pleas in Ireland. He was son of James Lawson, Esq., of Waterford, and was born in that city in 1817. He represented the borough of Portarlington in Parliament

## LARGER ACREAGE FOR ONIONS.

Nearly 80 per cent, of the onions consumed in Great Britain and Ireland in peacetime come from abroad. Supplies, valued at about £2,000,060 a year, arrive from Egypt, Spain, Holland and even the Argentine, and it can be said that the imports of onions are over four times as great as the total imports of all other vegetable crops. These figures are given to show the scope for increased production in this

country during wartime.

It is presumed that the reason why the crop has not been grown more is because it is so much attacked by the onion fly

Experiments have shown, however, that if whizzed naphthalene or drained creosete salts are applied along the rows at the rate of 3 or 4 cwt. to the acre before thinning is carried out, and again ten days later, there is no difficulty in keeping the pest away, even in districts where the fly is known to be possistently and Rain of the known to be persistently bad. Rain at the value of this remedy.

LIGHT SOIL PREFERRED. On the whole, onions prefer a soil of lightish texture and good depth. They like the clay loams which are rich in lime and hates, the brick earths and the tertile light loams which have been produced from ancient gravels. The peats, or moss

soils will grow this crop well.

Onions like a well-prepared seil, and must have good drainage. It is advisable to plough the land to a depth of 8in. or 9in., and to incorporate good well-rotted farmyard manure at the rate of 30 to 40 tons to the acre. Manure that has been standing in a heap for two or three years seems to

down to a fine tilth, superpho added at the rate of Bowt, per acre and sulphate of potash at 2cwt, per acre. In the case of the peaty soils the dung may be omitted and the artificials should then be 2cwt. of sulphate of ammonia, 5cwt. of superphosphate and 2cwt. of sulphate of potash. ## SHOCKING ACCIDENT AT BALLYMACMAGUE.

YOUNG MAN FATALLY INJURED.

Bus and Motor Cycle in Collision.

A shocking tragedy occurred on the main Dungarvan-Cappoquin road on Sunday evening last as a result of which a young man named Patrick Whelan, Carrigroe, Dungarvan received such severe head injuries that he succumbed within an hour. The 'bus involved was the 7.10 p.m. leaving Dungarvan for Cork which was driven by Thomas Walsh, and the scene of the accident was at Mr. John Moloney's forge at Ballymacmague where a bye-road leading from the village of Ballincoush joins the main road . The motor cyclist coming from the bye-road came in contact with the bus with fatal result. The tragic occurrence has cast a gloom over the area, and the deepest sympathy of all is extended to the mother and other members of the deceased's family in their great loss.

THE INQUEST. On Monday evening Dr. D. T. McCarthy, Coroner, opened an inquest into the circumstances surrounding the death of Patrick Whelan.

The first witness called was Ml. Whelan, brother of deceased, who replying to Superintendent Walsh said deceased was aged 26 years, unmarried and lived at Carrigroe, Dungarvan. He was a workman employed by the Waterford County Council. (old time) on Sunday 10th, when he left witness's house about 1.15 p.m. on a motor cycle, He had this motor cycle about 4 weeks. He identified the remains as those of his brother.

Replying to Mr. Farrell, solr., witness said the deceased was constantly employed by the County Council. Deceased lived with his mother and another brother who was unemployed. His father was dead. His mother was in receipt of the pension.

Dr. Curack deposed that he saw the deceased on Sunday evening at 7.40 p.m. He was then unconscious and had an extensive injury. Witness arranged for his transmission to hospital. On Monday evening, with the assistance of Dr. Casey he performed a post mortem examination and found that the body was that of a welldeveloped young man about 26 years old. Rigor-mortis was present. There was comminuted fracture of the right parietal bone, the left parietal bone was also fractured with extensive laceration of the brain tissues. There were minor superficial abrasions of the skin of the right arm and both legs. The heart was normal and no other external or internal injuries were The Life-Boat Service and Thoughts on St. Patrick's found. In witness' opinion death was due to shock and haemorrhage due to spacture of the skull and laceration of the brain, To Superintendent Walsh, Dr. Cusack said the head wound would be consistent with a severe impact with a moving vehicle. The inquest was then adjourned sine die.
The remains of the late Mr. Whelan were removed from the hospital to the Parish Church, Dungarvan, on Monday evening.




