DUNGARVAN COURT.

(Held on Tuesday last, before Mr. Justice Troy, D.J.)

Deed for Possession.—The Dungarvan Urban Council sought possession of a house at Cathal Brugha Place occupied by Patrick Morrissey at a weekly rent of 3/6, on which a sum of £2 10s arrears was due.

Mr. P. Walsh, rent collector, replying to Mr. T. C. Williams, solicitor for the Urban Council, gave evidence as to the amount due, and a decree for possession was given.

Mr. Williams, solicitor, said the tenant had made an offer, and if this is carried out, it is their intention not to execute the warrant.

Undertaken Civil Bills.—There were a big number of undertaken civil bills disposed of and decrees granted in all cases. Messrs. T. C. Williams, J. F. Kenny, L. F. Lanigan, and Messrs. Farrell and Morrissey, were the solicitors engaged.

Order for Committal Sought.—Mrs. Maeve Hickey, Ballintaylor, sought a committal order against her husband in respect of his failure to pay £1 5s per week maintenance allowance. Mr. Williams, solicitor, made the application.

Mr. Morrissey (Messrs. Farrell and Morrissey, solicitors) said they were originally in that case and the defendant paid the money through them. He thought they had on hand £8 or £9 which, owing to the issue of this summons, they did not pay out. Mr. Williams, solicitor, said the amount due to September 24th last was £9 3s. 6d. Defendant was supposed to pay every fortnight but does not pay until pressed by the court.

Mr. Morrissey, solicitor, said he thought the amount they had on hand would meet the demand up to last Saturday. The Justice, making an order for two months' imprisonment, with a stay of 14 days, and £1 in costs, by which it would be better for defendant to pay regularly.

Exemption Order for Fair Day.—Mr. T. C. Williams, solicitor, was on behalf of Miss Catherine Fegan, an exemption order.

Dance Licence.—Mr. L. F. Lanigan, solicitor, was granted a dance licence in respect of the Tower Ballroom, Tipperary, for Mr. Timothy Kiely.

Larceny of Bicycle.—Superintendent O'Mahony, charged Pte. John Hickey, 1st Field Ambulance, with (1) breaking and entering a house the property of Mrs. F. Flynn, Cappagh, and (2) stealing a bicycle therefrom.

Mr. Farrell, solicitor, representing the defendant, said they were pleading guilty to taking the bicycle.

Inspector McGonigal, who was acting for Supt. O'Mahony, agreed to withdraw the charge of breaking and entering. He said the bicycle was taken from a store and kept by the accused for three days until found by the guards.

Mr. Farrell, solicitor, said this man was down in the Dungarvan area on manoeuvres with the Army. His wife and children reside in Cappaghin. He got week-end leave and started to walk to Cappaghin. When he got as far as Cappaghin it began to rain and he took shelter in a shed belonging to Mr. Flynn, in which there were a number of bicycles. He took one of these, intending to leave it on his way back, but on returning he found that if he left back the bicycle he would be late, as the troops were moving out early on Monday.

Accused, in evidence, bore out Mr. Farrell's statement and said he had meant to deliver the bike at Dungarvan Barracks.

To Inspector McGonigal, he said he told his wife he got the bicycle in Dungarvan.

To Mr. Farrell, witness said that the manoeuvres took him in the direction of Carrick before he had time to give back the bicycle.

To the Justice, witness said that he had 10/8 a week and his wife and two children 3/6.

The Justice—You did a very foolish thing in taking this bicycle, for which you are liable to imprisonment up to six months' hard labour. He would accept the evidence in this case and impose a fine of £2.

School Attendance Cases.—Guard Enright v. Martin McCarthy, Ballinacorney. Defendant said he kept the boy at home to help with the harvest. He is trying to keep eight of them without a mother. The case was adjourned for two months.

Same v. Patrick Needham, Sarsfield Street, Abbeyside. Defendant said the child was suffering from tonsils and is going to hospital. The case was dismissed.

Guard Farrell v. Kate Morrissey, 48, Cathal Brugha Street, who was summoned in respect of William (13 years 10 months), and another boy, Paddy, who was absent 28 out of 47 days. Complainant said no effort was made to keep them at school. A fine of 2/6 in each case was imposed.

Same v. Bridget Dunne. The case was dealt with under the P.O. Act. **Guard S. MacCustin,** school attendance officer, Ring, prosecuted Sean Cuddyby, 244, James J. Curran, P.O.A. Declan Morrissey, P.O.A. **Lights on Vehicles.**—Guard Giblin

v. J. Downey, 1/-; same v. John Bunfa, Clones, 3/6; Patrick Power, Clones, 3/6; James Walsh, Ballinacorney, 3/6.

Sergeant Vaughan, Ring v. Lena Wall, Fitzgerald Terrace. Defendant said she could not get a candle. She was in Helvick for fish. The P.O.A. was applied.

Same v. Denis Daly, Loughmore. Defendant said he was also in Helvick for fish, and could not get a candle. He tried to get the shop in Cappaghin and Lismore the week before and could not get a candle.

Justice—You got home all right? (Laughter). Defendant—Yes.

The case was dismissed.

Horse Tied to Electric Light Standard.—A fine of 10/- was imposed on Michael O'Mahony, Ballygambon, charged with tying his horse to an electric light standard. Guard Giblin was complainant.

Driving Without a Licence.—A case brought by Guard Begley against Martin Flannery, Mooly St., Waterford, for driving a small public service vehicle without having a driver's licence, was dealt with under the P.O. Act. Mr. P. J. Morrissey, solicitor, said that the defendant, an experienced driver, had just returned from England and had since secured the necessary licence.

Lady Cyclist Charged.—Superintendent O'Mahony charged a young lady named Agnes Rafferty with the dangerous driving of a bicycle at Grattan Square on Monday 27th Sept. John Fraher, Eleanore, in reply to Inspector McGonigal, said that on Monday, 27th September, he was walking across the square from O'Connell St. to Main St. When opposite Rafferty he was struck in the back by a bicycle. He was knocked down and in the fall put out his shoulder. The cyclist was also knocked. She expressed regret for the accident. It was raining at the time. He had to go to Mrs. Slurphy, bone-setter, to get his shoulder settled. He reported the matter to the Guards. He did not want to have anything happen to his girl.

Miss Rafferty said that Mrs. Fraher, in her opinion, was crossing towards Mary St. from the Post Office at the time and that she did not hit him at all, but he walked into the front wheel of her bicycle.

To the Inspector, witness agreed she was cycling with an open umbrella in one hand.

McDERMOTTS DEFEAT KILGOBINET.

McDermotts, 9-5; Killgobinet, 0-1.

At the Gaelic Field, Dungarvan, on Sunday last, McDermotts defeated Killgobinet by 9-5 to 0-1, in the Western junior football final. They have now qualified to meet the winners of Eastern division, which match, between Mount Sion and Fetur, has yet to be played. Pearse (Eastern champions) in the county final. This will be the first appearance of the P. H. Pearse Junior string at Dungarvan, and if Tourin expect to repeat their victory of two years ago on Sunday they will want to be in earnest mood against this P. H. Pearse team, who have won all their matches this year in convincing fashion. P. H. Pearse have been the forefront in junior and minor competition for quite a number of years and this year they claim they are going to take county honours, and they are travelling at full strength.

Tourin, after an absence of two years will be making welcome reappearance at Shannon field where on the occasion of their last visits they gave two sparkling displays against Ballytruckle to win their first junior championship. Screen Walls—Arising from the minutes, the Chairman referred to the screen walls at O'Connell Street.

QUESTIONS IN DAIL. In the Dail on Thursday, October 21st, Mr. Denis Heskin, T.D., asked the Minister for Agriculture if he is prepared to take immediate steps to procure seed wheat for the 1943-44 sowing season as existing seed is worn out and very mixed.

The Minister for Agriculture, replying said—I do not agree with the Deputy's suggestion that our seed wheat is worn out. Growers who persist in using seed from their own crops, which has not been cleaned and may have been stored under unsuitable conditions, cannot expect to get good results. Each year there have been ample stocks of clean seed of high germination available to growers who are prepared to purchase their seed at prices sufficiently high to pay for the services of the seed assemblers. I have no doubt that sufficient stocks will be available again in the coming season. There is no possibility of procuring stocks from outside sources.

Mr. Heskin asked the Minister for Supplies if he will grant an allowance of 1 lb. of sugar per acre to growers of wheat, oats and barley for the 1944 harvest period, as an allowance per acre is needed by growers to cater for their workmen during such period.

The Minister for Supplies, in his reply, said—The proposal to make special allowances of sugar or other rationed foodstuffs to growers of cereals for the 1944 harvest period to enable them to cater for their workmen during that period would involve administrative difficulties of such a nature as to make it impracticable, and for this and other reasons could not be adopted.

CO. WATERFORD COMMITTEE OF AGRICULTURE

At Saturday's meeting of the Co. Committee of Agriculture, Mr. M. F. Walsh presided. Present were Messrs. Mr. S. Harty, Wm. Dowling, D. Coghlan, J. O'Dwyer, Secretary, D. Hurley, Agricultural Instructor, and P. O'Shea, Horticultural Officer. The Department wrote relative to the location of rams to approved applicants under the Committee's Sheep-Breeding Scheme for the current year, asking that arrangements be made for the purchase of suitable rams from the following breeders: Messrs. G. Bell, Curraghmore; J. Brett, Cappanacah, Cahir; D. Ryan, Whitechurch, do; J. Gavin, Tincur, Ballyjooby; F. Dunford, Bohadon.

The Secretary said the applicants had all been supplied now. The Department approved of the following provisional allocations for the year ending March 31st, 1945: Poultry Stations scheme, £819; Live Stock scheme, £2,230; subsidies to show, £185. Further communications will be addressed to approved allocations for the Day-Old Chick scheme.

A list of the approved cow-testing associations operating in the county under the provisions of the scheme for the registration of non-pedigree dairy cattle was received as follows: The Department; 13 associations, 202 members, 2,424 cows.

A copy of a letter received from the Department by the management of Mr. Congreve's lime works, relative to a recent enquiry by that firm stating that there were no funds at its disposal for the reconditioning of lime-kilns, repairing of roadways or building houses for agricultural workers. It stated, however, that under certain circumstances and subject to approved conditions proposed for the award of grants for the repair of lime-kilns put forward by County Committees of Agriculture, they considered by this Department.

After some discussion the matter was adjourned to a larger meeting of the Department, as there was no change in the Seed Potato Development Scheme, 1943-44.

The Chairman thought this was a matter for the Department.
