Mr. T. McCarthy, Chairman, presided at the meeting of the Dungarvan Urban Council on Friday. Also present: Messrs. T. A. Kyme, L. A. Veale, J. Dahill, M. Morrissey, T.D. Chairman, Mr. C. J. Murphy, hon. sec., Parish Council, wrote forwarding a cheque for £25 17s. 3d. portion of the Carnival proceeds, for the Children's Health Committee.

Turf Complaints.—A letter signed by Mary Atridge, Cathal Brugha Place, was read, in which she stated that she received 1 cwt. of turf, paid for by the Council, containing "15 stone of turf and the rest dirt," on November 18, from the contractors, Messrs. A. Moloney & Son, Ltd. She took it back to the contractors' yard, having first shown it to a Council member, Mr. L. A. Veale.

Continuing, the writer stated that she complained to Captain Whelan about the turf, and he, she alleged, told her "to take and dump it in the yard."

The letter continued: "What is the use of having the name of getting 'free' turf if we get a bag of dirt that is only fit for the garden? Why, I have already got a barrel of dirt from Moloney's turf. Several people getting the 'free' turf could send in a similar complaint, if they only would send to you instead of grumbling between themselves. I think it's a shame that someone responsible does not inspect what the poor people are getting and what is being paid for."

Mr. Morrissey, T.D. asked was there any check on the quality of the turf going out to these people.

The Chairman said that all he was told was that a ticket was issued to them.

Mr. Morrissey pointed out that the Minister for Local Government and Public Health had stated that these people should get the best quality turf. He thought that an inspection of the turf should be made periodically, to see that these people get the best quality turf—not dirt. He thought these people were entitled to the best.

Chairman—It's a shame the way these people are being treated regarding the turf. One cwt. of turf is not equal to a half cwt., because it is nearly all water. It's like wet sods. Other people can get a good enough, but these poor people are not being treated fairly at all. Turf is being thrown to them, like you would throw it to dogs.

Mr. Dahill—It's the same we are all getting.

Chairman—It isn't, Mr. Dahill. I can prove it. They're supposed to get free turf; it's dirt they're getting.

Mr. Dahill—It was hard to dig it. It was a bad summer to save it.

Chairman—That isn't any excuse. They didn't try to save it. I think there is plenty of turf saved and these people are entitled to it.

Mr. Morrissey—Did any other people make complaints? I think the Council agreed to Mr. Morrissey's suggestion to recommend to the Manager that periodical inspections of the turf be made.

Prices of Turf.—Replying to the Council's letter re prices charged for turf and potatoes in Dungarvan, the Department of Supplies wrote stating that the matter was under consideration by the Department.

Mr. Kyme said he hoped something would come out of it. The fault was in declaring this area a turf area.

Repairs.—Requests for repairs were read from tenants in 19, Keatinge St., 21, 23, 25, Loughmore, and 28, do.

Acknowledgments of votes of sympathy passed by the Council were received from Mr. Edward Kirby, Shandon, and Mr. Wm. Morrissey, Square.

Sympathy was expressed with Mrs. Butler, Main St., on the death of her uncle, Sergt. Liddane, on the death of his sister, Mr. B. Arigan, Abbey-side, on the death of his sister, Mr. Marty Walsh, Shandon, on the death of his wife, Miss M. Conneely, Abbey-side, on the death of her sister, Mr. R. McGrath, St. Carven's Tce., on the death of his brother, and with the relatives of the late Alice Deas, Square.

Re Deelish Dam and Completion of Filtration Plant.—The following letter from Mr. J. Bowen, B.E. S.S. was read:

"I am in receipt of your letter of 18th inst. Dungarvan Urban Council, and enclosure. I had already discussed the various matters with Mr. Maconchy. The position now appears to be much improved, and I am quite hopeful that the dam will soon be quite all right and watertight. I do not anticipate any serious difficulty following after the completion of the works as outlined by the consulting engineers, and I think it is best to reserve our observations until these matters have been dealt with. I return letter herewith."

The following letter, from Messrs. Dugg & Walsh, relative to above, was also read:

"We have to report that we have again examined the dam filter plant, the agreed period of 6 months from the time the water was raised in the reservoir behind the dam

having expired. We find that the dam is holding water well, there being a small but steady decrease in the various springs downstream. The interior of the dam tunnel was definitely in better condition than when inspected a couple of months ago, various weeps having taken up, and there are now only three points on which further observation appears to be required, these being: the roof at the upstream end near its joint with the tower, the east wall half way down from the tower to the centre of the dam, and a slight weep, at what is known as haircrack F, immediately below the puddle core; this latter has decreased in volume, and the indications are that the silt deposit in the reservoir is doing good work in sealing the dam.

From the records of the water levels, it appears that the leakage through the crack F only occurs when the water is within 4-6 ft. of high level, and when the crest of the dam, which was affected by the slip, is being repaired, the contractor may be able to discover and seal the point at which the water must be getting through. We have drawn up a complete list of works for the completion of the contract, both for what is required at the dam and at the filter plant, where two points of leakage were discovered, and we have asked the contractor to put the work of the filter plant in hand at earliest. The mechanical part of the plant was not completed by the makers at the time, as they required the reservoir to be full, and unfortunately they are engaged on war work other than water-works, and have had to close down the department concerned with the latter, so that they cannot now send over an expert to complete the plant.

We have therefore listed out what is required for Messrs. Fitzpatrick to put in hand, including the cleaning of existing and supply of fresh sand, so that when the various items have been completed we will be able to start dosing of the water in order to afford the town a clear supply. We have been promised full detail instructions with regard to this by the makers of the plant, but even if these do not arrive we expect to be able to set it going ourselves.

"With regard to the repairs to the crest of the dam, we think it would be unwise to have the work done in bad weather; the chance might be seized of undertaking it should a lull in the weather appear to be set in; or otherwise it should be postponed until after next spring. Such postponement will not interfere with the completion of the work at the filters, and it will in fact give a further period for observation of the seeps in the tunnel, the improvement of which may continue to develop.

"We have sent a full list of the works to be completed to the Borough Surveyor, for his information."

Following the reading of the report Mr. Morrissey asked was he to take it that the cost would be taken out of the retention money.

Mr. Dahill—What about the £500 spent on the exploratory works?

Mr. Morrissey—We were told that the whole cost is coming out of the retention money.

Chairman—It would be better not to discuss it at all.

Acting Clerk—I can find out.

Mr. Kyme said that after six months they were told they would have a report in six months' time. There was no report, and they were told there would be in a further six months. It was a question of sending the foot farther. It would be well if the Council washed their hands of the whole thing and asked for an inquiry.

Chairman—We asked that before.

Mr. Kyme—I suggest we ask for an inquiry.

Mr. Morrissey—I'm afraid it would be very little use now, in view of the engineers' statement and the B.S. saying it was getting along satisfactorily.

Mr. Kyme said that by the time it was finished it would break the town.

Chairman—A long time ago we asked for a sworn inquiry and it was turned down.

Mr. Dahill—Both the water and sewerage schemes.

Chairman—Yes.

Removal of Town Light.—Mr. Veale referred to the town light in Stran Street, near the sacristy of the Parish Church, and asked would it be possible to have it removed to the pole outside the church gates.

The Council agreed to shift the light to the position requested.

DEATH OF MR. E. O'DWYER, O'CONNELL ST., DUNGARVAN.

The news of the death of Mr. Laurence (Lory) Dwyer, O'Connell Street, caused a painful shock to the people of Dungarvan on Thursday morning when it became known that he had died early in Wednesday night. Member of the well-known local firm of Dwyer and Murphy, cattle dealers and auctioneers, the deceased was held in the highest regard throughout the province of Munster where his integrity in all his dealings earned for him and for his firm the utmost respect and confidence of the populace.

Deceased, a sportsman to his fingertips, was keenly interested in the sport of the leach and was, since the inception, one of the leading members of the Dungarvan Coursing Club, and an ardent supporter of all national games. His death, so unexpected and after a short illness is deeply deplored by all. To his bereaved sisters and other relatives deep sympathy is extended in their great bereavement.

The removal of the remains to the Parish Church, Dungarvan, on Thursday evening was made the occasion of a wonderful demonstration of public sympathy and regret at the passing of the deceased, when practically the entire population of the town and surrounding countryside were present to pay a tribute of respect to his memory.

ANNUAL GENERAL MEETING.

At the annual general meeting of the County Waterford Irish Dairy Shorthorn Breeders' Society, held in Dungarvan on Saturday last, Mr. D. Coughlan, Chairman, presided. Also present were: Messrs. G. Bell, P. Morrissey, J. D. Fives, P. Hickey, M. O'Donovan, J. Ryan, T. J. Flahavan, Pierce Coffey, H. Hobbs, P. Gough, James O'Regan (secretary); M. J. Dromey (cow-testing inspector); D. Hurley (agricultural instructor); and P. J. O'Sullivan (horticultural instructor).

The Chairman said they had a very good Show last year. The entries were better than they expected, and the accounts were very satisfactory, and in connection with the Show was over twice that of last year. Their own statement of accounts was the same as last year, and on the whole the accounts were very satisfactory. He hoped that before their next meeting the war would be over, when there would be a demand for heifers and bulls to stock Europe and Russia. It would be well for the dairy farmers to have some compensation for their labours. He was sorry their general secretary, Mr. P. J. Halliden, T.D., was not able to come to their meeting, but he wished to extend congratulations to him on his election to Dail Eireann.

Date of Next Show.—Tuesday, 28th March, was the date fixed for next year's Show.

Statement of Accounts.—The statement of accounts was then discussed, and considered most satisfactory, the Waterford Branch of the Society showing a credit balance of £28 5s. as against £26 14s. last year, while the proceeds from the Waterford and Wexford Show and Sale (1943) showed a balance to credit of £144 11s. 5d., as against £71 8s. 5d. last year.

Mr. Dromey—The accounts are quite satisfactory.

Mr. Bell—We are stronger now financially than we have been for a number of years.

Selection of Officers.—When the question of the election of officers came up for consideration, it was the unanimous decision of the meeting that all the outgoing officers be re-elected, seeing that things were going on so well under the present management.

Mr. Coffey—I don't think we could improve on them.

The outgoing officers were accordingly re-elected una voce.

Appointment of Auctioneers.—On the proposition of Mr. G. Bell, seconded by Mr. P. Morrissey, Messrs. Flahavan, Harty & Co. were appointed auctioneers.

Sales Yard Accommodation.—Mr. Bell said a number of complaints had been received relative to accommodation facilities at the Salesyard.

Mr. Coughlan—We were pretty overcrowded last year.

Mr. Dromey—It is not fair to ask a judge to set in such small spaces.

Messrs. Bell, Flahavan and O'Regan were appointed to investigate the possibility of improving the situation.

£10 was allocated to the general secretary, Mr. P. J. Halliden, T.D.

Correspondence.—A letter was received from the general secretary, Mr. P. J. Halliden, regretting his inability to attend, owing to the difficulty of travelling, and stating that he was hopeful that if the Government would put into effect the findings of the Post-War Agricultural Policy Commission, the position of the cow-testing and dairy cattle improvement scheme would be very much enhanced.

"In fact," he added, "it was only on Friday last, in a conversation, that Dr. Ryan told me that the secretary of the Department and his staff were working on it."

He hoped that they would have new proposals for the congress, which would be held this year in the second week in January. He concluded by stating that they were still pressing, and would not be satisfied until they secured 1/- per gallon for milk during the following milking season.

On the proposition of Mr. Coughlan, seconded by Mr. Bell, a resolution was adopted congratulating Mr. Halliden on his recent election to the Dail.

IRISH RED CROSS SOCIETY

ENJOYABLE FUNCTION AT DUNGARVAN.

First Aid certificates were presented to forty-three members of the Irish Red Cross Society, Dungarvan Branch, at Scoll na gCeard, Dungarvan, on Sunday evening last. Very Rev. T. Canon O'Brien, Chairman of the branch made the presentation. Present at the ceremony were: Rev. F. Farrell, C.C.; Rev. Brothers Flahavan and Larigy; Dr. M. K. Cusack; Dr. Dooley, Jas. F. Bowen, treasurer; D. Poole, P. Walsh, M. J. Harris, M.C.C. Jas. Lanigan, C.E.O., C.Q.M. Sgt. D. O'Doherty.

Prior to the presentation of certificates the Very Rev. Chairman said it gave him great pleasure to be present at such a function. He was proud of the Red Cross and the great work it was doing. A great burden was being thrown on them now in connection with the tuberculosis campaign.
