ACCIDENTAL DROWNING. CLONEA FARMER'S TRAGIC END.

A very sad and tragic discovery was made at Clonea strand on Mon-day evening, when the body of Mr. Michael Carroll (62), a well known farmer, of Knock, Clones, was found in the tide near Ballinclampar. The deceased was last seen alive leaving Ocean View Hotel at about 11 o'clock Ocean View Hotel at about 11 o'clock on Sunday night for his home. As the night was dark he asked for a lamp when making his departure. He was given a flash-lamp, and he then left for home. The body was found in about two feet of water five yards out from the edge of the tide. The matter was reported to Dungarvan Garda Station, and an inquest was accordingly held at Ocean View Hotel on Tuesday aversing.

He was sober. As he was leaving the hotel he turned back and asked witness for a lamp. Witness gave him a flash-light. He lived about 3 miles from the hotel. On leaving the hotel he took the direction for home across the fields. His route for portion of the way would be with the strand. Witness did not see him alive again.

Clones, said that at about 2.30 p.m. on Monday he found a walking stick on the strand at Clones, about 600 yards from the hotel, in the opposite direction to that which the deceased would take on his way home. Witness went to work on the golf links, and told a man named Declan Foley to gather seaweed on the strand. Foley went to gather the seaweed at about 4 p.m. Foley came back to witness, and told him the he saw a man floating on the tide. Foley then went and reported the matter to the Guards at Dungarvan. Witness then went to the strand to where Foley had said that he had seen the Foley had said that he had seen the body. Witness saw the body in about two feet of water, about five yards from the edge of the tide. Michl. and Wm. Treacy, who were on the strand, brought in the body to the strand, where it was left until the arrival of

Dr. M. A. Casey, Dungarvan, said he made a superficial examination of the body. It was that of a well-developed man of about 60 years. Rigor mortis had set in. There were no superficial marks of injury on the body. Witness formed the opinion that he died of shock, following immersion in water.

The Verdict.—This completed the evidence and a verdict that deceased met his death by accidental drowning was returned by the jury. The Coroner expressed sympathy with the relatives the foreman on behalf of the jury and Supt. O'Mahony oined in the expression.

The Obsequies.—There was a large and representative attendance at the removal of the remains to Garranbane Church, after the inquest proceedings, on Tuesday evening. The coffin was received by the Rev. Fr. Power, C.C., who read the prayers for the dead. CHILDREN'S ALLOWANCES ACT, 1944.

The Minister for Industry and Commerce desires to inform all persons who will be entitled to claim allowances under the provisions of the Children's Allowances Act that claimants will be required to satisfy the Minister that the Children, in respect of whom a claim is made, are under the age of 16 years on 1st May, 1944. .

In order to facilitate prospective claimants, a form (G.R.O. Form A3.), which will be accepted as evidence of age for all the children in a family, has now been printed and is obtainable or will be obtainable in the course of the next few days at any Post Office.
