The Minister for Industry and Commerce desires to inform all persons who will be entitled to claim allowances under the provisions of the Children's Allowances Act that claimants will be required to satisfy the Minister that the Children, in respect of whom a claim is made, are under the age of 16 years on 1st May, 1944.

In order to facilitate prospective claimants, a form (G.R.O. Form A3.), which will be accepted as evidence of age for all the children in a family, has now been printed and is obtainable at any Post Office.

Persons WHO HAVE THREE OR MORE CHILDREN WHO WILL STELL BE UNDER THE AGE OF 16 YEARS ON THE 1st MAY, 1944. should obtain this form IMMEDIATELY; fill it up in accordance with the instructions on the back of the form and send or deliver it to the local Registrar or Superintendent Registrar of Births.

Prospective claimants are advised, in their own interests, not to delay in having the ages of their children verified on this form. It may be difficult to do so at a later date, and the payment of Children's Allowances would be delayed in the absence of the required evidence of age.

Baptismal certificates will also be accepted as evidence of age. Such certificates (if it is proposed to use them in preference to G.R.O. Form A3) should likewise be obtained IMMEDIATELY.

When G.R.O. Form A3. is returned by the Registrar or Superinendent Registrar, or when baptismal certificates have been obtained THEY SHOULD BE RETAINED CAREFULLY until the Claim Forms for Children's Allowances, which are in course of preparation, have been issued. It is said of the progress of weterimary science and service as affecting the farmer that the Irish farming community are not at all aware of the advantages available to their industry from veterinary science, and therefore do not utilise the service as much as they should. The general idea of veterinary service in rural lifeland is that when an animal is sick the vet is sent for to effect a cure if possible. That idea held up to 15 or 20 years ago, but in the last decade important steps have been made giving retarinarians powerful made giving veterinarians powerful weapons not merely concerned with the cure of disease but with prevention—which at all times is better

#### COUNTY MANAGEMENT ACT. POWERS OF PUBLIC BODIES.

At a meeting of the Dungarvan Urban Council on last Tuesday night, a letter was read from the Minister for Local Government and Public Health, relative to the Co. Manage ment Act, containing his observations on the operation of the Act, following representations made to him by local bodies and views expressed by deputies in the Dail. It is evident stated the letter, that the extent of the powers vested in elected bodies under the management system is not generally realised and the following observations are intended to remove misconceptions on certain matter with a view to securing the fullest collaboration possible between the elected representatives and the managers in the discharge of their respective functions. The elected representatives are given by the Act wide powers in connection with the exercise by the Co. Manager of executive functions. The manager is bound by the decisions of the elected body on the provision made by them in the annual estimates, and save with their consent he cannot exceed the total amount provided by them for any particular purpose. He must whenever requested by the local authority furnish all information in his possession or procurement concerning any business of the authority. Subject to some exceptions set out in Sub-section (5) of Section 29 of the Act, any council or elected body at a meeting specially summoned for the purpose can, by resolution passed

in accordance with that section, require the manager to do any particular thing which he can lawfully do as part of his executive functions The business of such a special meeting need not necessarily be confined to a single resolution and every reso-lution for which separate notice has been given can be dealt with at one meeting. But it should not be necessary to resort to this procedure except on very rare occasions. Every manager should, as a matter of course, keep the local authority informed of the important details of his administration including particulars of projects in contemplation. The furnishing of such informa would be in addition to the production of meetings of the register containing copies of Orders made by the manager as required by the provisions of the Co. Management Act. It is understood that there has been a divergence in practice with regard to the circulation of these Orders. #### HOW TO GET CHILDREN'S ALLOWANCES

which might arise if many thousands

This was announced in a special broadcast from Radio Eireann explaining the provisions of the Bill, which will become law in a few days.

The Department of Judustry and Commerce will issue a special form which will obviate the need for procuring separate pirts, certificates for each child. It will be necessary to fill in on this form particulars regarding all children under 16 years and send it to the Registrar of Births, with a postal order for sixpence in respect of each child mentioned in the form.

When returned by the Registrar, the form should be attached to the application form when applying for the allowance. The special forms will be available from next Tuesday

at post offices,
IPayments, under the Children's
Allowances Act may be collected
weekly or placed to credit till the end of each quarter. The procedure for applicants will be set out in leaster form, which is to be issued shortly. Baptismal certificates will be sufficient proof of the ages of children under 10 years. The certificates have to be obtained before May 1st, which is the qualifying date, and are to accompany the applications. On approval of the applications, the allowed ances become payable from Aug. 1st.

Stating that some people in the North were suggesting, if not de-rnanding, vindictive treatment for Eire because of her neutrality, Cardinal MacRory, in his Lenten Pas-toral, asks: "I wonder what those people expect Eire to do? Did they want her to show gratitude when she could not possibly feel it? Did they want her to show gratitude for Partition, which only a few years pre-viously had unjustly cut up into two portions, against its will, one of the oldest nations in Europe?

"The fact is," he says, "that Eire deserves credit, in the circumstances, for not having allied herself with the Axis nations, and offered them hospitality and assistance.

The Cardinal makes a plea for the healing of Partition and the ending of "senseless and utterly un-Christian quarrels of Orangemen and Catholics on so-called religious grounds."
