Quality of Dungarvan Turf.

'Impossible To Light It' INSPECTOR'S OPINION QUOTED AT U.D.C. MEETING.

The opinion of a turf inspector who examined turf as sold in Dungarvan was quoted at the meeting of the Dungarvan Urban District Council on last Friday. It was stated that he described the turf as "impossible to light."

The Acting Clerk read a letter from Messrs. A. Moloney and Sons as turf. The letter stated they wished

re turf. The letter stated they wished to point out that they put into stock a large quantity of turf last summer on the advice of the Turf Inspector.
Pointing out the difficulty in saving turf last season, the letter went on to say that they did their best to procure the best available and, in fact, a large amount of the turi cost 37/6 a ton in Kerry. "At the moment," added the letter, "we are not in a position to take any more into stock as we could not manage to handle it. But should we be able to procure better quality turt after Chrismas we will take same." Mr. Kyne said it might be of in-terest to the public to know that an Inspector had been in town last

"A SEVERE FALL."

Dr. D. T. McCarthy said he arrived at the scene, near the Crooked Bridge, Clones, at about 6.45 p.m. on Dec. 17. The deceased was lying on the side of the road, attended by two young ladies. He was very collapsed and more or less unconscious. With difficulty witness got him into his (witness's) car and immediately conveyed him to the hospital.

FURTHER RECOMMENDATIONS SUGGESTED.

The report of the Visting Committee, who inspected conditions in the Dungarvan Co. Home on December 13th, was read at the monthly meeting of the Waterford Board of Assistance (Mr. F. Caulfield, Chairman, presiding) at the Courthouse, Dungarvan, on Monday last.

The report showed that conditions had improved very much, and their wast favourably commented and thei was favourably commented

The Visiting Committee comprised Messrs. M. Morrissey, T.D., and M. McGrath. The report was as follows:

"Accompanied by the Matron we visited the different wards and were pleased at the cleanliness of same, and the air of contentment of the patients. Some of the wards are presently undergoing repairs and when these are completed it is, we understand, the intention to have walls and woodwork distempered or painted. This, of course, will make a big improvement and help to make the lot of inmates and patients

make the lot of inmates and patients more cheerful.

"The kitchen was next visited and there we found dinner, comprising corned beef, white cabbage, potatoes and hot milk been prepared. Everything was spotlessly clean and every care and attention given to the preparation of the meal. Cooking was done on large turf range, boilers and potato steamer. We feel the cooking facilities are antiquated and inade-quate and need immediate alter-ation. With present facilities it is almost impossible to keep dinners hot due to turf range not giving sufficient heat.

NEEDED.

It is also out of the question to have a variety of cooking as this range is incapable of cooking a roast. Breakfast is often delayed and no hot water is available due to the difficulty of raising steam in the boilers. Modern equipment should be made available for the cutting of bread and pealing of potatoes.

"The wash-up facilities in the kitchen are very cyude, and involve a severe, fair len and hard-ship on the mist capable staff.

The wash-up is carried out in the yard adjoining the kitchen, where no proper sinks are available and no protection from weather afforded to

tion from weather afforded to embers of the staff.

"We submit, hereunder, recommendations regarding the foregoing, which we hope will be implemented with as little delay as possible.

"We found the stores well stocked with tea, cocoa, clothing, boots, bed linen, blankets, etc., and we wish to congratulate the Matron on her foresight and wisdom in purchasing these goods before and during the Emergency.

PROGRESS OF FARM WORK. "On the farm we found a good deal of work has already been gone within a short space of time, and every effort is being made towards putting the land back into cultivation. We feel it will take some time before the soil is restored to fertility and would suggest the pur-chase of 80 barrels of lime for use as

In his report on the audit of Council's finances for the year anding, March 31, 1945, the auditor (Sean O Mhurthuile) state; I beg to report that I have audited the accounts of the Dungarvan Urban District Council and Harbour Authority and I submit herewith certified abstracts of these accounts.

A rate of 20s. In the £ was struck for the services of the year under audit (the same as for the preceding year) and it proved sufficient to meet the Council's requirements.

Rate Collection—All rates were odged by the 31st March, 1945. The

Harbour Account.—The Harbour receipts were negligible during the year and fell far short of covering the minimum costs of maintenance. The deficit on the account for the year (including charges for lighting, salaries and roads payable to the Urban District Couseil) amounted to £354 2s. 6d.

Capital Accounts.—As previously reported steps should be taken to provide the necessary loans to cover expenditure on the Sewerage heme, waterworks improvements scheme and exploratory works at Deelish dam.

Consulting Engineers' Fees—Before paying the balance of fees to the consulting engineers, the Co-Manager should examine into the charge of £49 14s, for report-Ltd., and their report only cost the Council £107, 3s. 3d., and should he find this charge in order, he should also satisfy himself that the consulting engineers have not been paid fees in excess of the scale on the accounts submitted to date. County Council Demand.—A sum of £306 4s. Id. is still due to the Co. Council on foot of the demand for 1944 45 and should be paid forthwith. This was not taken into the accounts as an unpaid bill as it

should have been.
