"Irish Incomes and Expenditure" was the subject of a lecture (under the Barrington Trust Scheme), given by Prof. John Busteed, M.Comm., F.S.S., University College Cork, at Sgoil na gCeard, Dungarvan on last Wednesday night.

At the outset Professor Busteed said the measuring of the mational economy of a country was a very important thing. A good deal of work in this matter had been done in various countries during the past 10 years. 
