I COURSED AND TRACKED

(By "DICK THE LIAR.")

Owing to pressure on space the following was reluctantly held over from last issue— All old-timers will be looking forward to their local meeting and as the season is now in, most of us won't have long to wait as there are quite a number of local meetings listed for October and November. What a change from the monotony of track racing. Perhaps for some their may not be quite such a money in coursing as in racing, but from a sporting point of view coursing is the only game for dog or man. Track racing in comparison is only a racket. What a thrill to see a good pair of greyhounds coursing a good hare. We have no bad grading, no bumping, and no fighting. In fact I have the pleasure of knowing greyhound men, and I mean sportsmen who would sooner win a Duffer Stake on the coursing field than the greatest classics in greyhound racing, and those are the men that built up the greyhound business and made no fortunes out of it, but they are satisfied in the knowledge that they always played the game, and are now looking forward to another season's coursing where the muzzles are off and the traps are open. So let us look forward to a good season, good sport, good dogs, and above all good hares. I think punters had a bad time in Waterford on Saturday night as some of the fancied ones did not oblige. The Wexford dog "Hatchin" put up a good performance (39-60) winning the sixth race and was allowed to start at the very big odds of 5/1, so he must have surprised his connections. This fellow is nicely bred by "Darkie's Gift," who is a full brother to "Mad Tanist," and that great bitch "Astra." In fact I had a little bit on him just because of his breeding. Dick Widgeon won another race with "Lacken Delarot." She looked a good thing here as the class was moderate. The Tramore dog "Fast as Sparke" found his old form on Tuesday night as he came home alone in the principal race and was well backed. It was a pity to see the only hurdle race spoiled by fighting, and this could easily be avoided as there is no scarcity of results for the week now. Time after time I have tried to create an interest in hurdling in Waterford but I am forced to say I have received no co-operation from the management or stewards there. However, several other tracks are now doing their bit towards reviving this branch of the game, particularly Kilkenny. But as time goes on and dog breeding comes back to normal, with a few well bred dogs, it is bound to be a scarcity of dogs. Then the track or tracks that are conserved towards their patrons and the patronage they deserve and the others will be left with the fighters.

Sale of Fighters.

We hear a lot of talk about the slump in greyhound sales, and if readers will remember my articles in this paper regarding the unfair system of provincial fighters being put up at Dublin sales with clean cards and as I said before, specially prepared and perhaps getting into a trial with a few novices winning in good time. Nine times out of ten this dog is sold for a good price to some unscrupulous buyer, and the race taken across Channel, tried there in his own class, with the result another Irish fighter. Now this is one reason for the present slump. At the moment I have a race card from Stamford Bridge track and it is remarkable to see the very high percentage of English bred dogs running there, and a big number of old dogs whelped in 1943. In speaking to an Englishman regarding the future of greyhound sales, he is of the opinion that the English will have to be tightened up at this side and a better type of supervision introduced regarding fighters being allowed to be put up at sales with clean cards and not the flake big price racket. How often do we here of the big prices paid, yet the owner or breeder very seldom reaps the full benefit; in fact, the genuine greyhound breeder gets very little out of the business at the moment unless he is in the position of being able to send his dogs over to some reputable English trainer, but as the big majority of Irish breeders are farmers or small business men, they are not in that position, so they are forced to sell at home. The reason I mention that provincial tracks are the worst offenders regarding fighters is there is a general slackness in the stewarding, due, no doubt, to the fact that most of the stewards are dog owners or connected some way with the owners concerned. Therefore, they are very reluctant in warning off fighters, and seeing that their card is marked, it would be very interesting to see how many cards are marked on provincial tracks in the Dublin style bad fighter (in red ink). I am not for one moment suggesting that this is the only reason for the slump in greyhound sales, but it has a lot to do with it; also the very poor type of greyhound we are producing at the moment, due to using inferior dams and bad rearing. It is now a case of quantity, not quality, but as I have already pointed out, unless something is done and done quickly to put a check to the mass production of useless greyhounds and above all, the people in charge of public sales should be held responsible for keep-

All breeders are aware that the English Market is the mainstay of the Irish greyhound breeder. So it is up to everyone interested to do their best to hold that market by delivering the goods. In other words, play the game if you are to continue in the greyhound breeding business. It will pay, as the satisfied customer will always come back for more. That applies to all classes of business. So let our motto be a good article at a fair price.

Waterford Still Masters.

KILKENNY BEATEN IN OIREACHTAS SEMI-FINAL. Waterford, 2-6; Kilkenny, 0-9. Despite the absence of five of the All-Ireland side—Moylan, Curran, Hickey (through an injury), Cusack and Galvin (due to transport breakdown)—Waterford led Kilkenny a merry dance in the Oireachtas Cup semi-final at Waterford on Sunday last, and after a brilliant game won by 2-6 to 0-9. The game, however, had an unhappy ending when, with time up, spectators encroached upon the pitch and scenes of disorder and unpleasantness ensued.

Spectators did not know whether the match was over or not until some minutes later, when an official announcement was delivered over the loudspeakers to the effect that the match was over and Waterford were the winners.

There was a tremendous following from each side present. It is estimated that the attendance was up to 30,000. The stewards were unable to cope with the large crowd. It is estimated that up to 4,000 crashed their way through the main gate when anxious supporters learned that the gates were about to be closed.

A very strange aspect was that although the gates were ultimately closed, there was still an amount of accommodation left on the banks. Usually at matches of this kind even at Croke Park, it is noticed that at the back of the bank they are packed like sardines, while down nearer to the pitch there is plenty of room. It is estimated that on Sunday, at least 2,000 more could have been accommodated.

Stewards should also be blamed outside the entrance to make supporters queue up. In Waterford, too, there are not nearly enough entrance and exit gates. Entrances to the different enclosures should be as far apart as possible, with a separate entrance from the road into the pavilion.

Waterford certainly proved worthy title-holders on Sunday, and despite the intense celebrating since September they played a most exceptional good game. Kilkenny, who had undergone a special course of training for this game, gave all they had, but failed to master the champions. Of the subs, J. Allen (in place of C. Moylan) played a very good game, while L. Fanning (who replaced M. Croke) played ducks and drakes with their opponents and left nothing to be desired in the full line of defence. Mike Hayes and Jim Barron, helped by L. Fanning, as usual were the bulwark of the defence division.

There was nothing between the opposing midfield pairs. J. J. O'Brien was again the master forward, but somehow or another the new forwards did not blend to make this machine work as harmoniously as on the way to All-Ireland honours.

THE GAME. Waterford were first to score, Keane sending over for a point. Then Downey had two points for Kilkenny before Keane put Waterford ahead again with two points from free. Kilkenny were quickly back, and Dowling, Langton and Leahy (free) had points. Then came one of those lightning Waterford raids which saw Daly send to the net and Allen record a point. Just on the interval Leahy sent over the bar for Kilkenny, to give Waterford leading 1-4 to 0-6 at the interval.

O'Donnell had a Kilkenny point early in the second half, but Waterford kept it at, and O'Donnell (0-1) and Daly (1-0) completed their total before O'Donnell and O'Brien added Kilkenny points.

AN APPRECIATION

THE LATE SEAN KEATING, STAFF CAPTAIN, OLD I.R.A., ARDMORE, CO. WATERFORD.

Solemn Requiem Mass was celebrated on the 23/9/48 at St. Declan's Church, Ardmore, for the repose of the soul of the late Sean Keating, whose untimely death took place at the Mater Hospital, Dublin, at the age of 48 years.

He was the eldest son of Mr. R. P. Keating, ex-N.T., and the late M. C. Keating, a popular and highly respected family, the members of which displayed at all times a keen interest in the advancement of national affairs and everything associated with it. Their beloved son brought with him from nature the influences that go to make an Irishman, what an Irishman really should be, for in his day as a young man everything appeared to be shadowed as the thorns of Imperialism were beginning to make themselves felt. Sensed with a duty to his mother Ireland, he proved by his inherited qualities of parentage that his soldierly calling should take its course, so that he thus became one of the many born warriors of the Old I.R.A., to which the nation attributes her freedom.

He was on the G.H.Q. Staff from 1918 until the end of the war of Independence, and later on the Republican side during the civil war. He was held in high esteem, and a man of many gifted qualities which were readily recognised by those he served, that he was the youngest staff captain to be appointed to this position, which shows that he was a man of the highest integrity, who performed his national duties without the least shadow of fear, while at the same time his gentlemanly manner endeared him to all.

He had a deep sense of fairness, never asked those under his command to do what he himself would not do; never shunned the danger, and was always to be found in the front line—proof of which lies in the fact that he was one of the last to leave the G.P.O. in the turbulent days of strife in this country. This action, which shows that he was a man of the highest integrity, who performed his national duties without the least shadow of fear, while at the same time his gentlemanly manner endeared him to all.

He had a deep sense of fairness, never asked those under his command to do what he himself would not do; never shunned the danger, and was always to be found in the front line—proof of which lies in the fact that he was one of the last to leave the G.P.O. in the turbulent days of strife in this country. This action, which shows that he was a man of the highest integrity, who performed his national duties without the least shadow of fear, while at the same time his gentlemanly manner endeared him to all.

The Agricultural Wages Board.

The Editor, "Dungarvan Observer."

Dear Sir—In last week's issue of your paper under above heading you publish a letter signed by Patrick Tobin, workers' representative for Waterford. He claims to be on No. 5 Committee of the Board.

Mr. Tobin takes issue to task for a statement of mine at a recent meeting of the Mental Hospital Committee. He presents my view that the Agricultural Wages Board is (1) Inefficient, (2) Wasting its time, (3) Not representative of labour. He goes on to prove how wrong I am on all three points and then gives me some advice.

Well, I am always open to correction and I will try to make my reply for Mr. Tobin's benefit.

First of all my remarks about the Agricultural Wages Board were as an aside to one of the members at the meeting, who stated the Board fixed proper wages for agricultural workers. I am not quite certain of the actual words I used, but accept the Press report as being substantially correct.

Mr. Tobin claims that because there are five farmers and five labourers on the Committee of Board it cannot be considered. Will he state who appointed these members? Were they nominated or elected and by what person or persons? A Board made up of selected persons nominated by a certain party can be as one-sided in its decisions as if all the Board were of the one class interest.

To have a free vote I suggest it is necessary to have the members either freely elected or nominated by the various organisations representing and catering for the interests of both sides. Until I am satisfied that this is so I will continue to think the Board one-sided.

For No. 2 point he states that the increases granted show the Board is not wasting its time. He states he knows that even after all the increases since 1938 the present wages are not sufficient, but to quote himself: "It is the best we could do under the circumstances." What are the circumstances under which the workers' representatives had to accept wages which are admitted by Mr. Tobin to be unjust in so far as they do not permit a worker to keep himself and his family in comfort? Remember a certain Pope laid it down that a worker had a right to that wage as a minimum. Would I be right in thinking that the wages increases secured were dictated ones? If there was any dictation or compulsion on the workers' representatives to agree to a wage figure which is now admitted to be unjust, then I hold that the holding of meetings by the Board was not waste of time as those who were in control could just as easily have fixed the rate without calling any meeting. I know it would not fool the workers so well but it would be more honest.

On No. 3 Mr. Tobin claims that because the five workers' representatives are in fact workers it must naturally follow labour is represented. This is like the Fianna Fail claim that because their Party has workers in it that there was no need for a Labour Party. To be labour representatives you must represent organised labour as well as being a worker. Do you wish to agree, Mr. Tobin, that those whose interests are concerned should decide who should do so and not be asked to accept just any one selected? If you don't do so do a lot of workers concerned.

As regards Mr. Tobin's advice about getting the Minister's sanction for a higher wage, I am quite well aware of the fact that this can be done. If Mr. Tobin will again read the report of the meeting he will find that I proposed that the consideration of the increase be deferred to the next meeting and that the Minister be asked in the meantime to agree to include agricultural workers in the scheme. If he does so it will be automatic sanction and I will be very happy to propose that the increases be granted.

Not knowing Mr. Tobin personally or even having heard of him, I wish to make it clear that I did not intend to throw any discredit on his work on the Board. He may be a most sincere workers' representative who has always done his best for his class interests. What I said of the Board was my personal opinion of its formation and composition and not intended to refer to the individual members or their work on it. Until the Board is a truly constituted one of farmers' representatives elected or nominated by their organisations and in similar way the workers' representatives selected, I will look on the Board as a Government controlled body.—Yours sincerely,
