### DUNGARVAN URBAN COUNCIL

Mr. T. McCarthy, chairman, presided at the meeting of the Dungarvan Urban Council on last Friday night. Also present—Messrs. M. Clancy, N. Kelly, Senator J. Butler, and Mr. E. A. Deery, Town Clerk.

**UNSKILLED LABOUR ALLEGATION.**  
Arising from the minutes, Mr. Clancy referred to his allegation made at the previous meeting in connection with unskilled labour doing tradesmen's work on Abbeyside housing scheme and which Mr. Kyne promised to look into. Mr. Clancy said he had been speaking to Mr. Kyne during the week about it and he (Mr. Kyne) told him that it was only a matter of a few hours painting. That was not correct, said Mr. Clancy. There was a lot of painting done and there were painters idle in the town. That was not fair. There were housing schemes in the town before and the painting was done by painters. Now it was being done by unskilled workers.

Chairman—Are you definite about that? Mr. Clancy—Yes.  
A suggestion by the Chairman that the matter be left over to the next meeting so as to obtain more definite proof in connection with the complaint was agreed to.

**TOWN HALL REPAIRS.**  
Correspondence was read from the architects in connection with the suggestion in the Department's letter, read at the last meeting about the improvements to the Town Hall. In the Department's letter certain suggestions were made regarding the lighting, etc., of the hall. In their letter the architects pointed out that the Department had no objection to the roof along the lines proposed and that the object of the architects was to keep expenditure at a minimum. They suggested that tenders be invited immediately for execution of the work, and that tenders be invited also for the electrical installation in view of the Department's letter.

Replying to the Chairman, the Clerk stated that there were bookings for the hall from April 17th to June. He added that the architects recommended that the hall be closed for seven weeks of work.  
Mr. Clancy—Could we start in Lent?  
Clerk—I don't think so.  
Senator Butler referred to the suggestion in the Department's letter that electric clocks be installed and said he did not know what they wanted them for. The Department also suggested an alternative system of lighting.

Clerk—That's in case the other one broke down.  
Senator Butler—As far as I know in operating theatres and other places I don't believe they have alternative systems of lighting at all. I think we should not go to such expense.  
The Chairman referred to the switch board on which both the stage lights and the hall lights were and said they should be on separate switch boards.

Mr. Clancy, the Clerk said that the estimated cost of the improvements was £1,850. The Clerk added that he referred to the fact that it was also stated that the improvements could be carried out during that period.  
Senator Butler said that as bookings had been made from April to June, it might be probable that claims for compensation could be made against the Council if the work were done during this period. He suggested stopping bookings from July and then start the work.

Mr. Kelly referred to the fact that Dance Clubs for the night dances had to book in some cases bands six months in advance.  
Mr. Clancy asked would there be any use in making the clubs forego their bookings during this period.  
Mr. Kelly agreed with Senator Butler to leave the present bookings so and after that start the work.

Mr. Clancy again suggested that the clubs be asked to forego their bookings, and eventually it was agreed to refer this to the Manager. It was also agreed to advertise for tenders for the re-roofing of the hall.

**ABBESIDE HOUSE-OWNER'S REQUEST.**  
Mr. T. McCarthy came before the Council in connection with two houses of his in Sarsfield Street, Abbeyside, and said he wanted to repair the houses as he did not intend to go into a new house. He lived in one house and there was a tenant in the other who was willing to go into one of the new houses. If he got a grant and it was thought suitable, he could make the two houses into one. He added that the houses were condemned seven years ago.

The Clerk, referring to the file in connection with the condemned houses, had been condemned and in a subsequent review they were again condemned as they could not be repaired at reasonable cost.  
Mr. Brett said that since they were condemned he got no other communication about them.

Replying to Senator Butler, Mr. Brett said that no inspection had been made of them since they were condemned eight or nine years ago.  
Mr. Kelly said that if houses could be repaired at a reasonable cost he didn't see why people should get out of them and go into cheaper ones.

Mr. Clancy thought they should refer Mr. Brett's case to the Acting Borough Surveyor for a report. The whole Council agreed that there should be no demolition of houses. As regards the grant, the Council could not give that because the house was not on the list of those that could be repaired.

It was agreed to ask the Acting Borough Surveyor to report on the matter and that it be put on the agenda for the next meeting.

**GALLOWES HILL SCHEME.**  
Senator Butler referred to one of the Manager's orders regarding houses in Fair Lane in connection with the Gallowes Hill scheme, and asked the Clerk for information on the matter.

The Clerk said that a letter had been received from the Council's solicitor, enclosing a letter from Messrs. E. A. Ryan and Co. solicitors, regarding houses and land in Fair Lane owned by Mr. Wm. O'Brien and Mrs. Ellen Buckley. In Messrs. E. A. Ryan and Co.'s letter it was stated that their clients could not see their way to hand over their houses and lands to the Council. The Clerk also stated that a report from the Acting Borough Surveyor had also been received. In the course of this report it was stated that he (Acting Borough Surveyor) interviewed Mr. O'Brien and found that he and Mrs. O'Brien had carried out considerable improvements to their house, and in view of this the Acting Borough Surveyor was prepared to recommend certain modifications in the scheme. The Acting Borough Surveyor then went to explain what the Council's position was regarding the O'Brien's work.

The Acting Borough Surveyor added: "Mr. O'Brien seemed fairly disposed towards the suggestions and I believe they were quite acceptable."  
The Clerk added that the letter from Messrs. E. A. Ryan and Co. was dated January 4th and the Acting Borough Surveyor's report was dated February 3.

**C.B. PLACE TENANT'S COMPLAINT.**  
Messrs. Farrell and Morrissey, solicitors, on behalf of Miss M. Attridge, 13 C.B. Place, wrote stating that his client complained of a nuisance being caused by a neighbour and that legal proceedings were being taken.  
It was agreed to get a report from the Sanitary Officer and the Acting Borough Surveyor regarding the alleged nuisance.

The matter was adjourned pending a report from the Acting Borough Surveyor.

**APPRENTICES TO SKILLED TRADES.**  
A resolution from Bray Urban District Council was read, and the Clerk stated that he had received a report from the Council regarding the apprenticeship scheme. The resolution stated that the Council looked on this as a very important matter and that they were engaged in these trades could be apprenticed. Mr. Clancy—That rule does not extend to this town at all. Any boy in this town can be apprenticed.  
Clerk—That's another thing in regard to this. There was a number of men availing of vocational training and they were taken on in trades and they never served their time at all, only in vocational schools.

Mr. Kelly said there were young men such as in the factory who could serve their time in the furniture but they went to the Technical School and made pieces of furniture for themselves there.  
Mr. Clancy—You are depriving them of a way of living.  
Mr. Kelly—I am not.  
The resolution was adopted.

**VACANCY IN COUNCIL.**  
The matter was referred to the Clerk for the opinion of the Council's solicitor on the filling of the vacancy in the Council, caused by the resignation of Mr. M. Walsh.

**REQUEST TO BUILD PROTECTION WALL ON CAUSEWAY.**  
A resolution was read from the Abbeyside Branch of the Labour Party recommending the erection of a concrete wall on the eastern side of Abbeyside Causeway as a protection for pedestrians crossing the Causeway against the weather.

Chairman—That was passed before and it was not carried out.  
Mr. Clancy—Are you correct in saying that?  
Chairman—It was and there was a majority of the Council for it.  
The matter was adjourned so that the Clerk could look up the minute regarding it.

**ROAD WORK.**  
Mr. Clancy raised the question of the amount to be provided for road work and said very little was provided in the estimates for roads. He saw where the Government had doubled the grants for county roads and were giving grants of 40 per cent. for municipal roads. He didn't know if they had provided any money for urban roads. They must do something for the roads. Naturally, they were trying to keep down the rates.

Senator Butler—They were not getting anything like that now. In view of the estimates meeting he would like to know how they stood as regards the different services. Were there any unexpended balances?

The Clerk said there were a few, but he expected that at the end of the financial year there would be over-expenditure.  
Mr. Clancy said what he would like to know was what were the amounts of unexpended balances at the moment in respect of the current year, so that they could see where they were. The ratepayers, naturally, would be expecting a reduction in the rates, but he would like to have something to show to them as regards money for roads.

Clerk—There is money provided for roads.  
Mr. Clancy said that what he was referring to was the grant for main roads in the town. The Council would suffer because of this now. Senator Butler said that if there was money for the main roads going through the town they would be done.

Mr. Clancy again referred to his suggestion about getting information as to how the amounts in the services stood at the moment.  
The Clerk said he could give an estimate of how they were likely to be on March 31st next.

Senator Butler referred to the estimate for roads which had been submitted to the Council by the County Surveyor and said that a number of items had been cut out of them so that the estimate for next year would be the same as for the current year.

Mr. Clancy also referred to footpaths in the town and said nothing was being done for them.  
Senator Butler said that they would be asked to pay £100 in respect of grants and these could be spent on that. He thought, however, that the grants were cut down for the job near the Swimming Pool.

Mr. Clancy—I want a special grant for the Urban Council because they could do both ways as the Chief Clerk said. We cannot deal with roads now; they are budgetted for.  
It was agreed that the Clerk prepare a statement for the next meeting showing the credits and debits of the different services.

**LOUGHMORE COMPLAINT.**  
Mr. Clancy called attention to complaints by people in Loughmore about property being damaged there. One woman had her gate torn down and the garden and door of her house damaged. He thought they should ask the Council to do something to protect the property.

**HARBOUR MEETING.**  
The Chairman referred to the grounding of two boats in the harbour recently and asked the Harbour Master (Mr. Jas. Curran) the cause of it.  
The Harbour Master said the two boats grounded at the Abbeyside pier. The tides were exceptionally low at the time.  
Chairman—Isn't it true that the mud lodged where the boats grounded?

Harbour Master—That is not so.  
Chairman—We thought the dredger had done a great job now it doesn't seem as if it did a great job the way the mud was taken from one place and put in another. I suggest the mud be taken away immediately and made pieces of furniture will not come in again.  
The Harbour Master said it was at the end of the boats grounded. There was no mud there only sand and gravel. He did not agree that the mud was there.

The Chairman said it was quite peculiar since the mud was there. He observed that the captain of one of the boats was not at all satisfied with that particular part of the quay.  
Harbour Master—This place—Abbeyside pier—is a sandbank opposite the Look-Out.  
Chairman—Is it not a fact that the mud lodged at that particular place?

Harbour Master—No. That is a peculiar statement to make.  
Chairman—I am not making any peculiar statement at all, because certain people of the town told me to bring it up here. We are all doing our best for the ratepayers, and if the boats will not come in we will have to deal for the people of the town.  
Harbour Master—The pilot made a mistake and came in an hour after high water and he grounded there.  
Senator Butler—It was not the mud?

Harbour Master—No. The second vessel on the sandbank at the other side. The water was too low and the pilot unfortunately had to come up in the slack.  
Senator Butler—Anyway you do not agree with this allegation about the mud?  
Harbour Master—No.

Senator Butler—The Harbour Master has a report on the matter for the next meeting.

**PARKING OF CARS ON QUAY.**  
In connection with a complaint made at a previous meeting regarding the parking of cars and buses on the quay on the occasion of G.A.A. matches, Supt. P. O'Mahony, G.S., Dungarvan, wrote asking what was the Council's precise objection to the parking of cars on the quay, and asking the Council to suggest alternative parking places.

Dorgan, farmer, Ballinora, Ballyduff, said he was working in the haggard at his farm when he heard a noise and saw two lorries on the road, pointing in opposite directions. One of the lorries was the C.I.E. lorry which was on its proper side. The other lorry was on its proper side too. There was a bit of the fence torn away and a little damage was caused to an out-house. Witness saw tracks on the road. Cross-examined, witness said both lorries were stopped when he arrived on the scene. Witness could see the tracks going to the back wheel of Aird's lorry. Mr. Farrell called witness's attention to the fact that on the sketch map prepared by the Guard who investigated the matter, the tracks were not shown going back to Mr. Aird's lorry. In reply to that, witness said: "The Guard did not come until 10 minutes after."

Mr. Farrell—I put it to you that these tracks were those of some other lorry? Witness—I would not think so. Where there any other tracks there? There were but you could see these tracks were fresh. Guard Ryan said he got to the scene of the accident at 2.25 p.m. The C.I.E. lorry was on its correct side as far as it could be, and side too. Racing Commentary.

INTEREST in the Spring Double is beginning to pick up, although plans for the Grand National are still very obscure. The chief problem is the cold. Race at Cheltenham will supply the answer, but we must wait another two weeks for it. Acceptances for both races are not due until March 8th, which is only eleven days before the Lincoln on March 19th, with the National a further week away.

I do not intend to deal with the merits of the entries at this early stage and will confine my observations to some of the interesting facts arising from recent contests for the National. Sprig, winner of the National in 1927, was the last favourite to win the race (S.P. 8/1). His burden of 12st. 4lbs. has not been carried successfully since. Golden Miller (1946) and Reynoldsdown (1936) both carried 12st. 2lbs. to victory.

Twenty-five races have been run for the National at Aintree since the end of World War I. Only one horse has won the race twice in that period, Reynoldsdown, 1935 and 1936. During that time Workman (1939) is the only winner to have been previously placed in the race. He was third in 1938. Three horses have won it and have been placed subsequently.
