### LICENSING LAW BREACHES

#### Cases at Dungarvan District Court.

The Dungarvan District Court was held on Tuesday, before Mr. O'Riain, D.J., at the Court House, Dungarvan. Occasional Licence.—Mrs. Kenny, solr., on behalf of Mr. Kelly, Devonshire Arms Hotel, was granted an occasional licence for next Sunday night, from 10 to 12 o'clock. BREACHES OF LICENSING LAWS. Supt. O'Mahony charged the Dungarvan Literary Club with a breach of the Licensing Act on January 16th. Mr. Williams, solr., defended. The Superintendent said that at 12.10 a.m. on 16th January the Guards were admitted to the premises of the club and found drinks scattered about. All admitted having drinks. Mr. Williams said that on the Saturday night in question there was a 45 drive in the club. The bar was closed, but the men found on the premises stayed on to finish their drinks. The Superintendent added that at closing time the steward locks up the bar, but some collect enough liquor to keep them sipping until after midnight. The Justice, in issuing a severe warning, said the club must exercise more supervision. If there was not an improvement, the Superintendent may oppose a renewal of the licence. As Mr. Williams had stated, he hoped that the new and more active committee would see that the laws be carried out more rigidly. A fine of £3 was imposed, and 5/- each on those found on the premises. Supt. O'Mahony had a similar charge against the Dungarvan Club on the same night, at 12.30 a.m., and stated that the position was the same as that of the Literary Club. Mr. Kenny, solr., defended, said on that particular night the semi-finals of a billiard tournament were being played, while in other rooms other members played cards. Those on the premises were not there for the purpose of obtaining drink but for playing cards. There was no sign of anybody being intoxicated. The Justice said his advice to the club applied to this club also. A fine of £5 was imposed, and 5/- each on those found on the premises. Supt. O'Mahony charged Mrs. H. Cooney, Square, Dungarvan, with a breach of the licensing laws on 24th December. The two Guards who were admitted to the premises at 1.15 a.m., and found six men there. Mr. Kenny, solr., defending, said one of the men was her brother, and the other five were customers who were being entertained. It was Xmas Eve and there was a 45 drive on in the premises, and defendants were upstairs playing cards. When they were going out, defendant's brother insisted on bringing them into the bar for a "deoch an doirte". A fine of £3 was imposed on defendant, and 2/6 each on those found on the premises.

FELLING TREES WITHOUT A PERMIT. The Minister for Lands charged Mr. J. S. O'Keefe, Tallow, and Mrs. K. A. Walsh, Kilkannon, Cappagh, with felling trees without permit. Mr. Kenny (for Dr. Counihan, State Solicitor), prosecuting, stated that Mrs. Walsh sold 250 trees to defendant. Guard Halessey of Cappagh, called on Mr. O'Keefe about the cutting of the trees, and found he had no permit to cut them. Mr. Williams, defending, said it was a pure mistake. Mrs. Walsh thought Mr. O'Keefe thought Mrs. Walsh had it. The Justice remarked that surely Mr. O'Keefe must have known that a permit was necessary. The major part of the blame must be attributed to him, as he is engaged in the business. He imposed a fine of £3 (3d. per tree) on Mr. O'Keefe, and applied the P.O.A. to Mrs. Walsh. School Attendance.—A charge by Guard Giblin against Mrs. K. Dalton, 24, Loughmore, under the School Attendance Act, in connection with her three children, was adjourned for three months. "No Lights".—In a number of "no lights" cases, etc., the usual fines were imposed.

It is a matter for serious thought by our legislators. Such an important subject cannot be treated lightly if the dairy industry is to be saved.

The Government has decided to reduce the rates grants this year to come as a rude shock to the public. It will probably mean another addition to the rates and more unemployment.

A certificate was received from the Minister authorising a demand for an annual local contribution. They had done a wonderful job and had been most scrupulous in their efforts, watching all the details.

The opinion that this latter practice is highly undesirable and very dangerous is sheer ignorance. The best of advice on the present unit shows an appalling ignorance of the immediate needs of the community and of the primitive conditions existing at present. The necessary eye work can be carried out on my present suggestion quite satisfactorily for a year or so. Their immediate need was to pull their heads out of the clouds and get down to practical things. It is amusing to be told that his ideas on how best to do his work was dangerous and he told that by a person who never did eye work or a surgical operation is just too silly.

WATERFORD COUNTY COUNCIL

SPECIAL MEETING.

Mr. D. Heskin, chairman, presided at a special meeting of the County Council on Monday. Present were: Messrs. T. A. Kyne, T.D.; M. O'Ryan, D. Leahy, F. Roche, T. Duggan, M. Kelly, M. F. Walsh, M. McGrath, M. Harty, J. Meade, J. Quirk, R. Power, W. Norris, J. Mansfield, R. Barron, P. Butler, Senator J. Butler. The meeting was called to discuss a circular from the Department regarding road grants, the principal points of which are given hereunder:

1. As the scheme of Road Fund grants initiated in 1946/47 for the special purpose of restoring roads which had deteriorated during the war years has now been substantially implemented, it is necessary to institute a policy of restoring roads in keeping with normal requirements. Pending the outcome of the special consideration now being given to the policy, the Minister has set aside from the year 1949/50 his fixed on the basis set out hereunder. In making this allocation, the Minister has had special regard to the need for giving more attention to the improvement of county roads than those which have hitherto received. The Minister's policy on this matter was announced in his concluding speech on the Local Government Vote in the Dail on the 26th June last when he directed attention to the need for formulating a national scheme for the improvement of secondary roads. The Minister's policy as then announced has received widespread endorsement from County Councils and public representatives generally. In pursuance of that policy the Minister has set aside from the estimated income of the Road Fund for the special improvement of county roads, twice the total amount being allocated to special main road grants. The allocations to each county are based on the mileage of county and main roads respectively.

The County Road Grant.—On the foregoing basis the Minister has allocated to the County Council a free improvement grant of £36,600 on county roads. It is a condition of this grant that the Council provide out of rates for 1949/50—(a) at least as much for "ordinary works" on county roads as was provided out of rates for county road maintenance (including restoration) for 1948/49, viz., £28,336, (b) at least as much for "ordinary works" on main roads as was provided out of rates for main road maintenance (including restoration) in 1948/49, viz., £17,139.

The special object of the special road grant is to secure the permanent improvement of important county roads by drainage, strengthening, rolling, surface dressing and widening where necessary.

3. Special Main Road Grant.—The Minister is prepared to make available a special improvement grant of £16,000 to Waterford Co. Council for main roads.

4. Main Road Upkeep Grant.—This will amount to 70 per cent. of the cost of repairs on main road works. The grant will not be limited to works coming within the definition of "repairs" in the Public Works Act, 1929, in accordance with the condition (b) above attached to the Special County Road Grant, each County Council will provide from their revenues at least as much for main roads as has been provided this year. The amount so provided in County Waterford was £17,139.

The Chairman said the question before them was whether they should decide on the matter that day or adjourn it, seeing that it is going to be a long one. It was a fair, unselfish and unobtrusive grant, and it was not unreasonable to reduce the grants for main roads. The Government should increase the grant instead of reducing it, taking into account the revenue received from tax, petrol and insurance of mechanically propelled vehicles. He thought they were going to be in a position to raise the rates and it was most unfair and unjust at this stage to try and enforce an increased burden on the ratepayers. He thought they should agree to postpone it and ask the Deputies to support anything regarding increasing the grants.

Mr. Quirk.—If you decided this today, it would not strengthen the hands of the Deputies in the Dail. We're not going to raise the rates. I think we should fix it to adjourn. Mr. Kelly said the Minister said to him last week-end that he would not make any statement on the matter until after the Dail discussion. Mrs. Keane said she would support the words "free improvement grant," and said there was nothing free about it when there was a condition in it that they put up a certain amount. They were not going to raise the rates. It was decided that they adjourn the matter until after the Dail debate, when it would be decided before the 4th March.

Flooding.—Mr. Butler referred to flooding near Modeligo church, and the matter was referred to the engineer.

Popular Teacher Departs. The departure of Mrs. Broome, N.T., from Kilkalf National School, Tallow, is much regretted not alone by the pupils but by her many friends. Since taking up her appointment at Kilkalf some years ago, Mrs. Broome proved a general favourite, and seldom has a teacher's departure been so much regretted. Kind, considerate and conscientious, she earned the respect and esteem of pupils and parents alike, and her many friends join in wishing her every success in her new appointment. She is replaced at Kilkalf by Miss Duahy, N.T., to whom a hearty good mile falite is extended.

Modeligo Excursion Club.—The first dance of 1949 under the auspices of the Modeligo Excursion Club was held at the Town Hall, Dungarvan, on Friday night of last week and proved a most enjoyable function.
