Minister's Visit to Dungarvan

"I Am Pinning My Faith to the Dairy Shorthorn"

The Minister for Agriculture attended a meeting of the Waterford Co. Committee of Agriculture at the Courthouse, Dungarvan on Thursday and delivered the following address:

MINISTER'S ADDRESS.
I regard it as a distinct privilege to be given the opportunity of conferring with your Committee. I may say that I have always regarded members of Committees of Agriculture as being particularly well informed regarding agricultural conditions in their districts, and for this reason I resolved when I became Minister that I would come amongst them at the earliest possible moment to consult them on their own local problems. I have already visited several committees and everywhere have gone I have found the members most constructive and helpful. I am confident that I shall receive the same help and co-operation in Waterford that I have received in other counties.

Waterford is a good dairying county, having a density of 125 cows per 1,000 acres of crops and pasture as compared with a density of 104 cows for the whole country. It is satisfactory to know that the creamery system is well developed within the county, and that over 82 per cent of the cows are kept by creamery suppliers. Shortly after I came to office, I decided to increase the price of milk supplied to creameries and the price is now approximately 10 per cent above the 1928 price. I have a hopeful that the increased prices will prove to be an incentive to dairy farmers to increase milk production.

One of the fundamental weaknesses of our dairying system is the poor feeding of our cows over the winter period. To frequently one goes cow turned out in spring carrying little more than skin and bone. Such cows cannot be expected to produce healthy calves or to give satisfactory milk yields in their succeeding lactations. It is estimated that 100 cows would feed over the winter will give at least 150 gallons of milk per annum that given by a poorly fed cow is extra 20 gallons of milk would provide an extra cash income of about £10 per cow and would in addition provide a valuable amount of protein-rich feeding for calves, pigs and poultry.

While a good deal can be done through feeding alone to raise our yields, it is also of unquestionable importance to the farmer to have the right type of cow. I am pinning my faith to the dairy Shorthorn, and I believe that this breed is best fitted to be our foundation stock. I am endeavouring to encourage the use of the best strains of dairy Shorthorn bulls by artificial insemination and otherwise. I am satisfied that properly selected bulls of this breed can give us better milk cows and satisfactory stores and beef cattle.

It is most important that the milk yields of cows should be raised. It is not fitting that our country should be placed in the position of having to import a substantial proportion of its butter supplies from Denmark and New Zealand. It is true that we export at the present time a certain amount of chocolate crumb, condensed milk and dried milk. It is to our economic advantage to keep the production of these commodities going, and it would be a great pity if we should lose our grip on the markets abroad for these products. The proper policy in my opinion is to build up our milk supplies so that we shall be able to produce our full requirements of butter and at the same time expand our exports of commodities such as chocolate crumb, for which remunerative prices are obtainable.

Waterford has a long tradition for pig-rearing and for bacon curing. It is recorded that of 122,388 fitches of bacon sent to England in 1800, no fewer than 103,983 were consigned from Waterford. The present density of pigs in Waterford is 98 per 1,000 acres of crops and pasture, but about 65 per cent, higher than the average density for the whole country. The great barrier to the expansion of pig production at the present time is the dearth of imported feeding stuffs, maize being over five times its pre-war price. There can be no substantial increase in the pig population until we ground the industry on home-grown feedings. In times of scarcity consumers are not existing as regards

DUNGARVAN DISTRICT COURT

Held on Wednesday, before Mr. Justice O'Keefe.

The Urban Council Minister for Local Government refuses to approve of any plan that would include the whole hall being available, so that is how the position is.

Meeting of County Libraries Committee

A meeting of the County Libraries Committee was held in the Courthouse, Dungarvan, on Monday, 22nd inst. Present—Mr. M. O'Hara, B.A., Acting Chairman; Mrs. M. Maher, Messrs. M. J. McCarthy, N. Kelly, M.C.C.; N. Walsh, M.C.C. A letter of apology for non-attendance was received from Mrs. M. G. Moloney, chairman.

The minutes of the last meeting were read and signed. **Report on Sligo Conference Proceedings.**—The County Librarian submitted a comprehensive report on the proceedings of the annual conference held at Sligo. The main points of the report were as follows:—

Children's Libraries and Juvenile Reading.—The extent and scope of juvenile reading at different levels of service and of financial provision throughout the county. In County Waterford practically every national school in the area was provided with a juvenile centre. Irrespective of the adequacy or inadequacy of provision for our children, the material there was the question of the almost total absence of books with an Irish and Catholic background for our children. We were thus deprived of a principle means of inculcating a spirit of national and civic pride in our youth.

It was suggested that the Librarian Association of Ireland should be represented on the Educational Commission's Committee. **Northern Ireland Library Scheme.**—In a paper read by Mr. Berbigton, Belfast City Librarian, an account of the constitution of the S-X-County Library Advisory Council was given. On this council there were 19 practising professional librarians.

In the ensuing discussion members of the association reiterated their often-voiced dissatisfaction with the composition of our own Library Council where only one representative of the Librarian Association was appointed. **Village Halls and Public Libraries.**—Mrs. Bishop read a very interesting paper on the above subject. The Village Hall was envisaged as the centre of various social and cultural activities, in which the library as an integral component part is incorporated in a separate and suitable room. Unfortunately grants from the Carnegie Fund were no longer available for such halls but under 1941 L.G. Act, local authorities may secure Government grants for such purposes.

Meeting of County Libraries Committee

A meeting of the County Waterford Libraries Committee was held in the Courthouse, Dungarvan, on Monday, 22nd inst. Present—Mr. M. O'Hara, B.A., Acting Chairman; Mrs. M. Maher, Messrs. M. J. McCarthy, N. Kelly, M.C.C.; N. Walsh, M.C.C. A letter of apology for non-attendance was received from Mrs. M. G. Moloney, chairman.

The minutes of the last previous meeting were read and signed. Report on Sligo Conference Proceedings—The County Librarian submitted a comprehensive report on the proceedings of the annual conference held at Sligo. The main points of the report were as follows:—

Children's Libraries and Juvenile Reading.—The extent and scope of these varied with different levels of service and of financial provision throughout the county. In County Waterford practically every national school in the area was provided with a juvenile centre. Irrespective of the adequacy or inadequacy of the services, the Secretary of the County Librarian reported that on the completion of the Library Survey, which had recently taken place, he communicated with the County Manager, who acting on his advice, requested the Library Council to indicate what prospects there were of obtaining an immediate grant for building purposes. Following on this, and before the matter had come before the council for their consideration, the Secretary of the Library Council had included in her reply to the County Manager a paragraph which was tantamount to a declaration of the Library Council policy. The County Librarian had indicated, in a further letter to the County Manager, that he could not accept this as the purely personal opinion of the Secretary, at least until such time as the Library Council should have dealt with the matter officially.

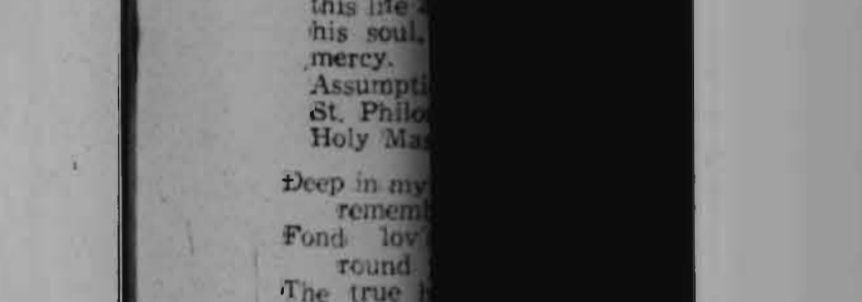
