SERIOUS WATER SHORTAGE

Hopes of new scheme for Dungarvan

DUNGARVAN for many years handicapped by a serious water shortage, may soon gain a new and plentiful supply if present plans are put into effect. This was announced at a meeting of the Urban Council when Mr. P. Walsh, B.E., reported on the serious position in existence at the present time

The proposed new scheme would have its source of supply in the Colligan river and would also supply certain needs of Waterford County Council. The estimated cost of the Dungarvan supply would be £66,700.

The matter was discussed at length under the chairmanship of Ald. Tom Kyne, T.D. It was stated by the Town Clerk that the raising of £66,700 would put 4/- on the rates over the period of repayment, but in fact, the position appeared to be that the new scheme would not mean such a big increase on the rate as any at all.

He felt that the cost of the scheme would not increase the rate by more than 2/- in the £, and with increased water rates and increased consumption, there was the possibility that increased revenue would practically offset an increase in costs.

The proposed new housing scheme at Boreenatra and there was the danger that these houses would be held up for want of water.

Mr. Walsh, B.E., agreed that the demand created by the new houses would certainly accentuate their present difficulties to the limit.

Mr. Moloney proposed that the County Council's views together with the annual maintenance costs be ascertained.

"HUMP ON THE RATEPAYERS"

Mr. Lee said he would object to the scheme. In his opinion "there was enough of a hump on the ratepayers." There was plenty of water available if it was looked after properly by those paid to do so. He could show water going to waste that would flood Dungarvan. It was not good enough at all, he added, and was not fair to the ratepayers who were being fleeced as matters were.

When Mr. Moloney assured him that no final decision was being taken at this meeting, Mr. Lee replied that he would persist in his objection. He went on to allege that this proposed new water scheme was the real reason why the Spring Well at Springmount was condemned.

MORE REVENUE

The Co. Manager agreed that the maximum increase in the provision of the new water scheme should not be 2/- in the £. They should be able to increase income from water supplies to the extent of £1,000. A point which they should bear in mind was that one local factory had informed the Council that if water was made available to them, they would be prepared to take twice as much. This would mean double the revenue being paid to the Council at present and that figure was considerable.

Mr. Lee spoke against the provision of a new scheme for the town stating that if they had new twin mains from Kiladangan to Dungarvan they could flood the town with water. There was enough water going over the weir out there, he said, that would "drown four towns."

The Chairman stated that that might be true of the position in Kiladangan at the time of year but the Council had to consider what the position would be in the height of summer. The Colligan river was the biggest source of supply they had and there was no doubt it seemed the ideal solution to their problem.

Mr. Kelly said the matter was a very serious one for the Council and for the people of the town. With only four members in attendance he felt they should adjourn it until they had a full house.

The Chairman replied to the effect that every member had received an agenda and knew only too well what was to be dealt with. It was up to each to attend if he could. To adjourn a matter because there was not a full attendance could be dangerous. If members were not in favour of something, all they need do if Mr. Kelly's suggestion was adopted, would be to stay away and the matter would be adjourned indefinitely.

"TERRIBLE" HE SAID

At a meeting of Dungarvan Urban Council, Mr. D. Moloney drew attention to the dangerous state of portion of the quay wall stating that if something was not done about it soon, it would topple into the sea. 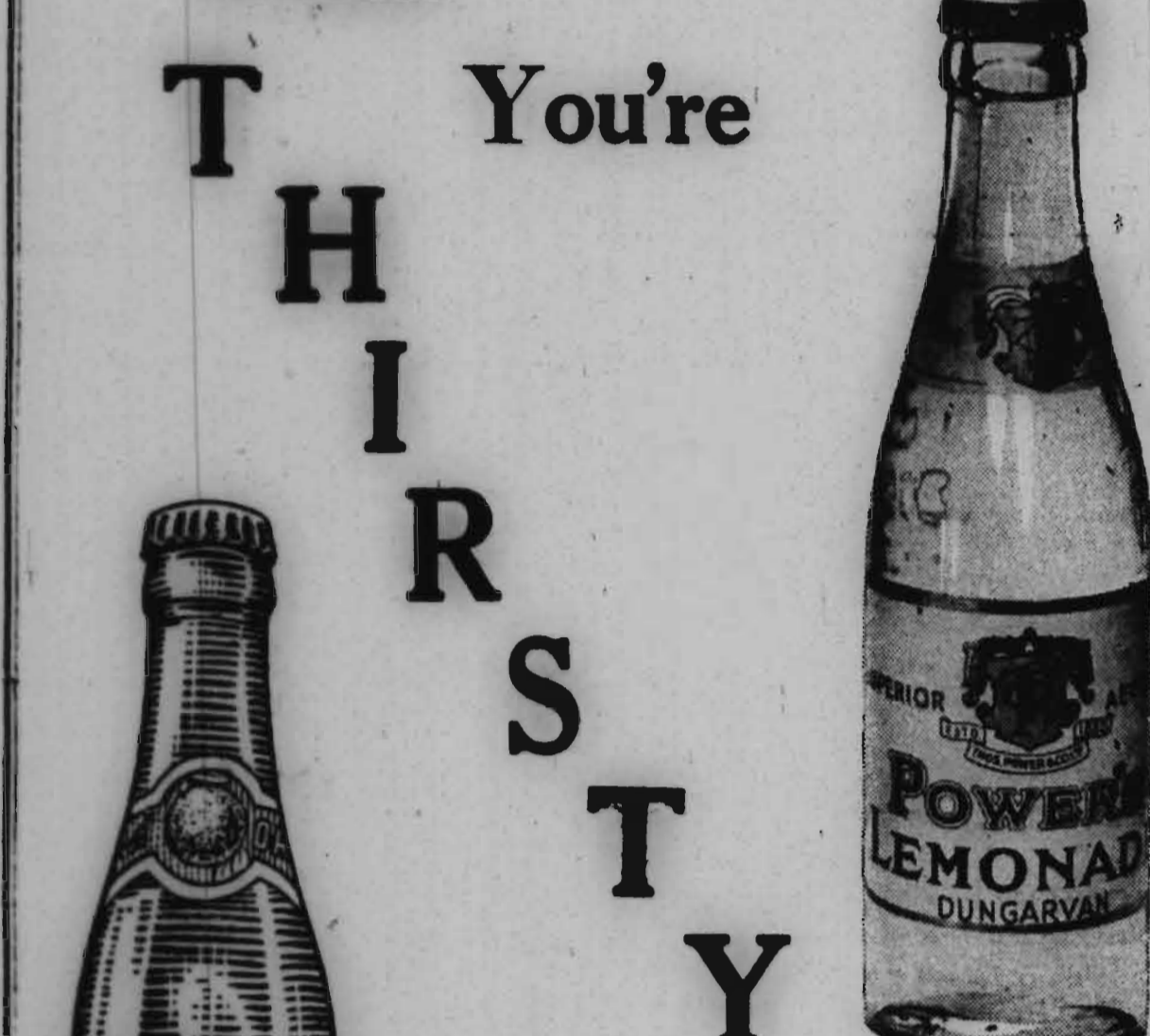

IRISH CLIMATE PRAISED

In his first public speech in Ireland, the United States Ambassador, Mr. Scott McLeod, spoke on the subject of the Irish weather. "You can honestly tell tourists," he declared, "that travel and sport are never interfered with by the weather in Ireland."

"No other area in the world that I know can state factually that it has no tornadoes, no hurricanes, no floods, no bitter cold, no plagues of insects and no snakes."

"I think that most Americans will agree with me that the Irish weather is near perfect."

Mr. McLeod said that San Francisco and Maine were two of the most famed American summer resorts and yet Dublin compared more than favourably with them with its summer temperatures.

"In my opinion, Ireland can sell its climate as 'Ireland, the land of perpetual springtime.'"

The average winter temperature in Ireland is 40 deg. F. to 42 deg. F., in summer 60 deg. F.

YOUGHAL COURT

At Youghal District Court before Mr. D. Mac Fionnlaith, C.J.

The Attorney General charged Ellen Meany, of Ballymadox, Youghal, that between July 22 and 26 at Ballymadox, Youghal, she did unlawfully steal a watch the property of Nora Smiddy, Ballymadox, and on the same day and place a Brownie camera.

In reply to Inspector Brennan, who prosecuted, Nora Smiddy stated that on July 20 last she came home on holidays, removed her wrist watch and put it on the kitchen dresser. A few days afterwards she looked for it and failed to find it. She reported the matter to the Garda at some time later the watch was recovered.

In reply to the inspector witness stated that she supplied the watch to the defendant in the kitchen for it. Miss Meany was one of the customers.

In regard to the camera, witness stated that it was laid in the dresser in the kitchen where the watch was.

Garda Carroll stated he was engaged in the disappearance of both articles. He met Miss Meany standing at her cottage and asked her the time. She said it was 12.30. Asked what time she had she produced the watch. He asked her where she got it and she said she found it with the camera on the road.

Garda Carroll, continuing, said she cautioned the defendant who made a statement in which she stated that she was coming along the road with the milk and she saw a black object on the road which she tipped with her shoe. It was a camera and was half open with a watch inside. Nothing would convince her but it was the people in the car which had just passed who lost it.

Inspector Brennan—Did you mention that you found these articles in your house?

—Yes, and there was a point in advertising the fact that I found them.

—Did you discuss the matter with your friends and neighbours?

—They are not up to much. You didn't try and find out who the owner was?—No.

Justice—Stealing by finding. I sentence her to one month in prison in each case, sentences to run concurrently.

Inspector Brennan—Defendant is looking after an invalid parent.

Justice—In the circumstances I will suspend the sentence provided she will enter into her own bond of £20 to be of good behaviour for 12 months and I will make an order for the return of the watch and the camera.

TRAFFIC OFFENCE.

Guard Winkle charged Albert John Grey, Brawonara, Ballyhooley Rd., Cork, that on August 23, 1957, at Mill Street, Youghal, being the driver of a motor van, he did stop the van within 30 feet of a road junction.

Keane, for defendant, stated that on the date in question he saw the van with a loud speaker attached and music coming from it. He went to defendant, asked him for his insurance certificate, which was in order. When he told defendant to move on he did.

In reply to Mr. Keane, defendant said he was an invalid and he was visiting a meeting on that day. He had a loud speaker and was playing records before starting the meeting. The Garda cycled past and came back to him. He didn't realise he was breaking the law.

The Justice applied the Probation Act.

The Attorney General charged Di. Casimira Knockraganagh, Yougal, with a breach of the licensing laws at 1.25 p.m. on Sunday July 23rd.

Garda Keane, who stated he was accompanied by Serg. Collins, inspected the premises and found five men there, two of them having licences.

Mr. MacLannara, for defendant, admitted the offence.

A fine of 10/- was imposed on defendant, 2/- of which he had to pay immediately and the balance of 8/- on the 10th.

Municipal authorities confer

EXCESSIVE SPEEDING ON ROADS DEPLORED

The concluding session of the Association of Municipal Authorities was held on Thursday in Bunranna, Co. Donegal, when the grave danger on the roads from the volume and excessive speed of motor traffic, both private and commercial, was stressed by delegates.

Two motions which were passed, one from Youghal U.D.C. and one from Midleton U.D.C. called for an amendment to the Road Traffic Act to provide for a speed limit on certain roads and in built-up areas.

Regulations were also recommended for the limiting of the size of vehicles "which tended to obstruct and impede other road users."

Mr. F. Walsh, Galway, said that seventy-five per cent of the fatal road accidents were caused by excessive speeding. Some consideration seemed to have no connotation with the safety of anybody in spite of the appeals in the newspapers and by various organisations and public bodies, the toll on the roads continued undiminished. In Germany, with its great highways, a speed limit was considered essential, but here in Ireland we were sitting back and doing nothing about this problem.

The Chairman, Mr. E. E. Byrne, said that legislation on a stricter rule was the answer. A motion from Bray Urban District Council calling on the Minister for Justice to introduce a system of licensing of commercial photographers was passed.

Mr. David Savers (Bray) who proposed the motion, said that there were many people who masqueraded as street photographers, taking money before supplying the print and thereafter never been seen again. He felt that if the practice was allowed to continue it would have a very serious effect on tourism. The motion was passed.

MALICIOUS DAMAGE CLAIMS
The local authorities were being unfairly shouldered with malicious damage claims was mentioned in a resolution from the Drogheda Corporation asking the Government to introduce legislation which would, in principle, place liability for proven claims under the malicious injury code upon the insurance company with whom the property was insured instead of upon the local authority as at present.

Colr. J. B. O'Reilly, moving the motion for the Corporation, said that the present legislation was antiquated and outdated. The position at the moment was that innocent people in towns were subject to these claims. He numbered a few cases in Drogheda which "people had to meet, cases over which they had absolutely no control.

Colr. E. Gibbon (Dun Laoghaire) said that in a lot of these claims the alleged offences were more ones of inadvertence than malice.

The present legislation could mean bankruptcy for some small local authorities.

Colr. Mrs. C. Byrne (Dublin Corporation) said that the City Corporation paid out thousands of pounds in such claims every year.

The Conference agreed to the suggestion by Mr. Liam Walsh (Navan) that the Association invest £20 in the Prize Bonds which were a gilt edged security.

STREET TRADERS

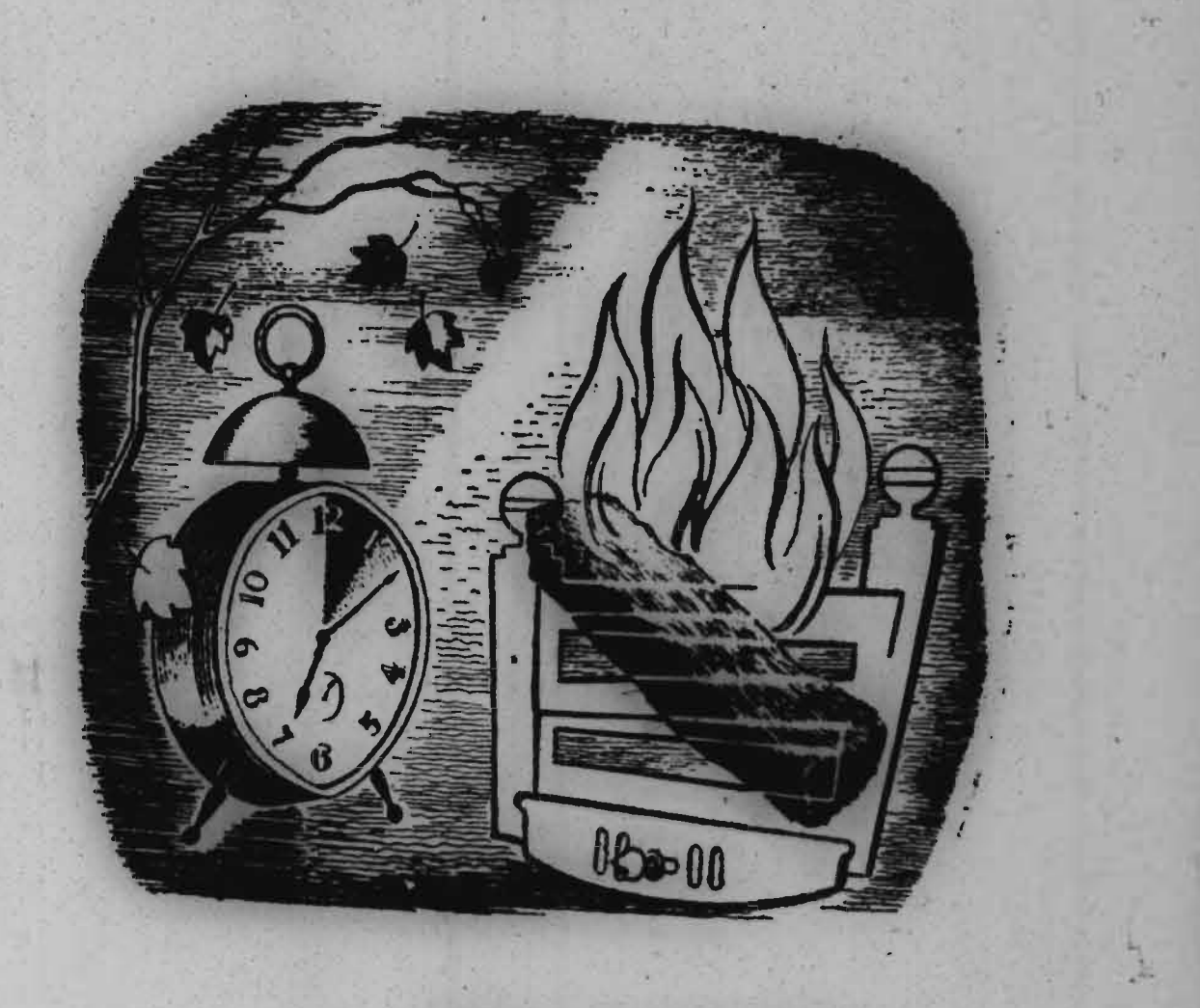

A hope at Last

As you will see from our report on the affairs of Dungarvan Urban Council, there is every hope of a proper water supply for the ratepayers of the town at long last.

A very fine report on the general position was put before the last meeting by the town engineer, Mr. Patrick Walsh, B.E. He summed up the situation very neatly when he stated "The present supply is anything but adequate to meet the needs of Dungarvan."

"It is well known, and it is well known to the people in the town know. We have had a system of water rationing in Dungarvan for quite a long while back. Exactly how long, I can't say but we are tired of it now and we are tired of the uncertainty of the whole situation.

Members of the Council fully appreciate the position. They certainly ought to from all the complaints that have reached them. Suggestions of improving the present system of supply are a waste of time. A new supply in addition to the old one is the only answer and it is good to see members of the Council thinking along these lines (with at least one member in opposition).

The proposed new source of supply would be the Colligan River. The scheme to harness its waters would be a combined one providing for certain needs of the County Council also. Dungarvan's share of the cost would be £68,700 and from the information I have seen on the proposal, I have no hesitation in stating it would be worth every penny of it. I certainly would have no objection to paying my share for a supply of water I can rely on.

However, nothing definite has been decided on the plan other than to refer it to the County Council for their views and to find out the maintenance costs. There may be a good deal of talk about increasing the rates to the tune of close on £67,000 in Dungarvan. My only hope is that councillors will not be put off by this. Let them bear in mind that we have a serious water shortage that has hampered business generally for too long and has endangered the health of the people more than we know of. Let them remember that if water is available such places as the Dickens Leather Co. and other local concerns will be happy to take a great deal more than they are using at present. And it will not be getting it free.

Better water supplies for the town will mean better revenue from water rates. It is possible according to the Town Clerk and the Manager that the increase in the rate in the £ will be completely offset by the increase in revenue from the water rate. From the Manager's attitude I believe that this will, in fact, be the case. And I believe it can be done.

But the people who will welcome the new scheme more than all others, if it comes about, will be the residents of the upper parts of the town who have been without supplies for so long. head." This column has always

Britain up to now has been adamant in excluding agriculture from the Free Trade Area. Recently, however, different views are coming forward. Most notable is the opinion by the Earl of Plymouth at a recent N.F.U. meeting in Shropshire. He accused the Government of trying to put the British farmers in direct competition with the low cost producers of the Commonwealth. At the end of this particular N.F.U. meeting in Shropshire a resolution was sent to the Headquarters of the powerful British Farmers Union to the effect "That subject to satisfactory negotiations the proper integration of agriculture with the European market would benefit Britain's farmers."

It seems to be very unlikely however, that she will eventually succeed in obtaining the best of both worlds, that is, to retain the European market for her industrial products and at the same time exclude agriculture.

As per usual, spectators were away inside both lines during the course of the game.

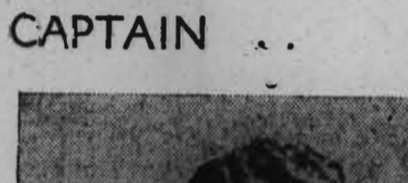
