

THE GREAT DAY TALLOW NEWS

Anyone interested in good continental films should not miss seeing "The Great Day," a really beautiful production, which will be screened at the Ormonde Cinema, on Monday and Tuesday next, May 1st and 2nd.

Founded on an actual occurrence, transported for dramatic purposes to an unnamed Cathedral city in Spain, and finally dubbed with English dialogue "The Great Day" promises to be one of the outstanding productions of the year. It is, perhaps, regrettable that, in their zeal for adaptation, the producers dropped the original title "El Trance Blanco" (The White Suit) and invented the rather vague and less appropriate one of "The Great Day."

Both, of course, apply to the unforgettable day of little Marcos' First Holy Communion when Spanish immemorial custom decrees that the happy participants are arrayed in a white uniform of robe or less military design. Marco, with the astonishing intensity of the preteenager, longs to array himself in just such a suit for the unique occasion of his First Communion. The only obstacle lies in the poverty of his parents. How effort and to admirable

illusioned and after the acclimatisation of purpose. For, after all, the Great Day is an intimate study of child psychology in a particular set of circumstances. The script writer succeeded admirably in his work of portraying with true Spanish dignity and restraint, an episode in the lives of the poor and the simple.

"The Great Day" is well worth seeing purely as a work of art, of good photography, and of human pathos.

His very voice, despite the unfortunate necessity of "dubbing" that of some other child on the sound track, is pleasing to the ear. Almost his equal is his fellow altar boy (Polonio) played by Miguel Angel Rodriguez.

The father (Luis Iduna) a poor workman sincerely devoted to his child, but understandably exasperated by the impossible task imposed on him of providing the necessary funds for the "Great Day," is perhaps a little too far removed vocally speaking from his social condition—the mother and sister being much closer to the type of their class; so too is the old watch-man, optimistic at times comic, and always perfectly in his role.

The elder brother, weak, dis-

dent in which the small brother is maimed, pathetically repentant, is another example of the actor who forgets to act, and who thereby achieves genuine art in all its splendour.

Old Dona Antonia, played by Marguerita Rubia, portrays admirable the "hard as nails" business woman with "no time" for small boys from poor homes. Her death-bed scene of repentance, during which she wills to Marcos exactly the sum of money required to realise his dream, is a triad of restrained pathos whilst the Madrid outitters, both men and women, provide in their secondary roles the perfect example of how a great artist can get the most out of a very brief appearance.

The whole story throws a light on something characteristically Spanish; the elaborate social event that First Holy Communion has become in the Latin countries. A THREAT TO CORN CROPS
 Leatherjacket grubs appear to be very plentiful in some parts of the country this year and may become a serious menace to corn crops. The leatherjacket grub is a dark grey creature rather like a caterpillar. It has a soft wrinkled skin and no legs and it ultimately develops into the fly known as Daddy-Longlegs. The leatherjacket spends the daytime in the shelter of small clods of earth, but at night it comes out and feeds on the young plants, cutting them across just at ground level. The damage is such that a plant cannot recover. It is most active during soft, warm weather and where there is a big number of grubs they can do a great deal of damage in a few days.

Charged with Murdering Farmer

Lismore Man Returned For Trial

DISTRICT JUSTICE L. SKINNER sat at Lismore on Monday for the purpose of the taking of depositions in the case in which Michael Langford (22), of Church Street, Lismore, is charged with the murder of Sean O'Farrell aged 64, of Ashbourne House, Lismore on March 19 last. After sitting for almost eight hours, Langford was returned for trial to the Central Criminal Court.

The first witness was Desmond Langford (19) of 6, Church Street, Lismore, brother of the accused, who said he lived with his mother, two brothers and a sister. His father was in hospital.

Witness said he knew Sean O'Farrell. His brother used to work for O'Farrell but had not done so regularly for over two years, the accused worked for O'Farrell on Saturdays.

Witness added: "I don't know anything of the relationship between O'Farrell and my brother. About fourteen months ago I worked for O'Farrell myself and my brother was with me. We were sawing timber for O'Farrell and the saw blade broke. My brother owned the saw and told O'Farrell that he wanted a new blade for it. There were some words between them and my brother said that if he would give him six months and my brother said to O'Farrell to get Michael Langford who was cycling and said he was going to Fermoy to collect a lorry which had broken down the previous evening.

Mrs. Bridget Hickey, of Bishopstown, Lismore, said she passed the entrance to Ashbourne House on March 19 and

Patrick Fegan, of Lismore, a bicycle dealer, said that in November of 1958 accused bought a bicycle on the hire purchase from him. O'Farrell, who was a customer of witness, made payments amounting to between £8 and £10 on the bicycle.

Mr. H. Cooke, Main St., Lismore, who went guarantor for the cycle for Langford, said he received a number of notices of arrears in payment on the bicycle and forwarded them to deceased.

Thomas Walsh, a farmer of Lismore, said he was employed by deceased and often heard Michael Langford and O'Farrell having arguments over O'Farrell's van.

Dr. Daniel Healy, Lismore, said he examined the body of O'Farrell and found that the garment he was wearing were perforated.

Sergt. J. Daly of Lismore said that as a result of a report by Desmond Langford (brother of the accused) at 7.30 a.m. on March 20th he went to Ashbourne House, where he saw the body of O'Farrell lying in the yard in the back of the premises.

In O'Farrell's pockets, said the Garda "I found two single £1 notes and a 10/- note as well as a 6d piece and a pocket watch."

SHOTGUN IN HALLWAY

Inspector M. Farrelly, Dungarvan, said he found a double-barrelled shotgun in the hallway of O'Farrell's house.

Garda C. Houlihan, Lismore, said that on March 20th he found two empty shotgun cartridges cases on the lawn at O'Farrell's house.

Garda T. Donovan, Cappoquin, said that on March 20th he found a cartridge case in the field beside the avenue leading to O'Farrell's house. He also found letters in O'Farrell's house.

Garda J. Winters, Dungarvan, said he found two documents in the living room of O'Farrell's house and handed them with the statement to Mr. A. C. Brooks, a handwriting expert of Naas, in Co. Kildare.

Suplt. M. Costelloe, of Dungarvan, said he arrested the accused at Adelphi Quay Garda Station in Waterford, where he saw him making a statement to Sergt. P. Spillane.

Already the depositions of the State Pathologist and Dublin Special Branch detectives, as well as a number of Waterford Gardaí have been taken.

HEARD A SHOT

Patrick Quinlan, Owbeg, Lismore, said that on March 19th he walked with his brother through a quarry on O'Farrell's land. He heard a shot, but had only "a faint recollection" of hearing a second one. After the shot, he carried out firing to determine the range from which shots at O'Farrell were fired. He formed the opinion that it was not greater than four yards and not less than eight yards.

"It was obvious from photographs," witness added "that the deceased was not facing in the direction of the gun when it was fired. He could have been facing in the direction of the gun before the discharge."

CONFIDENCE The influence of the N.F.A. was very obvious from the terms of the Budget, introduced by the Minister for Finance, last week. If agriculture is to be a source of positive policy on the part of the Government, it must be treated as a separate, distinct, and separate.

Furthermore, as Mr. Meenan pointed out the implementation of the suggested recommendations can lead only to "a terrifying amount of paper-work all round." As he so aptly concluded "it is for the income tax system to adjust itself to the type of economy and society in which it is to be operated, not the other way about, and if there is a clash between the interests of producers and the interests of the tax system, it is the latter which must give way to the former."

We would like to congratulate our Minister for Finance, Dr. Ryan in not taking any notice of these recommendations in the recent Budget. The N.F.A. feels justly proud of the influential part it has played in defending the Irish farmer in this matter. It is obvious from the report, that the only group who really put up a reasoned, hard-hitting, factual case for the farmers, was the N.F.A.

Indirectly, they have paid us a great tribute.

EDUCATION AND AGRICULTURE It is relatively easy to find a fault with our educational system, as a whole. The agricultural sector in all our competitor countries, is more highly organized than ours is. Their educational system is much more in line with present day modern demands. It gives them an edge on us, that we cannot afford. Due to the efforts of organizations such as the N.F.A., farming in Ireland is now being looked upon as a highly skilled vocation, requiring the top brains of the country, if success is to be achieved.

We agree with the editor of an influential provincial paper, that "the time has come for a critical reappraisal of our whole approach to this subject."

IRISH FARMER AND INCOME TAX-N.F.A. DEFENCE Last week the N.F.A. came out with a new motion on the side of Irish farmers. One of the main points of the Fourth Report of the Commission on Income Taxation appeared, it brought a new Irish relief, correcting many of the false assumptions contained in the report. Seven people signed the motion. Support—all non-farmers—and it is quite evident from their recommendations, that they are not in sympathy with the Irish farmer or indeed with any farmer with his problems.

For a first attempt at Thermos food jar cookery, you might try one of the following: Jointed cooked chicken in a rich cream sauce with mushrooms; cubed cooked meat, beef, lamb or chicken—in curry sauce; stewed steak in gravy with carrots and onions; black pea soup with chopped cooked sausage; spaghetti with meat or tomato sauce.

Celtic Continue Winning Nominations to An Bord
Sequence Baine

DUNGARVAN CELTIC selected the two valuable points that would give them their first league title or at least accede to a play-off, when they beat Portlaw 2-0 at Clasca Park on Sunday last.
