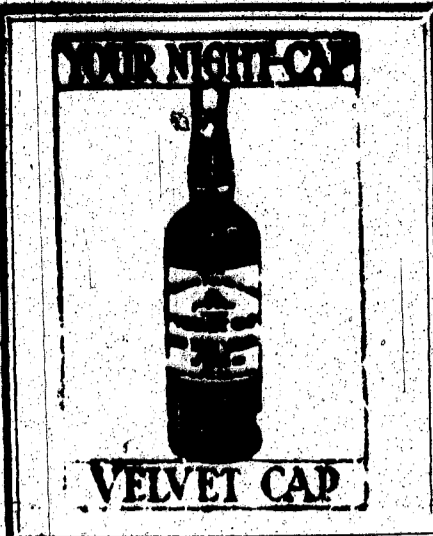

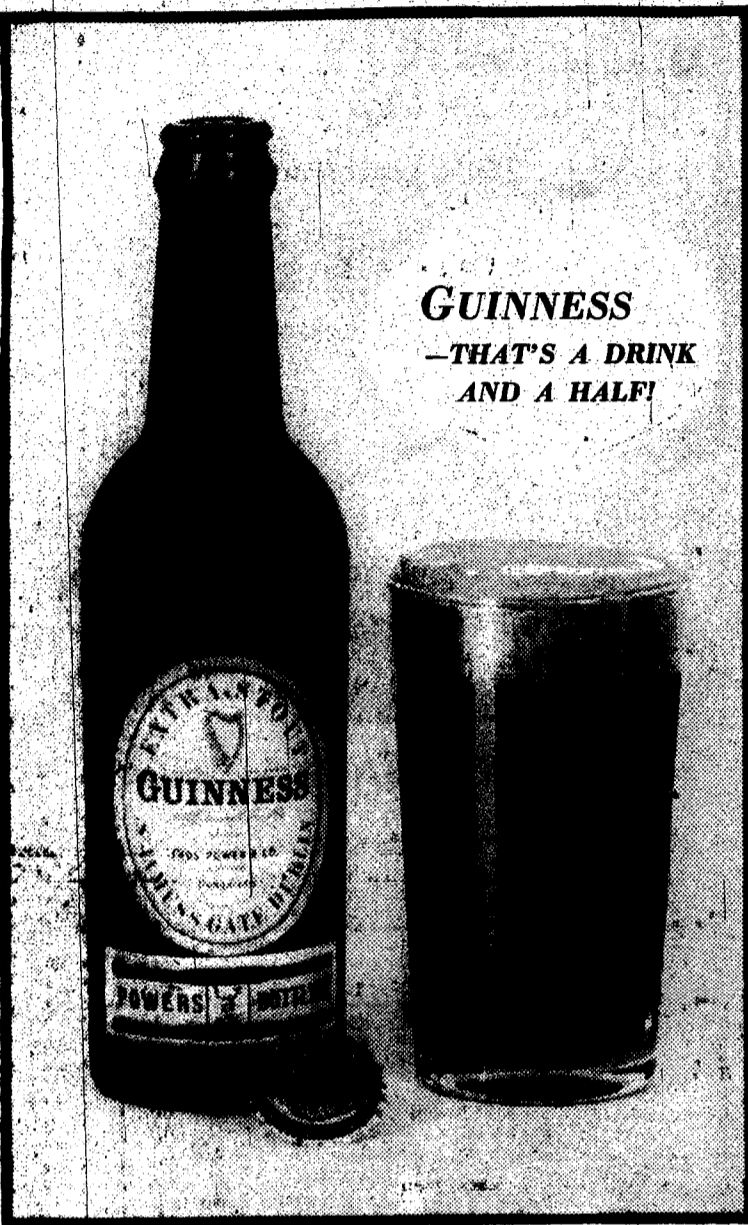

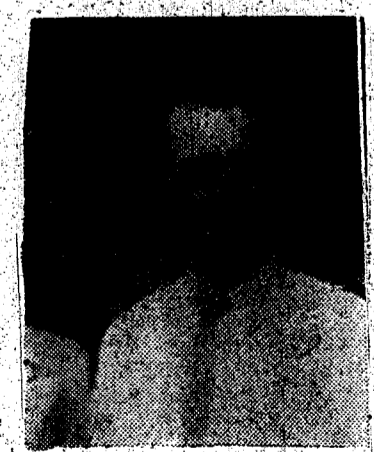
### BIRTHDAY PARTY

### "WENT AROUND WEDDING BELLS LIKE A LITTLE GANGSTER"

WHELAN-SCANLON

At Dungarvan Court on Wednesday, Justice Skinner adjourned for three months the case in which a local youth was charged with stealing six newspapers, the property of a local newsagency and taking unlawful possession of a bicycle without the consent of the owner at Cathal Brugha Place. He was also charged with assaulting Bernard Wall, by pointing a knife at him.

Supt. Costello said Bernard Wall was employed to deliver paper. The defendant took possession of his bicycle while he was in a house. He brought back the bicycle and threw it at the boy. He took out a knife and put it against the boy's throat and told him he would cut his throat. Wall's sister came along and pulled the defendant away. The defendant took six newspapers and ran away with them.

Justice Skinner said the defendant went around like a little gangster. He would not allow this to continue. He adjourned the case for 3 months to see how the defendant behaved himself.

### "A REMARKABLE CAPACITY"

A local man (18) pleaded guilty at Dungarvan District Court on Wednesday, with the larceny of a pair of gloves, valued 30/2, and with stealing two watches, valued 22 on December 26th.

Supt. Costello said the gloves were taken from a coat hanging on a halstand in a local hotel. The watches were taken from a house.

Mr. Farrell said the defendant who was a member of a respectable family, lost his job and went on a spree. He had a remarkable capacity and drank 18 small rums. He had no recollection of taking the article. Justice Skinner applied the P.O.A.

### Bench Warrant for Witness

Justice Skinner issued a bench warrant at the Dungarvan District Court last Wednesday for Michael O'Donnell, Ballinlisa, Leamybrien. The warrant was issued when he failed to appear in court as a witness in the case in which Maurice Pennell is charged with assaulting him at Kilineen on November 12.

The committee was set up at a public meeting held at Waterford, and was representative of education, industrial, agricultural and cultural interests in the city and county.

Best man was Mr. Thomas Whelan, brother of the groom and the bridesmaids were the Misses Mary Scanlon, sister of the bride, and Agnes Scanlon, cousin of the bride.

The bride, who was given away by her father, wore a full length gown of white satin brocade with train and full length veil held in place by tiara of pearls and sequins. She carried a bouquet of white and red carnations. The bridesmaids wore full length gowns of old gold satin and carried bouquets of carnations and maidenhair fern. The groomsmen were Mr. John Whelan, brother of the groom, and the trainbearer was Master Tony Devine.

Miss E. Mullins, A.L.C.M., presided at the organ and during the ceremony Mr. Michael Keane, Waterford, sang "Panis Angelicus" and "Silent Night".

The reception was held at the Hotel Menila, Clonmel, and the honeymoon is being spent in Scotland.

### Drunken Driving Charge Dismissed

Morgan Mansfield, Crobally Old Parish, was charged at Dungarvan Court, on Wednesday, with drunken driving of a van at Knockenpower, Ring, on October 18. Sgt. Mulvey, Ring, said he had a van parked on the centre of the road with its lights on full. He formed the opinion he driver was drunk and brought him to the barracks. Mansfield staggered on either side of the white line on the road. He told the Garda he was as drunk as an owl.

Dr. A. Casey said she examined the defendant at the barracks. He was well in command of himself. She came to the conclusion he had drunk taken earlier in the day but he was fit to drive a car. The Justice said there was a doubt in his mind and he dismissed the charge. He fined Mansfield a total of £1 for failing to produce a driving licence and having no rear white light on the van.

### Fined for Careless Driving

John Joyce, New Line, Abbeyside, Dungarvan, was fined a total of £6 at Dungarvan District Court on Wednesday, when he was convicted of careless driving and failing to stop at the scene of an accident, at Mitchell St., Dungarvan, on October 1. He was ordered to pay £10/10/2 in expenses.

The case arose out of an accident in which Teresa Wall was injured in a collision between defendant's car and a stationary van. She was removed to hospital for treatment. Joyce said he did not know about the accident until later.

Justice L. Skinner said it was a slight accident and reduced the charge of dangerous driving and ruled as stated.

Waterford No. 1—At Ballybricken, on Friday, 14th Feb., at 11 a.m. The value of the Nominations shall be as follows: Thoroughbred Stallions, £5; Irish Draught Stallions, £4; Half-bred Stallions, £3. Preference will be given to the best young mares under six years of age. An Entry Form shall not be accepted in respect of any mare which, having received a Nomination in 1963 and 1964, proved in both seasons to be barren, nor shall such mare be eligible for exhibition for nomination purposes in any future year unless the owner produces satisfactory evidence that the mare has become fruitful. As far as possible, two-thirds of the nominations shall be reserved for Farmers whose valuation is under £50. There is no upper limit in the valuation to debar an entry. The term "Farmer" is to be understood to mean a person who derives his means of living mainly from farming. Special attention is directed to the following regulations:— 1.—Only such farmers as are rated for holdings within the county are eligible for the exhibition of mares. (N.B. This regulation does not apply to herds). 2.—Each qualified rated farmer is entitled to compete for Nomination for one Mare only, but the Committee may award a second Nomination to Owners of Mares on the Reserved List. 3.—SPECIAL NOTICE.—Any person found (a) exhibiting a Mare not his bona fide property; (b) attempting to obtain more than one Nomination through any misrepresentation as to Ownership of his mare, or (c) sending for service a Mare other than the one in respect of which the Nomination was awarded, is, guilty of a Criminal Offence, and will be prosecuted. WATERFORD HEALTH AUTHORITY AMENDMENT OF ACTS relating to CHILDREN IN FOSTER HOMES, ETC. Attention is directed to the important changes effected by the Children (Amendment) Act, 1957, in the law relating to children placed in foster homes, or placed in employment in certain circumstances, by a person or by a body other than a local authority. By reason of these changes, all the existing requirements regarding children up to age 9 accepted in foster homes for onward now apply to such children up to age 16 and apply in addition to illegitimate children accepted in foster homes, other than the homes of relatives, irrespective of whether the child is received for reward or not. 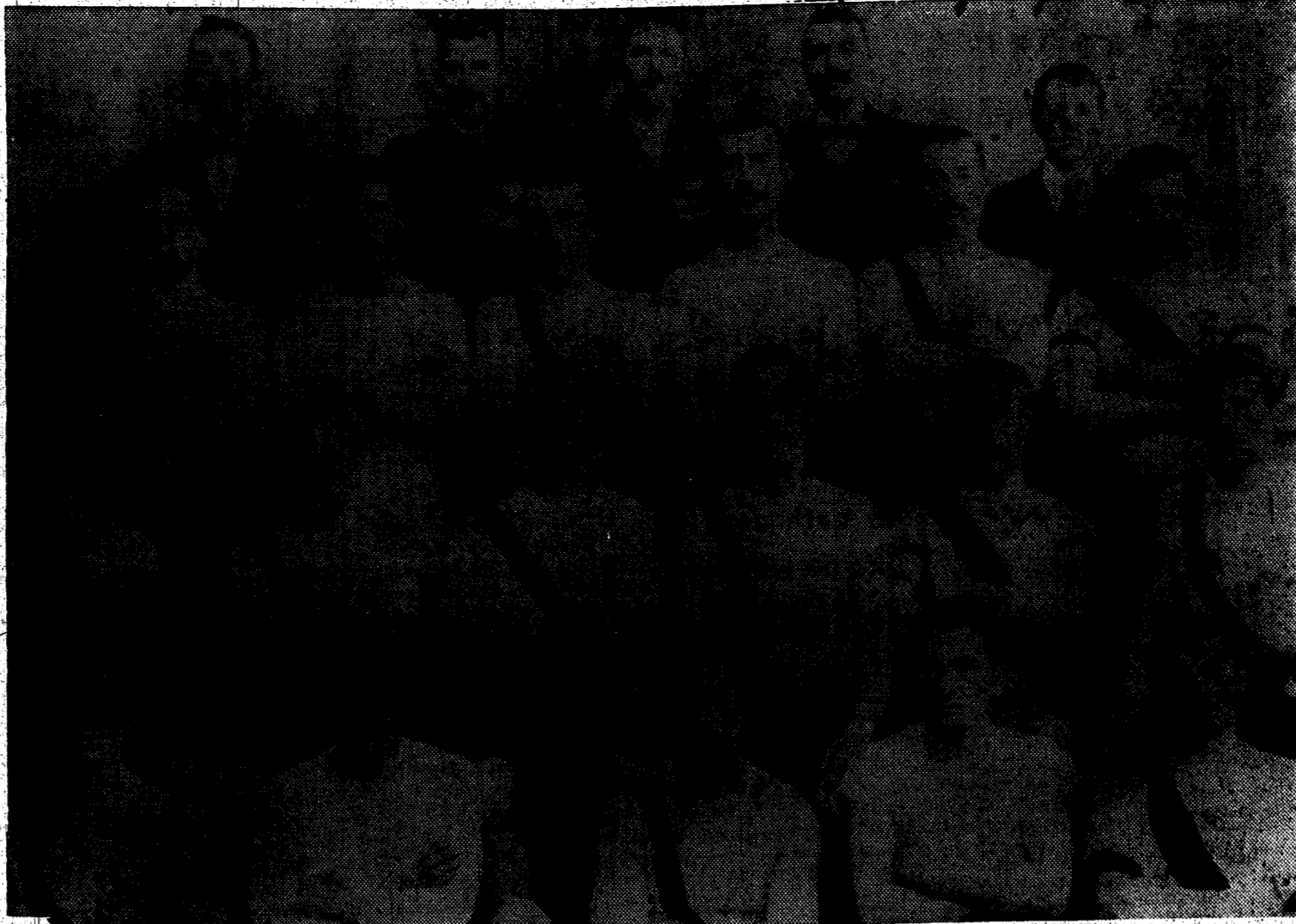

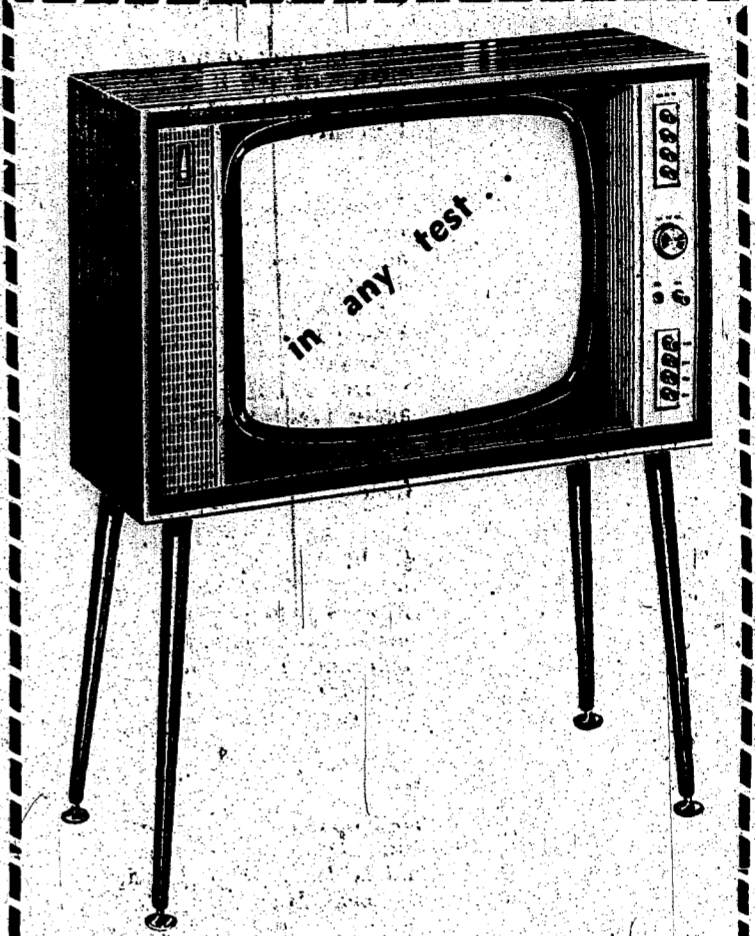

- CLASS 9.—Proficiency Competition.** Highest butterfat yield per acre.
- CLASS 10.—Proficiency Competition.** Best sugar-beet yield per acre.
- CLASS 11.—Proficiency Competition.** Highest wheat yield per acre.
- CLASS 12.—Farm Planning Competition for Young Farmers.** (Confined to Macra na Feirme Clubs and Muintir na na Tire Guilds). N.F.A. NEWS
N.F.A. Prepared to Resolve Unity Difficulties

The main heads of N.F.A. and completely untrue accusation that N.F.A. is interested in taking over I.C.M.S.A. unity was made by Mr. Richard Derry, President N.F.A. when he spoke in Limerick, last week.

Under the milk policy, he said: 1-An immediate increase in the basic price of all milk; 2-Incentive bonuses for the producers of high quality milk; and 3-The transfer to Central Funds of the present levy on the levy of 1.5p per gallon.

"Milk producers," he said, "must be relieved of this burden until the price of milk is raised to an economic level, if they are to have the confidence to expand in accordance with the targets of the output set by the Government's Second Economic Programme. Such expansion cannot be realised if producers are faced with milk prices which are not progressively reduced as output rises in accordance with the terms of the levy mechanism."

Full Benefits for Family Farm.—"The N.F.A.," said Mr. Derry, "stands for an adequate system and credit facilities to enable the producer at the end of our national dairy industry still further so that the highest possible family incomes can be earned from dairying on our family farms. Finally, we want full recognition of the part played by dairy farmers in providing our livestock industry with its basic raw material—the calves. It is our policy that where this recognition comes in the way of herbage grants, it should be administered on a sliding scale basis, so that the full benefits go to the family farm and are not left open to exploitation by large-scale operators."

These are the fundamentals of N.F.A. policy on milk and milk prices restated, not because they are not already well known, but rather because in all essentials they correspond so closely with the declared policy of, for example, the I.C.M.S.A., that we have in fact what amounts in all essential matters to a Common Milk Policy. One may therefore wonder why there is not a common effort to back this common policy.

Benefits from their Working Together.—At this time of the year our thoughts naturally turn to the future and we resolve ourselves to various measures of self-discipline and self-improvement. One field in which we can look back on 1963 and record a satisfactory measure of progress in achieving the targets we set ourselves in last year's good resolutions is that of farmer unity. The numbers of farmer organisations who are working ever closer harmony with N.F.A. is constantly growing and both we and they are feeling the benefits that arise from working closely together in the cause of Irish farming.

The most significant gap that still remains and prevents Irish Agriculture from presenting a united front to the Government and the industrial sector of our economy," said Mr. Derry, "is the situation which still exists between the N.F.A. and the I.C.M.S.A."

No Real Divergences of Policy.—"Since taking over from my predecessor, Dr. Joan Green, my personal efforts to close this gap have met with rich approaches, both formal and informal, as seemed reasonable to me to find out in what way an understanding might be reached. One of my suggestions was that an agenda should be drawn up setting out the points of difference, so that we could get down to a detailed examination, point by point, to see how these differences, be they real or unreal, could be resolved, and I very much regret that this idea has not been accepted."

"Therefore, I can only work on the basis of press statements appearing from time to time setting out various points of I.C.M.S.A. policy and opinion. From them I inevitably conclude that on all major policy issues, especially on milk and milk prices, there are no real divergences of policy separating the two organisations."

Similar Problems Successfully Resolved.—"It seems that some of the obstacles to unity of action in this sector," continued the President, "are as follows: 1-The lack of unity among producers in backing a milk policy which already exists and which is necessary in all essential matters; 2-The constantly voiced

These are questions which every farmer should ask himself. Now that 1964 has begun, you might go further and ask: "Is the N.F.A. there for the help you have remembered of all farmers and not for individual or individual sections? Have you shown this help when making criticisms or offering suggestions? These questions are reasonable ones and every farmer will do himself a good turn if he tried to answer them honestly."

Are you satisfied that all resolutions which have gone forward to your county executive or from your executive to national council with your support were fair and reasonable? Have you allowed a few individuals to dominate the proceedings? Have you been able to encourage non-members to attend the Association's meetings? At additional meetings held more especially at your A.G.M. have you voted on a personal basis rather than on ability?

If you are a branch official have you accepted your part as an honour or as a duty? Have you done your part in making a proper effort to get your members to play their part in organisational work? Have you been satisfied with merely maintaining your present position? Are your branch meetings interesting? What have you done to make or kill them? Are you helping your branch members to do what they can to help themselves?

With these thoughts we leave you all next week, when we will consider some other ways in which you can help the Association in 1964.

Every farmer would be well advised to obtain a copy. Somewhat similar information is included each year in the N.F.A. Yearbook, but there have been some changes since the 1963 edition was published.

Of importance to farmers also are the preliminary figures given for angling visitors. These indicate an increase of about 10% for 1963; up from £1,347,000 to £1,482,000. It is estimated that there were 27,800 game fishing visitors, spending £457,000 and 13,200 sea anglers spending £330,000. These calculations assume that game and sea anglers spend an average of £25 each and coarse anglers spend £24.

Report of Irish Language Commission

The following statement has been issued by the Government Information Bureau, on behalf of the Department of the Taoiseach: The Final Report of an Commission on Athbheochan na Gaeilge (The Commission on the Revival of the Irish Language) has been published. It was presented to the Taoiseach on the 13th July last by its Chairman, the Reverend Professor Tomás Ó Fiaich, and it incorporates two Interim Reports of the Commission which have not hitherto been published. The Interim Reports dealt with: (1) Television, dated the 20th March 1959, and (2) The Provision of Textbooks in Irish for Secondary Schools, dated the 4th July, 1959. The Final Report has been signed by all the members of the Commission, but its signature is subject to a number of reservations—subscribed by, in all seven members, out of the twenty-eight members of the Commission. Also published is a Summary in English of the Commission's Final Report, which was presented to the Taoiseach by the Chairman of the Commission with the Final Report itself (in Irish) on the 13th July last. Particular attention is invited to the fact, which is mentioned in the last paragraph of the Introductory note to the Summary, in English, of the Report, that the Summary is, of necessity, confined largely to conclusions, without attempting to adduce the arguments supporting those conclusions. The arguments are to be found in the Final Report itself. The recommendations of the Commission are at present being examined by the various Departments concerned, and when that examination has been completed, it is proposed to publish a White Paper embodying the policy of the Government on the Commission's recommendations.





# Western Board Takes Stock

 2.—That in 1964 Divisional and County Board deduct 5% of gross gate of all matches played under their jurisdiction with the intention of establishing a fund to erect dressing-room accommodation at venues invested in C.L.C.G.—Geraldines.  
 3.—That Bye-law one, County Bye-laws (1962) be amended as follows:—Where the words Primary are used at present, the words Junior Grade B be used.—Sappoquin.

**SECRETARY'S REPORT**

The Secretary's report states that the year under review was a most successful one from every point of view and that despite the many difficulties which arose because of a crowded championship programme we were able to complete all eight championships almost on schedule.  
 In affiliations a new record was set up and of the one hundred and eleven teams which entered of the championships, only eight did not fulfill their engagements.

In all a record total of one hundred and five matches were played in the championships and leagues and the fact that this programme was completed despite the many interruptions during the earlier part of the year, reflects great credit on the clubs and officials, without whose full co-operation this would not have been possible.  
 During the year there was a marked improvement in the standards of some grades, compared with previous years. This was not the case in the Primary championships however, as a number of the teams taking part were merely fulfilling a formality by playing. The decline in the standard in the grades mentioned is due to the fact that we have too many teams affiliating, with a consequent and inevitable reduction in the strength and standards.

Apart from the junior championships, at least there was a total of 45 primary teams entered for the championships and it is too much to expect that this division could field this number in any grade.  
 It was a great year as far as County titles were concerned and only two of our eight Divisional champions were defeated in the county finals. This was a most satisfying achievement when we consider the high standards of the eastern divisional teams in recent years.

**FINANCE**

Financially it was a good year and receipts showed a marked increase over previous years. This can be taken as a good indication of the increasing interest in our games due to the many and varied counter-attractions that had to be catered for during the year.

**NEW MEDALS**

During the year the new two championship medals were designed and presented to the champions. The West Waterford character of the design was decided on by the officers of the Board and submitted for approval to the clubs before being accepted. These medals, of a distinctive character, were designed in deference to a long standing de-

**JUNIOR HURLING**

Ten teams affiliated in the grade and before its conclusion this championship provided many fine games that were delightful to watch. From start to finish the competition gave us games well worthy of the contestants and in the nine hurling games played the standard of hurling and sportsmanship left nothing to be desired.

In the opening rounds they were splendid contests between Cappoquin and Fourmilewater; Lismore and Tallow; St. Michael's and Kilgobinet, and Shamrocks v. Kilrossanty. In the semi-finals St. Michael's and Shamrocks and Fourmilewater v. Tallow all produced hurling of a very high standard. The Divisional final between Shamrocks and Fourmilewater was the only game which failed to live up to expectations and for the second year running the champions Fourmilewater emerged victorious. Six weeks later the Divisional champions contested a great year by defeating De La Salle by the narrowest of margins in the County final and took the junior hurling title back to this Division for the first time this decade.

**PRIMARY**

The number of teams taking part in this championship increased by six over the previous year and as a result the problem of dates and venues was considerably increased. Still the splendid co-operation shown by all concerned eased the task of the Board and made it possible for us to complete the championship at a reasonably early date. Most of the games worth noting in this championship were reserved for the final and semi-finals and the quality of the hurling in these games compensated to some extent for the poor quality seen in the earlier rounds. The games between Tourin and St. Mary's, Tourin and Affane and St. Mary's v. Glenmore Rovers were of a high standard and in the divisional final between Abbeyside and Tourin this high standard was maintained despite the atrocious conditions under which it was played. Tourin emerged as very worthy champions and to their first Divisional Primary title they added the County crown when they proved too good for Butlers-town in the County final.

**JUNIOR FOOTBALL**

Because of the unexpected withdrawal of Baile Mhic Cairbre the number of teams taking part was reduced to seven. In all it provided us with not more than four well contested games and the all-round standard, in my opinion could not be favourably compared with that of previous years. Valley Rovers v. Kilgobinet and St. Michael's v. Cappoquin were the two best games in the series and for periods during these games the football reached a very high standard.

In the final between Valley Rovers and Ballinacorney the football was rather disappointing and neither side were able to produce their best football. Valley Rovers won their fourth Divisional title and in the County final their consistency was rewarded when they won their first ever junior football final in a close contest with eastern champions Tramore. No better team deserved this title as they had previously been unsuccessful in three county finals.

**PRIMARY**

In this grade there was an increase in the numbers taking part, from 22 to 24. Quite a number of the games in the earlier rounds of this championship were disappointing due to the fact that some clubs who were not overstocked with football talent had to rely on the services of too many juveniles and minors to assist them in their games and when we consider that it would require three hundred and sixty primary players to complete the teams who entered, the continued deterioration in the quality of the football standards is understandable. The semi-final stages were reached before we had any games really worthy of note, but from then on the quality was excellent.

The Divisional final between Brickey Rangers and Affane produced the best football seen in the Division since the inauguration of the champion-

ship and after the best certainly one of the most sporting finals of the year. Affane survived to represent the West in the county final. They again produced a high standard of football in the final when beating Fenor.

**MINOR HURLING AND FOOTBALL**

As in the previous year, 14 teams competed in the minor hurling championship and after some vigorously contested matches, Ballyduff and Abbeyside emerged as Divisional finalists. In the drawn game and in the replay both these sides gave us some delightful hurling before Ballyduff took the title. This was their club's second hurling victory this year and much credit is due to the men who have devoted their time and energies to training and coaching the young hurlers of this former hurling stronghold. In the county final they gave the best performance of an exceptionally good eastern champions.

Fourteen of the original fifteen teams fielded in the minor football championship and although the standard was not quite up to the quality of the football seen in former years in the earlier rounds, the standard improved wonderfully as the championship progressed. In the games between Fatha v. Cappoquin; Abbeyside v. Ballinacorney, and Abbeyside v. Ballinacorney, we had three delightful contests before Ballyduff and Abbeyside again emerged as the finalists. This final lived up to expectations with Abbeyside gaining a narrow but deserved victory. They failed to Tramore in the county final.

**SPORTSMANSHIP**

It gives me no pleasure to report on the poor standard of sportsmanship displayed in quite a number of our games during the year when the behaviour of some players reflected little credit on themselves or their clubs.

The tendency to regard toughness or ruthlessness as was the case in many games, as a suitable substitute for hurling or football ability when trying to outplay a superior opponent on the field, should be discouraged and condemned by all those who accept the responsibility of fostering games.

As a result of these incidents a record number of Board meetings were held to deal with offenders and there followed a record number of suspensions.

Happily for the Association the vast majority of our players showed a more educated approach and their behaviour at all times left little to be desired. These men are genuinely proud of their Association and its aims and as such they remain determined to play the game for the sake of the game. Let us all hope that their good example will be followed by the few others who appear to see things differently.

**REFEREES COMMITTEE**

During the year our faithful band of referees continued to serve us in their usual efficient manner, and it is pleasing also to report that a number of new referees have now joined the panel.

Unfortunately we did have a few occasions when the integrity and impartiality of these men were challenged by people whose ignorance of the playing rules is really amazing. One number of resolutions the Board had to severely deal with such offenders, and again the Chairman has had occasion to reiterate his pledge of last year that he would show no leniency in dealing with players or members who refuse to respect the authority of our referees.

Because of their splendid handling of the games during the year the Board has on occasions paid many tributes to the wonderful service being rendered by these men. Heaven speed the day when every man will appreciate and realise that without our referees, there can be no Association.

The formation of a referees committee this year has received enthusiastic approval in the Division. At a number of well attended meetings such matters as policy, match arrangements and playing rules have been discussed and recommendations which were subsequently made to the Co. Board have been approved. This committee will continue to meet regularly and during the coming season trainee referees will be admitted and instructed on the handling of games.

**JUVENILE CHAMPIONSHIPS**

At the commencement of both these championships the standard of hurling and football was disappointing and the

number of uneven contests was somewhat disappointing. As the championship progressed the all-round standard improved and we had many thrilling games before the Divisional titles were won.

In hurling the number of teams taking part was reduced to nine when three of the original entries were forced to withdraw.

In the Dungarvan group the Old Boro' side proved much too strong for Abbeyside and Cathal Brugha, but in the final of the group it took a tremendous effort to beat Stradbally. In the Divisional final Ballyduff who had already won out in the Lismore group, proved much too strong for Dungarvan, and two weeks later the new western champions won the county final defeating Mt. Sion in a very closely contested game.

In the football championship ten teams took part to

give us some very exciting games before Stradbally and Ballyduff won out in their respective groups. In an exciting Divisional final Stradbally won their first Divisional title. In the county final they came out on top after a hectic battle with Portlaoise.

Because of an objection and an appeal the ultimate destination of this championship has yet to be decided.

**WINTER LEAGUES**

Despite the many difficulties involved in completing a full championship programme it is gratifying to report that fairly satisfactory progress was made with our secondary competitions. Both the hurling and football leagues which remained to be finished at last Convention were completed by April. Geraldines, after years of unsuccessful effort in the hurling league, won their first title by beating the holders St.

Declan's in a great final. In the football final the holders Ballinacorney retained their league title in a closely-contested final with Kilgobinet.

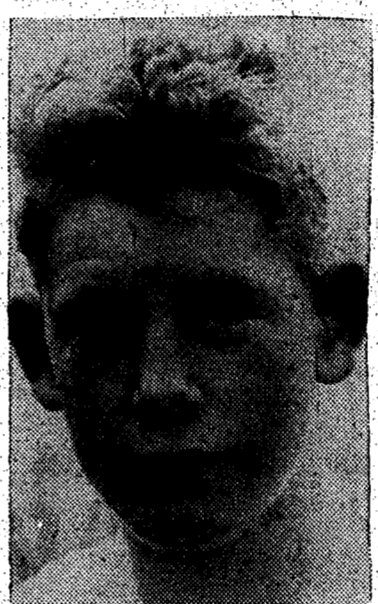
The final stage has now been reached in both the current hurling and football leagues and it is hoped to have both these games played within the next few weeks.

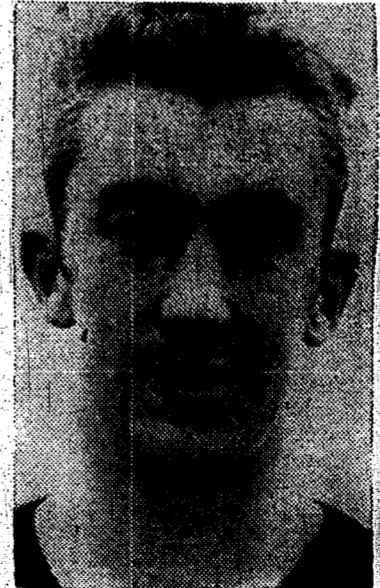
The organisers are preparing for a big entry in both races, and a special request is made to spectators to co-operate with the race demands in the interest of comfort for the competi-
