

## NO RATE AFTER 4-HOURS DELIBERATION County Council must meet again

FOR almost four hours on Friday last fifteen of the twenty three members of Waterford County Council tackled their onerous duty of arriving at a County rate for 1965/66. Confronting them was a proposed rate of 58/1.62d. in the £ representing an increase of 6/7.62d. on the current rate and at the end of their long evening "in session" they had further reduced this proposed increase by five-pence three-farthings. But not having gone completely through the estimates of receipts and expenditure, it was unanimously decided to adjourn the striking of a rate until Friday, 5th March.

In his report on the estimates, Mr. Simon Moylan, (Co. Manager) said that the estimate of expenditure for the coming financial year as prepared and considered by the estimates Sub-Committee provided for an expenditure of £1,357,289, excluding malicious injuries and town charges for Lismore and Tramore. The provision for water supply maintenance was £11,400 which showed an increase of £1,400 over the current year. The increase was due to the necessity of providing chlorination plants at Tallow and Clashmore, increased provision for the maintenance of the Lismore-Cappoquin, Ballymacarby and KilmacThomas schemes and also for the minor water supply schemes which were increasing in number and provision for increased remuneration for the water supply caretakers. As in previous years he wished to remind the Council of the importance of striking an adequate rate.

Breaking tradition with previous years the County Executive of the N.F.A. did not send a deputation to this year's meeting. Instead their Secretary, Mr. Brian Pearce, Monatrim, Lismore, sent a letter addressed to the Chairman, Mr. Charles Curran, pointing out that in previous years they had drawn attention to the heavy burden placed upon farmers and other ratepayers by the successive increases in the rate. This form of taxation had to be borne regardless of the ability of the ratepayer to meet the demand irrespective of his liabilities. The N.F.A. at a national level had made the Government aware of its great concern at the increasing burden of local Government taxation and had been gratified by the response of the Government towards the agricultural sector in recent years. They would continue to press for a further rationalisation of this burden.

The letter added: "We wish to point out that our executive are fully aware of the difficulties facing your Council at the present time and are very mindful of your members' concern at keeping expenditure within reasonable bounds, but we would press you to continue to exert every means to halt the continuing inflationary trend and the increasing demands being made upon the ratepayers whose contribution to the community has become increasingly disproportionate to other sections. In this connection he would again stress the importance of pressure being brought to bear on the Government in an effort to have a greater share of the Health Act carried by Central Funds and thus relieving local taxation. Active support

from your Council in this respect would be greatly appreciated." The letter concluded that the County Waterford Executive of the N.F.A. was anxious to play its part in co-operating with the Council for the betterment of the people of the County. Addressing the meeting at the outset, the Chairman (Mr. Curran) said that once again they were meeting to tackle the mammoth and thankless task of considering the annual estimates and striking a rate to maintain the public services in the administrative area of Co. Waterford. Here, as in all other counties there was a steep increase but in the main due to reasons outside the control of the Council.

Mr. F. O'Leary said that the Minister for Local Government decided to uphold the appeal of the Assistant County Engineers for an increase in salary and that would cost the Council £2,164 in back money. This meant about £360 for each of the six engineers involved. Mr. Norman Walsh said he believed a saving of £1,000 could be made in loan charges. He proposed they reduce the figure from £5,000 to £4,000—the same figure as last year. This was unanimously agreed to by the Council.

Replying to further questions by Mr. Lannon, the Co. Accountant said that on October 1st '63 the Assistant Engineers had a maximum of £1,400. Now their maximum was £1,880. The Co. Engineer (Mr. J. D. Hally) said that was a national award. Mr. Lannon said he did not care if it was a National award. The ratepayers could not afford to pay salaries like this. Where was it all going to stop. The Co. Accountant went on to state that five of their assistant engineers were on £1,400 and the other five were on £1,880. He said the Co. Engineer was on £2,000 and it was proposed to give him £3,135. That was on the agenda also for to-day's meeting.

It was also proposed to bring about it. They were being paid no more than their counterparts in other counties and it was out of their control. This Council had been most economically minded in this matter. Mr. O'Ryan—The members could have voted against the increases during the year. Mr. Lannon—It was all due to pressure from Dublin. Mr. Fahey said the officials in Waterford were always the last to get the increases. Repeating to Mr. Dowd, the County Accountant said the engineers got an allowance for the tax and insurance for their cars. If the car was under 10 horse-power they got an allowance of £44 a year. They were allowed travelling expenses at the rate of 4d. per mile for the first 4000 and 6d. a mile after that. Cars over 10 h.p. and under 12 h.p. got an allowance of £50 a year and 5d. a mile for the first 4000 miles and 7d. a mile thereafter. Cars over 12 h.p. got an allowance of £56 a year, 6d. a mile for the first 4000 and 8d. a mile after that. Mr. Dowd said he did not think any injustice would be done if they decided not to pay more than the rate for cars between 10 and 12 h.p. viz. 5d. and 7d. This resolution was passed with Messrs. Kyne, Galgey and Cahill dissenting.

Mr. Curran said the Dept. however had laid down their figures and there was nothing they could really do. Mr. Dowd said they could surely direct that no car in excess of 12 h.p. be used and if so they would not pay for it. (Continued on Page 5)

### Dungarvan Cattle Mart

In order to comply with the recent regulations of the Department of Agriculture, only 30-day Tested and Blue Card (other than drop calves) can now be sold at the above Mart.

- We would like to bring to the notice of farmers the following points which may be of assistance to them in this recent change of marketing procedure:
- (1) The Number on the ear tag must correspond with the number on the Certificate. If there is any discrepancy whatsoever, the animal will have to be removed from the Mart Premises immediately.
  - (2) On arrival at the Mart, please book your cattle at the Checker's Box and on receipt of your Lot Number proceed to the Cattle Crush and hand same to the Marker.
  - (3) It is essential that the animals are numbered in the Crush so as the Lot Number can be entered on the Blue Card or 30-Day Test Certificate.
  - (4) Once the cattle have left the Crush the Lot Number on the animal's back must not be changed under any circumstances.
- N.B.—NO SHEEP SALE ON MONDAY NEXT.

## Health Authority grants further increases

THIS is why we will have a budget this year that will shake the country to its foundations, said Mr. Charles Curran, at Dungarvan when the arbitrator's awards Monday's Health Authority meeting in on the revised salary scales for the Chief Medical Officer and Assistant Chief Medical Officer were announced. The new scale for the Chief Medical Officer is £3135 a year and £2350 for his assistant.

Having stated as quoted Mr. Curran went on: "Certain sections in this country are living in poverty. These people are already terribly well paid men and no one here can deny that these increases are contrary to the principles of Christian charity."

Mr. John Fahey said the ordinary people in the County would resist these enormous salary increases. They would have to make a stand and they should remember that there are people in the County rearing families on £8 a week. In places such as Tallow, Lismore and Cappoquin, where there was no great circulation of money, the small shopkeepers were really up against it and it was about time they took notice of what these people were saying. Mr. Norman Walsh—There is no regard for social justice at ministerial or union level. Mr. Lannon—It is all getting out of reach of what the people can afford to pay. If public bodies throughout the country rejected these increases they would not be given. Mr. Galgey—This is an arbitrary award. Who really put it up? It was a case of I'll scratch you and you'll scratch me. Mr. Lannon said at the next meeting he would put in a notice of motion that they accept no more arbitration. The Chairman said he ac-

BOVINE T.B. ERADICATION

The Department of Agriculture had intended to attest these six counties in two lots, but progress in getting rid of reactors and having herds re-tested has been so good all over the area that it has been found possible to treat the six as a unit from now on...

The completion of this final stage, apart from finishing off the eradication scheme, will make the largest single contribution to the attested herd as the six counties hold nearly 70,000 herds containing 1.5 million cattle...

They will be the last to become attested mainly because the incidence of bovine tuberculosis was the highest in the country - 3.5% in cows and 1.2% in other cattle compared with 1.5% in cows and less than 0.5% in other cattle in the other 20 counties...

As from 19th February the regulations covering the movement and sale of cattle in the area will be tightened and any herd which has not had two consecutive ear tags will be "locked-up".

The herds in the area which have already had two consecutive tests without showing any reactor, have been issued with blue cards covering the animals. Over 50,000 herds are now blue-carded and cards will be issued to the remaining herds according to the testing proceeds...

A special effort will be made by Department of Agriculture staff and the veterinary practitioners to avoid any delay in reaching attestation. The Director of Veterinary Services will make a tour of the counties within the next few weeks to meet the veterinary surgeons and other interested parties...

U.D.C. GIVES £1,400 FOR ROAD MAINTENANCE

On the proposal of Mr. R. Waisa, seconded by Deputy T. A. Kyne, Dungarvan Urban Council at a special meeting on Thursday night of last week decided to give £1,400 to Waterford County Council for the maintenance of urban roads for 1965/66. The proposed demand by the County Council was £2,500, whilst the figure agreed to by the Urban Council is £100 more than the current year's figure.

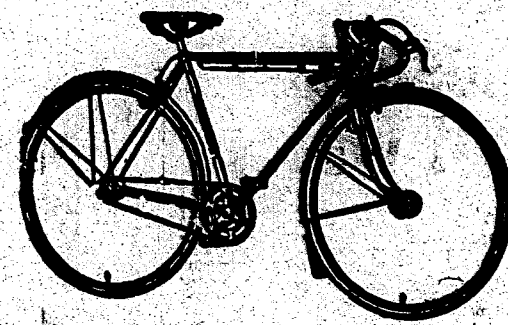
At the outset of the meeting, the Chairman, Deputy Kyne, said it was regrettable that only four members (Colrs. R. Walsh, J. Kenneally, P. Whelan and Deputy Kyne) should turn up for this very important meeting. He had driven from Dublin at 70 miles an hour to be present because he felt it was so important, yet five members from all parties were absent.

The Town Clerk (Mr. P. J. Doyle) said the County Council's demand was £1,200 more than they gave last year for maintenance and this represented an increase of 1/8 in the rates. Colr. P. Whelan said the rates would be high enough this year and the people could not afford to pay them.

Deputy Kyne said they would have to be fair to the people of the town. If it was necessary to economise on roads this year they would have to do so. Colr. Whelan proposed they leave the maintenance figure at £1,300, the same as last year, plus £60 legal expenses incurred during the year.

Deputy Kyne said if they increased last year's figure by £100 that would only put 1d. on the rates. Colr. Walsh agreed. Colr. Whelan said there would be a lot of 1d's before they were finished. Deputy Kyne said he did not want to cut the roads maintenance estimate where by they would not be able to keep them properly. Colr. Whelan then proposed they give the County Council £1,300 but he failed to get a seconder. Colr. Walsh then proposed £1,400, seconded by Deputy Kyne and this was carried by four votes to one.

INCREASED FEES FOR DOCTORS

By a vote of eight, Waterford Health Authority at its monthly meeting on Monday last decided to increase from seven to ten guineas per patient the fees of doctors under the Maternity and Child Health Services Regulations, 1964.

The Secretary (Mr. J. A. Hynes) said this matter had come before them previously and it was refused by the Committee. However, he had received a letter from the Minister which stated that the Minister felt they should reconsider their decision as the doctors could terminate their agreement with the Health Authority. If this happened the Authority would not be able to carry out its duties.

Mr. J. Power proposed they pay it. There was only £6,000 involved he said. Mr. Lannon said this would require a notice of motion. Mr. Hynes explained that it would not, because the six months since it last came before them was up to-day. Mr. E. Browne seconded Mr. Power's proposal.

The County Manager (Mr. S. J. Moynihan) said it was mandatory anyway and there was no use beating around the bush. Mr. Lannon proposed the increase not be given. They were not objecting to the service but to the money these doctors were getting.

Mr. N. Walsh seconded. The Chairman (Mr. P. Browne) said all other Health Authorities had agreed to the revised scale. Mr. Lannon - Have strength, mean what you say and you will get what you want. This is what this country is coming to. A vote was then taken and the increase was given by the one vote majority.

Laundry Service to Continue

A notice of motion by Mr. Thomas Lannon at last Monday's meeting of Waterford Health Authority that they continue the laundry in the County Home, Dungarvan, and that they provide any necessary equipment for it, was unanimously passed. Mr. Lannon said they were paying £40 a week for laundry which was being sent to the County Home to an outside laundry. That was costing nearly £2,000 a year and they should pass this motion.

Mr. Charles Curran seconded the motion said it was a matter of some urgency. Mr. William Kenneally said that he opposed this originally but he had only the County Engineer's view that the establishment of a laundry in Dungarvan would cost £20,000. However, he was on the visiting Committee for the month of February and saw the Dungarvan hospitals and he could not see where a laundry would cost £20,000. Now he believed they should spend the necessary money and have a proper laundry in Dungarvan.

Mr. J. Power said they were giving a Youghal laundry £40 a week, but he was sure that with the spending of a little money on the Dungarvan laundry they would save that and a lot more. Mr. Lannon said there was some equipment already in the County Home. All it would cost to get additional equipment was £4,000. The motion was passed without opposition.

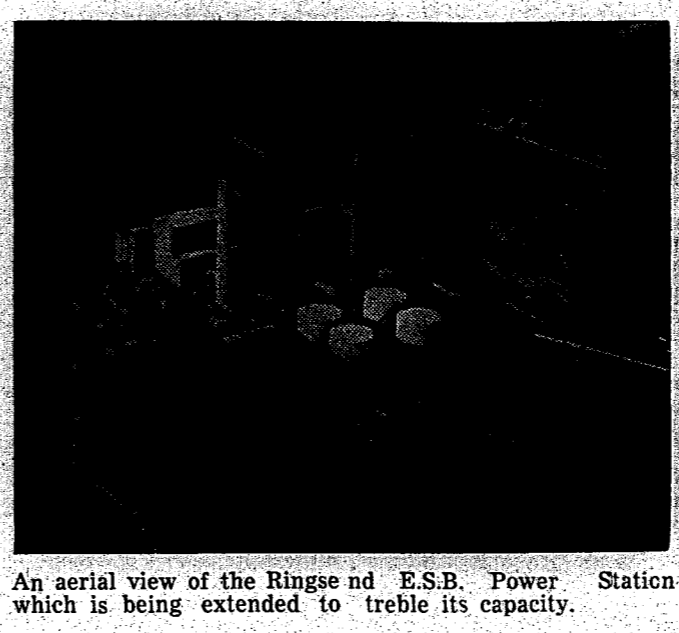

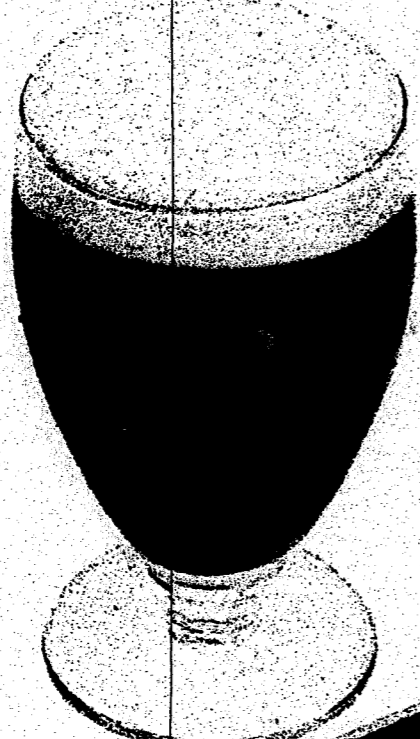

# No Rate Struck

(Continued From Front Page)

Deputy T. A. Kyne said the engineer was not entitled to buy a car and he could hire a hackney car at 1/3 a mile. Engineers were not being paid at 7d. a mile.

The Co. Engineer said that Mr. Dowd's proposal was not effective.

Mr. N. Walsh said that whatever about the travelling expenses, there seemed to be no justification for the tax and insurance allowances.

The Manager said it was the Dept. that laid down the regulations regarding travelling expenses and the Council hadn't got the right to dictate figures to them.

Mr. Curran said he was in favour of the terms of Mr. Dowd's proposal, but it was the Dept. who would decide the figures.

The Manager said he did not think there was any car in excess of 12 h.p. used by the Engineers.

Mr. N. Walsh said that if the Minister would bear 75% of the Health cost, thus spreading taxation over more shoulders, they could reduce their rates by 12/6.

He said the health system should be run on a voluntary health insurance basis and people should get their health services as a right and not as a charity.

On the proposal of Mr. John Drohan, seconded by Mr. J. Fahey, the Council decided to send a resolution to the Minister asking him to increase the health grant to 75%.

When dealing with Sanitary services, Mr. Lannon proposed and Mr. O'Ryan seconded, that salaries under sanitary be reduced from £2,600 to £2,250. This was passed but the Co. Manager said it was not effective and he could not accept it.

When discussing the General purposes, the Chairman Mr. Curran said the Vocational Committee's estimate was up by 3d.—the maximum

allowed by law. This big increase was due to salary increases, the reconstruction of the technical school, the establishment of a new Vocational school in Tallow, and the Mobile school in Knockanure.

Mr. Lannon remarked that the salaries were simply rocketing.

Mr. N. Walsh said the day was coming when they would kill the goose that laid the golden egg.

When considering the estimate for the Library service the Co. Librarian, Mrs. Hayes, said that her original estimate was for £13,955, but the estimates Committee reduced that figure to £12,855. The main increases in the service were books and salaries. She appealed to the Council to pass £12,855, as that was the minimum they must have to cope.

At this stage, Mr. Walsh said he wished to protest strongly to the manner in which the Library Council of Ireland deliberately misrepresented the Council's decision of a previous meeting in relation to the Library development plan. The Library Council was endeavouring to lead them up the garden path, and the decision was for the whole Library scheme or not at all. Going on the assumption that they were not going ahead with the Library development plan, he asked what reduction could be made in the rates.

Mrs. Hayes: None.

Mr. Dowd said the Library Council acted cunningly and meanly.

Mr. Walsh: We will fight them tooth and nail now.

Deputy Kyne: That will mean Dungarvan losing a £10,000 grant for its new Library.

Mr. Dowd then proposed that they provide £12,855 for the Library service. Deputy Kyne seconded. This proposition was defeated 7-5.

Mr. W. Foran then proposed and Mr. K. O'Ryan seconded, that they put up the same amount as last year (£10,800). This was passed by eight votes to five.

Mrs. Hayes said they would not be able to carry on the services with the amount they were being left with only £1,700 to work with for books. Salaries amounted to £6,552.

Mr. Dowd said he deeply deplored that such a small amount was being provided, but the Library Council of Ireland and those that aided and abetted them were to blame and not the Cols.

At this stage it was stated by the County Accountant that the net effect of their savings during this meeting was 53d., and it was decided to adjourn until Friday, 5th March, when a further attempt will be made to strike a rate.

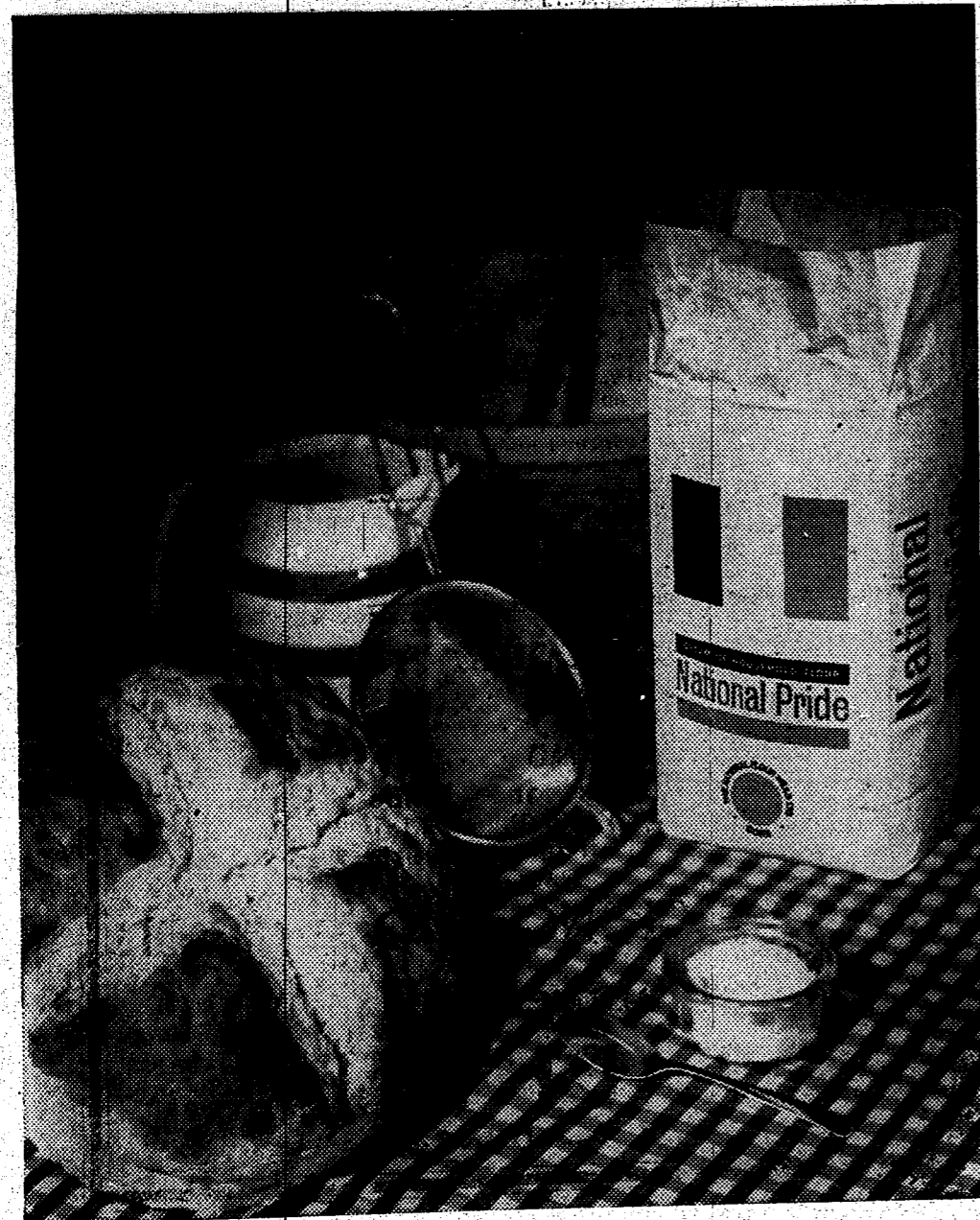

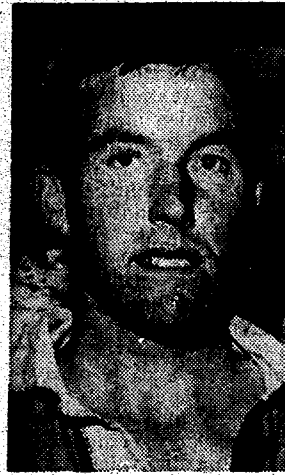

WATERFORD'S senior hurlers make their '65 debut at New Ross on Sunday next when they meet Leinster champions Kilkenny, in the O'Kennedy Shield. Waterford are holders of this trophy, which they won for the first time last year, but it will take a supreme effort by the chosen fifteen if they are to defend it successfully on Sunday.

Kilkenny have already had the benefit of an outing this year when they trounced the Rest of Leinster by the clear seven goals. As yet they have not announced a side for Sunday but it is expected that the majority of their championship stalwarts will be included.

Waterford, who face two important National League games in the coming weeks, are experimenting to some extent in this game. Five of the team have never tasted championship hurling but the most striking feature is the return of Joe Condon at left half back.

Of late there have been good reports of Condon from the City, and he is said to be quickly running back into top form. The eyes of selectors and followers will be on him on Sunday.

The defence has a much changed look about it, with such regulars as Tom Cunningham, Austin Flynn and Larry Guinan absentees. The goalkeeping job is again given to Jim Power, the St. Finbarr's (Cork) club man who has impressed so much since being handed the number one jersey.

Midfield, for long the "Achilles heel" of the side undergoes further alteration and on Sunday John O'Brien teams up with Abbeyside's

Liam Enright who deservedly continues to find favour. Strongest sector of the side is the half-line of attack — Flannelly, Cheasty and Frankie Walsh. This has been the team's championship trio in this sector for many years past now and the bulk of the scores will be expected to come from them.

Once again Charlie Ware has been given the full-forward berth in the continued absence of John Barron. But this to my mind is a most short-sighted policy by the men whose duty it is to pick the team. Ware has been tried on countless occasions without success and I hope I am not being too critical of the player when I say he will

hardly ever make the inter-county grade. Why then persevere with him when others could be tried out in the position?

Vinny Connors returns to the side at top of the right and Philly Grimes completes the fifteen in the other corner.

Without definite information on the Kilkenny line-out it is difficult to anticipate how this experimental Deise fifteen will fare out. The newcomers, however, will be battling for places on the team for the closing stages of the National league, and I confidently expect the side to give a very good account of itself on Sunday.

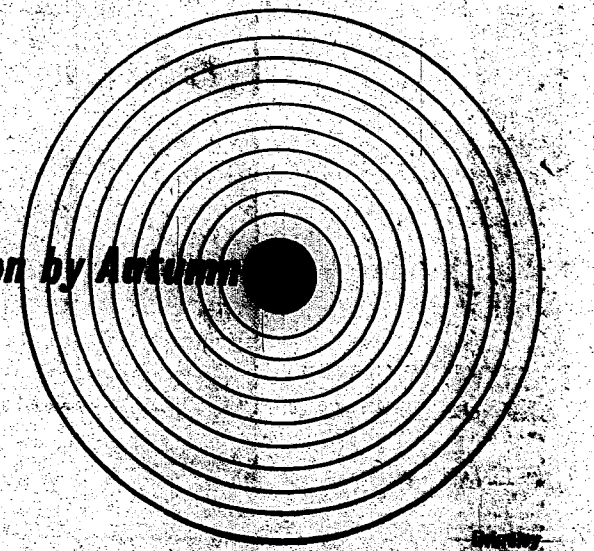

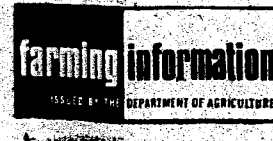
**Bovine Tuberculosis Scheme**

## Cork, Kerry, Kilkenny, Limerick, Tipperary, Waterford

- The fourth round of clearance testing in these counties is now under way. If it goes well, the area will be declared attested in the Autumn.
- Any herd not yet of "blue card" status is now locked up and a permit must be obtained to move any cattle into or out of such a herd.
- Each herd-owner will be notified by his Veterinary Surgeon of the date of the next test.
- A test may not be postponed. All cattle in the herd must be presented and all of the blue cards must be surrendered to the Veterinary Surgeon before the test can commence.
- Only attested, blue card or 30-day tested cattle may now be shown at a public sale.
