able com-factors were of opinion that, on account of some obscurity in the wording of the Corn Law, Rye would not be allowed to be imported. The impression in the Corn Market was general. In consequence, we are sorry to observe, the Daily Papers have fallen into the same error; thus, leading the Public. The aggregate average for the six weeks were:—

Wheat 92s. 9d. Barley 44s. 5d. Oats 27s. 6d. Rye 35s. 7d. All these descriptions of Grain are therefore freely admitted, without payment of any duty whatever, for the next three months, from foreign countries; and the import of every description of Grain is allowed from the British colonies in North America for the same period, until the next average is made up (15th February next). There is, however, a very important clause in the Act, deeply interesting to those concerned with shipments of Grain from the immediate coasts of Holland and France; imports from thence may only be allowed for six weeks. The following are the particulars:—

"But if it shall, at any time after importation is permitted, appear that the average price in the first six weeks succeeding the period, 15th February, 15th May, 15th August, and 15th November, shall have fallen below the import rates, the import from all places between the river Eider, in Holstein, and the river Bidassoa, in Spain, both inclusive, shall cease until a new average shall be made up and published in the London Gazette for regulating the succeeding quarter."

To prevent misconception, as to the giving way of the front wall of one of the houses opposite Carlton-house, the Public are respectfully informed, that it was occasioned by the separating of the wooden water pipe under the pavement, and discharging their contents into the foundations of the houses, bursting the drains, and carrying all before it; had the accident happened in the day, by diverting the course of the water the mischief would have been prevented; fortunately, the care that has been bestowed on these foundations has rendered the effects much slighter than would otherwise have been the case.

BONAPARTE.—When the Thais sloop of war left St. Helena, on the 29th of September, Bonaparte was well; but it is reported, that as his displeasure with the Governor, Sir Hudson Lowe, continued, all access to him by strangers, or communication with his residence, was cut off. It is stated, that when he was informed by Sir Hudson, that Government had ordered the reduction of his allowance from £20,000 to £8,000 per annum, he requested that an armorer from one of the regiments might be sent to him, to strike off the eagles and other imperial emblems from his plate, being determined to dispose of all that part of his property, and not be limited to so scanty an allowance.

A Sunday Paper gives a Letter from St. Helena, dated the 22d of September, which contains the following statement:—"A very curious circumstance occurred here a few days ago. Bonaparte, in a rage, ordered his service of plate to be broken up, the eagles which were engraved to be engraved, and the whole to be disposed of as old silver. He applied to a merchant, a resident of this place, who asked permission of the Governor. He thought that the amount would exceed £ or £4000 sterling. The Governor consented to the merchant's going to look at the plate; but observed, that the amount should not be paid to Bonaparte, but deposited in the hands of the Governor or the Payveyor. When the merchant went to look at the plate, instead of the sum above mentioned, the property was about £10,000 sterling—a sum rather too great to be packed here at so short a notice. However, in a day or two it is expected that this curious negotiation will be brought to a close. It is said, that Bonaparte wishes, by these means, to make himself independent of the British Government, and that, in future, he will never make any application for money, but live upon his own resources. DUEL BETWEEN MR. ALLEY AND MR. ADOLPHUS.

(Transmitted by a Correspondent.)

Public curiosity and surprise have been excited to no inconsiderable extent in the course of the last week, by the announcement of the meeting which took place between Mr. Alley and Mr. Adolphus, on Saturday, the 16th instant, at Cahel, and the circumstance has become a subject of much inquiry and comment in various circles, but particularly among the gentlemen of the profession to which the combatants belong.—The following is the most accurate account of the occurrences which preceded and ended in the meeting in question, that we have been able to obtain. It appears, that ever since the publication of the particulars of the dispute between Mr. Alley and Mr. Adolphus, the latter gentleman has not met with that cordial reception among his brother barristers, to which he had previously been accustomed. Many, who had been his intimate friends, seemed to view the part which he had taken in the transaction with disapprobation, and, indeed, some we know did not hesitate candidly to tell him, that the *shame* which he had manifested, however justifiable to himself, with the world did not redound much to his credit.—In such a situation of things, it was impossible for Mr. Adolphus to exist without the most mortifying sensations; and at length a hint having been given him, that the best course for him to pursue, would be to depart for Cahel, and invite Mr. Alley to follow him—he adopted that mode of proceeding. The circumstances which accompanied the invitation, however, it is stated, were rather of an extraordinary nature, and having since transpired, have induced many observations on the conduct of Mr. Adolphus, which we do not feel ourselves warranted in repeating. Thursday week was the day on which Mr. Adolphus carried his determination into effect. On the evening of that day, about seven o'clock, Mr. Alley having a large party to dinner with him at his house in Northumberland-street, a person came to his door with a double knock, and asked if Mr. Alley was at home? Being answered in the affirmative, he said he wished to speak with him on private business. Mr. Alley being informed of the fact, desired that the gentleman might be shewn into the drawing-room, and immediately followed him thither. On entering the room, the gentleman delivered him a letter, which, on opening, Mr. Alley discovered to be from Mr. Adolphus. Mr. Alley then asked him who he was, and whether he was to consider him as the friend of Mr. Adolphus. To these questions the gentleman made no other answer, than that all he was desired to do, was to deliver the letter, and having done that, he should withdraw. Mr. Alley then went down to his cousin, Captain Alley, who was with his other friends in the parlour, communicated the message he had received, and at the same time begged he would join the gentleman in the drawing-room, and, if possible, learn his name. Captain A. complied with his cousin's wish, but was unable to obtain the desired information, and the gentleman quitted the house without announcing himself, or even confessing himself to be the friend of Mr. Adolphus. The letter was couched in the most scurrilous and abusive terms; it imputed to Mr. Alley cowardice and falsehood, and called upon him, if he was disposed to dispute the first of these disgraceful charges, to follow Mr. Adolphus to Cahel, for which place he had departed that day, and where he should remain until Tuesday, the 19th. Allusion was then made to the conduct of Mr. Alley in the recent dispute—he was accused of having caused false reports of that transaction to be spread abroad, and it was insinuated, that his wish from the first was rather to avoid than to meet Mr. Adolphus in a hostile way. This was followed by reference to former disputes, every sentence being charged with the most insulting epithets, and finally, a threat was held out, that if Mr. Alley declined the proposed meeting at Cahel, he (Mr. Adolphus) would on his return to England publish such a statement of his conduct, both on that occasion and on various others, in the course of his professional pursuits, as he might think proper. Under the influence of the indignation produced by this letter, although some of his friends remonstrated with him upon the degradation to which he would subject himself by taking any further notice of the author, Mr. Alley determined to accept the challenge, and the next morning at day-break set off in a post-chaise and four, in company with his cousin, for Dover. Thither he was followed by two brother Barristers, Mr. Agar and Mr. Berkle, whom he invited to be witnesses to the contest, but any difference should hereafter exist as to the facts which might transpire. A packet-boat being engaged for their conveyance across the channel, they soon reached the French shore. It was then too late to go in search of Mr. Adolphus, who had started
