THE LATE CONSPIRACY.

We have just heard that a Special Commission is immediately to be issued for the trial of the conspirators who stand committed for High Treason.

The commitment of the prisoners to the Tower on the charge of High Treason is founded on the recent Act in amendment of the Statute of King Edward III. by which a conspiracy to levy war is declared to be High Treason, without an overt act.

It is not in Scotland.—We copy the following from the Inverness Journal of Friday last, March the 3d. It is dated half-past two, p. m.:

Ross-shire.—The mail just arrived from the north has brought the disagreeable intelligence of a serious riot which occurred yesterday near Culrain, in Ross-shire.

Private accounts received from Spain, alluding to the enterprise of Colonel Riego, state, that in his march to Malaga he suffered but little from O'Donnell's corps, and that he has pushed on to Grenada, from a knowledge that the sentiments of the inhabitants are favourable to the Constitutionalists.

These prospects of success in the South are likely to be seconded by revolutionary movements in the Northern Provinces of Spain, and particularly at the foot of the Pyrenees.

We hope the time is not far distant when the United States will free itself from the stigma of domestic slavery. The voice of public opinion is evidently beginning to be heard in its condemnation, and when that is the case, the Legislature of a free country cannot long resist its influence.

The Missouri Question, says the National Intelligencer, is at length determined in the Senate. After a debate, as full as deliberate, and as able, perhaps, as ever took place in that venerable body, the Senate have decided, by a vote of nearly two to one, that the Congress of the United States does not possess the right to impose upon the People of Missouri the proposed restrictions, as a condition of their admission into the Union.

It would seem as if the commercial policy of the United States were about to become one of entire prohibition, as affecting this Country. A letter, it is said, in these papers, had been received at Boston from Washington, stating, "that a Bill would soon be reported, to interdict all intercourse with the British West Indies, and the Provinces East and North of us."

THE BURNING OF THE EXETER THEATRE.—The Theatre at Exeter was totally destroyed by fire on Monday night, with every article of scenery, machinery, decorations, and musical instruments; not an atom of either is saved. Sir—Having, in a report of the trial in the case of Kennedy v. Keogh, a Barrister, inserted in your paper of the 9th inst., taken notice of an unaccountable and unfair statement made by Mr. Dalton, the Assignee, calculated to mislead and prejudice the public mind against the Defendant, I take the liberty of requesting you to state the following facts, which are of record in the proceedings under the Commission of Bankruptcy, as also in the matter of the Petition of Mr. Dalton himself to prevent the signing of Bankrupt's Certificate by the Chancellor, which Petition, after solemn argument, was dismissed with full Costs against Petitioner. The facts are:—

That the firm of Thomas Kough and Company failed in the month of November, 1816, from unforeseen losses in trade, at a period of unexampled distress in the Commercial World, for a sum under £80,000.

That they were before the Commissioners, by indigent documents, losses incurred, on the various transactions of a very extensive foreign and domestic trade, amounting to within a fraction of £25,000.

That the debts returned by Bankrupts, as due to their Estate, amounted to above £30,000. That Bankrupts' landed property, amounting to nearly £1000 per annum, was taken possession of under an Extent in Aid, at the Suit of the Crown, in the month of August, 1817, for a large debt due by Bankrupts to their Bankers in London, the rents of which lands the Custodian for the Crown has been ever since receiving.

That Bankrupts' furniture and other effects were at the same time sold under the Extent, save what has been returned by them in their general and private Schedules.

NEWFOUNDLAND.

The following extract of a private Letter contains the most recent information received from this settlement. It corresponds, in its statements, with others that we have seen, none of which mention any other intelligence worthy of notice:—

St. John's, Feb. 5.—As this will be the last opportunity before this season, I avail myself of it to send you the state of our market. About 120 barrels of pork were imported from Halifax, which brought the price down from £7 10s. to £6 10s., at which it remains dull sale. Sugar now is the only article very scarce, and if an early vessel off us from your port, a few boxes might be disposed of to advantage; hoping I shall receive a favourable account from you on Spring.

A most dreadful outrage has been stated to us, to have been committed by a man named Ryan, of Cashel, upon a female child of 11 years of age. The villain broke his escape, but was pursued by Capt. CARLOW, MARCH 9.—A man, named Denis Fogarty, was discovered on Thursday morning, the 2d inst., about four o'clock, lying on a dung-hill, near the house of Mrs. Margaret Gleeson, in the Royal Oak, cruelly mangled and beaten, senseless and speechless. He was brought into a stable by some of the help belonging to the Waterford Coach establishment, one of whom also caught his horse, which is a valuable one, near the turnpike gate in that village. As soon as day appeared, Mr. Hackett, who keeps the chief Inn there, very humanely took the poor sufferer into his care, and put the horse into his stable. He, very properly, immediately applied the Rev. Mr. Magath, the next Magistrate, of the circumstance, who promptly attended; and after examining a number of witnesses, he seemed to consider magisterial investigation necessary; accordingly, on Saturday, the 4th inst., he and the Rev. Mr. Roberts had a long examination of witnesses. It appears that the unfortunate man was going from Thurles, to Mr. J. Fitzhugh, near Carlow, with a horse for Mr. John Hamilton, of Dublin, agent to the Duke of Lancaster; that he called, about three o'clock in the morning, at one of those small inns, where he was usually accommodated, for refreshment for himself and his horse; and that either the accidental or intentional fracture of a pane of glass, in trying to make himself heard, led to the atrocious and cruel act. He could not be mistaken for a robber, as he repeatedly and loudly declared his business. He has neither since spoken since he received the injury, and has had the best medical attendance which the neighbourhood affords. Had it not been for some letters from Mr. Hamilton, which were found in his pocket, it would not have been possible to have discovered from whence he came. The transaction is, for the present, involved in obscurity; but we hope the perpetrators of this wantonly act of facility will meet the punishment they so highly merit.—Carlow Morning Post.

LONDON CORN-EXCHANGE, MARCH 10.—We had but little fine Wheat at market this morning, from which circumstance Monday's prices were fully supported for picked samples. Fine Barley being scarce, and in demand, is full as high as on Wednesday; but the sale of the middling qualities was very heavy. The Oat trade was rather better than on Wednesday, having had no fresh arrivals since that day. In Beans and Peas there is no alteration.

WATERFORD MARKETS.

The price of Butter has long been an unfavourable change since our last; on Saturday, 96s. was paid for first qualities, and those of very recent manufacture were considered worth 98s. to 100s.—yesterday, however, this the supply at the crane was only 18 firkins, and those mostly of first quality, the highest price obtained was 92s. There has been a further advance on Singed Pigs; good lots, yesterday, rated from 45s. to 46s. generally, and 6d. over was obtained in some cases. Stuffed Pigs have also gone higher; 45s. 6d. was paid for some prime ones on Saturday, and a few brought as high as 46s.—yesterday's market, as is generally the case on Mondays, furnished no criterion to judge by, there being but few for sale of good quality. The supply of Grain on Saturday fell considerably short of that day week's receipts—Prime Wheat got up to 38s. generally, and a few fine samples were taken at 38s. 6d.—the latter price was given yesterday in several instances. There has been likewise a further improvement in Oats; 13s. was currently paid on Saturday to Farmers, by Merchants, for good Potato Oats, and 13s. 6d. by a few purchasers; one remarkably fine sample brought 15s. 6d. for seed. Very little in yesterday, and prices about the same. Malting Barley has not yet advanced beyond 15s., though grinding qualities have been improving, and the finer kinds of the latter almost reach the level of the former. Other articles remain nearly stationary.
