



LONDON.

A question of considerable importance, not only to Clergymen, but to all possessing Rights of Presentation, came before the House of Peers last night. The speeches, on this occasion, deserve the attention of all who are interested in such discussions.

Several Petitions were presented to the Commons on behalf of the Agriculturalists, who complain loudly of the pressure of the times, and solicit the attention of the House to their circumstances.

A Petition from Newcastle-upon-Tyne, praying for a Reform in Parliament, was also presented. The Petitioners disclaim all mischievous doctrines—such as Universal Suffrage and Annual Parliaments; but express a wish that the Elective Franchise may be taken from the rotten Boroughs, and given to other places not properly represented.

A Petition, from Liverpool, prayed that economy should be regarded in settling the Civil List.

A Petition, signed by nearly 3000 Inhabitants of Oldham, praying the House to inquire into the Military Outrage alleged to have occurred in that place, was also presented.

Another Petition was presented from the Merchants, Manufacturers, and Traders of Birmingham, stating the existence of great distress in that town.

The Paris Papers of Wednesday arrived this forenoon.—Grevier, the detected incendiary, has been transferred to La Force. A number of individuals are said to be implicated in this affair; five or six have been arrested. One of the Journals says, that during the hundred days he was employed by the Police to go about as a spy, in the disguise of a mendicant.

The Madrid Journals, of the 29th April, announce, that in consequence of the inquiry instituted into the unfortunate events at Cadix, General Campaña and Valdez, who were then in command of the place, have been arrested, as also the Colonels of the Regiments of Guides and Loyalty, who had shown themselves instruments in the massacre committed on the inhabitants.

A private letter from Mexico, of the 6th of May, confirms the report of the Queen of England having arrived there, on her way home. She travels under the name of the Marchioness de Bult, and her toilette has this expressive device, *Spem meliore tector!*

Some equipages belonging to her Majesty arrived at Ghent on the 6th inst. They were proceeding direct for Brussels, whence it is conjectured that her Majesty will not take Paris in her route.

The installation of the Knights of the Bath, in Westminster Abbey, was originally fixed for the 1st of June. The preparations for this august ceremony are going on with the greatest rapidity, but we understand it is deferred until the 4th of June, it being found impossible to complete the necessary preparations before that day.

The sentence of death passed on Bruce, for having been concerned with M. Linn in the shooting of Birch, the constable, has been transmuted into transportation for life.

Emigration.—The spirit of emigration from the West of Scotland to British North America seems to be greatly on the increase; nor is it prevalent chiefly with those whom penury distress, or want of employment at home, may be supposed to actuate in changing their situations. Many substantial farmers, carrying with them considerable sums of money, and with large families, are among the number of recent emigrants. There are likewise, however, numerous emigrants, as destitute of means as of work, who are emigrating in the hope, that we trust will not prove vain, of bettering their condition which cannot be worse where they are going, than it is in the country they are leaving. The late disturbances in the West may have had no small share also in increasing the number of emigrants, many implicated in those proceedings having quietly left their country for their country's good—a determination, by the bye, which, however excellent of itself, some will be inclined to think, would have been greatly improved had it been taken a few months sooner. Yesterday morning, the 9th instant, the Speculation, Douglas, sailed from hence to Quebec, with about 120 passengers, consisting of farmers, mechanics, and others, chiefly, we understand, from this county, and the shores of Lunenburg and Ayr. On the same day, the Minerva, Williamson, for Quebec and Montreal, took her departure from this port, with 61 passengers of a similar description with the former, and from the same districts.—Greenock Advertiser.

THE ARMY.—We are informed, that the building of Cavalry Barracks, near to Sheepscot Bar, is to commence in a few days.

The Yorkshire Hussars, commanded by the Rt. Hon. Lord Grantham, will assemble in York, on Monday, the 22d inst., to remain on permanent duty for ten days.

Extensive Military Barracks are about to be erected at Stockport.

The 71st, or Royal Glasgow Regiment, which has been so long in garrison at Chester, and has conducted itself with so much propriety, is about to change its quarters. The route is, we understand, to Hull; the 88th Regiment will succeed it at Chester.

Four Troops of the Derbyshire Yeomanry Cavalry, consisting of the Colke, Derby, Chaddesden and Apley, and Hartborne, have received orders to assemble on permanent duty on Monday next,

May 13, at Derby, for six days, under the command of Lieut.-Colonel Sir Robert Wilmot, Bart. Lord Rolle's Regiment of Militia, the South Devon, are to be embodied for training on the 29th inst. Lord Ebrington, acting Lord Lieutenant, has intimated to the Colonels of the other Devon Regiments, that his Majesty has not altogether abandoned an intention of issuing similar instructions to their several respective corps.—Should the whole of the Devon Regiments be called out, the ballot, which must necessarily follow, will be a very heavy one.

Three Ladies from the neighbourhood of Hull, anxious to witness the procession which attended the Coronation of George the III. engaged a room, for which they paid thirty guineas. On their way to take possession of it, they were met by a crowd, to avoid which they descended into the cellar of a green-grocer. The owner was not at the time, but returning soon after, and fearing the mob might injure his goods, he immediately fell a trap door, which he fastened on the outside, and took his departure, leaving the disconsolate trio in "durantia vite." Here they remained until all their wares, and then the man, coming to his shop, found, to his surprise, more than he expected. They were, of course, liberated; and thought, with Franklin, that they had "paid too much for their school."

It is stated in a Morning Paper, that the interviews between the Chancellor of the Exchequer and the Governors of the Bank have terminated in an understanding on the part of the latter, that the five millions are to be paid off in the course of this year, according to promise. By what means this is to be effected we have no idea, as the Chancellor of the Exchequer has not disclosed his financial plan for the year. It will, however, be recollected, that Mr. Mahony's suggestion of a ten per cent. property tax was not ill received in the House of Commons.

The following intelligence is extracted from the Dublin Evening Post of Tuesday:—

EXPEDITION IN THE PERSIAN GULF. CAPTURE OF THE TOWNS OF RASULKHYMA, AFTER A RESISTANCE OF SIX DAYS.

By an arrival from India, considerably the latest that has reached Europe, we have, exclusively, an Official Account of the important capture of the town of Rasulkhyma, the strong hold of the Pirates in the Persian Gulf, by the troops under the command of Major-General Sir Wm. Grant Kier. The town was taken possession of on the 8th of December, after an obstinate and spirited resistance of six days, during which the British Army and Navy displayed all their usual bravery and resolution. Sir W. G. Kier, commanding the Army, and Captain Collier, at the head of the Naval Department, seem to have conducted their respective operations with great skill and intrepidity; but as the details are long, we must, for the present, content ourselves with stating the result, and giving the following return of the killed and wounded. The loss, considering the bold resistance, and, in two instances, very spirited attacks of the Enemy, is not extensive:—

The state of Paris is very far from being one of tranquillity. Our last publication noticed the second attempt on the life of the Duchess de Berri. We concur in the opinion of a Contemporary, "that this is most atrocious and cowardly." Such attacks upon the life of an innocent, unoffending woman, and a stranger, cannot be too loudly execrated, or too severely punished. It is, however, a manifestation—a terrible manifestation—of the spirit which exists in France, and of the (we believe prevailing) determination to free the nation from the Bourbon dynasty."

Some former accounts have been published, but they are so full of repetitions, and so blended with previous statements, that we shall here briefly give the material points. Just when the Prince (or GRAYEVILLE) was seized, one of the Police

Inspectors, CASAR, with great coolness and courage, seized the petard, and extinguished the match, which was already burning, by folding it up in his handkerchief. On being carried to the presence of the Duke of TREVISO, the Major-General on duty, he was taken all a year's time; on being interrogated, he stated, that he was born at Barcelonnette, was thirty years of age, and had served as a Captain in the Lauzers of the E. Gardle. It is said, that he has since followed different courses; that he has been for some time in the commercial line; but that, being at first without employment, he had turned politician. He is described as a short, deformed, ill-looking man, and that, during the hundred days, he was employed by BONAVENTURE as an Agent in Belgium, to revolutionize that Country, where he was seized, put into prison by the Government of the Netherlands, but liberated, and allowed to return to France, after the battle of Waterloo.—He is reported to have acknowledged, that he fired the first petard; and it is added, that various letters, found at his lodgings, prove him to have been in correspondence with certain well known Capitalists; and the Gazette de France attempts to throw the odium of his crime upon the Liberaire. Several of these statements require stronger evidence than has as yet been presented to the Public. It is also asserted, that CASAR has informed upon his accomplices, that six or seven of them have been arrested, and that fifteen petards were found at their respective places of abode. The criminal has been placed in the prison of La Force.

Accounts from Paris say, that there has been a serious altercation between the newly arrived Spanish Charge d'Affaires and the Minister for Foreign Affairs, M. PASQUIER. The former, it is said, complained to the latter of the attacks in the Royalist Newspapers on the present order of things in Spain; and as the Journals are now under Censorship, the Spanish Government considered such attacks as official, and, in that case, it would act accordingly. M. PASQUIER then asked, if the Spaniards had 100,000 soldiers to assist them in their menaces? The Charge d'Affaires replied—"No, we have not; but we can hoist the tri-coloured flag on the Pyrenees, and that will have more effect in France than 100,000 Spanish troops."

Accounts from Madrid state, that twelve individuals have been arrested in that Capital on a charge of conspiracy against the Government, and that orders had been issued to bring them to trial without delay.

It is stated, among the alleged inconveniences that will arise from fixing the Coronation of GEORGE IV. for the 1st of August, "one will be, the postponement of the English Assizes for a fortnight, or three weeks, by which many human beings, who may eventually be proved innocent, will be kept immured in prison so much longer than they otherwise would be; and all this evil is to be suffered not to put the Nobles to the trouble of returning to town for a day or two."

The following novel proceeding took place in the Court of King's Bench, London, on Friday last: EXAMINATION OF THE POPE.

"RICHARD HAYES, Clerk, & A. E. A. KESWELL, Esq.—Mr. GIBBY moved for a rule to show cause why a Commission should not be sent out to Rome for the purpose of examining, an interrogatory, his Holiness Pope Pius VIII., Cardinal GONZALEZ, and other Church Dignitaries of that City, in order to support certain special pleas of justification to an action for a libel, brought by the Plaintiff, a Catholic Clergyman of Ireland, against the Defendant. The cause was set down for trial by a Special Jury at the Sittings after next Term, and it was sworn, that the Defendant could not safely proceed to trial without the testimony of the above named witnesses. Mr. Justice HOLROYD (the only Judge in Court) granted a rule to show cause."

ADDRESS OF THE IRISH ROMAN CATHOLICS TO THE KING.

The following Address was presented to his Majesty, at his Levee, on Wednesday, the 10th instant, by the Earl of Fingall:—

TO THE KING'S MOST EXCELLENT MAJESTY, The humble and dutiful Address of his Majesty's Subjects, professing the Roman Catholic Religion in Ireland.

We, the undersigned, your Majesty's dutiful and loyal Subjects, the Roman Catholics of Ireland, beg leave to approach your Majesty with sentiments of the most profound respect and veneration, and to offer to your Majesty our sincere Condolence on the late melancholy event—an event which has deprived your Majesty of your Royal Father, this Empire of a beloved Sovereign, and your Majesty's Roman Catholic Subjects of a generous Protector, under whose reign they have derived important benefits, of which they will never cease to entertain a grateful recollection.

But, amidst the melancholy feelings which the late National Calamity inspires, we had consolation in the reflection, that our late deservedly lamented Sovereign has been succeeded by a Prince of the same illustrious House. We, therefore, humbly entreat, that your Majesty will be graciously pleased to receive our Congratulations on your Majesty's accession to the Throne of this Realm, to accept the expression of our unalterable fidelity and allegiance, and to allow us to assure your Majesty, that no class of your Majesty's Subjects shall evince greater zeal in support of the principles of our invaluable Constitution, or a more steady attachment to your Majesty's Sacred Person, and the illustrious House of Brunswick, than the Roman Catholics of Ireland.
