SAMUEL RIALLS, their Uncle, amounting to £2100, and to contingent Jointures, for the Wives of the Bankers, amounting to £1500.

SMUGGLING. In the month of January last, we mentioned the seizure of 200 bales of Tobacco, made by BANTON ASPINSON, Esq. Port-Surveyor and Land-waiver of Dungarvan.

On the 20th ult. Mr. ASPINSON received information that Tobacco had been landed on the coast, some miles from Dungarvan, whether he immediately proceeded, with the other officers, and the military, and there discovered 43,000 lbs. of Tobacco, and 19 kegs of Brandy, in a pit, ingeniously constructed as almost to baffle human ingenuity in its detection.

On the 31st of the same month, having received similar information, he ordered the Cavalry and Revenue Officers to proceed to Ballycreegan, with Mr. COCHRAN, Tide-Surveyor, and directed the Infantry, with Mr. ANDERSON, Pro-Collector, to protect him from their station on the cliffs, while he himself proceeded in the Revenue pinnace, with Mr. A. H. S. Deputy Surveyor, and, after a most diligent search amongst the rocks and in caves along the coast, he discovered and seized 70 bales of Tobacco and 110 kegs of Tea, which he sent to Dungarvan, under the care of some of the Revenue Officers; he thereupon instantly proceeded to the interior of the country, and, on the night of the same day, seized in a house 79 bales of Tobacco; and, at day-light, commenced a further search, and found 13 bales in a bog. On the 6th inst., having again received information, he proceeded, with the before-named officers and the military, to Ballycreegan, and there discovered, in three pits similar to the one already described, 174 bales of Tobacco, 18 bales of Tea, and 2 kegs of Brandy, which he brought to Dungarvan; and, on the night of the same day, accompanied by Mr. COCHRAN and six dragoons, he intercepted, on the mountain between Dungarvan and Youghal, a party conveying Tobacco through the country, when he seized four horses and 18 bales of Tobacco—making in the whole, since the month of January last, 684 bales of Tobacco, 110 kegs & 18 bales of Tea, and 21 kegs of Brandy. The seizure in January last being disposed of, the latter are safely lodged in his Majesty's store in Dungarvan. Mr. ASPINSON'S zeal and indefatigable exertions in suppressing a traffic so injurious to his Majesty's Revenue, and to the fair trader, are truly laudable, and will no doubt call forth the well-merited approbation of his Majesty's Government, and of every other man who values the welfare and prosperity of his Country.

It is truly astonishing with what facility he procured information, and it is to his own frank and generous disposition, and to the confidence reposed in him by the people at large, that he stands indebted for it. Nothing but his activity and perseverance, and that of the officers in his department, could, in a country so extensive, and, in this respect, so lawless, have led to such vast and valuable seizures, the duty alone upon which will not fall short of the amazing sum of £10,000!

Two of the desperate gang concerned in the robbery and brutal ill-treatment of Tobias Rossiter, of Newham, in the County of Wexford, Esq., on the 27th of March, and for the apprehension and conviction of any one or more of which gang a reward, amounting to £574 12s. 4d. has been offered by the principal Gentlemen of the County Wexford, have been arrested in this City by Henry Alcock, Esq. Sheriff. One of the Prisoners has turned King's evidence, and the other has been fully identified by Mr. Rossiter's family.

In consequence of information, Sheriff Alcock has found in a ditch, not far from the Abbey Church, two blunderbusses and one horse pistol, all loaded more than half way. They had been deposited there by the party who came hither after robbing Mr. Poole and Mrs. Doyle in the Co. Wexford.

STOLEN WATCHES.—Sheriff Alcock has likewise three silver watches, pledged here by the same gang of robbers. The owners may have them upon verifying their property.

BRITISH CATHOLIC PETITION. The following Petition was presented on Thursday at the Levee, by his Grace the Duke of Norfolk:—

TO THE KING'S MOST EXCELLENT MAJESTY. The humble Petition of the undersigned Persons professing the Roman Catholic Religion in Great Britain:—

That your Petitioners approach your Majesty's presence, ever entertaining the deepest gratitude for the benefits conferred upon them by the Acts passed for their relief during the benevolent reign of your Majesty's Royal Father, their late lamented Sovereign.

That there are, however, several penal and disabling laws still in force against them, which are alike injurious to their particular interests, and prejudicial to the general welfare of the State. They impose upon your Petitioners the same incapacities with which the law visits convicted criminals—they encourage popular prejudices—they perpetuate religious divisions and they prevent their general concert in the Empire so essential to its happiness, prosperity, and independence.

That though your Petitioners are marked out as persons unworthy of public trust, yet they yield to no class of their fellow-subjects in affectionate loyalty to your Majesty, in dutiful submission to the laws, in attachment to the liberties and zeal for the honour of their Country. They have been accused of giving to a Foreign Potentate part of that allegiance which they owe to your Majesty's sacred Person and Government; but they have repeatedly denied the charge, and they beg leave, at the foot of your Majesty's throne, again most solemnly to deny it.

They have lately joined, with heart and voice, in proclaiming your Majesty their legitimate Lord and Sovereign. To your Majesty they swear full and undivided allegiance; in your Majesty alone they recognize the power of the civil sword within their realm of England. They acknowledge in no foreign Prince, Prelate, State, or Potentate, any power or authority to use the same within their civil realm, in any matter or cause whatever, whether civil, spiritual, or ecclesiastical.

With these sentiments your Petitioners throw themselves upon your Majesty's wisdom, liberality, and justice. They humbly pray, if it shall seem meet to your royal judgment so to do, that your Majesty may be graciously pleased to recommend their case to the favourable consideration of Parliament. And they beseech Almighty God, by whom Kings do reign, to bless your Majesty with long and happy years to rule over them.
