DEATH OF THE DUKE OF ORLEANS.

Paris, Wednesday, 9, p.m. A dreadful disaster has fallen upon the King, the Royal Family and France. The Prince Royal is dead!

The Duke of Orleans, who was to leave this evening for St. Omer, went to Neuilly, to bid farewell to his august father. On the road of La Revolte the horses of his carriage took fright.

The King, who was to preside at Paris at a council of ministers, happened about the same time to leave Neuilly. He arrived on the spot almost at the moment the prince was taken up. His Majesty was accompanied by the Queen and Madame Adelaide.

The Duke of Orleans was placed on a brancard, and carried by soldiers to the chapel of the Chateau de Neuilly. The Queen, Madame Adelaide, and the Duc d'Angoulême followed on foot the funeral procession.

The price, at the Cafe de Paris fell, on the news of the death of the Duke of Orleans, to 70; they rallied to 77, and closed at 76 1/2.

THE NATIONAL BANK AND ITS DEFENDER.

Sir,—In your journal of Saturday last, an anonymous writer, under the signature of Veritas—a name, by-the-by, which I shall show you he has no fair claim to, at least in the present case—has thought proper to question the accuracy of a statement which appeared in the Chronicle on the preceding Tuesday, respecting an occurrence about the exchange of sovereigns which took place in the National Bank office, on Saturday, the 9th instant.

Now, sir, beg leave to say emphatically, that every syllable of that statement was, both in substance and in spirit, true to the letter; and that the writer, styled Veritas, in the Mail of Saturday, has stated what he does not believe to be true; and that his premises, as well as his conclusions, are absolutely false; nay more, that he has willfully so stated them, as the sequel will prove.

Some clerical gentlemen who had followed the cortege recited the prayers usual on such occasions. The prince was alone in the carriage, a demi d'Amont, (travelling chaise,) which had a drum slung in front of it. The drum got loose and frightened the horses.

His mother, Marie Amelie, the present Queen of the French, is daughter of Ferdinand, King of the two Sicilies, and whom Louis Philippe exposed at the time that he was wandering abroad as plain Duke D'Orleans.

SUMMER ASSIZES, 1842.

COUNTY COURT—SATURDAY.

Precisely at 9 o'clock this morning the Lord Chief Justice took his seat on the bench. The following gentlemen were called and sworn as a jury. Andrew Carbery, Gregory Lyneberry, James A. Merritt, Robert Howell, Wm. I. Tulloh, William M'Grath, Denis Fitzmaurice, Washington Hobbs, Denis C. Flynn, Lewis Lyneberry, Stephen Gamble, George Moore.

Mr. Scott, Q.C., stated the case to the court and jury. William Hearn sworn—Knows Mr. Wm. Budd; knows he has a weir at Cape Conesa in this county; saw it erected on the river Suir upwards of 2 years ago; it is made with pound and two tiers of nets fixed on poles in the bed of the river outside lower water mark; extends more than 50 yards between the wings of the weir; the poles are placed out from the shore, and the nets are fixed to the poles; they are put down at the beginning of the season and taken up till the season is finished; salmon passes up the river where the net stands; saw Mr. Budd there at the erection of the weir; saw them fishing it; fish when they get in cannot pass through it; catches the salmon fry; the meshes of Mr. Budd's net is under five inches; witness's nets are the regulation size; they were measured by Mr. Kelly.

Cross examined by Counsellor Hassard—Part of the weir is outside lower water mark; it is all between high and low water mark, 34 inches between knot and knot; it is 9 miles from the Hook Tower to Cape Conesa. Edmund Delany sworn—Knows Mr. Budd's weir; it is situated at Cape Conesa; was employed by Mr. Budd to fix the poles in the ground; he was overacting the work at that time; it is about 2 years ago; saw nets attached to the poles with gates underneath; the nets are fixed constantly to the poles during the season; not one out of 10,000 salmon that go in can get out of it; never saw the nets used; would call it a Scotchman's weir or net; the size of the meshes is about 4 inches; the nets used by the boat of Messrs Budd & Co. are 7 inches.

Cross examined by Mr. Barlow—Knew Mr. Budd before he employed witness; Cape Conesa is about 10 miles off the Hook Tower. Thomas Tobin sworn—Knows Mr. Budd; he has a weir at Cape Conesa; saw him erecting and saw him fishing it; it has two tiers of nets and two tiers of poles; no fish going in can get out till nets. Cross examined by Counsellor Hassard—A stop net is commonly called a Scotch weir; it was built 6 or 7 years ago; saw it down since; never missed the weir out of the place it is now in.

Edward Fitzgerald sworn—Lives in Passage; Mr. Budd lives there; has a weir for fishing; saw him repairing and laying it down; saw him at work there 6 months and a year ago; saw it yesterday morning; Mr. Budd never complained of witness; saw James East, who was in Mr. Budd's employment, fishing the weir; has been in Asia, Africa, Europe and America in vessels from a line of battle ship to a 10 gun brig. Cross examined by Counsellor Barlow—Took a glass this morning; his pocket gave it to him; will give clearer evidence against more of them. Case closed for the prosecution.

Counsellor Hassard, for the defence, contended that the port of Waterford was in the county of the city, and therefore the trial could not be had in the county, and the offence being stated to have been committed in the county was fatal, and relied on the charter of the 10th of Charles the 2nd. Mr. Scott said they should prove the charter. It was finally arranged that all the traversers should plead guilty, there being 5 other cases depending on this one; that they should enter into their own recognisance in £500 each, to take up the nets by Saturday next, not to use them for one year except the legislature should pass a law making that legal.

Mr. Scott stated that on this being done they should not be called on for judgment. The traversers were then called, pleaded guilty, and entered into the recognisance on the terms stated. Robert Downey was next indicted, for that he on the 8th of May, at Tournass, did commit a rape on Mary Barrow. After a long and patient trial the jury, without leaving the box, acquitted the prisoner. Ellen Mulcahy was indicted for that she on the 9th of March did desert and expose an infant child at Cullin in this county. Not guilty. She appeared to be a poor woman of weak intellects. Mary Walsh pleaded guilty to an indictment for stealing a gown, value two shillings, at Coolin, the property of Mr. Flynn. To be imprisoned for one fortnight. John M'Grath pleaded guilty to an indictment for stealing an ass, value 20s. To be imprisoned and kept to hard labour for three months. John Connors pleaded guilty to an indictment for stealing £7 10s 0d, the property of Patrick Power, of Crobally. Sentenced to be imprisoned for 6 months, each alternate week to be at hard labour.

Anne Mansfield pleaded guilty to an indictment for stealing an apron, the property of Ellen Walsh, value 10s. To be imprisoned and kept to hard labour for one week. William Harper pleaded guilty to an indictment for stealing, on the 15th of February, 15 silver spoons, the property of his master, John Clarke, Esq. To be imprisoned for 6 months, each alternate week to hard labour. Mary Burke was indicted for stealing a cloak, on the 6th of July, at Clones, the property of Patrick Schofield—Guilty. To be imprisoned for 3 months. Patrick Cronan pleaded guilty to an indictment for stealing two sheep, the property of Michael Malloway. To be transported for 10 years. John Bulger was indicted for stealing, on the 22d of June, at Danganvar, one stone of wool and a sack, the property of John Foley—Guilty. To be imprisoned for 6 months and kept to hard labour each alternate week. This closed the criminal business of the Assizes.

The same jury was returned to try traversers on the new road from Danganvar to Youghal, when George Boste was awarded £39 5s 0d—Breadford Boat was awarded £201 0s 7d—Edwd. Galwey £177 3s 9d and R. Greene was awarded £89 5s 0d. Appeals were next called on which closed all the business of this Assizes, when the Court rose at half past seven o'clock. CITY RECORD COURT—SATURDAY. (BEFORE CHIEF JUSTICE DOHERTY, AND A COUNTY JURY.) Lessee, Henry V. Brown. In this case in which a verdict for the plaintiffs was entered on Friday, it was finally arranged that the defendants should pay the plaintiff the sum of £175 before the 1st of August next, or execution against the lands to issue. Executors of Foshan v. Brennan. Mr. Hatchell stated the case. This was an action of assumpsit in which the plaintiffs, as executors of Mary Anne Foshan, deceased, who kept a Brewery in Carrickbeg, claimed the sum of £31 2s 0d for beer and ale, sold the defendant who was a publican residing in the neighbourhood of Carrick, the case was fully proved by Mr. Quan, a clerk in the plaintiffs' employment, and although cross examined at some length by Mr. Kirwan, whom the court allowed to plead on his statement that the defendant was too poor to employ counsel, yet nothing favorable to the defendant was elicited. Verdict for plaintiffs £31 2s 0d and costs. Counsel for Plaintiffs—Messrs. Hatchell and Harris—Agent—Mr. E. T. Power. For Defendants—Mr. Kirwan, Attorney. Ralph Hudson v. Wm. Randall, and Wm. Randall, jun. The plaintiff in this case, who brought his action for recovery of £117 16s 5d for freightage, and £50 for demurrage due to the owners of the schooner Hero, of Sunderland, obtained a rule nisi to change the venue from Tralee to Waterford, and damages were laid in the declaration at £2000; the defendants pleaded the general issue, and a set off to the money counts. Mr. Hatchell stated the case for the plaintiff. The plaintiff is a shipowner residing at Sunderland, and the defendants are merchants carrying on business at Limerick and Tralee. In the month of February, 1841, the defendants chartered the schooner Hero, belonging to the plaintiff to carry a cargo of coals to Tralee; she was chartered for 54 working days, on her arrival at Tralee some delay was occasioned in consequence of the shallowness of the river at Tralee roads, and they were obliged to discharge a part of her cargo into lighters before she could be got to the landing of the weather wharf; she was discharged there she was freighted with a cargo of grain for London, where some more delay occurred, and on these grounds the plaintiff claimed 16 days demurrage at three guineas a day—the other sum being the balance of £296 attributable to the delay of the weather wharf; a portion only of which had been paid at Tralee. The facts stated by counsel were proved on the evidence of Mr. Ralph Hudson son to the plaintiff, Mr. Harrington, a broker, from Sunderland, and the mate of the schooner William Lawson. Mr. Kirwan gave in evidence the latter part of the statement of the plaintiff to the utmost stretch, by the stupidity, whether real or assumed, of his manner. He would answer no question without referring to his log book, and every reference took up at least ten minutes, and when under cross examination the plaintiff's son had to get on the table to find out the entries in his log book, and he could find no entry at all, then, that was called for, though in his own handwriting. For defendants it was urged that the delay in the port of Tralee, was not attributable to them, and that they were not liable to be charged with demurrage—that the delay in London was partly his fault of the consignee, and partly attributable to the state of the weather; witness was justified in withholding a portion of the amount of the freight as the plaintiff had deceived them in misrepresenting the capability of the vessel when chartering her. Mr. Alexander R. Pope was examined for the defendants as to the practice of the trade in cases of demurrage, and what should be considered working days—Knows the custom of charging and paying for demurrage—when the weather is so bad as to injure cargo, no working day—where demurrage is claimed application should at once be made to the party from whom it is claimed, and notice given from day to day—if no provision is made in the charter party for the payment of the expense of lighterage, such expense to be borne by owners—if no charter party, then the bill of lading is the document to be guided by. On the cross examination, if the term of the charter party expires, and vessel still detained by charterer, then the Sunday is counted as a working day. His lordship in charging the jury expressed his surprise, without meaning the slightest disparagement to the respectable jury he was addressing, that the plaintiff in changing the venue to Waterford had not thought proper to procure the trial to be held in the county of the city, which is the venue, who must necessarily be conversant with the law, and in his usual brief and lucid manner recapitulated the evidence when the jury retired and shortly after returned with a verdict for the plaintiff of £76 17s 5d damages and 6d costs. A ground of objection was here handed in by Mr. Marley, which his lordship placed in his note book. Counsel for the plaintiff—Messrs. Hatchell, Q.C., Dickson; Counsel for the Defendant—Messrs. Marley and Rolleston. The following prisoners were placed at the bar to receive the sentence of the Court. Philip Harney, for petty larceny—6 months' imprisonment and hard labour. James Halloran, for petty larceny—6 months' imprisonment and hard labour. Edward Keane, bigamy, to be transported for seven years. Stephen Nash, for returning twice from transportation—Sentence of death recorded; his lordship in reply to the prisoner's appeal for mercy—said—though commiserating the unfortunate man for the peculiar hardship of his case, yet he is bound to tell him that there was no discretion left him in the matter, and but that a new law had been passed within the last three or four weeks and which will come into operation the 1st of October next, changing the punishment of death to transportation for life, the benefit of which law he would see his intercession with, he (the judge) would have been compelled to pronounce sentence of death. His lordship having disposed of all the business before him, retired about 5 o'clock. Chief Justice Doherty returned to Court in the evening and took his seat on the Bench, unrobed, to assist in finishing the County business. Several appeals were niled, the parties not appearing, Wm. Kirbey, appellant, James Kennedy, respondent. The respondent obtained a decree in the civil bill court for £27 lost sustained by reason of his boat which he lost to appellant to catch bait having been wrecked whilst in his possession. It was contended for the appellant that the damage complained of was an act of Providence and not chargeable to his account; on the other side evidence was gone into to prove neglect. His lordship after very patiently hearing the case decided on reversing the decree without prejudice and without costs. This closed the Assizes. BOARD OF GUARDIANS—THURSDAY. The weekly meeting was attended by—Messrs. Aylward (in the chair), Dobbyn, Maher, Thomas, Hearn, Holden. The clerk read a letter from the Commissioners notifying their acceptance of Mr. T. F. Strange's resignation, and his intention of issuing an order for a new election for Kildrilly in his place—read a letter enclosing three copies of an Appendix to the Commissioners' report on the Medical Charities. A sum of £81 was voted for payment of different salaries, and for payment of the copying clerks employed on the rate books. The chairman said he had represented to the bank the great convenience it would be to have these sums paid, and the bank consented to make this further grant. The board expressed their surprise and displeasure that they had no weekly statement from the collector for the rural districts, and the clerk was directed to write to him on the subject. A resolution was passed to have 8 stone of wool purchased, in order to have it woven into clothes for the inmates, the weaving to be done out of doors, as there are no looms in the house. Mr. Baird said that this system had been found to save money at the Mendicant Asylum, and it would probably have the effect of preventing some of the distressed weavers from the necessity of becoming inmates.
